Vice President Baldwin submitted a report on enrollment for the 1951 Summer Session stating that the total enrollment this year is 6614 compared to a total enrollment of 7390 for the 1950 Summer Session. He reported the changes in enrollment from last year by various classes of students and indicated that the largest reduction of 23% in the undergraduate group was largely accounted for by the decrease in the number of veterans enrolled.

At the request of Regent Laird, the Vice President of Business and Finance explained the item in the above recommendation for the Zoology Animal House at an estimated cost of \$120,000.

Upon motion of Regent Jones, seconded by Regent Renk, it was VOTED, That, upon recommendation of the Campus Planning Commission, the Dairy Instruction and Research Center Building be located on Linden Drive (straightened) between the Livestock Pavilion (far enough west to leave space for a possible campus entrance from the South) and the present Dairy Barn, and that it be located in line with the front of the Livestock Pavilion.

Regent Renk suggested that the Regents should give consideration to providing about \$100,000 to improve the dairy and beef cattle herds of the University.

Regent Werner explained that the long-range campus plan included permanent facilities for the Extension Division in a new building to house the Extension Division and the University administrative offices and that at that time the facilities to be presently provided for the Extension Division in the Stadium could be utilized by other departments of the University.

Upon motion of Regent Jones, seconded by Regent Campbell, it was VOTED, That \$15,000 be allotted from Unassigned I-E to the Office of Director of Student Personnel Services for the purchase of test booklets, answer sheets, and for labor and supplies needed to expand the state-wide testing program as requested by the Wisconsin Association of Secondary School Principals.

Regent Laird inquired as to why the state-wide testing program was not carried out by the State Department of Public Instruction. Regent Watson explained that it was done by the University because the University had more adequate staff and facilities for this work. It was explained that the University is reimbursed for the cost of this program.

Regent Werner reported that the Special Regent Committee appointed to prepare an inscription for the Lincoln Statue would not have a report to submit until the committee has an opportunity to meet with former Regent Grady who was appointed as a member of this committee.

Regent Watson moved the adoption of the following resolution:

RESOLVED, That the Regents extend their sincere appreciation to Mr. and Mrs. A. Matt. Werner for their graciousness in inviting the Regents and their wives to be their guests in connection with this meeting at Sheboygan and for the most enjoyable entertainment so far provided and yet to be looked forward to.

The motion was seconded by Regent Renk and adopted unanimously by a rising vote.

Regent Werner thanked the Regents for their expression of appreciation.

Regent Laird moved reconsideration of the resolution relating to a plaque for the Memorial Library, adopted by the Regents on May 12, 1951, and moved that the proposed plaque for the Memorial Library be revised to read as follows:

MEMORIAL LIBRARY

This building is dedicated as the University of Wisconsin Memorial Library to honor the men and women who served in the armed forces of the United States in the Second World War. Many of them gave their lives that we might live in freedom. Let us not forget.

Other men of vision and devotion to the University have contributed to the realization of this memorial. The citizens of Wisconsin, represented by the 1945 and 1949 Legislatures, and by Governors Walter S. Goodland and Oscar Rennebohm, provided the public funds for the creation of this great study and research center at the beginning of the second century of the University of Wisconsin.
