POSTPONED REGULAR MEETING OF THE BOARD OF REGENTS

Madison, Wisconsin

Saturday, October 25, 1947, 9 A.M.

PRESENT: Regents Arveson, Callahan, Campbell, Gelatt, Grady, Hodgkins, Jones, Kleczka, Sensenbrenner, Werner.

Upon motion of Regent Werner, seconded by Regent Callahan, it was VOTED, That the minutes of the postponed regular meeting of the Board held on September 27, 1947, be approved as sent out to the Regents.

RECOMMENDATIONS OF THE PRESIDENT

- Faculty Actions -

1. That the following faculty actions be approved:

- (1) A revised curriculum in Electrical Engineering as submitted in EXHIBIT A attached.

Upon motion of Regent Werner, seconded by Regent Campbell, recommendation No. 1 (1) listed under Faculty Actions was adopted.

- (2) Two recommendations of the Graduate School as follows:

- (a) A program leading to the Doctor of Philosophy Degree in Commerce, as submitted in EXHIBIT B attached.
- (b) A program leading to a Master of Science Degree in Applied Art, as submitted in EXHIBIT C attached.

Upon motion of Regent Kleczka, seconded by Regent Werner, recommendation No. 1 (2) listed under Faculty Actions was adopted.

2. That Thompson Webb, Jr., be appointed Director of the University of Wisconsin Press (rank of assistant professor) from November 1, 1947 to June 30, 1948; salary \$4000 for the period; charge to 15 (WARF).

- (b) 5000.00 - from the Rockefeller Foundation, New York City, as a grant-in-aid for the Centennial Drama Training Program sponsored by the Wisconsin Idea Theatre and the Wisconsin State Centennial Drama Committee, for the period terminating September 30, 1948. *Papers in gift file*
- (c) 100.00 - from a Medical Faculty member to be applied toward the Medical Library Building Fund. *Letter with papers. Donor to remain anonymous.*

In addition to the over-all policy committee, the Executive Committee is authorized to appoint sub-committees to advise on particular aspects of the University.

President Fred stated that in order that much of Dean Ingraham's time may be released for work on the study of the University's functions and policies, it would be necessary to appoint someone to assist him with the administrative work in the College of Letters and Science. He reported that Dean J. H. Herriott was willing to devote part of his time for this purpose and that Dean Elvehjem was willing to release him from part of his work in the Graduate School. Upon motion of Regent Hodgkins, seconded by Regent Kleczka, it was

VOTED, That J. H. Herriott be appointed Associate Dean of the College of Letters and Science for the remainder of the fiscal year 1947-48 and that his salary be increased from \$8400 to \$8700, on the twelve months' basis, effective October 27, 1947; increase of \$204.03 from October 27, 1947 to June 30, 1948, chargeable one-half to Letters and Science (Spanish) and one-half to Graduate School. (Mr. Herriott will still remain Associate Dean of the Graduate School and Professor of Spanish.)

President Fred presented a request from the School of Music for an allotment from the income of the "Anonymous Fund" for payment of expenses in connection with the commemoration of the 150th anniversary of the birth of Franz Schubert. Upon motion of Regent Kleczka, seconded by Regent Jones, it was

VOTED, That \$1000 be allotted from the income of the Anonymous Fund for this purpose.

Upon recommendation of President Fred, and upon motion of Regent Gelatt, seconded by Regent Jones, it was

VOTED, That the office of Dean of the Summer Session be abolished and that John G. Fowlkes be appointed Director of Summer Session. The Director of Summer Session will act as a coordinating officer on budgetary matters and will have specific responsibility for publications and institutes. After the educational programming has been effected by the departmental chairmen and the college deans, the deans will submit the program and budget to the Director of Summer Session. After the budget has been approved, appointments and payrolls will be administered in the same manner as during the regular academic year. The details of planning the summer session program will be carried on by the departmental chairmen and the deans of the various colleges involved. In other words, the selection of courses to be offered with necessary staff will be handled by the departmental chairmen and college deans. Matters pertaining to institutes should be handled directly with the Director of Summer Session.

Upon recommendation of President Fred, and upon motion of Regent Kleczka, seconded by Regent Grady, it was

VOTED, That the salary of Lester W. Paul, professor of radiology, be increased from \$6600 to \$7500, on the twelve months' basis, to take effect February 1, 1948; increase chargeable to Medical School, Radiology.

President Fred stated that there had been discussed with the Regents at various times in the past few months the possibility of certain gifts from Mrs. Eleanor Gooding Lawrence and Miss Anne Blaine of Chicago, Illinois, and that since the last Regent meeting there had been received a letter enclosing quit claim deeds to the farm previously known as the Milford Meadows Farm, another letter enclosing a check for \$100,000 from Mrs. Anita McCormick Blaine, and certificates of title for twenty-eight head of related purebred Holstein cattle. The President read these two letters, together with a letter of July 5, 1947, which gave a more detailed explanation of these matters. (Copies of letters on file.) *with papers of meeting*

In connection with these gifts, the President made the following statement:

"The Dean of the College of Agriculture and various members of the faculty have assured me that these gifts will be of large service to the program of the Agricultural Experiment Station and to the agriculture of the state and nation. The spirit which prompted Mrs. Anita McCormick Blaine, Mrs. Eleanor Gooding Lawrence, and

Miss Anne Blaine to make these gifts is particularly significant. Their interest in carrying forward the program established by Emmons Blaine Junior for the improvement of agriculture, and particularly the dairy husbandry phases of agriculture, is of long standing. This represents in a very definite way their continuing interest in this work. The University of Wisconsin can feel both grateful and fortunate that the donors chose to make these gifts to this University to promote dairy cattle breeding and dairy farming. You will be interested to know that Emmons Blaine Junior attended the University of Wisconsin short course in agriculture in 1916."

Upon recommendation of the Dean of the College of Agriculture, and upon motion of Regent Jones, seconded by Regent Kleczka, it was

VOTED, That the Regents of the University of Wisconsin accept from Mrs. Eleanor Gooding Lawrence and Miss Anne Blaine their offer to convey or cause to be conveyed to the Regents a farm consisting of some five hundred and fifty acres of land located in Jefferson County north and east of Lake Mills, with buildings to house over one hundred milking cows, together with other suitable houses and buildings, with the understanding that the farm is to be used for at least twenty-five years as an agricultural experiment farm and to be known as the Emmons Blaine Junior Experimental Farm.

Upon recommendation of the Dean of the College of Agriculture, and upon motion of Regent Grady, seconded by Regent Gelatt, it was

VOTED, That the Regents of the University of Wisconsin accept a gift from Mrs. Anita McCormick Blaine of \$100,000 to be placed in trust, the fund to be known as the Emmons Blaine Junior Fund, with the understanding that the income from this fund is to be used to assist in the experimental activities carried out on the Emmons Blaine Junior Experimental Farm.

Upon recommendation of the Dean of the College of Agriculture, and upon motion of Regent Kleczka, seconded by Regent Grady, it was

VOTED, That the Regents of the University of Wisconsin accept the gift from Mrs. Anita McCormick Blaine of twenty-eight head of related purebred Holstein cattle, with the understanding that these cattle, so far as practicable, are to be used as part of the experimental dairy cattle breeding program to be carried out on the Emmons Blaine Junior Experimental Farm.

Regent Jones stated that the University is greatly pleased to receive these gifts and presented, upon behalf of the Regents, the following resolution:

"BE IT RESOLVED that the Regents of the University of Wisconsin express to Mrs. Eleanor Gooding Lawrence and Miss Anne Blaine their appreciation for the gift of the Emmons Blaine Junior Experimental Farm, and to Mrs. Anita McCormick Blaine their appreciation for gifts consisting of a trust fund of \$100,000 to be known as the Emmons Blaine Junior Fund and twenty-eight head of related purebred Holstein cattle.

In tendering these gifts to the University, the donors called attention to the fact that 'Emmons Blaine Junior chose to begin his life work in the field of his choice - agriculture - on the farm of the friend of his deepest devotion - Henry B. Favill.

'We, acting on his behalf, bring in his name to the State of Wisconsin this gift in the hope that it will further the high policies in which the work of this farm was founded and carried forward.'

The Regents of the University of Wisconsin are pleased to accept these gifts in the spirit in which they were tendered because of their conviction that the gifts will enable the University to be of increasingly greater service to the people of the state and the nation. The desire of the donors to make these gifts in such a way that they will serve the public welfare in the field of agriculture is to be commended.

The donors and the people of the State of Wisconsin may be assured that the University will use every effort at its command to see that the high purposes for which the gifts have been made will be carried forward in the most effective manner possible as a fitting tribute to Emmons Blaine Junior."

Upon motion of Regent Jones, seconded by Regent Grady, the above resolution was unanimously adopted by a rising vote.

President Fred presented a letter from Mr. Joe Rothschild of Madison, Wisconsin, in which he offered to the University, as a gift, the first prize steer of the 1947 Junior Live Stock Show and the first prize lamb of the 1947 show, for use in the instructional program of the College of Agriculture. Upon motion of Regent Grady, seconded by Regent Campbell, it was

VOTED, That the gift be accepted.

President Fred displayed a plaque which was presented to the University by the United States Navy as a mark of commendation for effective cooperation in training naval personnel during World War II. Upon motion of Regent Grady, seconded by Regent Kleczka, it was

VOTED, That the plaque be accepted.

RECOMMENDATIONS OF THE DIRECTOR OF BUSINESS AND FINANCE

I. Contracts, Leases and Agreements

Amended 1. That the Director of Business and Finance be authorized to sign a contract with the United States of America for a research project during the period September 15, 1947 to February 14, 1948, on the stability of lyophilized cultures of Brucella.

Upon motion of Regent Jones, seconded by Regent Kleczka, recommendation No. 1 listed under the recommendations of the Director of Business and Finance (I. Contracts, Leases and Agreements) was adopted.

II. Report of Contracts and Agreements Signed by the Director of Business and Finance in Accordance with Regent Authority of September 27, 1947

2. Repairs to the chimney on the community building at Badger Village 300 (estimated)
3. Lease of 18 acres of land from Mrs. Sherwood Bishop, Kenosha, for vegetable crop research work - January 1, 1948 to December 31, 1948 360
4. Use of space in Presbyterian Student House, Madison, for use as a rehearsal room for the A cappella choir (School of Music) Total cost per semester 198
5. Rental of 20 acres of pasture land from Grant Newby, Town of Buena Vista, Plover, Wisconsin, for use by the Coddington Branch Agricultural Experiment Station during the summer of 1947 40

Upon motion of Regent Werner, seconded by Regent Kleczka, the report of contracts and agreements signed by the Director of Business and Finance in accordance with Regent authority of September 27, 1947, was approved.

III. Miscellaneous

1. That upon the recommendation of the Director of Physical Plant, Mr. Gerald N. Reis and Mr. Harry Bartholomew be given police powers within the provisions of the state statutes.

Upon motion of Regent Kleczka, seconded by Regent Campbell, recommendation No. 1 listed under the recommendations of the Director of Business and Finance (III. Miscellaneous) was adopted.

Upon recommendation of the Secretary, and upon motion of Regent Campbell, seconded by Regent Grady, it was

VOTED, That Chapter I, Sections 1 and 2, of the By-Laws of the Regents be amended to provide that annual and regular meetings of the Board be held at ten o'clock instead of nine o'clock in the morning.

Regent Werner presented the report of the Finance Committee. Upon motion of Regent Werner, seconded by Regent Kleczka, it was

VOTED, That the Secretary of the Regents be authorized to sign in behalf of the Regents an agreement and stipulation of interests by and between Little Nick Oil Company, National Bank of Tulsa, Cities Service Oil Company, The Atlantic Refining Company, Anderson-Prichard Oil Corporation, W. T. Myers, and Marjorie C.

Nichlos and the Regents relating to the pooling of oil and gas rights in certain lands in Grady County, State of Oklahoma, in which the University holds a beneficial interest in the Estate of W. H. Kipp, deceased.

Upon motion of Regent Werner, seconded by Regent Hodgkins, it was VOTED, That the Director of Business and Finance be authorized and directed to request the State Bureau of Personnel to revise its rules regarding over-time compensation to include the cost-of-living bonus in addition to the basic salary in computing the rate of compensation for over-time services. *Copy 3 resolution by State Management Board with papers.*

Upon motion of Regent Werner, seconded by Regent Campbell, it was VOTED, That the budget totalling \$40,135 covering room and board for the 1947-48 Farm Short Course be approved. (Copy of budget attached.)

Upon motion of Regent Werner, seconded by Regent Kleczka, it was VOTED, That the President and the Director of Business and Finance be authorized to make allotments not exceeding a total of \$75,000 from 1-E unbudgeted receipts for the purchase of required equipment, furniture, apparatus and other miscellaneous capital items.

Upon motion of Regent Werner, seconded by Regent Hodgkins, it was VOTED, That the bid of the C. A. Hooper Company, Madison, for new steam piping and alterations to the existing tunnel on Linden Drive be accepted; that the Director of Business and Finance be authorized to request the Governor to release funds from the post-war construction appropriation for this purpose; and that he be authorized to sign a contract with the C. A. Hooper Company in the sum of \$57,975.

Upon motion of Regent Werner, seconded by Regent Kleczka, it was VOTED, That the request of the residents of the East Hill Trailer Camp to operate a cooperative store on the same basis as the cooperative store established at the Monroe-Randall Trailer Camp be approved; and that authority be granted to purchase a building from the War Assets Administration for this purpose.

Upon motion of Regent Werner, seconded by Regent Kleczka, it was VOTED, That the Director of Business and Finance be authorized and directed to request the Emergency Board for funds needed to meet the cost of the civil service salary adjustments approved by the Personnel Board and the Emergency Board for the period October 1, 1947 to January 31, 1948.

Upon motion of Regent Werner, seconded by Regent Hodgkins, it was VOTED, That the Director of Business and Finance be authorized to accept the offer of the Office of Scientific Research and Development to settle a disputed claim for overhead by payment of the sum of \$3722.35, which represents one-half of the sum in dispute.

Upon motion of Regent Werner, seconded by Regent Hodgkins, it was VOTED, That Mr. H. M. Schmelzer, Administrative Assistant in the Office the Controller, be authorized to sign payrolls, disbursement lists, trust fund vouchers and requisitions. Such lists are to be countersigned by the Secretary or Assistant Secretary of the Regents.

Regent Campbell reported that a collection of oil paintings of great Indian chiefs and scouts, left to the City of Minneapolis by Mr. T. B. Walker, is being offered for sale. He stated that Clifford Lord, Director of the State Historical Society, had been consulted and it is understood that the Minneapolis officials will hold the sale in abeyance for thirty days to permit the University or the Historical Society to negotiate for the purchase of the collection. Upon motion of Regent Hodgkins, seconded by Regent Jones, it was

VOTED, That Mr. Lord be requested to investigate the value of the collection and the probable cost of acquisition, and that it is the feeling of the Board of Regents that if Mr. Lord finds the paintings are worth purchasing, the University and the Historical Society try to work out a plan for acquiring the collection.

At 10:40 A.M. the meeting adjourned.

PROGRAM LEADING TO THE DOCTOR OF PHILOSOPHY DEGREE IN COMMERCE

I. Major Fields

For the preliminary examination the candidate must offer himself for intensive examination in Economic Theory and its Development given by the Department of Economics and in his field of concentration which may be any of the above fields. He must also pass an examination in a secondary field within the department. Fields 2, 4, 6, and 9 will be administered by the Department of Economics in conjunction with the members of the Commerce faculty teaching in these respective fields.

- II. Minor Fields: A candidate for the Ph.D. degree in Commerce shall not minor in Economics or vice versa. Either the School of Commerce or the Department of Economics may on its own motion permit a secondary field in the other department.

Exhibit 8

PROGRAM LEADING TO THE MASTER OF SCIENCE DEGREE IN APPLIED ART

The master's degree in Applied Arts is offered for those candidates who have shown ability to do creative work in some specific field of the Applied Arts.

For admission to the Graduate School for work toward an advanced degree in Applied Art, the candidate must present an equivalent of the undergraduate course in Applied Art at the University of Wisconsin including a minimum of 54 credits in Art Education or allied courses, or the equivalent of these credits as evidenced in a qualifying examination.

SPECIFIC REQUIREMENTS:

1. The selection of a field of specialization in the Applied Arts, agreed upon by the chairman, a professor in that field and the candidate; the professor then becomes the candidate's major professor and adviser.
 2. The election of a minimum of 6 and a maximum of 8 graduate credits outside the field of Applied Arts. The courses selected are to form a coherent group for expanding the candidate's depth of knowledge in his elected field of specialization.
 3. An exhibition of his creative work and a substantial written report of research done in this field. It is stipulated that this exhibition and report will serve as a test of the candidate's research and creative ability in his field of specialization.
 4. Four credits in the graduate seminar in Art Education and Applied Art. The paper prepared in this seminar will be accepted in lieu of a thesis.
 5. A one-hour oral examination before a committee appointed by the Dean of the Graduate School.
 6. The total number of credits must aggregate not less than 24 graduate credits.
