Embarkation - October 20, 1942. Served in - Asiatic-Pacific Theatre. Awarded - Purple Heart. Rank - Corporal. Served - 23 months. Missing in Action at Tarawa Atoll, November 20, 1943. Declared dead by Navy Department l year later.





Rank - Private First Class. Served - 37 months.

First combat mission destroyed two Junker 88's. Pilot on longest combat flight for single engine fighters. Volunteered for first fighter plane shuttle flight to Russia from England. First buried at Hetzerath, Erkelenz, Germany. Removed to U. S. Military Cemetery at Margraten, Holland. Plot U, Row 12, Grave 291.





Awarded - Bronze Star, Purple Heart. Rank - Second Lieutenant. Served - 28 months 25 days. Killed in Action, February 25, 1944 on Mission over Graz, Austria. Was lead Navigator of the left Wing at the time of his death. Crash landed after engine trouble at Terrmhuten, Dutchlandsberg, Austria.


