REGULAR MEETING OF THE BOARD OF REGENTS

Madison, Wisconsin

Saturday, February 15, 1947, 9:50 A.M.

President Sensenbrenner presiding

PRESENT: Regents Callahan, Cleary, Grady, Jones, Kleczka, Sensenbrenner, Werner.

ABSENT: Regents Campbell, Hodgkins, Holmes.

President Sensenbrenner read the following statement expressing the appreciation of the Board of Regents of the services rendered by President E. B. Fred since his appointment as President of the University of Wisconsin on February 15, 1945:

Today marks President Fred's second anniversary as administrative head of the University of Wisconsin. It was two years ago today, on February 15th, 1945, that Dr. Fred became the twelfth president of the University as he began his thirty-third year of distinguished service to our State. Today, the Board of Regents desires to express its recognition of President Fred's invaluable service. Especially since the end of the war, the University has been faced with the most difficult problems of enrollment and staff, and with the need for expansion of facilities and services. In this crucial period, President Fred has exhibited great administrative ability and educational leadership. The Board of Regents, and the entire State which it represents, is deeply grateful to him.

Upon motion of Regent Cleary, seconded by Regent Werner, the statement was unanimously adopted by rising vote.

President Fred expressed his appreciation of the statement made by the Regents with reference to his services.

Upon motion of Regent Cleary, seconded by Regent Kleczka, it was VOTED, That the minutes of the special meeting of the Board held on January 17, 1947, be approved as sent out to the Regents.

RECOMMENDATIONS OF THE PRESIDENT

1. That, effective January 20, 1947, the full refund of tuition previously granted to all students who withdrew from the University to enter the armed service apply only to those students who are required to withdraw by reason of induction under the regulations of the Selective Service System.

Upon motion of Regent Werner, seconded by Regent Callahan, recommendation No. 1 listed under Administration and General was adopted.

2. That the admission of students to the summer terms and fall semester of 1947 be governed by the same policy and regulations as were in effect for the summer terms and fall semester of 1946.

Upon motion of Regent Kleczka, seconded by Regent Callahan, recommendation No. 2 listed under Administration and General was adopted.

- Resignations -

1. That the resignation of Ruth C. Foster, associate professor, student health, be accepted; to take effect January 31, 1947.

Upon motion of Regent Werner, seconded by Regent Cleary, recommendation No. 1 listed under Resignations was adopted.

- Appointments -

1. Charles F. Edson, associate professor of history, to receive a special research appointment for the second semester of 1946-47; salary \$2200 for the semester; charge to allotment 46:51.

Upon motion of Regent Cleary, seconded by Regent Werner, recommendation No. 1 listed under Appointments was adopted.

2. That William H. Young be appointed associate professor of political science beginning with the 1947 summer semester; salary at the rate of \$4500 per academic year; charge to L & S balances.

Upon motion of Regent Kleczka, seconded by Regent Callahan, recommendation No. 2 listed under Appointments was adopted.

Upon motion of Regent Werner, seconded by Regent Grady, recommendation No. 1 listed under Short Courses was adopted.

1. That Charles C. Center be promoted from assistant professor of commerce to associate professor of commerce, beginning with the second semester of 1946-47; and that his salary be increased from the rate of \$3750 to \$4250 for the academic year 1946-47; charge increase to commerce budget, p. 60.

2. That Maia L. Schade be promoted from assistant professor of physical education - women, to associate professor of physical education - women, beginning July 1, 1947.

Adopted.

Upon motion of Regent Cleary, seconded by Regent Kleczka, recommendations 1 and 2 listed under Promotions were adopted.

1. That the leave of absence granted to Howard Becker, professor of sociology, for the second semester of 1946-47, be changed from leave without pay to leave

of absence on the adjusted summer session basis; salary \$1200 for the second semester; charge to the summer session budget.

Upon motion of Regent Kleczka, seconded by Regent Grady, recommendation No. 1 listed under Salary and Service Adjustments was adopted.

- Leaves of Absence -

1. That Burr W. Phillips, professor of education, be granted leave of absence, without pay, for sixty days, beginning January 27, 1947. (This leave to be extended for thirty days, if required by Mr. Phillips' duties in Germany and Austria.)

Upon motion of Regent Cleary, seconded by Regent Werner, recommendation No. 1 listed under Leaves of Absence was adopted.

Upon motion of Regent Werner, seconded by Regent Grady, it was VOTED, That resignations numbered 1 to 107, inclusive, listed under Actions by the President, be approved.

Upon motion of Regent Cleary, seconded by Regent Werner, it was VOTED, That appointments numbered 1 to 286, inclusive, listed under Actions by the President, be approved.

Upon motion of Regent Kleczka, seconded by Regent Cleary, it was VOTED, That salary and service adjustments numbered 1 to 85, inclusive, listed under Actions by the President, be approved.

Upon motion of Regent Werner, seconded by Regent Cleary, it was VOTED, That promotions numbered 1 to 6, inclusive, listed under Actions by the President, be approved.

Upon motion of Regent Jones, seconded by Regent Werner, it was VOTED, That leaves of absence numbered 1 to 9, inclusive, listed under Actions by the President, be approved.

The above actions by the President taken since the January 17, 1947, meeting of the Board and approved by the Regents in the foregoing resolutions are made a part of the records of this meeting.

President Fred reported that a Regent-appointive vacancy existed in the membership of the Board of Visitors due to the death of Mr. A. D. Gillett. Upon motion of Regent Werner, seconded by Regent Kleczka, it was VOTED, That Mr. Clough Gates of Superior, Wisconsin, be appointed to fill the unexpired term, ending July 1, 1949, of the late Mr. A. D. Gillett.

Upon recommendation of the University Committee and the Administrative Committee, and upon motion of Regent Cleary, seconded by Regent Kleczka, it was VOTED, That steps be taken to assemble the laws and rules of the Regents and other rules governing the administration of the University; that the assembled laws and rules be presented for the consideration of the Regents together with proposed revisions; and that the necessary funds be appropriated and the administrative officers of the University be authorized to employ the necessary personnel to undertake the assembling and revision of such laws and rules.

President Fred reported on the need for the furnishing of nursery service for children of veterans living in the Randall and Monroe Trailer Camps. Upon motion of Regent Werner, seconded by Regent Callahan, it was

VOTED, That authority be granted to establish nursery service for children of veterans living in the Randall and Monroe Trailer Camps, and that not to exceed \$1000 be appropriated from unbudgeted LE receipts for this purpose.

President Fred ^{faculty} stated that the report on the need for junior colleges had been completed by the special committee assigned to make the study pursuant to an informal request of the Executive Committee of the Regents on July 12, 1945. Copies of a statement relating to the report were distributed. (Copy attached.) Upon motion of Regent Callahan, seconded by Regent Cleary, it was

VOTED, That the Regents receive the Junior College report and authorize the allotment of sufficient funds for the publication of the report by the University. (Charge to unbudgeted LE receipts.)

Upon recommendation of President Fred, and upon motion of Regent Werner, seconded by Regent Kleczka, it was

VOTED, That \$2000 be appropriated from the Anonymous Trust Fund for the purchase of representative paintings by the late John Steuart Curry, University Artist-in-Residence.

President Fred submitted the report of Dean Middleton regarding the proposal of the Scandinavian-American Association for the exchange of medical students from Scandinavian countries with medical students of this country. Upon motion of Regent Kleczka, seconded by Regent Cleary, it was

VOTED, That the administrative officers of the University be authorized to work out a plan for the reciprocal exchange of medical students from Scandinavian countries without payment of fees.

Letter from Middleton on file with papers

President Fred reported that the legislative appropriation requests for the 1947-48 biennium did not include a request for funds covering the expenses of the Centennial Program at the University. Upon motion of Regent Cleary, seconded by Regent Jones, it was

VOTED, That the administrative officers of the University be authorized to request the Wisconsin Legislature for an appropriation of \$50,000 to cover expenses in connection with the Centennial Program at the University.

Upon recommendation of Dean Elwell, and upon motion of Regent Kleczka, seconded by Regent Cleary, it was

VOTED, That the establishment, beginning in the summer of 1947, of the following schools be approved:

- (1) The Executive School of Credit and Financial Management at the University of Wisconsin.
- (2) The School for Mortgage Bankers at the University of Wisconsin.

(These are short institutes conducted during the summer months.)

RECOMMENDATIONS OF THE DIRECTOR OF BUSINESS AND FINANCE

I. Contracts, Leases and Agreements

1. That the Director of Business and Finance be authorized to sign an agreement with the U.S. Government for the use by the University of storage and laboratory buildings located at Truax Field. No cost other than operation and maintenance expenses chargeable to the University.

Upon motion of Regent Jones, seconded by Regent Callahan, recommendation No. 1 listed under the recommendations of the Director of Business and Finance (I. Contracts, Leases and Agreements) was adopted.

II. Budget Items

1. That the amount of \$146,000 budgeted as Contingent in the 1946-47 budget of Intercollegiate Athletics, Fund 5-C, be transferred as follows: \$6,300 to Salaries and Wages to provide funds for additions in staff and \$139,700 to Supplies and Expense to be applied on the indebtedness on the Field House and Stadium; and that \$50,000 from unbudgeted receipts be added to the Supplies and Expense budget of Intercollegiate Athletics, Fund 5-C, to provide additional funds to be applied on the retirement of the indebtedness on the Field House and Stadium, and to provide for additional supplies and expenses for operations during the remainder of the year 1946-47.

Upon motion of Regent Cleary, seconded by Regent Callahan, recommendation No. 1 listed under the recommendations of the Director of Business and Finance (II. Budget Items) was adopted.

III. Miscellaneous

1. That the gift of \$1500 from Louis F. Schoelkopf be paid to the Wisconsin University Building Corporation to be applied by the Corporation on the purchase price of property south of University Avenue.

Upon motion of Regent Jones, seconded by Regent Kleczka, recommendation No. 1 listed under the recommendations of the Director of Business and Finance (III. Miscellaneous) was adopted.

2. That upon the recommendation of the Executive Committee, all bids received on January 9, 1947, for the Short Course Dormitories be rejected on account of excessive costs.

Upon motion of Regent Cleary, seconded by Regent Grady, recommendation No. 2 listed under the recommendations of the Director of Business and Finance (III. Miscellaneous) was adopted.

ADDITIONAL RECOMMENDATIONS OF THE DIRECTOR OF BUSINESS AND FINANCE
APPROVED BY THE FINANCE COMMITTEE

1. That the Secretary of the Regents be authorized to request the Governor to appoint Mr. George I. Haight, Chicago, as special counsel to represent The Regents of the University of Wisconsin and the State of Wisconsin in any and all matters relating to closing the Estate of Kemper K. Knapp, deceased, including authority to represent The Regents and the State in any court of law and in any action relating to the said Kemper K. Knapp Estate.

Upon motion of Regent Kleczka, seconded by Regent Cleary, recommendation No. 1 listed under the additional recommendations of the Director of Business and Finance was adopted.

2. That the Finance Committee be authorized to act for the Board in approving budget adjustments, including requests to the Legislature for supplemental appropriations to complete the fiscal year 1946-47.

Upon motion of Regent Grady, seconded by Regent Callahan, recommendation No. 2 listed under the additional recommendations of the Director of Business and Finance was adopted.

3. That the Director of Business and Finance be authorized to request the Legislature for authority to destroy vouchers for payrolls and other civil claims against the University for supplies and equipment when ten years old.

Upon motion of Regent Grady, seconded by Regent Kleczka, recommendation No. 3 listed under the additional recommendations of the Director of Business and Finance was adopted.

Regent Cleary reported on the need for authorized representatives of the University to appear before the Wisconsin Legislature from time to time in regard to legislation concerning the University. Upon motion of Regent Cleary, seconded by Regent Jones, it was

VOTED, That President Fred, President Sensenbrenner and Director Peterson be authorized to appear and speak for the Board on any legislative matters affecting the University.

The Secretary reported that the next regular meeting of the Board was scheduled for March 15, 1947, and that the annual banquet sponsored by the Madison and Wisconsin Foundation for the members of the Wisconsin legislature would be held on March 19, 1947. Upon motion of Regent Kleczka, seconded by Regent Grady, it was

VOTED, That the by-laws be suspended and that when this meeting adjourns it adjourn to March 19, 1947, at 1:30 P.M.

Regent Jones presented the report of the Educational Committee and reported that the committee had had several meetings with the Advisory Committee for the School for Workers regarding the various aspects of education in the field of labor-management relations. Upon recommendation of the Educational Committee, and upon motion of Regent Jones, seconded by Regent Kleczka, it was

VOTED, That the Board of Regents recognize that in Labor-Management problems, it is the primary function of the University to provide for instruction and research of a kind which approaches such problems from the standpoint of the public interest. Therefore, the Board requests the President of the University to invite the participation of appropriate groups on this campus to study and explore ways and means by which the public interest may be safeguarded from the adverse effects of differences of opinion between Management and Labor, and that the findings of this study be reported to the Board of Regents, together with recommendations for appropriate action.

Regent Jones presented the report of the Constructional Development Committee. Upon motion of Regent Jones, seconded by Regent Cleary, it was

VOTED, That the College of Agriculture be authorized to employ a full-time person to have complete and direct charge of the foundation seed stock operations; that authority be given for the construction of a two-story processing building 40' x 56' at an estimated cost of \$16,000, two 40' x 80' quonset buildings to provide additional storage capacity at an estimated cost of \$14,000, and the necessary processing equipment, heating facilities, electric facilities, and other required utilities at an estimated cost of \$5,000, to be used in connection with the foundation seed stock program; and that the transfer of \$35,000 from balances in Fund 3-K to Fund 11, Revolving Fund Surpluses, be approved to provide these facilities.

Upon motion of Regent Jones, seconded by Regent Kleczka, it was

VOTED, That the Wisconsin University Building Corporation be authorized to purchase the Gugel Farm for a consideration of \$47,040; that the Wisconsin University Building Corporation be authorized to borrow the necessary funds for this purpose for a term of ten years at an annual interest rate of 3%; and that the President and the Secretary be authorized to sign a lease by the Wisconsin University Building Corporation to the Regents, covering the Gugel Farm, at an annual rental sufficient to amortize the purchase over a ten-year period.

Regent Grady voted "No" because he believed the price was excessive.

Upon motion of Regent Jones, seconded by Regent Cleary, it was

VOTED, That a representative of the University, of the Veterans Administration and of the State make an appraisal of the value of the site which the Veterans Administration has requested be conveyed to the Government for an approach to the proposed Veterans Administration hospital west of the Forest Products Laboratory and determine the proper amount to charge the Government for the easement for a roadway to the Veterans Administration hospital site, including an amount to cover the cost to the University of moving fences, irrigation systems and roadways.

Upon motion of Regent Jones, seconded by Regent Kleczka, it was VOTED, That the Director of Business and Finance be authorized to execute a lease or permit to the Government for the use of land immediately east of the Economic Entomology Building to be used as a quonset-type laboratory building for use in connection with research being conducted by the University of Wisconsin under a contract with the Navy Department, with the understanding that such lease or permit will be for a term not to exceed five years, and with the provision that the lease or permit will be invalidated six months after the termination of the research contract between the Navy Department and the University of Wisconsin.

Upon motion of Regent Jones, seconded by Regent Grady, it was VOTED, That the work on plans for the construction of a Short Course Forum Building, as authorized by the action of the Regents taken on September 14, 1946, be held in abeyance until further action is taken by the Regents to proceed with the Short Course Forum project.

Upon motion of Regent Jones, seconded by Regent Callahan, it was VOTED, That the State Historical Society be granted space on the University campus for the location of a State Historical Museum.

Upon motion of Regent Jones, seconded by Regent Kleczka, it was VOTED, That the Wisconsin University Building Corporation be authorized to remodel the carriage house at the rear of the Schlimgen Building on University Avenue to provide facilities for audio-visual classrooms and laboratories at an estimated cost of \$12,000; and that the Wisconsin University Building Corporation be authorized to borrow the necessary funds for this purpose for a term of thirty years at an annual interest rate of 3%.

Upon motion of Regent Jones, seconded by Regent Cleary, it was VOTED, That the Wisconsin University Building Corporation be authorized to purchase for a consideration of \$3150 from the City of Madison the following six vacant lots located in the area south of University Avenue:

Madison, Wis. (Special) - A basis for broadening widely and deeply opportunities for general education beyond high school in Wisconsin is presented for consideration and study by the citizens of Wisconsin in the 166-page report of the Committee on Junior College Needs in Wisconsin, made public as it was submitted to the University of Wisconsin Board of Regents at its meeting in Pres. Edwin B. Fred's office in Bascom Hall here Saturday.

Setting up definite criteria for the establishment of junior colleges in any part of the state, the report declared that on the basis of such criteria

"it seems that junior colleges may be established with reasonable probability of success in the following cities or areas: Green Bay, Kenosha, Marinette, Menasha-Neenah area, Racine, Sheboygan, and Wausau."

"It is assumed that the junior colleges located in these cities will serve the county, as well as contiguous counties or areas," the report declares. "To illustrate, the recommendation has been made that junior college students at Merrill and Antigo be transported to Wausau. With increased high school attendance and high school graduates continuing at collegiate institutions, Barron, Cumberland, and Rice Lake in Barron County might be the nucleus to insure the successful establishment of a junior college at Rice Lake. Likewise with adequate transportation facilities available and with Clintonville and Waupaca each contributing their proportionate share of students, a junior college might eventually be established at New London to serve Waupaca County and contiguous areas."

In a letter of transmittal accompanying the report, Pres. Fred pointed out to the Regents that "this report is not an over-all study of education in Wisconsin, but rather a consideration of one phase of education. The committee does not consider the report a definite plan to be followed but rather a factual analysis of the situation which exists in the State, with suggestions as to how junior college work may be extended throughout the State."

Members of the committee making the report included F. O. Holt, L. H. Adolfson, C. V. Easum, Richard Evans, John Guy Fowlkes, Mark H. Ingraham, Robert C. Pooley, C. H. Sorum, and M. O. Withey. Members who served as chairmen were Mr. Holt and Dean Fowlkes, who prepared the report assisted by Henry C. Ahrensbrak.

Summarizing Wisconsin's liberal education picture beyond the high school, the report indicated that

ad 1 - junior college report

"For a large number if not possibly a majority of high school graduates in Wisconsin, two years of work in institutions of higher learning will be sufficient,"

the report then proceeded to define a junior college as a "two-year institution admission to which is open to those who have graduated from high school or can show evidence of equivalent training."

The report explains that a junior college may offer two years of liberal terminal education; two years of work which is a combination of liberal terminal and semiprofessional or vocational terminal education; or the freshman and sophomore years of work of a four-year college of letters and science.

The report pointed out that the State Constitution provides that

"Provision shall be made by law for the establishment of a state university at or near the seat of government, and for connecting with the same, from time to time, such colleges in different parts of the state as the interests of education may require." (Wis. State Constitution, Article X, Section 6, 1848).

The report states that "It must also be realized that adequate and proper educational opportunity demands adequate funds. In the past, public institutions of higher learning in Wisconsin have not had sufficient funds. This is particularly true of the state teachers colleges. Wisconsin, along with the rest of the nation, has expressed its faith in public education. This faith must be bulwarked by necessary funds.

"The only ultimate resource a state has is its people. People, like land, must be cultivated. Like fallow land, undeveloped people will not only be non-productive but will become the most troublesome and expensive liabilities a state can have.

"Wisconsin has moved into a period of new interest in and concern for educational opportunity beyond high school. Young men and women recognize the fundamental need for their development to the utmost of their capacities and interests in terms of society's demand for personal services and human satisfaction. The following educational charter is suggested for the State of Wisconsin: the best public educational opportunity for all within our financial ability, with reasonable guarantee of operating efficiency so that maximum value per dollar spent will be received."
