ANNUAL MEETING OF THE BOARD OF REGENTS OF THE UNIVERSITY OF WISCONSIN

Madison, Wirrensin

Held in the President's Office

Monday, June 5, 1961, 2:30 P.M., and Tuesday, June 6, 1961.

President Stewer presiding

PRESENT: Regents Bassett, DeBardeleben, Friedrick, Gelatt, Jensen, Konnak, Rennebohm, Steiger, Watson, Werner.

President Steiger welcomed Mr. Maurice B. Pasch, who had recently been appointed by the Governor as a member of the Board of Regents. Mr. Pasch was present during the entire meeting but did not participate, since his appointment as yet had not been confirmed by the State Senate.

Approval of the minutes of the Regent meeting held on May 12-13, 1961, was deferred until the July meeting of the Regents, since the minutes had not been distributed.

President Steiger announced that the next order of business was the election of officers of the Regents.

Regent Gelatt nominated Mr. Carl E. Steiger for election as President for the ensuing year; and the nomination was seconded by Regent Watson. Regent Konnak moved that the nominations be closed, and that the Secretary cast a

unanimous ballot for the election of Mr. Carl E. Steiger as President for the ensuing year. The motion was seconded by Regent DeBardeleben. Vice President Werner assumed the chair, put the question, and it was voted. The ballot was cast and Mr. Carl E. Steiger was declared elected President for the ensuing year.

President Steiger resumed the chair, and expressed his appreciation to the Regents for their confidence in his handling of the Presidency.

Regent Gelatt nominated Mr. A. Matt. Werner for election as Vice President for the ensuing year. The nomination was seconded by Regent Friedrick. Regent DeBardeleben moved that the nominations be closed, and that the Secretary cast a unanimous ballot for the election of Mr. A. Matt. Werner as Vice President for the ensuing year. The motion was seconded by Regent Konnak, and it was voted. The ballot was cast, and Mr. A. Matt. Werner was declared elected Vice President

Regent Watson nominated Mr. Clarke Smith for Secretary for the ensuing year, and the nomination was seconded by Regent Rennebohm. Regent Gelatt moved that the nominations be closed, and that a unanimous ballot be cast for the election of Mr. Clarke Smith as Secretary for the ensuing year. The motion was seconded by Regent Konnak, and it was voted. The ballot was cast, and Mr. Clarke Smith was declared elected Secretary for the ensuing year.

Regent Watson moved the nomination of Mr. Joseph S. Holt for Assistant Secretary for the ensuing year, and the motion was seconded by Regent DeBardeleben. Regent Konnak moved that the nominations be closed, and that the Secretary cast a unanimous ballot for the election of Mr. Joseph S. Holt as Assistant Secretary for the ensuing year. The motion was seconded by Regent Gelatt, and it was voted. The ballot was cast, and Mr. Joseph S. Holt was declared elected Assistant

President Steiger announced that the next order of business was the election of representatives of the Regents on the Coordinating Committee for Higher Education. Regent Werner moved that Regents Robert C. Bassett, Arthur DeBardeleben, Charles D. Gelatt and Ellis E. Jensen be elected as the representatives of the Regents of the University on the Coordinating Committee for Higher Education for the ensuing year. The motion was seconded by Regent Konnak, and it

was voted. Regents Robert C. Bassett, Arthur DeBardeleben, Charles D. Gelatt and Ellis E. Jensen were declared elected for the ensuing year as members of the Coordinating Committee for Higher Education.

President Elvehjem stated that he had a report with recommendations on the Medical School, involving personnel matters, and asked the Regents what procedure they desired to follow.

Upon motion of Regent DeBardeleben, seconded by Regent Jensen, it was VOTED, That the Board resolve itself into Executive Session to consider the personnel matter, or matters, involved in the President's report on the Medical School.

A member of the press, representing the Milwaukee Journal, inquired whether the Regents would first have to determine the facts in the matter to be presented with reference to whether the facts warranted the Regents considering the matter in Executive Session. He referred to an opinion that had been issued by the Attorney General in connection with the possible consideration of this matter by the Regents. The Secretary stated that he had, on this date, received such an opinion and also stated that the record should show that he had not requested the opinion. Regent DeBardeleben stated that the action just voted by the Regents established the fact that there was a personnel matter involved, and that the Regents had determined that it should be considered in Executive Session. The press left the meeting and the Regents went into Executive Session at 2:40 P.M.

The Regents arose from Executive Session at 1:05 P.M., June 6, 1961, with all Regents present, and with President Steiger presiding.

President Steiger presented the report on the matter considered in Executive Session, and stated that the Regents and President Elvehjem had received from Dean John Z. Bowers the withdrawal of his previously submitted resignation as Dean of the Medical School, which withdrawal Dean Bowers had presented with the following statement:

"I withdraw my resignation as Dean of The Medical School with the sincere hope that, through the continued cooperative understanding of the Regents, the Administration, my Administration and the Medical School Faculty, the problems so obvious in the Medical School can be resolved and we can move ahead."

President Steiger then reported that President Elvehjem had made the following statement to the Regents upon receipt of the withdrawal of his resignation by Dean Bowers:

"I am tremendously concerned about the future of the Medical School and will bend every effort, every power I have, to further its progress. I realize there are many problems and it is going to take time to work them out. We will need the support of everyone in the Medical School and the University Hospitals to arrive at a satisfactory solution. Everyone in the state has an interest in the progress of the University of Wisconsin Medical School. With time, effort, and patience their best interest will be served."

President Steiger then presented the following statement, which had been made on behalf of the Regents:

"The Regents express their support of the administration of the University in its continuing efforts to resolve the differences which have existed in the Medical School and their confidence that, with the cooperation of the Administration, the Dean of the Medical School, and the faculty, there will be continued improvement in the high quality of instruction, research, and public service by the University of Wisconsin Medical School and Hospitals, which we are confident will include resolution of the differences which gave rise to the recent dispute."

Regent Jensen moved the adoption of the above statement by the Regents, the motion was seconded by Regent DeBardeleben, and it was voted.

Regent Gelatt suggested, in recognition of Governor Rennebohm's services as a member of this Board, that the Regents honor him by having him preside during a portion of this meeting.

Upon motion of Regent Jensen, seconded by Regent Friedrick, it was VOTED, That the By-Laws be suspended and Regent Rennebohm be appointed President pro tem.

President Steiger left the Chair and the Chair was assumed by President pro tem. Rennebohm.

Regent Rennebohm expressed his appreciation to the Regents for honoring him by this appointment.

The roll was called with all Regents present except Regent DeBardeleben, who had temporarily left the meeting.

President Elvehjem continued the presentation of his report and recommendations.

Upon motion of Regent Watson, seconded by Regent Gelatt, it was VOTED, That the gifts and grants listed in EXHIBIT A and EXHIBIT A and that the Vice President - Business and Finance be authorized to sign the agreements.

Upon motion of Regent Werner, seconded by Regent Jensen, it was VOTED, That the actions taken by the President of the University since the last meeting of the Regents, relating to appointments, resignations, leaves of absence, and change of status of personnel with rank less than that of Associate Professor, which are included in the file of employment forms presented at this meeting, and the non-resident tuition remissions, be approved, ratified, and confirmed.

The balance of the report of the President of the University was deferred until later in the meeting.

Vice President Peterson presented the Recommendations and Report of the Vice President - Business and Finance.

Upon motion of Regent Werner, seconded by Regent Steiger, it was VOTED, That recommendation 1., listed under the Recommendations and Report of the Vice President - Business and Finance (I. Recommendations) (EXHIBIT B attached), be approved.

Regent DeBardeleben re-entered the meeting at 1:22 P.M.

Upon motion of Regent Watson, seconded by Regent DeBardeleben, it was VOTED, That recommendations 2. to 5., inclusive, listed under the Recommendations and Report of the Vice President - Business and Finance (I. Recommendations)(EXHIBIT B attached), be approved.

Upon motion of Regent Konnak, seconded by Regent Friedrick, it was VOTED, That recommendation 6., listed under the Recommendations and Report of the Vice President - Business and Finance (I. Recommendations) (EXHIBIT B attached), be approved.

Vice President Peterson presented, for the information of the Regents, a Report of Actions Taken by the State Building Commission on May 22, 1961, Affecting the University (see Item II. of the Recommendations and Report of the Vice President - Business and Finance, EXHIBIT B attached).

Upon motion of Regent Jensen, seconded by Regent Gelatt, it was VOTED, That the Report of Actions Taken numbered III., IV., and V., listed under the Recommendations and Report of the Vice President - Business and Finance (EXHIBIT B and EXHIBIT B-1 attached), be approved, ratified and confirmed.

The Vice President - Business and Finance presented, for the information of the Regents, Report of Actions Taken (pursuant to Regent authorization of March 14, 1942)(see Item VI. of the Recommendations and Report of the Vice President - Business and Finance, Exhibit B, and Exhibit B-1, appended to EXHIBIT B attached).

The Vice President - Business and Finance presented the report of budget transfers for the period May 10, 1961 through May 26, 1961, for the information of the Regents. (See Exhibit B-2 appended to EXHIBIT B attached.)

The Secretary reported, for the record, that the Wisconsin Alumni Association had appointed Mrs. L. J. Walker, Berlin, Wisconsin, as a member of the Board of Visitors for the term ending July 1, 1965, to succeed Mr. Fred W. Genrich, Jr.; and had appointed Mr. Adolph J. Ackerman, Madison, Wisconsin, as a member of the Board of Visitors for the balance of the term ending July 1, 1964, to succeed Mr. Russell A. Teckemeyer, who had resigned.

Regent Steiger presented the report of the Executive Committee.

Upon motion of Regent Steiger, seconded by Regent Konnak, it was VOTED, That the following resolution adopted by the Executive Committee since the May 12, 1961, regular meeting of the Board, be approved, ratified and confirmed:

That, subject to the approval of the Governor and the Director of the Bureau of Engineering, Wisconsin State Agencies Building Corporation be authorized to award contracts for utilities extensions and for construction of the Mathematics Building (Van Vleck Hall)(Project No. 5330) on the Madison campus of the University to the low bidder in each division of the work on the basis of the base bids with alternate bids and negotiated revisions accepted as indicated:

Upon motion of Regent Steiger, seconded by Regent Werner, it was VOTED, That the following resolution adopted by the Executive Committee since the May 12, 1961, regular meeting of the Board, be approved, ratified and confirmed:

That, subject to the approval of the Governor and the Director of the Bureau of Engineering, Wisconsin State Agencies Building Corporation be authorized to award a contract for the installation of 26.4 KV Primary Substation, Kenwood Campus, University of Wisconsin - Milwaukee (Project No. 5021A), on the basis of the base bid with alternate bids accepted as indicated, to the low bidder, Dietz Electric Company, Inc., Milwaukee:

At the request of President pro tem. Rennebohm, Vice President Peterson presented the report of the Special Regent Committee on Agricultural Lands.

Upon motion of Regent Gelatt, seconded by Regent Steiger, it was VOTED, That the following recommendations of the Special Regent Committee on Agricultural Lands be adopted:

1. That the following budget for the administration of the Hill Farms development be approved for the fiscal year July 1, 1961 to June 30, 1962, chargeable to receipts from the sale of Hill Farms lands:

Salaries and Wages \$6,000.00
Supplies and Expense, including taxes on unsold lots 4,000.00
Total \$10,000.00.

2. That the appointment of Leo B. McCann as Supervisor of University Hill Farms Development on a part-time basis be continued for the fiscal year July 1, 1961 to June 30, 1962, at a salary of \$500.00 per month, chargeable to the budget for University Hill Farms Development.

Vice President Peterson reported that the United States Supreme Court had thrown out the law suit which had been blocking the development of the Hilldale Shopping Center.

Regent Bassett, Chairman of the Special Regent Committee on Acquisition of Land in Milwaukee, reported that that Committee had expressed to the Milwaukee City administration a willingness to meet whenever necessary to discuss matters connected with the University of Wisconsin - Milwaukee development and the Urban Renewal Program in Milwaukee, but that there had been no need for such a meeting up to this time.

Upon motion of Regent Gelatt, seconded by Regent Werner, it was VOTED, That the meeting recess for committee meetings.

The meeting recessed at 1:40 P.M. to be reconvened following committee meetings to be held at 2:15 P.M.

The meeting reconvened at 3:48 P.M., June 6, 1961, with President Steiger presiding

PRESENT: Regents Bassett, DeBardeleben, Friedrick, Gelatt, Konnak, Rennebohm,

Steiger, Watson, Werner.

ABSENT: Regent Jensen.

President Elvehjem presented the following recommendation:

That authority be granted for the preparation of preliminary plans and specifications for the construction and fixed equipment of a new Cancer Research Building, to be financed by the grant of \$2,475,000 from the National Institutes of Health (Grant No. 4C-7100)(Fund No. 484-3575).

Dean Wendt showed the proposed location of the new Cancer Research Building on a plot plan as being on the west side of North Randall Avenue between the Nurses Dormitory and the Children's Hospital.

Regent Watson moved the approval of the above recommendation, the motion was seconded by Regent Werner, and it was voted.

President Elvehjem presented the following recommendation:

That authority be granted for the preparation of preliminary plans and specifications for the construction and fixed equipment for a Clinical Cancer Research Addition to Wisconsin General Hospital to be financed by a grant of \$448,000.00 from the National Institutes of Health (Grant No. 4C-7101) (Fund No. 484-3576).

Dean Wendt showed the proposed location of the Clinical Cancer Research Addition to Wisconsin General Hospital as being the addition of three floors to the east wing (C Wing) of the Hospital.

Regent Konnak moved the approval of the above recommendation, the motion was seconded by Regent Friedrick, and it was voted.

President Elvehjem presented the following recommendation:

That, subject to the approval of the State Building Commission, authority be granted for the acquisition of the site and for the preparation of preliminary plans and specifications for the Wisconsin Primate Center to be located west of the Psychology Department's Primate Building on Coyne Court, the costs of land purchases and architect's fees to be charged to the grant from the National Institutes of Health (Grant No. H-6288) (Fund No. 484-3578); and that the Vice President - Business and Finance be authorized to negotiate for the acquisition of the site and to conclude the purchase of the site, subject to approval of price and terms by the Executive Committee.

Dean Wendt showed the proposed location for this facility on a plot map. Vice President Peterson explained that, if this recommendation was approved, there would be an appraisal made of the property, and then the purchase would be subject to approval by the Executive Committee of the Regents. He also explained that no part of the grant for this project could be used for razing buildings on this site without the approval of the National Institutes of Health.

Regent Gelatt moved approval of the above recommendation, the motion was seconded by Regent Friedrick, and it was voted.

President Elvehjem presented the following recommendation:

That the final plans and specifications be approved for the Hydrobiology Building and that authority be granted to advertise for bids.

Dean Wendt showed the proposed location for the Hydrobiology Laboratory on a map, distributed a budget estimate for the project, totaling \$502,000.00, and showed floor plans of the building. In answer to a question by Regent Rennebohm, Dean Wendt stated that the building would be located 145 feet west of the Hydraulics Laboratory.

Regent Rennebohm again expressed his opinion that the area north of Bascom Hall to the lake should be developed to provide sites for needed buildings instead of spending large sums to purchase additional land and should also be developed for the purpose of providing a suitable landscaped area in place of the present second growth woods.

Regent Werner moved the approval of the above recommendation, and the motion was seconded by Regent Gelatt.

Regent Gelatt inquired of Regent Rennebohm whether his previous comments were made in objection to the proposed location of the Hydrobiology Laboratory; and Regent Rennebohm replied that they were not, and that he merely wanted to remind the Regents that they should give consideration to the beautification and the development of the Bascom Woods area.

The question was put on the above motion and it was voted.

President Elvehjem presented the following recommendation:

That, subject to the granting of the additional funds required for this project, authority be granted for the preparation of preliminary plans and specifications for the Veterinary Science Building, to be located on the Madison campus.

Dean Wendt showed on a map the location of the proposed Veterinary Science Building as being in the general area on the north side of Linden Drive between Babcock Drive and Elm Drive. He also emphasized that the development of this area for new agricultural buildings would require the relocation of all of the tennis courts presently in that area; that possible sites for relocating these tennis courts might be in the area south of the Holt Dormitories and south of the West of Elm Drive Dormitories. He also noted that new funds would be required for relocating the tennis courts.

Regent Gelatt moved approval of the above recommendation, the motion was seconded by Regent Konnak, and it was voted.

President Elvehjem presented the following recommendation:

That, subject to the granting of the additional funds required for this project, authority be granted for the preparation of preliminary plans and specifications for the Zoology Research Building.

Dean Wendt indicated on a map the general location of the proposed Zoology Research Building as being in the area on the south side of West Johnson Street between North Charter Street and North Mills Street. He indicated a possible location in that area for this building, and stated that the exact location of the first unit would be studied in connection with the preparation of the preliminary plans and specifications.

Regent Konnak moved the approval of the above recommendation, the motion was seconded by Regent Bassett, and it was voted.

President Elvehjem presented the following recommendation:

That, upon the recommendation of the Madison Campus Planning Committee, authority be granted to prepare plans and specifications and to advertise for bids for relocating sidewalks, correcting drainage and miscellaneous improvements in the Kronshage Dormitory area.

Dean Wendt showed on a colored plot plan the area involved and explained the types of improvements to be made, including landscaping work; and stated that the estimated cost of these improvements was \$30,000.00, which would be charged to University Residence Halls funds.

Regent Werner moved approval of the above recommendation, the motion was seconded by Regent DeBardeleben, and it was voted.

Regent Konnak presented the report of the Educational Committee:

Upon motion of Regent Konnak, seconded by Regent DeBardeleben, it was VOTED, That the following recommendations of the Educational Committee be adopted:

1. That Frances L. Zuill, Associate Dean, School of Home Economics, be employed on full time basis for the months of July and August 1961, at a monthly salary of \$1,133.33, to supervise, coordinate and participate in the operation of the School of Home Economics until the new dean, Josephine Staab, reports for her assignment the first of September 1961.

2. That Dr. William D. Stovall be employed on full time basis at an annual salary of \$15,000.00 for the fiscal year 1961-62; salary to be paid as follows: \$5,000.00 to be charged to University Hospitals (1/3 time), \$2,500.00 to the Medical School (1/6 time), and \$7,500.00 to the Laboratory of Hygiene (1/2 time) to be paid from a grant from the National Institutes of Health.

Upon motion of Regent Konnak, seconded by Regent Friedrick, it was VOTED, That M. Starr Nichols, Professor Emeritus of Sanitary Engineering, be employed on a part-time basis, in the 1961 eight week summer session (June 16 to August 11, 1961), at a salary for the period of \$900.00; to be charged to Fund 20, Activity 2.

Upon motion of Regent Konnak, seconded by Regent DeBardeleben, it was VOTED, That George E. Watson, Professor of Education, University of Wisconsin - Milwaukee, be given a special assignment during the summer of 1961 (July 15 to August 11, 1961), half-time basis, at the University Extension Division in Milwaukee; salary for the period \$725.00; to be charged to the Ford Urban Grant (47-3351-Milw. Admin. -20-Ext.-Addl.).

Regent Watson did not vote on the above motion.

Upon motion of Regent Konnak, seconded by Regent DeBardeleben, it was VOTED, That Professor Irvin Wyllie be named Gordon Fox Professor of American Institutions for the three-year period beginning July 1, 1962.

Upon motion of Regent Konnak, seconded by Regent Bassett, it was YOTED, That Mr. Sam E. Ogle, Madison, be appointed as a member of the Board of Visitors for the term ending July 1, 1965; and that Mrs. John C. Lobb, Milwaukee, be appointed as a member of the Board of Visitors for the balance of the term ending July 1, 1962.

Upon motion of Regent Konnak, seconded by Regent Gelatt, it was VOTED, That the Promotion List dated June 1, 1961, for promotions of members of the University Faculty to be shown in the University budget for 1961-62, be approved (Copy on File.).

Upon motion of Regent Konnak, seconded by Regent DeBardeleben, it was VOTED, That the following recommendations of the Educational Committee be adopted:

1. That the following appointments by the President of the University of faculty, student and alumni members of the Athletic Board for the year 1961-62 be confirmed:

Regent Konnak presented the following recommendation of the Educational Committee:

That, upon recommendation of the University Faculty, based on the "Report of the Committee on Loans and Undergraduate Scholarships Relative to 'Need' Analysis" (Faculty Document 1481), the Office of Loans and Undergraduate Scholarships be relieved of the task of the initial evaluation of "need" for scholarship applicants; and that the University of Wisconsin participate in the College Scholarship Service, the facilities of which will be used to analyze the "need" of those students requesting financial assistance from funds administered by the Committee on Loans and Undergraduate Scholarships of the University of Wisconsin.

Regent Konnak stated that the Educational Committee was recommending the adoption of the proposed procedure, referred to in the above recommendation, for a trial period of one year; and reported that the Committee made the recommendation reluctantly because of the additional charge to students.

Regent Konnak moved the adoption of the above recommendation the motion was seconded by Regent DeBardeleben, and it was voted, with Regent Bassett voting "No" because he was not familiar with the problems involved in this matter.

Regent Gelatt presented the report of the Business and Finance Committee.

Upon motion of Regent Gelatt, seconded by Regent Werner, it was VOTED, That authority be granted for the razing of the building at 429 North Park Street, and for the development of the property as a University parking lot.

Regent Gelatt presented the following recommendation of the Business and Finance Committee:

That the following revisions in University Residence Halls rates, per person for room and board, for the academic year, be approved effective in September 1961:

Regent Gelatt reported that this increase of \$50 per academic year, per student across the board, was about one-half due to normal increases in operating costs and the balance due to the increased costs of the dormitory construction program.

Regent Gelatt moved the adoption of the above recommendation, the motion was seconded by Regent Watson, and it was voted.

Regent Gelatt moved the adoption of the following recommendation of the Business and Finance Committee, and the motion was seconded by Regent Werner:

That, subject to the approval of the Governor and of the Commissioner of the Department of Administration, authority be granted to lease the following properties until June 30, 1966, subject to availability of funds for the payment of rentals:

- (1) Approximately 500 sq. ft. at 201 North Charter Street \$ 80 per month
- (2) Approximately 3 000 sq. ft. at 540 University Avenue \$580 per month
- (3) Approximately 1,760 sq. ft. at 1415 University Avenue \$310 per month;

chargeable to the budget of Buildings and Grounds.

Regent Watson inquired as to the use to be made of this space; and was informed by Vice President Peterson that the tentative plans were to assign the space to Scandinavian Languages, Psychology, and possibly Economics and Education.

The question was put on the above motion, and it was voted.

Upon motion of Regent Gelatt, seconded by Regent Werner, it was VOTED, That, subject to the approval of the Governor, Wisconsin University Building Corporation be authorized to purchase the following property located in the dormitory expansion area at the price stated, chargeable to funds transferred from Residence Halls Revolving Fund to Wisconsin University Building Corporation, to be used for construction and equipment costs and temporary financing for approved student housing projects:

311 North Lake Street - North 1/4 of Lot 10, Block 7, University Addition to the City of Madison \$18,000.00.

Regent Gelatt read the following resolution:

RESOLUTION

WHEREAS, additional lands are required by The Regents of The University of Wisconsin for university purposes in the City of Madison. Dane County, Wisconsin, and

WHEREAS, funds are available for acquisition of such lands, and

WHEREAS, the properties listed on the attached Schedule I, located in Block 15, University Addition to the City of Madison, Wisconsin, and more particularly described in Schedule I attached, are required for the building program which the Regents have planned for needed University expansion,

NOW, THEREFORE, Be It Resolved, by The Regents of The University of Wisconsin, in regular meeting assembled, in accordance with section 32.07, Wisconsin Statutes, that it is necessary to take and acquire for university purposes by condemnation proceedings and it is hereby so determined, the real estate described in the attached Schedule I situated in the City of Madison, Dane County, Wisconsin.

Be It Further Resolved, that, if satisfactory arrangements for the purchase of the said properties have not been concluded by June 15 1961, that subject to approval of the Governor of the State of Wisconsin, the Attorney General of Wisconsin be and he is hereby requested, authorized and instructed to commence and prosecute proceedings in accordance with the provisions of Chapter 32, Wisconsin Statutes, and to take any other appropriate legal action which may, by him, be deemed necessary to acquire said properties free and clear of all encumbrances, in the event that the owners refuse to accept any jurisdictional offers of The Regents of The University of Wisconsin made pursuant to said Chapter 32 and after compliance by the Regents with all necessary jurisdictional steps required by said Chapter 32 as conditions precedent to condemnation.

Regent Gelatt moved the adoption of the above resolution, the motion was seconded by Regent Konnak, and it was voted.

Regent Gelatt moved the adoption of the following recommendation of the Business and Finance Committee, and the motion was seconded by Regent Werner:

That, subject to the approval of the project by the State Building Commission, authority be granted for the preparation of preliminary plans and specifications for a Scholarship Cooperative Dormitory for Men, for about 50 students, to be located immediately south of David Schreiner House on North Orchard Street, at an estimated cost of \$260,000.00, including the purchase of land, to be financed by the following allotments of funds and authorization for borrowing which are hereby approved:

- (1) Allotment of balance on July 1, 1961, in the Income Account of the Henry H. Rust Memorial Fund, for part of the cost of the project.
- (2) Allotment of an amount from the Principal Account of the Anonymous Trust Fund, for part of the cost of the project, equal to the market value on June 30, 1961, of the Principal Account of the Henry H. Rust Memorial Fund.

- (3) Balance of cost of project to be financed by funds to be borrowed by Wisconsin University Building Corporation.
- (4) Transfer annually on July 1, beginning July 1, 1962, the unexpended balance in the Income Account of the Henry H. Rust Memorial Fund to the Income Account of the Anonymous Trust Fund.
- (5) Transfer to the Principal Account of the Anonymous Trust Fund the total amount in the Principal Account of the Henry H. Rust Memorial Fund at such time as the latter becomes available for expenditure.

In response to a question by Regent Rennebohm, the Secretary read the terms and conditions relating to the use of the principal and the income of the Henry H. Rust Memorial Fund.

The question was put on the above motion, and it was voted.

Regent Werner made the following statement:

"Mr. President and members of the Board, it is with a feeling of deep regret that we realize this is perhaps the last meeting that Regent Watson will attend. As an expression of our feeling of appreciation for what he has done for the University and our sense of regret, I offer the following resolution:

"RESOLUTION

"In the twelve years George Watson has served on this Board of Regents he has made a lasting impression on the University of Wisconsin through his wisdom and wit. His understanding of the basic goals of all education in a free society has been exceptional. It is a rare governing board that can have the devoted and courageous contributions of such a gifted policy maker and skillful administrator.

"The decisions of this Board have often reflected the judgment of George Watson who has utilized, for us, his intimate acquaintance with the solution of problems in elementary, secondary and vocational schools and in higher education. His sturdy, clearly-understood recommendations were never based on merely the safest approach, but the best possible solution for the University and the people of Wisconsin. He not only stated, with eloquence, long-range goals, but stood up to the test of public voting to make his stimulating ideas a reality. He somehow managed to keep his vast knowledge of specific detail on educational matters from cluttering his crisp, well-informed statements about plans and procedures for our University.

"His sharp sense of humor has had special value for us since he applied it immediately to suit the question at hand and, usually, to clarify a point at issue.

"Our regret at having George leave our Board is tempered with the knowledge that he will continue his service to the University and the State as a professor and administrator in the University of Wisconsin - Milwaukee. His will be the unusual mission to implement at staff level the policies he has helped to form as a vital member of this Board. He carries to his new post our congratulations, gratitude for sterling service and our confidence that he will add another significant chapter to a volume of achievements in strengthening education in Wisconsin."

Regent Werner moved the adoption of the above resolution, the motion was seconded by Regent Gelatt, and President Steiger stated that he was certain that the motion was seconded by all of the Regents. The question was put on the above motion and it was voted unanimously.

Regent Watson responded with the following statement:

"May I ask the indulgence of the Board for a few seconds.

I wasn't prepared for this kind of eulogy, but I sincerely appreciate it and I would like to use this opportunity to say one or two things that have been in my mind all day long.

"My service of twelve years on this Board has been one of the very interesting and satisfying aspects of my State Superintendency. It has been especially satisfying for two reasons. In the twelve years, some of us have seen Regents come and go. There have been a great variety, both from the way in which they acted and the volume of the voices in which they carried on their transactions, but with all of that variety I haven't seen anybody sitting around this table but individuals who wished to be of service to the state and the University. I haven't seen any group representatives or party representatives, just citizens of the state, and that has been very gratifying. It has also been my privilege to work--I hope they would agree with this statement of mine, that I have worked with them -- with two very fine presidents, with President Fred and President Elvehjem. I have found them in every instance extremely anxious, along with the people associated with them, in doing what they think is best for the University. These two things have been very prominent in my thinking all day long and yesterday.

"Because we have been confronted these two days with a very difficult problem--and I don't want to speak for the Board--I just want to think as an individual. It seems the President of the University and his colleagues have labored with this problem and worked within the tradition of this University to find an answer within which harmony could be restored and progress continued. All of us would hasten to say that, in the Medical School, there has been some tremendously fine progress made. In the group of people

"responsible for that progress would be the Dean of the School of Medicine. I would express the hope that, out of the deliberations of today, there could be some tempering of points of view, some lowering of excitement, that there might be some determination on the part of everybody concerned with the School of Medicine to shore in the fine accomplishments that have been made, and that, by the integration of the personal points of view and problems, we can go from here on into a better School of Medicine. I am saying it very poorly. No one has lost or won today that I know of. It is a possible victory for the School of Medicine and the University, if, in this typically Wisconsin tradition, between the University administration, the University Regents, the Medical School administration and the Medical School faculty, there can be a pulling together and setting of higher sights and a determination that we are going to get there. I would like to have my last official word just the expression of hope that we will not consider that anybody has lost or that anybody has won, except that the University may win if we all attack the problem as men of good will. Thank you very much."

President Steiger reported that the annual meeting of the Association of Governing Boards of State Universities and Allied Institutions would be held at the University of Nebraska, Lincoln, Nebraska, October 10 to 15, 1961; and recalled that the Regents had authorized two members of the Board to attend the annual meeting of that Association last year.

Upon motion of Regent Gelatt, seconded by Regent Werner, it was VOTED, That up to and including two members of this Board, who desire to go, be authorized to represent the Regents of the University of Wisconsin at the annual meeting of the Association of Governing Boards of State Universities and Allied Institutions at the University of Nebraska, Lincoln, Nebraska, October 10 to 15, 1961.

Consideration was given to the schedule of Regent meetings for 1961-62. There was discussion of when the 1961-62 University Operating Budget would be ready for consideration by the Regents; and Professor William H. Young informed the Regents that, in this connection, the distribution of faculty salary increases has not been resolved and that the Civil Service pay schedule, now before the Legislature, has not been finally determined. He suggested that July 20 would be a realistic date for the Regent meeting for which the budget material might be ready. It was suggested that it might be desirable not to schedule a meeting in August, due to the late date suggested for the July meeting.

Upon motion of Regent DeBardeleben, seconded by Regent Friedrick, it was VOTED, That the By-Laws be suspended; that the meetings of the Board for 1961-62 be held at 9:00 A.M., except in the

case of the annual meeting, which is to be held at 2:00 P.M.; that all the meetings be held in Madison with the exception of the meetings in December, 1961, and April, 1962, which are to be held in Milwaukee; and that the following schedule of Regent meetings for 1961-62 be approved:

Regent DeBardeleben, noting that he had been temporarily absent from the meeting when the acceptance of the gifts and grants was considered, inquired, with reference to the annual grant from Wisconsin Alumni Research Foundation, whether the allocations had been made for the large amounts for grants-in=aid and for fellowships. President Elvehjem stated that the allocations had been made on a preliminary basis, and that this information could be mailed out to the Regents.

Dean Wendt and Professor Leo Jakobson distributed to the Regents printed copies of the Sketch Plan and of the Core Area Plan for the University of Wisconsin - Milwaukee Kenwood Campus. Dean Wendt stated that these documents were essentially the same as those previously submitted to the Regents, except for the inclusion of a few photographs.

President Steiger announced that, unless there were objections, he would probably reappoint the Regents to the committees on which they had been serving.

Upon motion of Regent Werner, seconded by Regent Gelatt, it was VOTED, That the meeting be adjourned.

The meeting adjourned at 4:50 P.M.

REVISION OF DANCE MAJOR IN DEPARTMENT OF PHYSICAL EDUCATION FOR WOMEN

A minimum of 125 credits and a cumulative grade-point average of at least 2.50 are required for graduation with a B.S. degree in Physical Education (Dance) and the University Teacher's Certificate. These credits must be distributed as follows:

- 1. A minimum of 60 credits in liberal studies to be met through:
 - (a) One of the basic degree programs of the College of Letters and Science plus needed electives, or
 - (b) A pattern of liberal studies requiring minimums of 12 credits of English (including freshman English), 12 credits of social studies (including U.S. history and institutions requirement), 14 credits of science and mathematics, 6 credits of humanities (including art history and/or art education), and 16 elective credits.
- 2. A minimum of 18 credits in professional education courses.
- 3. A minimum of 31 credits in professional dance education course.
- 4. Completion of one of the following:
 - (a) A minor in a primary teaching field.
 - (b) A comprehensive teaching field combining the dance major with related courses chosen from among general physical education, dance, and health education.

PROPOSED PROGRAM FOR THE NON-TEACHING DANCE MAJOR

The non-teaching dance major curriculum is designed for students who are interested in dance from a general cultural point of view or who wish to gain a foundation in dance as a performing art. This major does not fulfill the requirements for a University or state of Wisconsin teacher's certificate. Students who wish to transfer from the non-teaching major to the teaching major must meet the 2.50 grade point requirement for admission to the teaching major.

The specific requirements for graduation in the non-teaching dance major are as follows:

- At least 120 credits and 240 grade points are required for graduation.
- Completion of the lower division requirements of one of the general courses of the College of Letters and Science: Bachelor of Arts (Group A, B or C), Bachelor of Science (Group A or B), or Integrated Liberal Studies.
- 3. Completion of an academic minor of at least 24 credits as defined in the School of Education Bulletin. Methods and student teaching related to specific academic minors are not required for the non-teaching dance major.
- 4. A minimum of 30 credits in dance courses to include basic preparation in: dance accompaniment, dance composition, philosophy of dance, dance production, and dance technique; plus additional elective credits to be selected from among advanced accompaniment (music-dance relationships), advanced composition, and history of dance and methods.

REQUIREMENTS FOR MAJORS IN HOME ECONOMICS

- 1. A minimum of 124 credits and 248 grade points is required for graduation with a Bachelor of Science (Home Economics) or a Bachelor of Science (Home Economics and Education) degree.
- 2. Distribution of credits includes for all students:
 - a. A basic foundation program including a minimum of 41-43 credits in general education courses taken outside the School of Home Economics.

- b. A basic foundation program including 22 credits in courses representing all major areas of Home Economics.
- c. A maximum limit of 48 credits in Home Economics within the 124-credit requirement.
- 3. A maximum limit of 24 credits in professional Education courses is maintained for Education majors, except when additional Education credits are required in the minor (example: Health Education).
- 4. The total number of credits within a major varies according to the field of specialization.

The Faculty of the College of Engineering recommends the establishing of a curriculum in Nuclear Engineering leading to the Bachelor of Science degree. This recommendation conforms to the requirements for College of Engineering curricula as established by the Faculty and approved by the Regents. Specifically, it meets the required division between basic sciences, engineering, and non-technical studies as follows:

- 1. A minimum of nine credits must be devoted to non-technical subjects, and six of these credits are further restricted to meet the History requirement of the College. A required elective shall be Economics, and recommended electives will include Philosophy, Psychology, and Contemporary Trends.
- 2. A minimum of nine credits must be devoted to courses offered by the College of Engineering.
- Six credits may be devoted to subjects in Engineering, Science, and/or Liberal Arts.
- 4. The student will be required to submit a proposed elective plan to the N.E. Committee at least six weeks before the end of his 5th Semester and to obtain Committee approval of his plan.
