PRESENT: Regents Callahan, Wilkie, Ullsperger, Grady; President Frank, Business Manager Phillips, Secretary McCaffrey.

Upon recommendation of President Frank, the following action was taken:

That the special tuition fees of \$50 per semester in the Medical Sc ool and \$25 per semester in the Law School be reduced fifty per cent for the year 1933-34.

In accordance with the action of the Board referring cases of undue hardship to the Executive Committee and the Finance Committee, the following action was taken:
