REGULAR MEETING OF THE BOARD OF REGENTS

Madison, Wisconsin

Saturday, October 16, 1943, 9 A.M.

President Hodgkins presiding

PRESENT: Regents Callahan, Campbell, Cleary, Glover, Grady, Hodgkins, Holmes, Kleczka, Sensenbrenner, Werner.

All Regents present.

Upon motion of Regent Werner, seconded by Regent Kleczka, it was VOTED: That the minutes of the regular meeting of the Board held on September 18, 1943, be approved as sent out to the Regents.

The Secretary called attention to the annual meeting of the Association of Governing Boards of State Universities and Allied Institutions, which is to be held on Friday and Saturday, October 22 and 23, 1943, at the Drake Hotel in Chicago in conjunction with the annual meeting of the National Association of State Universities. The President of the Board was requested to appoint a Regent to attend the meeting.

Upon recommendation of Superintendent Gallistel, and upon motion of Regent Grady, seconded by Regent Werner, it was

VOTED, That police authority on University property be granted to Robert H. McCabe, biologist at the Arboretum, and Herman H. Dresen, chief painter, to be effective October 8, 1943.

The Secretary presented a communication from A. Roy Myers, dated October 6, 1943, in which he advised that the Varsity Apartments at 415-417 North Park

Street are for sale for a consideration of \$35,000 and presented an operating statement. The Chair directed that this communication be referred to the Constructional Development Committee. *sample*

Regent Grady presented the following resolution: *on file*

WHEREAS a most befitting tribute to the late Julia M. Wilkinson has been written by Mary Frank,

BE IT RESOLVED, That the Secretary of this Board be directed to procure a copy thereof, in appropriate printed form, and have the same framed and hung on the wall of the office of the Secretary of the President.

Upon motion of Regent Grady, seconded by Regent Kleczka, adopted.

Regent Kleczka, Chairman of the Educational Committee, stated that the requested information on scholarship stipends had not yet been received and that he was unable to report at this time.

Regent Holmes, Chairman of the Regent-Faculty Conference Committee, reported upon the public hearing on the matter of a separate School of Commerce, which was held in the Joint Finance Committee Hearing Room in the State Capitol on Friday, October 15, 1943, and stated that a copy of the transcript would be sent to each Regent and a further meeting of the committee and interested members of the faculty would be held in the near future.

Gilbert H. Doane, University librarian, Edward P. Alexander, Superintendent of the State Historical Society, Fred L. Holmes of the State Historical Society and Dean Sellery appeared before the Board to discuss the survey of the libraries of the State Historical Society of Wisconsin and the University of Wisconsin by Theodore C. Blegen, Dean of the Graduate School of the University of Minnesota, and Keyes DeWitt Metcalf, Director of the University Library of Harvard University, and presented the following memorandum: *on file*

copy ← MEMORANDUM FROM A JOINT COMMITTEE OF THE UNIVERSITY AND STATE HISTORICAL SOCIETY SUMMARIZING REQUESTS MADE OF THE REGENTS, OCTOBER 16, 1943

1. That the Regents grant \$5,000 to the University Library at once in order to begin putting together the catalogues of the two libraries, and that an additional grant of \$5,000 be made annually to complete the project.
2. That the Regents authorize the University Library to take over the purchase of the general periodicals and the books on the history of Britain and the

Americas south of the Rio Grande--hitherto the obligation of the Society--so that the Society may be able to take care adequately of its proper fields of collection, namely Wisconsin and American history.

3. That the Regents provide for additional library facilities for undergraduates by an extension of Bascom Hall, so as to make the reading rooms of the main Library less inadequate.

4. That the Regents join with the Curators of the State Historical Society in securing from the Legislature an appropriation to fill up the court of the present Historical Society building so as to provide additional library facilities for both the University and the Society.

Librarian Doane spoke at length with reference to the matter and statements were made by the other members of the committee. Upon motion of Regent Kleczka, seconded by Regent Callahan, it was

VOTED, That a grant of \$5,000 be made from Regents Unassigned at once for one year as requested in recommendation No. 1 in the memorandum. Regent Grady requested that he be recorded as not voting.

Upon motion of Regent Glover, seconded by Regent Kleczka, it was

VOTED, That recommendations 2, 3 and 4 in the memorandum be referred to the Executive and Educational Committees for investigation and report at the next meeting of the Board.

Regent Grady presented the following report of the Regent Committee on Constructional Development:

"Your Committee, on Construction and Development, begs leave to report that since the last meeting, a conference was had with three members of the Administration; the State Engineer, the State Architect, and the Director of the State Planning Board; that your Committee recommends that a request be made of the Legislative Committee, to recommend to the Legislature, provision be made for funds to carry out the building projects hereinafter specified, in the order in which such requests and needs, are hereinafter set forth:

phase potential construction

First: That a request be made that an appropriation for enlarging and equipping the Wisconsin General Hospital, to meet the post-war needs, be considered a State wide project, in that the facilities will be required not only for teaching purposes and for the medical staff serving State patients, but that the enlargement thereof, is imperative in the interest of public welfare and that the appropriations to meet such needs be treated as distinct from the University Building Program.

Second: That after an inspection of a number of buildings on the Campus, it is the recommendation of your Committee, that the expense necessary to the fire proofing of Bascom Hall be given precedence over all other appropriations and building needs. There has been a suggestion of making repairs on the interior to accomplish the purpose of reducing the fire hazards, but it is the opinion and recommendation of your Committee that the interior of said buildings be removed and replaced by non-inflammable material, so as to insure the life and safety of the occupants and frequenters thereof. The plan, therefor has not yet been presented, so it is impossible to state with any degree of certainty, the amount of money to be required.

Third: In point of time of construction, we recommend the erection of a new dairy building, cost of which is estimated at three hundred and sixty thousand dollars (\$360,000.00).

Fourth: That the next requirement, in point of immediate needs, is a wing to the Home Economic Building, at an estimated cost of two hundred thousand dollars. (\$200,000.00).

Fifth: An Engineering Building, the cost of which is now estimated at one million, four hundred and fifteen thousand dollars. (\$1,415,000.00). This amount may be reduced should a different plan and structure be adopted.

Sixth: Library Building, the cost of which has been estimated at one million, six hundred eighteen thousand dollars (\$1,618,000.00), which is subject to reduction in the event a less extensive structural plan is adopted.

Seventh: Replacement of the central portion of the Chemistry Building, the cost of which is now estimated at one million, six hundred ninety six thousand dollars. (\$1,696,000.00).

Many of the existing buildings present a condition of extreme fire hazards. This is especially true of Bascom Hall and the Chemistry Building. This building is inadequate for the College of Pharmacy, for which more modern and commodious quarters should be provided. We present herewith a separate sheet, showing the 'TENTATIVE SCHEDULE OF FIRST PHASE OF POST WAR CONSTRUCTION PROGRAM,' with an estimate of costs, subject to change as plans, therefor, are approved and adopted.

It is recommended by your Committee that a request be made for appropriations such as meet the needs herein specified, in so far as such appropriations can be made by the present Legislature and within such legal limitations. We further recommend that application be made to succeeding Legislatures for funds sufficient for the needs and requirements herein specified, in the carrying out of a program involving appropriations for the buildings herein mentioned, to be erected if possible, during the next six years. That the Tentative Schedule attached hereto with the Blue Print, to be presented to the Legislative Committee at its first meeting which your Committee is advised will be held sometime in November, 1943.

Upon motion of Regent Glover, seconded by Regent Kleczka, adopted.

Regent Sensenbrenner, as Chairman of the Regent Expansion Program Committee, presented the following report: *original on file*

"At its meeting on June 26, 1943, the Board approved a memorandum which provided for the creation in the office of the President of the position of assistant to the President, and outlined the duties of the person occupying such position in eight paragraphs. We have given the entire subject careful consideration and recommend the following:

1. That the Department of Public Service be created and that the person appointed to head up the Department have the title of Director of Department of Public Service.
2. That the responsibilities of the person occupying that office shall be as follows:
 - (1) To accelerate and expand a program of State relations designed to develop closer contacts between the University and business, industry and labor, and with professional and other groups in the State.
 - (2) With the approval of the Board of Regents to cooperate with the Alumni Association, and the Alumni generally in promoting the welfare of the University.
 - (3) To use the student body and faculty in reaching the people of the State, thus increasing the contacts between the campus and the citizens of Wisconsin.
 - (4) To act as off-campus liaison officer for the University in discovering additional services which the Colleges and the departments of the University can render.
 - (5) He shall, through the President, be responsible to the Board of Regents, or a special committee thereof, and report through the President to the Board of Regents from time to time on the status of the relations between the University and the State.

In addition, if and when his duties outlined above permit, he

shall at the request of the President

- (1) Represent the President in Alumni Association matters and in contacts with additional organizations, schools, and colleges of the State.
- (2) Represent the President before groups and associations which invite the President to speak when the President cannot accept such invitations because of the pressure of other duties.
- (3) In general, to give the President help and support in official campus contacts and activities, and to be on call for any assignments which the President may make.

Your committee on Expansion was directed to find a man qualified to fill this important position. After giving careful consideration to a good many names which were submitted to us, and realizing the special qualifications necessary to make the most of the opportunities provided by the creation of the new department, the Committee has come to the conclusion that the man should be one from our own campus who has

1. Complete knowledge of the services every department of the University can render, and which he is expected to make available to the citizens of the State.
2. Is well known to members of the Alumni Association and the student body and the faculty.
3. Is well acquainted with numbers of the business men, professional men, and citizens of the State.

We, the majority of the Committee, recommend the appointment of Frank O. Holt, present Dean of the Extension Division of the University.

We further recommend the approval of this report in substitution for the action taken at the meeting of the Board of Regents, held June 26, 1943, referred to in the first paragraph hereof.

Upon motion of Regent Sensenbrenner, seconded by Regent Kleczka, it was VOTED, That the salary of Mr. Holt be continued at the present level (\$8000) until further action by the Board. Regent Grady voted "No" for the same reason that he voted "No" for the appointment of Mr. Holt.

President Dykstra reported that the faculty and alumni members of the
Athletic Board were announced on May 28, 1943; that the student member, Ray Patter-
son, now President of the Student Athletic Board, is added to the Board for 1943-
44. Upon motion of Regent Grady, seconded by Regent Cleary, approved.

Upon recommendation of the President, and upon motion of Regent Cleary, seconded by Regent Sensenbrenner, it was

VOTED, That the salary of Arthur M. Strommen, assistant professor of agronomy (also Branch Stations), be increased from \$2800 to \$3500 per annum, beginning November 1, 1943; charge \$866.68 to Strommen, agronomy, p. 103, \$1,000 to branch stations, p. 110, \$446.60 to animal husbandry, vice Overfield, p. 106.

In connection with the absence of Librarian Gilbert H. Doane, the President recommended that Lawrence C. Burke, associate librarian, be made acting librarian during the absence of Mr. Doane, beginning November 1, 1943, and that his salary be increased from \$3660 to \$4800 per annum; that Mrs. Ethel M. Lynaugh, senior library assistant, be promoted to assistant librarian (rank of instructor) while Mr. Burke is acting librarian, and that her salary be increased from \$1848 to \$2100 per annum, beginning November 1, 1943. Upon motion of Regent Grady, seconded by Regent Holmes, it was

VOTED, That these two recommendations be referred to the Executive and Educational Committees in connection with the other library matter which was referred to them today.

Upon recommendation of President Dykstra, and upon motion of Regent Cleary, seconded by Regent Sensenbrenner, the following grants from Regents Unassigned were approved:

- (a) \$300.00 - Dean of Women, for additional clerical help, 1943-44
- (b) 950.00 - Agriculture, appointment of Barbara A. McLaren, assistant in biochemistry, September 15, 1943 to June 30, 1944, salary \$100 a month. (The University to be reimbursed for salary and other expense in connection with this research up to \$1500 by the State Conservation Department.)

Regent Glover presented John D. Jones, Jr., the new member of the Regents, and a response was made by Mr. Jones.

Upon motion of Regent Grady, a rising vote was taken in expression of the deep appreciation for the splendid service and the enjoyable and kindly association of Mr. Glover while a Regent.

At 11:30 A.M. the meeting adjourned.

EXHIBIT A

PROVISIONS FOR JOINT MAJORS FOR THE MASTER'S DEGREE

1. Diplomas and transcripts of all students who receive, or are candidates for, the master's degree shall indicate the major department or departments.
2. Joint programs for the master's degree may be arranged by any two departments as major departments. Not less than nine credits must be taken in any department which is to be designated as one of the major departments to be listed on the diploma and transcript. An examination in each of the designated major fields is required.
3. Arrangement for joint majors by the departments shall be submitted for approval and as a matter of record to the Administrative Committee of the Graduate School. Any subsequent changes in these arrangements shall also be subject to the approval of the Administrative Committee.
4. Each department shall name an adviser to review and approve study programs for joint majors, a list of whom shall be filed in the Graduate Office. The candidate shall designate his majors on the study list at the time of initial registration in the Graduate School.

EXHIBIT B

THE UNIVERSITY OF WISCONSIN

Requirements for the Master's Degree in Child Development

- A. The general regulations of the Graduate School, except as modified below, apply to the candidate for a Master's degree in Child Development. See page 25 of Bulletin of the University of Wisconsin on the Graduate School 1941-1943.
- B. Special regulations governing the Master's degree in Child Development.
 1. A student will be admitted for work toward the Master's degree in Child Development upon the approval of the Committee on Child Development.
 - a. If a student has not satisfied the equivalent of the undergraduate major in Child Development at the University of Wisconsin, he will be required to make up such deficiencies as in the judgment of the committee may be necessary.
 - b. The Committee on Child Development will assign each student to the appropriate department of specialization and in conjunction with this department he will be assigned to an adviser.
 - c. The course program for each student is worked out with the adviser, and is approved by the Committee on Child Development within the framework of the curriculum of the Child Development program.
 2. Candidates for the master's degree will normally complete an amount of work equivalent to 24 semester hours beyond the bachelor's degree. The mere accumulation of these credits, however, is deemed not as important as the attainment of an integrated knowledge of, and skills in, the field of child development, and as the demonstration of the ability to carry on independent administrative, educational, clinical, or investigative work in this field.
 3. A thesis is regard^{ed} as part of the regular requirement for the degree. It may, however, be waived in some cases if the adviser and the Committee on Child Development deem this desirable.
 4. Candidates must pass final comprehensive examinations covering the thesis or equivalent and the fields studied in preparation for the degree. These examinations will be arranged by the committee, and may be oral or written at its discretion.
- C. The achievement of a Master's degree in Child Development will presume on the part of the student some knowledge acquired at the undergraduate or graduate level of the four fields listed below:
 1. Biological Foundations of Child Development
 - a. Physical and physiological growth and development
 - b. Health and disease
 - c. Nutrition
 - d. Genetics

2. Social Foundations of Child Development

- a. General sociology
- b. The family
- c. Child welfare problems
- d. Social pathology

3. Educational Foundations of Child Development

- a. General principles
- b. Child training
- c. Special educational techniques
- d. Educational behavior and adjustment problems

4. Psychological Foundations of Child Development

- a. General principles
- b. Experimental methods
- c. Psychological behavior and adjustment problems
- d. Developmental psychology
