REGULAR MEETING OF THE BOARD OF REGENTS

Madison, Wisconsin

Saturday, September 30, 1944, 9 A.M.

President Hodgkins presiding

PRESENT: Regents Callahan, Campbell, Cleary, Grady, Hodgkins, Holmes, Jones, Kleczka.

ABSENT: Regents Sensenbrenner, Werner.

Communications were presented from Regents Sensenbrenner and Werner in explanation of their absence.

Upon motion of Regent Cleary, seconded by Regent Callahan, it was VOTED: That the minutes of the special meeting of the Board held on August 19, 1944, be approved as sent out to the Regents, and that the minutes of the meeting of the Executive Committee held in Milwaukee on August 28, 1944, be approved, ratified and confirmed.
