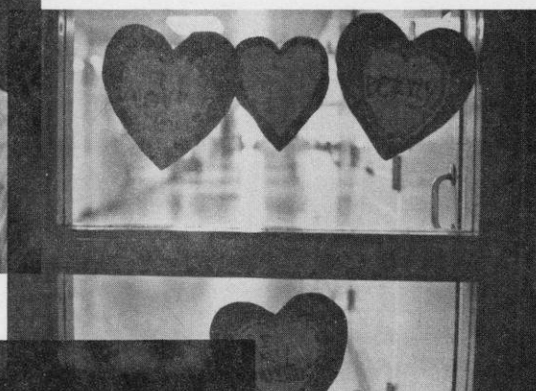
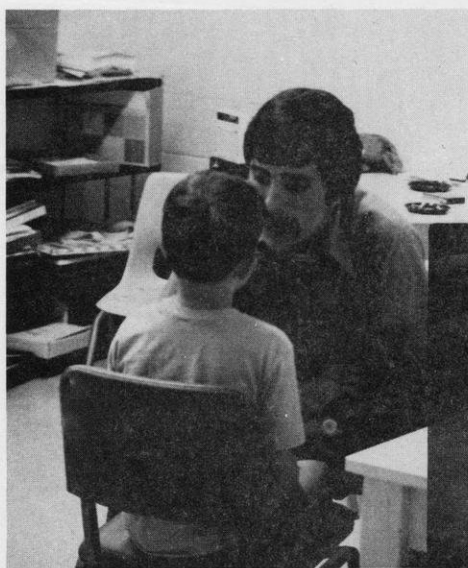

DEAR DR. GLUNZ:

DURING THE PAST YEAR WINNEBAGO BEGAN ITS SECOND CENTURY OF OPERATION. OFTEN SUCH MILESTONES ARE MORE SYMBOLIC THAN REAL. NOT SO THIS ANNIVERSARY, HOWEVER. THE START OF THE HOSPITAL'S SECOND ONE HUNDRED YEARS SAW MASSIVE CHANGES IN THE WHOLE MENTAL HEALTH SYSTEM IN WISCONSIN, AND WITH THOSE CHANGES CAME NEW ROLES, NEW FUNCTIONS, AND NEW RESPONSIBILITIES FOR WINNEBAGO MENTAL HEALTH INSTITUTE.

THIS BRIEF REPORT OUTLINES SOME OF THOSE CHANGES. BREVITY DICTATES THAT THIS BE AN EXCEPTION REPORT ONLY. BUT IT IS IMPORTANT TO REMEMBER, IN FAIRNESS TO THE PROGRAMS AND THE PERSONS IN THOSE PROGRAMS, THAT A GREAT DEAL OF CREATIVE AND EFFECTIVE ACTIVITY OCCURS IN EACH OF OUR MANY PROGRAMS HERE, NOT ALL OF WHICH, UNFORTUNATELY, CAN BE ADEQUATELY HERE DESCRIBED OR PORTRAYED.

WHILE ROLES, FUNCTIONS, AND RESPONSIBILITIES CHANGE, THE BASIC MISSION OF THE WISCONSIN MENTAL HEALTH SYSTEM -- A RESPONSIVE AND RESPONSIBLE NETWORK OF SERVICES FOR THE MENTALLY ILL AND THEIR FAMILIES -- REMAINS A CONSTANT. WE ARE PLEASED, HERE AT WINNEBAGO, TO BE A PART OF THAT CONSTANT AND THOSE CHANGES.

## OVERVIEW

FOR THE FIRST SIXTY YEARS OF ITS EXISTENCE, WINNEBAGO WAS CALLED NORTHERN HOSPITAL FOR THE INSANE. FOR THE NEXT FORTY YEARS IT WAS KNOWN AS WINNEBAGO STATE HOSPITAL. NOW IT IS NAMED WINNEBAGO MENTAL HEALTH INSTITUTE. CHAPTER 90, STATE LAWS OF 1973, CREATED THE INSTITUTE FOR "RESEARCH, SPECIALIZED PSYCHIATRIC SERVICES, AND CONSULTATION, QUALITY CONTROL AND MONITORING OF COUNTY PROGRAMS". ONE OTHER SUCH INSTITUTE WAS CREATED IN MADISON--MENDOTA MENTAL HEALTH INSTITUTE. EACH INSTITUTE SERVES ABOUT 36 OF THE STATE'S 72 COUNTIES.

COMPARED TO THE USUAL PUBLIC MENTAL HEALTH FACILITY, WINNEBAGO IS SMALL--ABOUT 300 PATIENTS--ESPECIALLY CONSIDERING THAT ITS CATCHMENT AREA IS ONE-HALF THE STATE. THIS IS, AND HAS BEEN, POSSIBLE BECAUSE WISCONSIN'S UNIQUE COUNTY MENTAL HOSPITAL SYSTEM HISTORICALLY CARRIED RESPONSIBILITY FOR THE LONG-TERM PATIENT, ALLOWING WINNEBAGO TO CONCENTRATE ON INTENSIVE TREATMENT OF THE ACUTELY ILL AND ON PATIENTS WITH HIGHLY SPECIALIZED DIAGNOSTIC AND TREATMENT NEEDS. NOW WITH INCREASING DEVELOPMENT OF COMPREHENSIVE COMMUNITY PROGRAMS, THE INSTITUTE IS ABLE TO CONCENTRATE ITS EFFORTS STILL FURTHER ON SKILLED CONSULTATION AND TREATMENT ON SPECIALIZED AND REGIONAL PATIENT POPULATIONS.

THE INSTITUTE HAS THE FOLLOWING SPECIALTY SERVICES: ADULT PSYCHIATRIC, ADULT BEHAVIOR MODIFICATION, YOUNG ADULT, CHILD-ADOLESCENT, AUTISTIC, CHILDREN'S CONSULTATION (CCS), ALCOHOLIC, DRUG ABUSE (TELLURIAN COMMUNITY), PSYCHO-GERIATRIC, MEDICAL-SURGICAL, WINNEBAGO COUNTY COMPREHENSIVE MENTAL HEALTH CENTER, TUBERCULOUS MENTALLY ILL, AND FORENSIC. THE LATTER TWO SERVICES HAVE A STATE-WIDE RESPONSIBILITY SINCE WINNEBAGO HAS BEEN THE SOLE COMMITMENT FACILITY FOR THE FEMALE MENTALLY ILL CRIMINAL OFFENDER IN THE STATE, AND SERVES A SIMILAR ROLE FOR THE TUBERCULOUS MENTALLY ILL.

COMMUNITY OUTREACH IS SUBSTANTIAL, WITH AN AVERAGE OF 1000 HOURS PER WEEK DEVOTED TO SUCH CONSULTATION, EDUCATION, AND TRAINING EFFORTS, IN ADDITION TO CASE-CENTERED CONSULTATION OCCURRING AROUND MOST REFERRALS. THE CHILDREN'S CONSULTATION SERVICE IS SPECIFICALLY SET UP TO PROMOTE THE DEVELOPMENT OF PREVENTATIVE MENTAL HEALTH SERVICES IN COMMUNITIES, TO EFFECT COORDINATION BETWEEN THE INSTITUTE AND THE COMMUNITY, AND TO OFFER SERVICES WHEN COMMUNITY RESOURCES NEED TO BE SUPPLEMENTED.

TRAINING PROGRAMS ARE IN OPERATION FOR PSYCHIATRISTS, PSYCHOLOGISTS, SOCIAL WORKERS, PROFESSIONAL AND PRACTICAL NURSES, TEACHERS, LIBRARIANS, OCCUPATIONAL THERAPISTS, CHAPLAINS, DENTAL ASSISTANTS, AND DIETITIANS. OVER 500 STUDENTS PER YEAR FROM TWENTY DIFFERENT FORMALLY AFFILIATED SCHOOLS TRAIN AT THE INSTITUTE, IN ADDITION TO LARGE NUMBERS OF STUDENTS WHO DO PRACTICUM WORK HERE ON A LESS FORMAL AFFILIATE BASIS. EXTENSIVE IN-SERVICE TRAINING PROGRAMS RUN CONTINUOUSLY FOR PSYCHIATRIC AIDES, NURSES, AND ACTIVITY THERAPY PERSONNEL OF BOTH THE INSTITUTE AND COMMUNITY PROGRAMS. RESEARCH HAS BEEN CARRIED OUT IN MANY OF THE CLINICAL AREAS, BUT HAS BEEN PARTICULARLY FOCUSED IN THE AREAS OF DISTURBED CHILDREN, ALCOHOLISM, BEHAVIOR MODIFICATION, SUICIDE, AND DRUG ABUSE.

THE INSTITUTE HAS A THREE-YEAR, APPROVED PSYCHIATRIC RESIDENCY PROGRAM ACCREDITED BY THE EDUCATIONAL COUNCIL OF THE AMERICAN MEDICAL ASSOCIATION. THE INSTITUTE IS ACCREDITED BY THE JOINT COMMISSION ON ACCREDITATION OF HOSPITALS, AND IS CERTIFIED AS A PARTICIPATING HOSPITAL FOR HEALTH INSURANCE UNDER SOCIAL SECURITY. THE DENTAL CLINIC IS ACCREDITED BY THE AMERICAN DENTAL ASSOCIATION AND IS ONE OF ONLY FEW SUCH ACCREDITED FACILITIES IN PSYCHIATRIC HOSPITALS NATIONALLY.

## PROGRESS AND PROBLEMS

### A SIGNIFICANT CHANGE-OVER

ON JANUARY 1, 1974, EACH COUNTY IN WISCONSIN ASSUMED A MANDATORY, STATUTORY RESPONSIBILITY FOR PROVIDING A CONTINUUM OF SERVICES TO EACH PERSON IN EACH COUNTY WHO WAS MENTALLY ILL, ALCOHOLIC, DRUG DEPENDENT, OR DEVELOPMENTALLY DISABLED. AS MIGHT BE EXPECTED, THE TRANSFER OF A SIZABLE STATE RESPONSIBILITY TO AN EMERGING COMMUNITY NETWORK ON A SINGLE ARBITRARY DATE FOUND COMMUNITIES IN VARYING DEGREES OF READINESS. FOR SOME, THE TRANSITION WENT SMOOTHLY, QUICKLY, AND COMFORTABLY. FOR OTHERS, THE TRANSITION IS STILL OCCURRING.

THAT SAME ARBITRARY DATE CARRIED WITH IT SIGNIFICANT CHANGES FOR WINNEBAGO, FROM A GENERALIZED, LARGELY SERVICE INSTITUTION, TO A SPECIALIZED, SECONDARY AND TERTIARY TREATMENT FACILITY. WINNEBAGO ASSUMED, AS WELL, GENEROUS NEW RESPONSIBILITIES IN COMMUNITY CONSULTATION, PROGRAM MONITORING, TRAINING, EDUCATION, AND RESEARCH. THAT ARBITRARY DATE FOUND THE PROGRAMS AT WINNEBAGO IN VARYING DEGREES OF READINESS TO MAKE THE ABRUPT TRANSITION, AND TO SOME EXTENT THAT TRANSITION IS STILL OCCURRING. WHERE THE CHANGE HAS ALREADY OCCURRED, THE NEW ROLES ARE PROCEEDING SMOOTHLY. THERE HAS BEEN A GOOD, HEALTHY, AND RESPECTFUL RELATIONSHIP BETWEEN THE COMMUNITY PROGRAMS AND THE WINNEBAGO PROGRAM AND, INDEED, IT HAS BROUGHT WINNEBAGO AND COMMUNITY PROGRAMS INTO THE SAME NETWORK OF SERVICES.

### POPULATION

NATURALLY, SUCH A CHANGE-OVER HAD AN IMPACT ON POPULATION. IN THE PRIMARY CARE AREAS, WHERE THE COMMUNITIES WERE BEST ABLE TO TAKE OVER THEIR NEW RESPONSIBILITIES QUICKLY, ADMISSIONS DROPPED RATHER DRAMATICALLY. THIS WAS PARTICULARLY EVIDENT AND MOST DRAMATIC IN THE ALCOHOLIC UNIT, WHERE ADMISSIONS DROPPED FROM 854 IN 1972-73, TO 481 IN 1973-74. LARGELY THIS CHANGE WAS DUE TO MILWAUKEE COUNTY'S BEGINNING TO TAKE CARE OF ITS OWN ALCOHOLICS AS OF 1-1-74.

THE OTHER MORE SPECIALIZED PROGRAMS SUCH AS THE CHILDREN'S UNIT, THE TELLURIAN COMMUNITY, THE STEP PROGRAMS, THE FORENSIC UNIT, AND THE SECONDARY AND TERTIARY CARE UNITS ALONG WITH THE GERIATRIC UNIT, WERE NOT AFFECTED NEARLY AS DRAMATICALLY.

SINCE ADMISSIONS DECREASED, OBVIOUSLY SO DID RESIDENT POPULATION. AVERAGE DAILY POPULATION FOR THE YEAR WAS 413, COMPARED TO 503 IN 1973-74. IT MUST BE REMEMBERED AND EMPHASIZED THAT PATIENTS NOW RESIDENT, HOWEVER, REPRESENT A MORE COMPLEX AND SPECIALIZED TYPE OF PATIENT, SINCE THOSE PATIENTS MOST EASILY CARED FOR IN COMMUNITY FACILITIES HAVE ALREADY BEEN TRANSFERRED TO THOSE FACILITIES. ONE CANNOT LOOK AT RESIDENT POPULATION ALONE AS A QUANTITATIVE MEASURE OF WORKLOAD SINCE THERE HAVE BEEN SIGNIFICANT QUALITATIVE CHANGES TOWARD A MORE DIFFICULT, COMPLEX, AND RESOURCE-REQUIRING GROUP.

## BUDGET DROPS

WITH A DECLINE IN RESIDENT POPULATION IT HAS BEEN POSSIBLE TO DROP SOME STAFF POSITIONS FROM THE BUDGETED COMPLEMENT OF WMHI. IN THE 1971-73 BIENNIUM 39 POSITIONS WERE DROPPED. IN 1973-74 AN ADDITIONAL 136 POSITIONS WERE DROPPED, ADDING UP TO A TOTAL OF 175 POSITIONS DROPPED FROM THE STAFFING PATTERN OF WINNEBAGO IN A THREE-YEAR PERIOD. TRANSLATED INTO DOLLARS, THIS REPRESENTS NEARLY TWO MILLION DOLLARS PER YEAR IN SAVINGS. THE WORK FORCE NUMERICALLY HAS GONE FROM 793 GPR POSITIONS IN 1970-71 TO 618 GPR POSITIONS IN 1973-74.

THUS THERE HAS BEEN A SIZABLE REDUCTION IN WORK FORCE COMMENSURATE WITH REDUCTION IN WORK LOAD. IT IS ANTICIPATED THAT ANOTHER 40 OR 50 POSITIONS WILL BE DROPPED FROM THE BUDGET OF WINNEBAGO DURING THE NEXT BIENNIUM, BRINGING THE TOTAL REDUCTION TO OVER 225 POSITIONS IN A SHORT PERIOD OF TIME.

A COMPARABLE NUMBER OF POSITIONS HAS BEEN DROPPED AT MENDOTA, IN FACT SOMEWHAT MORE SINCE THE DECLINE IN RESIDENT POPULATION HAS BEEN EVEN MORE STEEP THERE THAN HERE, DURING THE SAME PERIOD OF TIME. THE MENDOTA DROPS, ADDED TO THOSE HERE, MEANS THAT OVER 500 POSITIONS WILL HAVE BEEN DROPPED FROM THE TWO INSTITUTES IN A FIVE-YEAR TIME SPAN. IN TOTAL THIS IS THE EQUIVALENT OF CLOSING A WHOLE INSTITUTION. WHILE THE DECLINE IN POPULATION AT THE INSTITUTES DOES GET CONSIDERABLE VISIBILITY, THE FACT THAT A SIZABLE AND COMMENSURATE DROP IN WORK FORCE HAS ACCOMPANIED THE RESIDENT POPULATION DROP DOES NOT SEEM TO GET VISIBILITY AND CONTINUES TO BE EITHER OBSCURED OR OVERLOOKED ENTIRELY.

THE DROP IN 500 BUDGETED POSITIONS--OR A DROP OF NEARLY FIVE MILLION DOLLARS ANNUALLY FROM THE BUDGETS OF WINNEBAGO AND MENDOTA--NEEDS TO BE AS FULLY KNOWN AND FULLY APPRECIATED AS THE DROP IN RESIDENT POPULATIONS.

## CONSULTATION AND AUDIT SECTION

ONE OF THE NEW RESPONSIBILITIES OF WINNEBAGO IN THE NEW ROLE OF INSTITUTE, IS THAT OF COMMUNITY CONSULTATION AND MONITORING OF COMMUNITY PROGRAMS. RICHARD STAFFORD, M. D. RE-JOINED THE STAFF OF WINNEBAGO TO ASSUME LEADERSHIP OF THAT NEW SECTION AND THE PROGRAM IS WELL UNDER WAY. THIS SECTION WORKS CLOSELY WITH THE DISTRICT ADMINISTRATORS TO DEVELOP AS WELL AS MAINTAIN QUALITY CONTROL IN COMMUNITY PROGRAMS. TECHNICAL CONSULTATION AROUND SPECIFIC CLINICAL PROBLEMS AND PROGRAMS WILL BE PROVIDED BY STAFF FROM THE CLINICAL PROGRAMS OF THE INSTITUTE BUT SUCH TECHNICAL CONSULTATION WILL BE COORDINATED BY THE CONSULTATION AND AUDIT SECTION.

## FORENSIC UNIT

A KEY IMPROVEMENT IN THE TREATMENT OF FORENSIC PATIENTS AT WINNEBAGO OCCURRED IN MAY, 1974 WHEN ALL SUCH PATIENTS WERE CONSOLIDATED ON A SINGLE UNIT. IN THAT SETTING THE FORENSIC PATIENT CAN RECEIVE COMPREHENSIVE PSYCHIATRIC TREATMENT WITH SPECIAL ATTENTION TO THE PARTICULAR LEGAL PROBLEMS THAT ARE OFTEN INTERWOVEN WITH THEIR PSYCHIATRIC PROBLEMS. THE STAFF CHOSEN FOR THIS UNIT HAVE BEEN GIVEN SPECIAL TRAINING IN THE CARE AND TREATMENT OF THE FORENSIC PATIENT. IN 1973-74, 60 PATIENTS WERE ADMITTED TO THE FORENSIC UNIT, COMPARED TO 50 IN 1972-73. IT IS IMPORTANT TO NOTE, HOWEVER, THAT IN THE FIRST SIX



MONTHS OF THE OPERATION OF THE FORENSIC UNIT AS A SEPARATE CONSOLIDATED SERVICE, ALREADY 50 PATIENTS HAD BEEN ADMITTED. THE REASON FOR THIS INCREASED ADMISSION RATE IS A COMBINATION OF INCREASED TRANSFERS OF PATIENTS WITH CRIMINAL COMMITMENTS OR SEX DEVIATE COMMITMENTS FROM CENTRAL STATE HOSPITAL, ALONG WITH INCREASED UTILIZATION OF WINNEBAGO BY COURTS ACROSS THE STATE FOR CRIMINAL OBSERVATIONS. THE UNIT IS RUNNING AT FULL CAPACITY AND ITS PRESENT CENSUS IS 42.

THE POPULATION OF THE FORENSIC UNIT CURRENTLY CONSISTS OF (1) ALL OF THE FEMALE CRIMINAL COMMITMENTS (UNABLE TO STAND TRIAL OR NOT GUILTY BY REASON OF INSANITY) IN THE STATE OF WISCONSIN; (2) MALE CRIMINAL OBSERVATION CASES SENT DIRECTLY TO WINNEBAGO BY THE COURT; AND (3) SELECTED MALE TRANSFERS FROM CENTRAL STATE HOSPITAL OF PATIENTS FOUND UNABLE TO STAND TRIAL OR NOT GUILTY BY REASON OF INSANITY. ALSO, THERE ARE TRANSFERS FROM THE VARIOUS CORRECTIONAL FACILITIES SUCH AS THE WISCONSIN HOME FOR WOMEN AND THE LINCOLN BOYS SCHOOL. ADDITIONALLY THERE ARE TRANSFERS FROM CENTRAL STATE HOSPITAL UNDER THE SEX CRIMES TREATMENT PROGRAM.

SEPARATE PROGRAMS EXIST ON THE UNIT FOR DIFFERENT SUB-GROUPS OF FORENSIC PATIENTS. THE LARGEST OF THESE IS THE SEX OFFENDER PROGRAM, WHICH HAS A RESEARCH AND EVALUATIVE FORMAT ALONG WITH TREATMENT.

IN ADDITION TO THE INPATIENT FORENSIC TREATMENT PROGRAM, THE STAFF OF WINNEBAGO HAS BEEN PROVIDING PSYCHIATRIC CONSULTATION TO CENTRAL STATE HOSPITAL ON A WEEKLY BASIS, AIDING THEM IN PREPARING REPORTS TO THE COURT ON CRIMINAL OBSERVATIONS AND SEX DEVIATE COMMITMENTS. ALSO, DR. BAKER, THE DIRECTOR OF THE FORENSIC PROGRAM, HAS BEEN PARTICIPATING ON A REGULAR BASIS ON A SPECIAL BOARD CREATED BY SECTION 51.21(8) REVIEWING ALL NEW PATIENTS ADMITTED TO CENTRAL STATE HOSPITAL. IN ADDITION, A GREAT DEAL OF CONSULTATION HAS BEEN PROVIDED BY THE PROFESSIONAL STAFF TO THE COURTS IN THE FORM OF OUTPATIENT EVALUATIONS AND IN THE FORM OF GENERAL CASE CONSULTATION OVER THE PHONE.

## AFFIRMATIVE ACTION

IN JULY, 1974 AN AFFIRMATIVE ACTION ADVISORY COMMITTEE WAS FORMED TO ASSIST THE AFFIRMATIVE ACTION OFFICER IN MEETING WINNEBAGO MENTAL HEALTH INSTITUTE'S OBJECTIVES IN THIS IMPORTANT AREA. THUS FAR, THE COMMITTEE HAS FURNISHED A LIST OF MINORITY RECRUITING SOURCES TO THE PERSONNEL OFFICE. THE COMMITTEE'S AWARENESS OF LOCAL MINORITY PROBLEMS WAS INCREASED BY HAVING SEVERAL QUALIFIED PERSONS SPEAK TO THE COMMITTEE MEMBERS. TWO COMMITTEE MEMBERS PARTICIPATED IN A WORKSHOP ENTITLED "INCREASING JOB ACTION FOR WOMEN". ALREADY TWO HOSPITAL UNITS AND THEIR UNIT DISCIPLINARY STAFF MEMBERS ARE ACTIVELY WORKING WITH THE MILWAUKEE AND GREEN BAY-BASED INDIAN GROUPS. THE EXPERIENCE HAS BEEN POSITIVE AND REWARDING FOR BOTH INSTITUTE AND INDIAN STAFF REPRESENTATIVES. A NUMBER OF BILINGUAL STAFF VOLUNTEERS HAVE BEEN IDENTIFIED AMONG EMPLOYEES AND ARE AVAILABLE TO PATIENTS AND THEIR RELATIVES.

## PSYCHIATRIC RESIDENCY

EIGHT PHYSICIANS ARE NOW TAKING THREE-YEAR POST-GRADUATE TRAINING AT WINNEBAGO. AT THE END OF THE THREE YEARS THEY WILL BE SPECIALISTS IN PSYCHIATRY. WINNEBAGO HAS ONE OF THREE SUCH APPROVED PROGRAMS IN WISCONSIN, THE OTHER TWO BEING AT THE MEDICAL COLLEGE OF WISCONSIN, MILWAUKEE, AND THE UNIVERSITY OF WISCONSIN MEDICAL SCHOOL, MADISON.

WE HAVE CONTINUED TO BE PLEASED WITH THE QUALITY OF THE RESIDENTS AND WE INTEND TO HAVE THE FULL COMPLEMENT OF NINE RESIDENTS BEGINNING JULY 1, 1975. AS A RESULT OF THE SITE VISIT BY THE EDUCATIONAL ACCREDITATION COUNCIL OF THE AMERICAN MEDICAL ASSOCIATION ON 11-5-73, THE RESIDENCY PROGRAM WAS GIVEN FULL APPROVAL, AND THE AMERICAN MEDICAL ASSOCIATION'S LETTER TO THAT EFFECT IS APPENDED AS A PART OF THIS REPORT.

THERE IS A SIZABLE COMMUNITY OUTREACH OF THE PSYCHIATRIC RESIDENCY PROGRAM INTO THE SURROUNDING COMMUNITY, AND WE HAVE ENJOYED SPLENDID COOPERATION FROM SITES SUCH AS FACILITIES IN WINNEBAGO, FOND DU LAC, WAUSHARA, GREEN LAKE, OUTAGAMIE, DODGE, AND MANITOWOC COUNTIES.

## ACCREDITATION

THE HOSPITAL WAS SURVEYED BY THE JOINT COMMISSION ON ACCREDITATION OF HOSPITALS ON JANUARY 14-16, 1974. AS A RESULT OF THAT VISIT A TWO-YEAR ACCREDITATION WAS AWARDED BY THE ACCREDITATION COUNCIL FOR PSYCHIATRIC FACILITIES. THE EXAMINER WAS MOST IMPRESSED WITH THE OPERATION OF THE HOSPITAL AND THE ONLY RECOMMENDATIONS THAT WERE MADE WERE IN THE AREA OF FURTHER WORK NEEDED TO MEET LIFE-SAFETY CODES IN SEVERAL BUILDINGS. REQUESTS TO COMPLETE THOSE REQUIREMENTS HAVE ALREADY BEEN SUBMITTED AND HOPEFULLY WILL BE FULLY FUNDED.

## CORRECTIONS ALCOHOLISM PROGRAM

DURING THE YEAR ARRANGEMENTS WERE BEGUN, AND FINALIZED, TO HAVE A PRE-RELEASE ALCOHOL TREATMENT PROGRAM, RUN BY THE DIVISION OF CORRECTIONS, HOUSED IN KEMPSTER HALL. ABOUT 50 CLIENTS FROM THE VARIOUS CORRECTIONAL FACILITIES WILL BE TREATED, ON A VOLUNTARY BASIS, FOR ALCOHOL PROBLEMS WHERE THOSE PROBLEMS HAVE BEEN A SIGNIFICANT PART OF THE PROBLEM OF THE CLIENT. THE RELEASE RECORDS AND PAROLE OUTCOME OF THIS TREATMENT GROUP WILL BE COMPARED THEN TO THE OUTCOME OF A COMPARABLE GROUP NOT SO TREATED.

## STATEWIDE SUBSTANCE ABUSE TRAINING CENTER

THROUGH FUNDS PROVIDED FROM THE NATIONAL INSTITUTE OF DRUG ABUSE, THE WISCONSIN COUNCIL OF CRIMINAL JUSTICE, THE DEPARTMENT OF PUBLIC INSTRUCTION, AND THE PIZER DRUG REBATE MONIES, A STATEWIDE SUBSTANCE ABUSE TRAINING CENTER WAS ESTABLISHED AT WINNEBAGO. THIS CENTER WILL WORK CLOSELY WITH THE TELLURIAN COMMUNITY AS ITS ACTUAL TRAINING GROUND, AND WILL HAVE A VARIETY OF TRAINING CYCLES FOR PERSONS FROM LAW ENFORCEMENT, SCHOOL, PUBLIC AND PRIVATE TREATMENT SETTINGS AND AGENCIES. INITIAL FUNDING, VIA THESE POOLED GRANTS, AMOUNTED TO \$129,950.00. THE TRAINING CENTER ITSELF WILL BE HOUSED IN GORDON HALL AND WILL BE UNDER THE OVERALL DIRECTION OF MR. MIKE SACK. WHILE THE FOCUS INITIALLY IS ON CHEMICAL ABUSE PRIMARILY, ULTIMATELY THE CENTER WILL LINK TRAINING EFFORTS IN ALCOHOLISM AND OTHER DRUG ABUSE TOGETHER RATHER THAN TREATING THOSE TWO ENTITIES SEPARATELY. WITH OVER 150 TREATMENT PROGRAMS FOR DRUG ABUSE AND OVER 125 TREATMENT PROGRAMS FOR ALCOHOLISM STATEWIDE, THE NEED FOR TRAINING OPPORTUNITIES FOR PERSONS WORKING IN THOSE SETTINGS IS OBVIOUS.

## TRAINING AND RESEARCH

DURING THE YEAR SEVERAL NEW TRAINING AFFILIATIONS BEGAN. STUDENTS AND COMMUNITY PROGRAMS IN INCREASING NUMBERS AND DISCIPLINES CONTINUE TO LOOK TO WINNEBAGO AS A TRAINING AND EXPERIENCE SITE. OVER 500 STUDENTS FROM MORE THAN TWENTY UNIVERSITIES, COLLEGES, AND TECHNICAL SCHOOLS COMPLETED FORMAL AFFILIATION IN TEN DIFFERENT DISCIPLINES. IN ADDITION TO FORMAL AFFILIATION, NUMEROUS OTHERS GAINED PRACTICUM EXPERIENCE AS UNDERGRADUATE OR GRADUATE STUDENTS IN SOCIAL WORK, PSYCHOLOGY, SPECIAL EDUCATION, ACTIVITY THERAPY, AND LIBRARY SCIENCE. ON ANY GIVEN DAY APPROXIMATELY 100 PERSONS ARE AT THE HOSPITAL IN SOME FORMAL EDUCATIONAL ACTIVITY.

IN ADDITION TO THOSE STUDENTS, HUNDREDS OF OTHERS FROM A VARIETY OF PROFESSIONS AND SETTINGS ATTEND CONFERENCES OR SEMINARS PUT ON BY THE HOSPITAL. A LISTING OF SOME OF THOSE IS A PART OF THIS REPORT.



IN RESEARCH, A NUMBER OF CLINICAL STUDIES ARE UNDER WAY IN THE AREAS OF INFANTILE AUTISM, SUICIDE PREVENTION, COMPUTER ASSISTED INTERVIEWS, SPECIAL TREATMENT OF THE EXCEPTIONAL PATIENT (STEP), FOLLOW-UP STUDIES ON TREATMENT EFFECTIVENESS IN ALCOHOLISM, DRUG ABUSE, AND CHILD-ADOLESCENT PROGRAMMING. SPECIAL PROJECTS IN THE AREA OF FORENSIC PSYCHIATRY ARE A PART OF THE FORENSIC UNIT AND STUDIES IN THE AREA OF PSEUDO-DEMENTIA ARE A PART OF THE PSYCHO-GERIATRIC UNIT PROGRAM. A PROJECT WAS ALSO UNDERTAKEN IN THE STUDY OF PROCESS AND OUTCOME IN THERAPEUTIC COMMUNITY APPROACHES TO THE TREATMENT OF DRUG DEPENDENCY.

#### VOLUNTEERS

OVER 14,000 HOURS OF TIME WERE DONATED TO THE HOSPITAL BY VOLUNTEERS FROM THE SURROUNDING COMMUNITIES. A TOTAL IN EXCESS OF \$50,000 IN MATERIALS AND MONEY WAS DONATED FOR THE USE OF THE HOSPITAL AND ITS PATIENTS. JUST AS CONSIDERABLE CHANGE HAS OCCURRED IN OTHER AREAS OF THE HOSPITAL, SO HAS THE ROLE OF VOLUNTEER CHANGED. MORE VOLUNTEERS HAVE BEEN ASSIGNED TO EVENING ACTIVITIES. DIFFERENT TYPES OF ACTIVITIES HAVE BEEN DEVELOPED REQUIRING NEW SKILLS AND ABILITIES.

MR. O'REILLY, VOLUNTEER COORDINATOR, HAS BEEN VERY ACTIVE IN WORKING WITH THE AMERICAN ASSOCIATION OF VOLUNTEER SERVICE COORDINATORS AND THE EXTENSION DIVISION OF THE UNIVERSITY OF WISCONSIN IN DEVELOPING A CURRICULUM AND EDUCATIONAL PROGRAM FOR VOLUNTEER SERVICE COORDINATORS FROM ALL OF THE COMMUNITY PROGRAMS IN THE STATE. THIS HAS CULMINATED IN SETTING UP SEMI-ANNUAL WORKSHOPS AND UTILIZING THE SEVERAL CONTINUING EDUCATION NETWORK FACILITIES AVAILABLE TO REACH THE VOLUNTEER SERVICES COORDINATORS THROUGHOUT THE STATE.

ONE SPECIAL PROJECT WAS THAT CHOSEN BY THE FUTURE BUSINESS LEADERS OF AMERICA ORGANIZATION WHO LAUNCHED A STATEWIDE CAMPAIGN TO PURCHASE A STATION WAGON FOR THE CHILDREN'S UNIT PROGRAM. THE ORGANIZATION MET ITS GOAL, AND ON 7-30-74 A STATION WAGON WAS PRESENTED TO THE FARMS PROGRAM FOR USE BY THEM.

Attached are the recommendations for the improvement of the quality of patient care based on the findings of the survey. These warrant your attention and should be put into effect without delay.



Enclosed you will find a Notice of Grant Award in the amount of \$96,703 for your Hospital Improvement Program research grant. Please note that only \$77,281 is authorized for direct costs and the remaining \$24,300 is authorized for indirect costs. The base against which the 34% Indirect Cost Rate was applied is \$71,470 (Salaries and Wages, less Fringe Benefits).

Your attention is directed to Page 2 of the enclosed award notice. Since you requested \$91,330 for direct costs and we are awarding only \$77,281, a redistribution by category of the latter amount will be necessary. Alteration of the \$71,470 Salaries and Wages figure will result in a proportionate alteration in the authorized amount of indirect costs. If you wish to keep the Salaries and Wages intact, thereby retaining the \$24,300 for indirect costs, adjustments will have to be made to Fringe Benefits and/or items in the "Other" Category.
