ADJOURNED MEETING OF THE BOARD OF REGENTS

Madison, Wisconsin

Saturday, February 11, 1939, 10 A.M.

President Wilkie presiding

PRESENT: President Dykstra; Regents Backus, Baker, Brown, Callahan, Christopherson, Gates, Kelly, Wilkie.

ABSENT: Regents Campbell, Combs, Glover, Hones, Mead, Miller, Richards.

The Board of Visitors was present at the opening of the meeting and sat with the Regents throughout the session.

Upon motion of Regent Callahan, seconded by Regent Gates, it was VOTED, That <u>George P. Hambrecht</u> be appointed a member of the Board of Visitors to succeed Zona Gale Breese, deceased, for the term ending July 1, 1942. Called vote was taken, all Regents present voting and voting "Aye".

Upon motion of Regent Gates, secomded by Regent Callahan, recommendations listed under Agriculture, Engineering, Medicine, Research, Fellows and Scholars, School for Workers in Industry, Extension and Degrees were adopted.

The cases of Jack Eck and Meade Harris, non-resident students who are sponsored by members of the legislature for relief from non-resident tuition, were discussed. Upon motion of Regent Baker, seconded by Rogent Gates, it was Si VOTED, That the Attorney General be requested for an opinion as to

whether the dates mentioned in the statute, August first and December first, are mandatory or directory; that these two students be permitted to remain in the University upon payment of the resident fees until the opinion of the Attorney General is received; that the request to the Attorney General for an opinion is also to cover the question as to whether an appointment by a newly elected legislator made after January first can be recognized as valid whether or not an appointment has been made by nomination from that district.

VOTED, That S. A. Corey be appointed <u>Assistant Dean</u> of the Graduate School for the summer of 1939 at a salary of \$375; charge to 1939-40 budget. (Total salary for summer \$750 - \$375 already included in 1939 S.S. budget.)

Regent Brown had arranged for a meeting of the <u>Business</u> Committee to consider the problem of erecting a new boathouse. His train was late and the committee meeting was not held. There appeared before the Board, however, Harry Stuhldreher, Walter Hirshberg, Harry Thoma, Ralph Hunn and William Aspinwall. Mr. Stuhldreher made a statement giving such information as he had with reference to the matter, and since the special order of business had not yet been taken up, the matter of the committee meeting had to be postponed.

Regent Backus stated that he had been unable to have a meeting of the Committee on Student Life and General Welfare to consider the recommendation of the Committee on Loans and Undergraduate Scholarships requesting that the Regents ask the legislature for a continuing appropriation of \$2750 for undergraduate scholarships, which was referred to the Committee by the Board on January 17-18, 1939, and stated that his committee would meet to consider this matter on Tuesday, February 28, 1939.

Regent Kelly then brought up the matter of the Clare L. Opper gifts. After considerable discussion Regent Kelly made the following motion:

> That unless the provisions of such a bequest excluding these special religious groups be changed and agreed to by the individual making the donation, the Board will refuse to accept the bequest.

The motion was seconded by Regent Backus.

Regent Christopherson moved that Regent Kelly's motion be laid over to the next meeting of the Board. This motion was seconded by Regent Callahan. Called vote was taken, Regents voting "Aye", Baker, Callahan, Christopherson, Wilkie (4); Regents voting "No", Backus, Brown, Gates, Kelly (4). The vote resulting in a tie, President Dykstra was called upon to vote and voted "Aye". Motion carried.

Visitor Dorner reported that the Engineering Society of Milwaukee has just received a gift from the wife of one of its former members - \$400 a year available for some student at the University interested in scientific subjects. The following resolution was presented by President Dykstra:

A RESOLUTION PROVIDING FOR A REVISION IN THE ESTIMATE OF THE COST OF THE HEATING STATION PROJECT, PWA. WIS. 1594 - F, AND RELATING TO THE AVAILABILITY OF SUFFICIENT FUNDS.

WHEREAS, the estimate of the cost of the construction of an addition to, alterations of and replacements in a heating plant, including necessary heating plant equipment and appurtenances (PWA Docket Wisconsin 1594 - F), of the Regents of the University of Wisconsin needs to be revised by reason of the following:

> To record the award of contracts and to adjust Item 4., Engineering, and Item 5., Legal and Administrative Costs.

NOW, THEREFORE BE AND IT IS HEREBY RESOLVED BY THE REGENTS OF THE UNIVERSITY OF WISCONSIN of the County of Dane and State of Wisconsin:

Upon motion of Regent Kelly, seconded by Regent Gates, the above resolution was by called vote adopted, all Regents present voting and voting "Aye".

Regent Gates presented the following resolution:

WHEREAS, the student dormitories are an integral part of the educational plant and an important factor in the educational process as applied at the University of Wisconsin, and

WHEREAS, all buildings erected on the campus for this purpose in recent years have been paid for largely by funds collected from students themselves and not at all by funds furnished by the state, and

WHEREAS, the full financial benefit from living in such dormitories can be enjoyed only by students of future generations at the expense of those of the present who are paying the obligations, and

WHEREAS, it is the desire and intent of this board to co-operate to the fullest possible extent in giving due recognition to dormitory residents for the contribution thus being made, be it

RESOLVED, that the Board of Regents hereby establishes the following regulations affecting certain charges being made by the University against dormitory operation:

1. That charges for heat and heating service be waived as against all dormitories wherein a substantial portion of students' room-rent payments is being allocated to debt amortization.

- 2. That a reduction of electric charges be made under the same circumstances, the basis for such reduced charge to be computed and referred to this board for approval by the Director of Dormitories, Superintendent of Buildings and Comptroller of the University.
- 3. That the Dormitory payroll be relieved of such payments as the University may properly take over affecting instructional staff members; that the extent of and time of giving effect to this latter item be determined by this board after receiving a report and recommendations from the President of the University.

Regent Christopherson moved, with second by Regent Callahan, that this resolution be referred to the Business Committee. Regent Kelly then moved, seconded by Regent Brown, that the matter be referred to the President to report at the next meeting of the Board. The amendment was carried by an "Aye" and "No" vote, and upon motion, the motion as amended was also carried by an "Aye" and "No" vote.

The President presented a recommendation of D. L. Halverson, Director of Dormitories and Commons, to name the new women's dormitories "Elizabeth Waters Hall". Upon motion of Regent Callahan, seconded by Regent Brown, the recommendation was unanimously adopted.

The Secretary reported that the residue in the Estate of Gurine Gjermundsen coming to the University amounts to \$4648.42. Upon motion of Regent Brown, seconded by Regent Kelly, it was

VOTED, That the funds be accepted in accordance with the terms of the gift which provides that the principal is to be kept intact and the income expended as follows; namely, to be used for the research and study for the purpose of solving any one or more of the practical problems that the Wisconsin farmer is confronted with in his daily life; that the Board of Regents shall have entire discretion in selecting what problems or problem this fund shall be expended in solving. This research fund shall be known as the "Gurine Gulsteen Research Followship".

Upon recommendation of the President, and upon motion of Regent Christopherson, seconded by Regent Gates, the following appointments in Engineering and Agriculture were approved; charged to Regents' Unassigned 1A:

Upon recommendation of the President, and upon motion of Regent Brown, seconded by Regent Callahan, it was

VOTED, That the Charles H. Mills Memorial Library as a memorial to the late Dr. Mills from the friends of the School of Music be accepted.

Upon motion of Regent Kelly, seconded by Regent Gates, the following memorials to Zona Gale and Mrs. James A. Wilkie were unanimously adopted:

Zona Gale, writer and dramatist, distinguished graduate of the University of Wisconsin, Class of 1895, died December 27, 1938. She contributed much to her Alma Mater. Loyally and devotedly she served the University as Alumna, as Regent from 1923 to 1929, and as a member of the Board of Visitors from 1935 until her death.

The Regents of the University of Wisconsin recognize this service and honor her memory. They direct that this memorial be entered in the records of the University and that a copy be sent to her surviving family. Wisconsin has been ennobled by her life and works.

RESOLVED, That the Board of Regents of the University of Wisconsin extend through its Secretary to Regent Harold M. Wilkie and his family its profound regret that they have suffered the loss of his mother and its sympathy in their bereavement. Mrs. James A. Wilkie, nee Annie Marie Lang, died in the home where she had spent practically all her life at 136 East Merrill Avenue, Fond du Lac, Wisconsin, December 8, 1938, at the age of seventy-seven. She had served her community as a teacher and was a member of the Public Library Board for twenty-two years besides being a leader in church and civic work. Besides her son, Harold M. Wilkie now President of this Board, she leaves a daughter, Mrs. Cole, in Fond du Lac, a son, Edwin J. Wilkie of Milwaukee, and nine grandchildren.

BE IT FURTHER RESOLVED, That this resolution be embodied in the minutes of this meeting and that a copy be sent to Regent Wilkie.

Upon recommendation of the President, and upon motion of Regent Brown, seconded by Regent Kelly, it was

VOTED, That an additional \$200 from <u>Sears-Roebuck & Company</u> for a Scholarship to be awarded during the current year to an outstanding sophomore be accepted. (The original agreement approved by the Regents April 27, 1938, accepted \$3375 for freshmen scholarships.)

The President reported upon the arrangement for reciprocal non-resident fees which was followed this year and recommended that this plan be made permanent. Upon motion of Regent Brown, seconded by Regent Callahan, adopted.

President Dykstra presented the following resolution relating to the Library School:

WHEREAS, section 43.10 of the Wisconsin statutes designates the Library School as "the school of library science of the university", and authorizes the Regents of the University of Wisconsin to "cooperate with the free library commission in the maintenance of the library school and to aid in securing specialized teaching and equipment for said school and otherwise to aid said school in such manner as will conduce to the development of said school and of library science in the state," and

WHEREAS, the Wisconsin Free Library Commission by resolution duly adopted at a meeting of the said Commission held January 21, 1939, has requested the Regents of the University of Wisconsin to cooperate with the said Commission in the operation and maintenance of the Library School during the fiscal year, 1938-39, and

WHEREAS, it is conducive to the proper operation and development of the Library School to maintain the school at the University and to register the students enrolled in the school as students of the University in the Library School,

NOW, THEREFORE, in accordance with the authority given in section 43:10 of the statutes be it resolved:

That the students enrolling in the Library School for the second semester of the academic year 1938-39 be enrolled and registered as students in the University, that the fees paid by such students be credited to the appropriations made by section 20.41 (1) (a) and 20.41 (1) (E) of the Wisconsin statutes, and that the fees collected from Library School students in the University in the first and second semesters of 1938-39 be appropriated for the payment of expenses of the Library School.

(Confirming verbal approval)

Upon motion of Regent Gates, seconded by Regent Christopherson, adopted.

Upon motion of Regent Callahan, seconded by Regent Brown, it was VOTED, That the minutes of the last meeting of the Board held January 17-18, 1939, be approved as sent out to the Regents.

Upon recommendation of the President, and upon motion of Regent Callahan, seconded by Regent Gates, it was

VOTED, That Paul Klieger be appointed research assistant in mechanics for four months, beginning February 1, 1939; salary \$400 for the period; charge \$200 to National Concrete Masonry Association fund, 15B, and \$200 to Research 1A, engineering.

Upon recommendation of the President, and upon motion of Regent Christopherson, seconded by Regent Callahan, the following recommendation was adopted:

That, upon the recommendation of the Comptroller, the 2-AB revolving fund budget of the Extension Division be increased \$17,000 on account of additional fee receipts, the increase to be distributed as follows:

2. That the interest rate on the Frederick C. Easton loan (N.T.S.) originally \$9000, now \$6900, be reduced from 5% to $4\frac{1}{5}$ % effective January 19, 1939.

Adopted.

 That the interest rate on the Clark Investment Association Loan (Clark apartments) originally \$16,000, now \$15,000, be reduced from 5¹/₂% to 5% effective February 9, 1939. (On fifteen year amortization basis.) Adopted.

4. That interest rates on new real estate loans for the present be approved on the following basis:

45% to 50% of loans -- 5% 40% to 45% of loans -- $4\frac{1}{2}$ % 35% or less of loans -- 4%
