The Degree of Master of Music

Superior graduates of reputable four-year courses leading to a bachelor's degree in Music may be candidates for the second degree of Master of Music even though they do not satisfy the non-music academic requirements of our B. M. degree. Their graduate studies shall consist of at least twenty-four credits in advanced music beyond the work they have done for their bachelor's degrees. The following outline represents the minimum that will be required of them.

- I. To play on the piano from scores such as the simplest string quartets, Haydn and Mozart's orchestral scores.
- II. Advanced courses in harmony,
 Counterpoint,
 Double counterpoint, canon and fugue.
 With regard to the last named course, the
 candidate will be expected to present four
 or six original fugues.
 Orchestration and advanced study of this subject
 in connection with practical application to
 various types of ensembles, small, medium
 and large orchestras and concert bands.
 Advanced history of music and seminar.
 Advanced Applied Music.
- III. Thesis: Various orchestrations of different types of composition for Chorus, Orchestra and band or Original Compositions for these groups.

Document 496-b - March 1936

REPORT OF THE REGENT-FACULTY CONFERENCE COMMITTEE ON ATHLETICS

The committee of the Regents on conference with the faculty, after conference with the faculty committee on conference recommends that action be now taken by the Regents, embodying the joint conclusions of said Regent-Faculty Committees as follows:

Resolved, (1) That faculty control as referred to in the Conference Rules includes the reviewing power of the Board of Regents, but involves a primary jurisdiction in a faculty committee or board in respect to intercollegiate athletics.

- (2) That the recent action of the Board of Regents as to personnel in the department involved the exercise of this reviewing power of the Board of Regents, and that the action of the Regents did not violate any rule of faculty control as expressed in the rules of the Conference or the rules and regulations of this University.
- (3) The Regents recommend to the faculty that the Athletic Board be reconstituted so as to be chosen as follows:

 4 members chosen from the faculty by the President of the University in conjunction with the University Committee, 2 alumni members chosen by the President from a panel of 6 nominees presented by the Alumni Association, and 1 student who shall be the President of the Student Athletic Board, such appointments being subject to confirmation by Board of Regents.

Soverno

Department of Intercollegiate Athletics, including matters of budget and personnel, the power to initiate action is lodged in such Athletic Board.

Budget &

(5) The power to initiate action in matters of budget and personnel is the power to nominate and recommend to the President. If these recommendations are approved by the President they are subject to veto or acceptance by the Board of Regents as in the administration of all other departments of the University.

Ju telien

(6) The power to initiate an action after being exercised by the Athletic Board does not lapse in the event that
the recommended action fails to receive the approval of the
Board of Regents but reverts to the Athletic Board for further consideration and recommendation subject to the right
and obligation of the Board of Regents to act or modify
action where there is an emergency and the necessities of
good administration require such action.

We are advised the above action has the concurrence of the faculty committee on conference with Regents and will be recommended to the faculty for approval.

To facilitate action, the Executive Committee of the Regents wis hereby authorized to act upon any appointments to the newly constituted Athletic Board.

Dear President Frank:

There is transmitted to you herewith for presentation to the Board of Regents a final revision of the budget of the Summer Session for 1936. The books cannot be closed and a final account rendered until after the opening of the fall semester, when the pre- and postsession accounts, for which we are reserving \$1500 in the budget, will be checked and paid. This revision adjusts all salaries and wages for the three-, four-, five-, six-, nine- and ten-week sessions and all special courses.

The distribution of enrollments by departments is quite irregular this summer, necessitating unexpectedly large increases in the teaching staffs of certain departments with few corresponding decreases in others. The following summary shows the general results, the details being shown in the remaining tables.

The additional appropriation requested is \$2000. The receipts will probably total from \$12,000 to \$13,000 more than all expenditures when the books are closed.
