REGULAR MEETING OF THE BOARD OF REGENTS OF THE UNIVERSITY OF WISCONSIN

Milwaukee, Wisconsin

Held in Room 205, University of Wisconsin - Milwaukee Library Building (Kenwood Campus)

Friday, December 8, 1961, 9 A.M.

President Steiger presiding

PRESENT: Regents DeBardeleben, Gelatt, Jensen, Konnak, Rothwell, Steiger, Werner. ABSENT: Regents Friedrick and Pasch.

President Steiger reported that the Governor had appointed Mr. Gilbert C. Rohde for the balance of the unexpired term of Mr. Robert C. Bassett, who had resigned as a member of the Board of Regents. He stated that Mr. Rohde had been invited to attend this meeting, although his appointment had not yet been confirmed by the State Senate, and that Mr. Rohde would probably be present later in the day.

There being no objection, President Steiger ordered that the minutes of the regular meeting of the Board held on November 17, 1961, stand approved as sent out to the Regents.

REPORT AND RECOMMENDATIONS OF THE PRESIDENT OF THE UNIVERSITY

Upon motion of Regent Jensen, seconded by Regent Rothwell, it was VOTED, That the gifts and grants listed in <u>EXHIBIT A</u> and <u>EXHIBIT A-1</u>, attached, be accepted; and that the Vice President - Business and Finance be authorized to sign the agreements.

President Elvehjem read the offer (<u>EXHIBIT C</u> attached) from Mr. and Mrs. Walter Harnischfeger to make a gift to The Regents of The University of Wisconsin of their property located at 4430 North Lake Drive, Milwaukee, Wisconsin. President Elvehjem presented the following recommendation for the acceptance of this offer of gift:

> That the offer (EXHIBIT C attached), dated December 1, 1961 of Walter Harnischfeger and Eleanor Harnischfeger, his wife, of the gift to The Regents of The University of Wisconsin of their property located at 4430 North Lake Drive, Milwaukee, Wisconsin, be accepted; that the deed, dated December 1, 1961 conveying an undivided one-half interest in said property to The Regents of The University of Wisconsin be accepted; that the Secretary be authorized on behalf of The Regents of The University of Wisconsin to accept conveyance of the remaining interests in the title to said property for use in accordance with the terms and conditions of said offer; and that the sincere appreciation of the Regents be conveyed to Mr. and Mrs. Harnischfeger for this generous gift.

President Elvehjem stated that the University would pay the proportionate share of the costs of the upkeep of this property equal to its interest in the property. He reported that the remaining one-half interest might be transferred to the University during 1962.

Regent Gelatt moved the adoption of the above recommendation and the motion was seconded by Regent Werner.

Regent Jensen inquired whether this property is near other University property in Milwaukee; and he was advised by Provost Klotsche that it is about a mile north of the property given to the University by Mr. and Mrs. Uihlein. Provost Klotsche stated that a careful study would be made as to how this property can best be used by the University, and stated that the property can either be used by the University or sold.

The question was put on the above motion and it was voted.

Upon motion of Regent Rothwell, seconded by Regent Gelatt, it was VOTED, That the actions taken by the President of the University

since the last meeting of the Regents, relating to appointments, resignations, leaves of absence, and change of status of personnel with rank less than that of Associate Professor, which are included in the file of employment forms presented at this meeting, and the nonresident tuition remissions, be approved, ratified, and confirmed.

Resolutions of The Regents of The University of Wisconsin Relating to The Award of Contracts, The Schedule of Costs, and The Source of Funds for Gymnasium Unit #1, (EXHIBIT D attached), and Resolutions of The Regents of The University of Wisconsin Relating to The Lease and Sublease (Gymnasium Unit #1) (EXHIBIT E attached), were presented to the Regents for their consideration.

Dean Wendt reported that the base bids received on December 1, 1961 for this project were about \$850,000 below the estimates given to the Regents at the October meeting. He reviewed the proposed schedule of costs for this project, as set forth under item 2. of <u>EXHIBIT D</u> attached, and explained that the contingency allowance included \$50,000 for desirable items of work that should be included in this project but were not included in the bidding, and also included an estimate of \$73,000 for the heating and ventilating work, for which the recommendation of award of contract was not ready for consideration at this time.

Regent Gelatt inquired as to the large amount for architectural and engineering services. Dean Wendt explained that this amount included the actual expenses for such services that had been incurred in connection with the plans for this project, for which bids were received a year ago and rejected because of excessive costs, and also included negotiated amounts for additional services in connection with the completion of this project in accordance with the understanding in this regard reached with the Business and Finance Committee of the Regents at their meeting in Milwaukee a year ago.

Regent Gelatt moved the adoption of the Resolutions of The Regents of The University of Wisconsin Relating to the Award of Contracts, The Schedule of Costs, and the Source of Funds for Gymnasium Unit #1 (EXHIBIT D attached), the motion was seconded by Regent Rothwell, and it was voted.

Regent Konnak moved the adoption of the Resolutions of The Regents of The University of Wisconsin Relating to the Lease and Sublease (Gymnasium Unit #1) (EXHIBIT E attached), the motion was seconded by Regent Gelatt, and it was voted.

President Elvehjem presented the following recommendation:

That the final plans and specifications be approved and authority granted for advertising for bids for the construction of the Hydrobiology Building. -3

Copies of the outline specifications and the estimated schedule of costs, totaling \$502,000, for this project were distributed to the Regents.

State Architect Yasko showed and explained the plot plan, the floor plans and elevation drawings for the Hydrobiology Building, and explained the principal revisions that had been made in the plans from the original plans.

Regent Gelatt moved the adoption of the above recommendation and the motion was seconded by Regent DeBardeleben.

Regent Jensen inquired as to the high per square foot cost estimated for this building, in view of the fact that it did not seem to be extremely complicated. Mr. Yasko explained that in this type of building, with laboratory facilities involving considerable plumbing work, the cost is relatively high, and that other factors affecting the higher cost are the foundation problems and water problems, due to construction on a lake shore.

The question was put on the above motion and it was voted.

President Elvehjem presented the following recommendation:

That the final plans and specifications be approved and authority granted for advertising for bids for the construction of the Southeast Dormitory #1 (HHFA Project No. CH-WIS.-58(D)).

Copies of the estimated schedule of costs, totaling \$7,143,000 for this project, were distributed to the Regents.

Mr. Yasko showed models of the North and South Lower Campus Areas and the Southeast Dormitory Area. He pointed out the two dormitory structures to comprise Southeast Dormitory #1, and explained the location of the food service unit and the dormitory unit to be constructed as the next project to be undertaken, following Southeast Dormitory #1. The two units comprising Southeast Dormitory #1 will accommodate somewhat over 1,000 students, both men and women, and would have a common lobby. He explained that the outdoor area South of this first project would not be developed at this time, because it would have to be torn up in a few years in connection with the construction of the next units.

Regent Konnak stated that he understood that for several years the students in this project would have no dining facilities, and that he understood there was a proposal to feed these students in a proposed addition to the Wisconsin Union, to be constructed south of University Avenue. He was advised that an additional Student Union cafeteria facility had long been proposed to replace the temporary structures of the Breese Terrace Cafeteria, but that such a facility would probably not be provided in time to feed the students in the Southeast Dormitory #1 project; and that the students in this project could be fed in the present Memorial Union facility by a proper meal scheduling.

Mr. Yasko showed on the model and explained the contemplated order of the construction of the second and third units of the Southeast Area single student

dormitories. He also showed architects' colored sketches of the Southeast Dormitory #1.

Regent Werner moved approval of the above recommendation and the motion was seconded by Regent Jensen.

With reference to the item in the schedule of costs for the Southeast Dormitory #1 Project of \$1,100,000 for land and right-of-way, Vice President Harrington reported that, at the Regents' suggestion, the University administration had begun a general investigation of the cost of living in dormitories, and of various possibilities of keeping such costs at a minimum. He noted that the possibility is being considered of shifting the cost of the educational program in the University dormitories to the University budget, and that part of the cost of the land, since part of it would be used for all-University purposes, such as recreation, might be charged to other than dormitory revenues.

Regent DeBardeleben inquired whether the estimate for legal and adminstrative costs in the estimated schedule of costs related only to this particular project. He was advised by the Secretary that this item of \$60,000 related only to this project and might be somewhat high, since it could not be determined at this time what the cost would be in connection with the issuance and sale of the bonds to be handled under an agreement with Blyth and Company, Inc., and that only a relatively small portion of this amount would be on account of the cost of the issuing of a portion of the bonds under the Loan Agreement with Housing and Home Finance Agency.

Regent DeBardeleben inquired as to whether the amount of \$230,000 estimated for interest during construction wasn't too high, in view of the fact that it amounted to interest for practically a full year. He was advised that the construction period would be about a year and a half, that the non-Housing and Home Finance Agency portion of the bonds would have to be sold at the beginning of the construction period, and that until the non-Housing and Home Finance Agency bonds were sold, the interest cost could not be determined with any appreciable degree of accuracy.

The question was put on the above motion and it was voted.

President Elvehjem presented the following recommendation:

That the preliminary plans and specifications be approved and authority granted for the preparation of final plans and specifications for the construction of the Cooperative Dormitory for Men, to be located south of David Schreiner House.

Copies of the outline specifications and the estimated schedule of costs, totaling \$260,620 for this project, were distributed to the Regents.

Mr. Yasko showed and explained the plot plan and floor plans, explained the minor changes in the plans for this dormitory from those of the adjacent David Schreiner House, and explained that the kitchen and dining facilities, to be included in a connecting structure between this dormitory and David Schreiner House, would provide for feeding the residents of both houses. Regent Steiger inquired whether additional dormitory facilities could be constructed above the section containing the kitchen and dining facilities. Mr. Yasko explained that the request for plans had not provided for such additional dormitory facilities and that the design would have to be revised for such purposes. Director Newell Smith explained that experience has indicated that the optimum cooperative housing capacity should be about 50 students to obtain the most effective living conditions for this type of housing. The Regents were advised that probably not over 14 additional rooms could be built over the dining and kitchen unit of this project, even if it were redesigned to provide adequate footings. Regent Gelatt suggested that this project should not be delayed by reason of redesigning at this time, but that the suggestion of providing additional dormitory units above the dining and kitchen facilities might be considered in planning for the next cooperative dormitory.

Regent Gelatt moved the approval of the above recommendation and the motion was seconded by Regent Konnak.

In answer to questions by the Regents, Director Smith explained the work that is done by occupants of cooperative dormitories in preparing and serving food, and noted that students by living in these accommodations were saving what amounted to approximately a \$300 scholarship per student, per year, but that these facilities were not of as permanent a type of construction as the conventional dormitories. He noted that this project was planned for occupancy in September, 1963. Regent DeBardeleben inquired whether the project would be delayed if the suggestion was followed to provide additional living units above the kitchen and dining unit. He was advised that the project would be delayed in that case.

It was agreed that those working on the planning of this project should have some discretion as to whether they want to come back to the Regents with a revision in the plans for this project to provide the suggested additional housing space.

The question was put on the above motion and it was voted.

President Elvehjem presented the following recommendation:

That the preliminary plans and specifications be approved and authority granted for the preparation of final plans and specifications for the construction of the Clinical Cancer Research Addition to Wisconsin General Hospital; and that authority be granted to advertise for bids, subject to approval of the final plans and specifications by the Madison Campus Planning Committee.

Mr. Yasko showed and explained the floor plan for this proposed addition to the C Wing of Wisconsin General Hospital. The C Wing is located at the northwest corner of the intersection of University Avenue and North Charter Street. He explained that alternate bids would be taken to provide for one additional floor that might be constructed at the seventh floor level by using a lighter type of construction, in the event sufficient funds are available for such an additional floor.

Regent Rothwell moved the approval of the above recommendation, the motion was seconded by Regent Werner, and it was voted.

President Elvehjem presented the following recommendation:

That authority be granted for the preparation of preliminary plans and specifications for the Medical Library Building.

President Elvehjem reported that the Medical School Alumni Association has raised about \$500,000 toward the cost of the Medical Library Building and would like to proceed with the project. He explained that the staff of the Medical Library had wanted a completed facility costing about one million dollars, but that now the Medical School Library staff, the Medical School Alumni Association and the Medical School faculty have agreed that the first portion of the building should be constructed with the addition for completion to be constructed at a later date. Dean Wendt showed on a map the proposed site of the Medical Library Building as being on the Southeast corner of the intersection of Linden Drive and North Randall Avenue extended, which site had previously been approved by the Regents and which provides adequate space for the initial structure and the subsequent addition.

Regent Werner moved the approval of the above recommendation, the motion was seconded by Regent DeBardeleben, and it was voted.

President Elvehjem presented the following recommendation:

That authority be granted for the preparation of plans and specifications for the remodeling of Children's Hospital, subject to the release by the State Building Commission of the necessary funds for this purpose from the balance of the \$100,000.00 appropriated by Section 20.240(73), Wisconsin Statutes, for the remodeling of the facilities of Wisconsin General Hospital.

President Elvehjem reported that there were many, many possible uses for this small sum, but this had been determined to be the best use to be made of these funds at this time. Dean Wendt explained that, in the schedule of future

releases of funds by the State Building Commission, the amount of \$200,000 was scheduled for release in May of 1962 and would include funds that could be used for moderrization of the Wisconsin General Hospital elevators. He reported that the hospital administration and the Madison Campus Planning Committee had decided that the best use of the approximately \$300,000 to be made available would be to complete the remodeling of the Children's Hospital and the modernization of the elevators in Wisconsin General Hospital.

Regent Jensen moved the approval of the above recommendation, the motion was seconded by Regent Gelatt, and it was voted.

President Elvehjem presented the following recommendation on the basis of the Preliminary Studies of the North Lower Campus Area Development prepared by J. and G. Daverman Company, Grand Rapids, Michigan, and dated October 16, 1961:

That the North Lower Campus Area Development Plans be approved in principle.

President Elvehjem explained that some of the Regents had seen these plans in connection with previous presentations to other groups. He explained that planning had reached a stage where the formal approval of the Regents of the principle of the plans for the general development of the area of the Memorial Union and the Wisconsin Center was needed. At the request of President Elvehjem, Mr. Yasko explained the North Lower Campus Area Development Plan with maps and models, and explained that the North Lower Campus Area was bounded by Lake Mendota, North Lake Street, and State Street, and that the South Lower Campus Area was bounded by State Street, North Lake Street, University Avenue and North Park Street. He explained that the plan for the North Lower Campus Area was put together by a joint committee representing the University, the Wisconsin Alumni Association, the Memorial Union, and the University of Wisconsin Foundation. He explained the need for careful planning for this area, because it would be the future focal point of the University campus.

He explained that the general development of this area would involve the raising of the ground elevations on both sides of Langdon Street, in the center portion of the North Lower Campus mall, with traffic on Langdon Street to be depressed under two foot bridges, which would provide pedestrian access across Langdon Street in the mall area. In the mall area immediately north of Langdon Street, the development would include the proposed Memorial Union Games Unit, to be constructed underground, north of which would be an underground parking area, with boating and swimming facilities and facilities for other outdoor activities along the lake shore at the north end of the mall. These proposed developments would include a high rise building of about eight stories for a Guest House between the easterly limits of the mall and the westerly limits of the Wisconsin Center and immediately north of Langdon Street, and an underground auditorium with about 400 to 450 seating capacity to be located north of the Guest House and attached to the basement level of the Wisconsin Center, and an addition to the Wisconsin Center Building to be located on the lake shore north of the existing Wisconsin Center Building to provide facilities for the Wisconsin Alumni Association and the Wisconsin Center. Underground access to the underground parking area and to the Memorial Union would be provided from North Lake Street at a point between the present Wisconsin Center Building and the proposed addition to the north. A map showing student pedestrian patterns in this area was explained by Mr. Yasko. He also showed a cross section view of some portions of the proposed developments in this area.

There was discussion of the belief of some individuals that parking facilities should be provided above ground in the mall area north of Langdon Street. The Regents were advised that plans for such parking were not included in this proposal, which in all respects was in accord with the previous commitments by the Regents and the University of Wisconsin Foundation as to the use of the mall area north of Langdon Street.

Dean Wendt reported that the North Lower Campus Area Development plans had been approved in principle by the Madison Campus Planning Committee, that they have been presented to and approved by the various interested organizations associated with the University and concerned with developments in this area, and are in complete accord with the total Lower Campus Area Development Plans previously approved by the Regents in principle.

Regent DeBardeleben questioned the proposed location of the Alumni House on the shoreline in the proposed addition to the Wisconsin Center Building, since such a location would reduce the greater availability of this area to the students.

Regent Gelatt left the meeting at 10:55 A.M.

Regent DeBardeleben was informed that, although it had at one time been contemplated that quarters for the Wisconsin Alumni Association might be provided by remodeling the Washburn Observatory Building, the proposed site for facilities for the Wisconsin Alumni Association had for several years been the area immediately north of the present Wisconsin Center Building. It was explained that this site was selected because of the relationship of the site to the Wisconsin Center Building and because returning alumni want to come to the area of Lake Mendota and the Memorial Union Building. Although detailed plans have not been made, the statement was made that about one-half of the proposed addition to the Wisconsin Center Building would be for Wisconsin Center purposes (offices and classrooms) and about one-half for Wisconsin Alumni Association facilities, including Alumni Records Offices, lounges, etc.

In answer to Regent DeBardeleben's question as to the use to be made of the proposed Guest House, Dean Wendt reported that about 50% of the space would be used for housing resident graduate students and the other 50% for housing persons attending functions at the Wisconsin Center Building. There was discussion of the use of the proposed Guest House for transient individuals in competition with privately operated motels in the area. Dean Wendt stated that every group that has developed an adult education center has found it quite essential to provide facilities for housing a substantial share of those attending institutes in such centers. This is necessary to keep the groups together to obtain the best results from the conferences. He noted that the original plans for the Wisconsin Center Building had included an underground parking facility and two additional floors for housing

accommodations for about 240 persons in 120 double rooms, but that these two facilities had been deleted, due to lack of funds. He noted that when additional funds were available, two additional floors could be constructed on Wisconsin Center Building to provide additional classroom and conference space. Regent Jensen suggested that, if the Guest House is to be built in the reasonably near future, as much publicity as possible should be given to it, in view of the privately operated housing accommodations in the area.

Regent Gelatt returned to the meeting at 11:10 A.M.

Dean Wendt reported that the proposed Guest House has been given wide publicity, since he and others in the Department of Planning and Construction have frequently given talks in Madison about the development plans of the University in this regard. President Elvehjem mentioned that the Guest House would not be built in the too immediate future, since the Armory will first have to be removed after replacement facilities are provided. Regent DeBardeleben inquired as to the financing of the construction of the Guest House; and he was advised that it would be on a self-amortizing basis.

With reference to the North Lower Campus Area Development Plans in the portion of the area south of Langdon Street, Dean Wendt noted the future additions that would be made to the Memorial Library south of the present stack area, and called attention to the possible future need of extending the library's reading rooms underground under the mall between the Memorial Library and the State Historical Society Building.

Regent Konnak moved the approval of the above recommendation.

Dean Wendt noted that each development in these plans will come back to the Regents for approval in the usual stages of planning and construction. The motion was seconded by Regent Jensen.

Regent DeBardeleben stated that he was not convinced of the appropriateness of the proposed location of the Alumni House, and that he had some misgivings about the proposed Guest House; and that, on the basis of the consideration of the matter so far, he would have to vote against the motion on the basis of the location of the Alumni House.

The question was put on the above motion and it was voted, with Regent DeBardeleben voting "No".

President Elvehjem presented the following recommendation:

That authority be granted for the employment of architects, by either the University or the University of Wisconsin Foundation, for an Addition to the Wisconsin Center Euilding to include facilities for the Wisconsin Alumni Association. Regent Konnak moved the approval of the above recommendation and the motion was seconded by Regent Gelatt.

Regent DeBardeleben stated that he assumed that this motion presupposes the location of the Alumni House as being as indicated in the North Lower Campus Area Development Plans. President Steiger stated that that assumption was correct.

The question was put on the above motion and it was voted, with Regent DeBardeleben voting "No".

Upon motion of Regent Werner, seconded by Regent Gelatt, it was VOTED, That, to correct a typographical error, item 54. in the University of Wisconsin Building Priorities 1963-69 (EXHIBIT C, attached to minutes of Regent meeting of November 17, 1961,) be revised from "Administration Building Completion - Madison \$3,500,000" to "Administration Building Completion -Madison \$2,500,000", and the cumulative totals be revised accordingly.

Dean Wendt distributed copies of University of Wisconsin Building Priorities Schedule of Self-Amortizing or Gift Projects Presently Anticipated During 1963-69, (EXHIBIT F attached). He noted that this was not actually a completed list of such items that might come up through 1969, since there undoubtedly will be additional gifts and grants for buildings and some of the items might subsequently be dropped from the list. He noted that the State Puilding Commission had requested that this list be filed separately from the regular building priority list. He noted that the items in this list were not in priority order.

On motion of Regent Gelatt, seconded by Regent Werner, it was VOTED, That the University of Wisconsin Building Priorities Schedule of Self-Amortizing or Gift Projects Presently Anticipated During 1963-69 (EXHIBIT F attached), be approved for filing with the State Building Commission.

President Elvehjem presented, for the information of the Regents, the following resolution adopted by The Coordinating Committee for Higher Education on October 27, 1961:

"WHEREAS the Coordinating Committee for Higher Education is responsible for planning for the efficient use of buildings, and "WHEREAS the Coordinating Committee for Higher Education is sensitive to the need to encourage more and more qualified students to attend the colleges and universities of the State, and

WHEREAS many persons with physical handicaps are discouraged from seeking a higher education by the difficulty or impossibility of gaining entrance to classroom buildings unless special provisions are made, and

WHEREAS it is good public policy to help handicapped persons to lead full and rich lives,

THEREFORE BE IT RESOLVED that the Coordinating Committee for Higher Education urge the two boards of regents to consider in the design and construction of new buildings the practicability of providing ingress and egress for physically handicapped persons."

President Elvehjem stated that the above recommendation of the Coordimating Committee for Higher Education was being brought to the attention of the Regents and would also be brought to the attention of the University Campus Planning Committee. Regent Konnak stated that all buildings at the Illinois Rehabilitation Center have ramps for the convenience of physically handicapped people.

The approval of the above recommendation of the Coordinating Committee for Higher Education was moved by Regent Konnak, seconded by Regent Rothwell, and it was voted.

Regent Jensen again raised the question as to what was being done regarding planning for radiation fall-out shelters in plans for new buildings. Mr. Yasko reported that this matter is being studied with Civil Defense people, but that nobody seems to know what to do or when to do it, and to date they have not been able to obtain specific recommendations from experts in this field. Dean Wendt reported that a team from the Defense Department will visit Madison soon to study what use can be made of public buildings for this purpose. He recalled that a previous study by the University of providing an underground parking and fallout shelter facility under Bascom Hill had resulted in such a project being abandoned for the time being because of excessive costs.

President Elvehjem recalled that the matter of naming buildings or portions of buildings for donors had been discussed with the Regents at the November Regent meeting, at which time a further report had been requested. He stated that this was found to be a much bigger job than anticipated.

Vice President Harrington stated that there could be made at this time only a progress report and a confession that statements have been made in (fund raising) brochures which have implied promises as to the naming of buildings and parts of buildings after donors. He stated that, although such brochures have often contained provisions that buildings could be named after persons, and even companies, the record indicates that very little of this had been done. Vice President Harrington stated that the University administration hoped to have a report on this for the Regents at the January meeting, perhaps with some recommendations.

Regent Gelatt stated that perhaps the report would cover this point, but it seemed to him that after a month of consideration there are two categories, one for honor and one for cash. He suggested that under the cash category the naming of buildings or parts of buildings should probably be restricted to deceased persons of good character.

Dean Wendt and Professor Jakobson reported that slow progress was being made in developing the agreement between the City of Madison and the Regents regarding the Urban Renewal Program.

Dean Wendt reported that a committee had been appointed to represent the University to study the University Avenue development plan of the City of Madison and to work out areas of negotiation with the City of Madison. He stated that additional reports will be made to the Regents on this matter, from time to time, and perhaps in about five months it will be possible to have some recommendations for the Regents to consider.

President Elvehjem announced that the University Committee would like to meet with the Regents at the time of the January 1962 Regent meeting to discuss the matter of the physical education program on the Madison campus.

President Elvehjem reported that a new movie of the University of Wisconsin is being made under the sponsorship of the Board of Visitors and others, and that he was sure the Regents would enjoy this film very much. (This film will probably be ready for viewing by the Regents at the time of the February 1962 Regent meeting.)

Vice President Harrington reported that the Army ROTC Commandants at Madison and Milwaukee have reported that the combined advanced course Army ROTC enrollments at Madison and Milwaukee for students enrolled in the advanced course in the Fall of 1961 exceeded the 75% requirement established by the Regents.

> The meeting recessed at 11:40 A.M., to be reconvened following committee meetings

The meeting reconvened at 11:47 A.M., December 8, 1961, with President Steiger presiding, for the purpose of giving formal consideration to two items which had been considered in the meeting of the Business and Finance Committee with all the Regents present.

PRESENT: Regents DeBardeleben, Gelatt, Jensen, Konnak, Rothwell, Steiger, Werner.

ABSENT: Regents Friedrick and Pasch.

(The following two items had been discussed in the meeting of the Business and Finance Committee, with all Regents present, and were referred to the full Board without the recommendation of the Business and Finance Committee.)

Regent Gelatt moved the approval of the following recommendation, and the motion was seconded by Regent Werner:

That, effective July 1, 1962, the monthly rates in the Harvey Street and Eagle Heights Married Student Apartments be increased from \$72.00 to \$75.00 per month for one bedroom apartments, and from \$85.00 to \$88.50 per month for two bedroom apartments.

Regent Werner stated that it might be fairer to keep the rates for the University apartments closer to those of the private operators.

There was continuation of the discussion that had been had in the meeting of the Business and Finance Committee regarding the questions raised by Regent DeBardeleben as to the need for increasing these rates and the reason for increasing them as of July 1, 1962. Director Newell Smith reported that it would be necessary to increase the rates in the University operated Married Student Apartments in connection with the operation of the proposed group of approximately 100 apartments that would be put in operation, probably in 1963, and recommended that the increased rates be made effective July 1, 1962 to provide funds for moveable equipment and to avoid the impression that the increased rates on all of the apartment facilities are due solely to the increased cost of the proposed new apartments. Regent DeBardeleben questioned the propriety of the psychological reason for proposing that the increased rates be made effective July 1, 1962, instead of when the new apartments are placed in operation. Director Newell Smith reported that the Harvey Street Apartments actually were operating at a loss on the basis of the present rates. The Secretary explained that, if the rates were not increased prior to the beginning of the operation of the proposed new apartments, the funds necessary for the purchase of moveable equipment for the proposed new married student apartments would have to be obtained from the revenue from the operation of the single student dormitories, with the result that such funds would be diverted from the interim financing of the Southeast Dormitory #1 Project and would increase the cost of the latter project by the cost of borrowing such an additional amount for the interim financing of the latter project.

The question was put on the above motion and it was voted, with Regent DeBardeleben voting "No".

The following recommendation, which also had been considered in the meeting of the Business and Finance Committee and referred to the full Board without recommendation by the Business and Finance Committee, was presented for consideration:

> That, upon recommendation of the Director of Residence Halls, the following schedule of rates for room and board in the University Residence Halls at Madison be approved effective with the 1962 eight week Summer Session:

Director Newell Smith explained the above recommendation and gave comparative rates for comparable privately operated dormitory accommodations.

Regent Gelatt moved the approval of the above recommendation and the motion was seconded by Regent Werner. The question was put on the above motion and it was voted, with Regent DeBardeleben voting "No".

Regent Gelatt suggested that all of the Regents should have an opportunity to hear the "Report on the University of Wisconsin - Milwaukee Six Years After Merger", which was listed on the agenda for the meeting of the Educational Committee. President Steiger stated that all of the Regents would meet for this purpose at the time of the meeting of the Educational Committee, scheduled for 2:00 P.M.

President Steiger introduced Mr. Gilbert C. Rohde, the new Regent appointee, to the Regents and the members of the administrative staff.

The meeting recessed at 11:55 A.M., to be reconvened following committee meetings to be held at 2:00 P.M.

The meeting reconvened at 4:14 P.M., December 8, 1961, with President Steiger presiding

PRESENT: Regents DeBardeleben, Gelatt, Jensen, Konnak, Rothwell, Steiger, Werner.

ABSENT: Regents Friedrick and Pasch.

(Mr. Rohde, the new Regent appointee, was also present but not acting, since his appointment had not yet been confirmed by the Senate.)

Vice President Peterson presented the recommendations and report of the Vice President - Business and Finance.

Vice President Peterson presented, for the information of the Regents, Report of Action Taken by the Board on Government Operations on November 15, 1961, Affecting the University (see Item I. of the Recommendations and Report of the Vice President - Business and Finance, EXHIBIT B attached).

Upon motion of Regent Gelatt, seconded by Regent Werner, it was VOTED, That the Report of Actions Taken numbered II., III., and IV., listed under the Recommendations and Report of the Vice President - Business and Finance (EXHIBIT B attached), be approved, ratified and confirmed.

Vice President Peterson presented, for the information of the Regents, the report of Budget Transfers from November 22, 1961 through November 24, 1961, (see Item V. of the Recommendations and Report of the Vice President - Business and Finance, (EXHIBIT B-1 appended to <u>EXHIBIT</u> <u>B</u> attached). Vice President Peterson reported briefly on his recent trip to Europe for the purpose of assisting in setting up the Junior Year in France program for University of Wisconsin and University of Michigan students. He stated that he believed Dean Ingraham and Professor Hill had done a very good job in selecting Aix-en-Provence as the location for this program. He reported that on their trip they were accorded a very fine reception by the officials of the Government and of the institution; that Aix-en-Provence is located about 18 miles northeast of Marseilles; that there is a very good library of high quality available there; that there are accommodations for 15,000 students--half of them at Aix and half of them at Marseilles. The officials of the institution seemed to welcome the proposed program enthusiastically. He reported that the main problem was to find housing for the students. He described the dormitories in which they could find accommodations for ten students, which would leave the problem of finding other rooms for about 30 students.

President Steiger presented the Report of the Executive Committee.

Upon motion of Regent Werner, seconded by Regent Jensen, it was VOTED, That recommendation 1., listed under the Report of the Executive Committee (EXHIBIT G attached) and adopted by the Executive Committee since the November 17, 1961 regular meeting of the Board, be approved, ratified and confirmed.

Regent Konnak presented the Report of the Educational Committee.

Upon motion of Regent Konnak, seconded by Regent DeBardeleben, it was VOTED, That John R. Schmidt, Associate Professor of Agricultural Economics, be granted leave of absence, without pay, from January 1, 1962 to December 31, 1962.

Regent Gelatt presented the Report of the Business and Finance Committee.

Upon motion of Regent Gelatt, seconded by Regent Werner, it was VOTED, That the Vice President - Business and Finance be authorized to sign a non-exclusive agreement with University Microfilms, Inc., Ann Arbor, Michigan, for reproduction on microfilm of current and backfile volumes of Monatshefte on payment to the University of a royalty of 10% of gross receipts. Upon motion of Regent Gelatt, seconded by Regent Werner, adoption of the following resolution, recommended by the Business and Finance Committee, was voted:

WHEREAS, State Statutes presently provide varying arrangements for the payment of taxes on State-owned property, and

WHEREAS, similar properties owned by different State agencies are treated differently in the matter of payment of real estate taxes,

NOW, THEREFORE, BE IT RESOLVED, That The Regents of the University of Wisconsin support the study by the Legislative Council as provided in Joint Resolutions 85, S and 98, S, and authorize the Vice President -Business and Finance to participate in the study of the taxation of State lands as requested by the Executive Secretary of the Legislative Council.

Regent Gelatt moved approval of the following recommendation by the Business and Finance Committee and the motion was seconded by Regent Jensen:

> That the University Administration be requested to study and report on the advisability of obtaining liability insurance for faculty and staff and public liability insurance for the University.

Vice President Peterson explained that the Legislature in 1959 had authorized the State Colleges to take out this type of insurance which they have done. Similar legislation authorizing the University to take out this type of insurance was passed by the Legislature in 1961 but was vetoed by the Governor, because he found that such authorization was already permitted under existing statutes. Regent Konnak inquired whether it was true that the University is actually exempt from liability on the basis of being a department of the sovereign State government. Vice President Peterson reported that that was correct, but that the attitude of the State Claims Commission had changed, with the result that it was becoming more liberal in recommending payment of claims against the State.

The question was put on the above motion and it was voted.

Upon motion of Regent Gelatt, seconded by Regent Rothwell, it was VOTED, That, subject to the approval of the Governor, Wisconsin University Building Corporation be authorized to purchase the following property for a future dormitory site in the Southeast Dormitory Area at the price stated, chargeable to funds transferred from Residence Halls Revolving Fund to Wisconsin University Building Corporation or to funds borrowed by the Corporation for interim financing of student housing projects: 801 West Dayton Street - Parcel No. 179-10 Charles R. and Bernadette M. Johnson \$14,000.00

President Steiger appointed Regent Gelatt Chairman of the Special Regent Committee on Acquisition of Land in Milwaukee to succeed former Regent Bassett, resigned.

Upon motion by Regent Gelatt, seconded by Regents Jensen and Werner, the following resolution, relating to the services of former Regent Bassett, was unanimously adopted:

RESOLUTION

WHEREAS Robert Bassett, Regent of the University of Wisconsin from 1958 to 1961, now leaves the Board;

WHEREAS this native son of Wisconsin, educated in the state from boyhood, placed his keen mind and expert knowledge of law and of the state's institutions at the disposal of this Board;

WHEREAS this man of many talents brought to this body the wide experience gained from many posts of public service in government, education and industry;

WHEREAS he has resigned his Regency because he has moved to our sister state of Illinois, where he will doubtless continue to occupy responsible public service posts;

THEREFORE, BE IT RESOLVED, that The Regents of the University of Wisconsin do hereby place in the record their sincere thanks for his work with the Board, and their wishes that he will continue to serve the cause of education with distinction.

V

President Steiger stated that he would like to bring to the attention of the entire Board a matter of the acceptance of a considerable sum of money for the Student Union Building on the Milwaukee Campus, for which he believed all agreed there is a great need. He stated that he was bringing this matter up at this time in spite of the fact that at the morning session of the Board it had been agreed to postpone any action on the naming of buildings or portions of buildings after donors until a recommendation is received from the University administration. He reported that at the meeting of the University of Wisconsin Foundation which he had attended during the noon hour he had learned, indirectly, of a possibility of a gift of several hundred thousand dollars that might be made to the University of Wisconsin Foundation for the University of Wisconsin -Milwaukee Student Union Building Addition, with a provision for placing a plaque in a room indicating that the gift was made through the generosity of a certain individual or individuals (because he did not know who they were), and with the understanding that the gift would be accepted in the year 1961. It was his understanding that, if the gift were not so accepted, it would be given to some other worthy cause or institution. He inquired whether the Regents would be willing to accept the contribution under those terms. Regent Gelatt inquired whether a room would be named after the donor. President Steiger stated that it would merely involve the placing of a plaque recognizing who gave the money. Regent Gelatt inquired whether the wording on the plaque would be merely factual; and President Steiger replied that he believed that that would be the case. Regent Konnak wondered whether there would be any objection to wording such as, "at a time when the need of the University of Wisconsin - Milwaukee was great, the donation of was given". Regent Werner stated that he did not believe that

the need of the University is ever going to be so great that the Regents should put its prestige on the auction block. He indicated that, if money comes to the University without a requirement of recognition, the Regents should recognize the source of funds, but not as a condition preceding the acceptance of the gift. Regent Steiger stated that he understood that the proposed gift had not been solicited on the basis of the indicated requirements but that in the process of solicitation the question had been raised by the prospective donor.

There was discussion of what had been done in the past in this regard, discussion of the distinction, if any, between naming a room or portion of a building and providing a plaque as means of recognizing a gift, and regarding the distinction between a gift being made freely and being bargained for. Regent DeBardeleben objected to the fact that President Steiger had previously presented this matter in two separate secret sessions, once to the Educational Committee and once to the Business and Finance Committee. He did not believe that was a proper method of presenting the matter and obtaining a commitment. As far as the merits of the matter were concerned, he did not believe that the Regents had anything before them to act on. He did not believe the University should be placed in the position of bargaining. He noted that there had been no dissent in the morning session to the agreement to defer action by the Regents on this general subject until the University administration had completed its study of past practices and the principles involved and submitted a recommendation to the Regents. He stated that he might vote to accept the money under the stated conditions, but that this cannot be decided until the Regents have something to act on. He supported Regent Werner's position in this matter.

Regent Steiger indicated that the only reasons he had brought the matter up at this time were that he had only learned about this proposed gift since the morning session of the Regents, and because, apparently for income tax purposes, the proposed gift would have to be accepted during 1961.

There was discussion of the possibility of authorizing the proper persons to give assurance that plaques would be placed in recognition of gifts provided the University has some control over the wording of the plaques. There was further discussion of the distinction between the case where the University solicits gifts with assurance that recognition by a plaque will be provided if a certain amount is given and the case where the prospective donor initiates the requirement for a plaque. Regent Gelatt noted that the terms and conditions of many gifts and grants were negotiated by representatives of the University before they were presented to the Regents. He also noted that many individuals and organizations who regularly make gifts probably have certain sets of requirements with reference to such gifts, and that the University, in turn, administratively, no doubt has developed certain requirements regarding gifts that must be met before they are presented to the Regents. He stated that he was not concerned about the fact that gifts are negotiated, and believed that the acknowledgment of the fact of a gift, in a public manner, is not wrong. However, he thought that naming a building or room should be reserved for people no longer living. There was discussion of the difference between negotiating the terms relating to funds to carry on research projects or other activities financed by the government, or by foundations, and the negotiating of terms relating to honoring donors for gifts of particular amounts.

Regent Werner moved the adoption of the following resolution:

The University intends to make appropriate acknowledgments of gifts, and such acknowledgments may take the form of a plaque or such other form as the Regents may from time to time determine.

The motion was seconded by Regent Konnak and it was voted. Regent DeBardeleben stated that he was not voting until the Regents have arrived at a policy in this regard.

There being no further business, the President declared the meeting to be adjourned at 4:55 P.M.

WHEREAS, The Regents of The University of Wisconsin, a body corporate created and existing under and by virtue of the laws of the State of Wisconsin (hereinafter called the "Regents"), is presently the owner of certain premises which it desires to lease to Wisconsin University Building Corporation for the purpose of having constructed thereon Gymnasium Unit No. 1, an athletic facility to provide for inter-collegiate, physical education and intramural activities for men and women students and staff of the University of Wisconsin at an estimated cost of \$1,250,000 (all of which is hereinafter called the "Project"); and

WHEREAS, upon execution and delivery of said Lease, the Regents desires to sublease said premises and the Project from Wisconsin University Building Corporation; and

WHEREAS, Wisconsin University Building Corporation has signified its willingness to lease said premises from the Regents for a term of fifty (50) years in consideration of its construction of the Project, and to sublease said premises and the Project back to the Regents at certain stipulated rentals;

NOW, THEREFORE, BE IT RESOLVED, that, subject to the approval of the Governor and Commissioner of the Department of Administration of the State of Wisconsin, the President or the Vice President together with the Secretary or Assistant Secretary of the Regents be and they hereby are authorized and directed for and on behalf and in the name of the Regents, to execute and deliver a Lease from the Regents, as Lessor, to Wisconsin University Building Corporation, as Lessee, covering the premises described in Schedule I annexed hereto and made a part hereof, such lease to provide specifically for the payment of rental of \$1.00 per year and for the construction of the Project by Wisconsin University Building Corporation, and to be in substantially the form of the Lease presented and filed with the papers relating to this meeting, and incorporated in the bound copies of the minutes thereof.

BE IT FURTHER RESOLVED, that, subject to the approval of the Governor and Commissioner of the Department of Administration of the State of Wisconsin, the President or the Vice President together with the Secretary or Assistant Secretary of the Regents be and they hereby are authorized and directed, for and on behalf and in the name of the Regents, to make, execute and deliver a Sublease from Wisconsin University Building Corporation, as Sublessor, to the Regents, as Sublessee, covering the premises described in Schedule I annexed hereto, and the Project to be constructed thereon; such Sublease to provide generally for the payment of rentals in the amount of \$58.000 on or before on March 15, 1964, and annually thereafter February 1, 1962, and \$58,000 during the term of the Sublease, and such other rentals as are provided in such Sublease; to permit the assignment and pledge by Wisconsin University Building Corporation of rentals payable thereunder as security for the indebtedness incurred by Wisconsin University Building Corporation to pay the costs of the Project; to provide for a waiver by Wisconsin University Building Corporation of all rights of re-entry upon the above described premises; and to be in substantially the form of the Sublease presented and filed with the papers relating to this meeting, and incorporated in the bound copies of the minutes thereof.

BE IT FURTHER RESOLVED, that the Regents hereby consents to the assignment and pledge of rentals payable under the Sublease for the purposes therein provided, and the President or the Vice President together with the Secretary or Assistant Secretary of the Regents are hereby authorized and directed, for and on behalf and in the name of the Regents, to make, execute and deliver a formal Acknowledgment of notice of such Assignment and pledge of rentals pursuant to which Acknowledgment the Regents, as Sublessee under said Sublease, agrees to comply with the provisions of said Assignment insofar as applicable to it (including specifically the provisions thereof requiring the payment of rentals directly to the Assignee thereof) and waives and relinquishes any rights the Regents may have to cancel or terminate said Sublease or to make any offset or counterclaim against the rentals for other sums payable to said Assignee by reason of default by Wisconsin University Building Corporation under said Sublease, or any claim the Regents may have against Wisconsin University Building Corporation or any indebtedness of Wisconsin University Building Corporation to the Regents.

BE IT FURTHER RESOLVED, that the aforesaid authorized officers of the Regents be and they hereby are authorized and directed for and on behalf and in the name of the Regents, to make and consent to such minor revisions, additions or supplements in or to said Lease and Sublease and in and to the Acknowledgment of said Assignment as may be necessary or advisable to effectuate the transaction authorized by these resolutions, and to execute and deliver all such revisions, additions or supplements as shall be approved by the Attorney General of the State of Wisconsin and are further authorized and directed to make, execute and deliver all such additional and supplemental documents as may be necessary to meet the requirements of the lenders of the funds to be borrowed by Wisconsin University Building Corporation to pay the costs of the Project.

BE IT FURTHER RESOLVED, that the execution of any of the documents or instruments above referred to shall conclusively establish the due authorization and approval thereof under these resolutions. 11/27/61
