Regent Callahan, as chairman of the executive committee, read the following report of the meeting of the executive committee held on January 20, 1931:

At a meeting of the Executive Committee held in the President's office on Tuesday, January 20, the Business Manager reported the results of his negotiations with the City of Madison officials, the officials of the Chicago, Milwaukee & St. Paul Railroad and Dr. Bradley regarding the construction of a road from University Avenue to the proposed site for the Forest Products Laboratory:

The City of Madison and Chicago, Milwaukee & St. Paul Rail-road officials have assured the University that the construction of the road from University Avenue across the rail-road right of way will not involve any cost to the University. The only part of the road that will involve any cost to the University will be from the right of way to the laboratory site. Dr. Bradley has assured the Business Manager that the land necessary for that section of the road will be donated by Mrs. Bradley. The cost of the road that will have to be borne by the University is estimated at \$2000 for gravel and \$4000 for concrete.

Regent Schmidtmann made verbal report for the committee on constructional development. He stated that the regents had a proposal from outside parties for financing and constructing dormitories to house one thousand men, with refectory; that the matter would receive further study and consideration by the Business Manager and the State Architect's office.

The Business Manager presented a communication from Dean Turneaure reporting an additional cost on the publication of two engineering research bulletins ordered last year. Upon motion of Regent Berger, seconded by Regent Backus, it was VOTED, That upon recommendation of Dean Turneaure \$800 be transferred from salaries and wages, Electrical Engineering (C. A. Andree) to printing and publishing in the 20.41(1)A budget of the College of Engineering.

Upon recommendation of President Frank, it was VOTED, That date of the April meeting of the regents be changed from April 21-22 to April 14-15.

The budget for the summer session for industrial workers for 1931 was discussed and it was decided that the matter be referred to the committee on summer session and the executive committee.

President Frank presented a communication from Dean Goodnight, recommending that legislative scholarships be set aside for four years, beginning in September, 1931, for each of the two children of William T. Purdy, the composer of "On Wisconsin", and the establishment of two William T. Purdy Scholarships for the sum of \$300 a year each, for four years, beginning September - 1931. The matter was referred to the Finance Committee for report at the next meeting of the regents.

It was VOTED, That a check for \$200 from the American Society for Testing Materials, and future remittances to a total of five or six hundred dollars, for research work on certain properties of cast iron, done in the department of mechanics of the College of Engineering under the direction of Professor J. B. Kommers, be accepted.

President Frank had distributed to the regents copies of an excerpt from a report of the Committee on Ethics of the American Association of University Professors on Propaganda by Public Utility Corporations, which he prefaced by the following note:

"At an earlier meeting of the Regents, I suggested that the report of the Committee on Ethics of the American Association of University Professors on Propaganda by Public Utility Corporations contained, besides its specific discussion of the utility propaganda, an adequate, socially sound, and statesmanlike statement of policy on the problem of gifts for university research and the outside employment of academic instructors. I submit herewith to the Regents the portions of that report in which this policy and problem is discussed." (Copy on file)

THIS CERTIFIES THAT:

- At a regular meeting of The Regents of the University of Wisconsin held on due notice and pursuant to the By-laws thereof, on the third Wednesday in January, 1931 (January 21, 1931), at ten o'clock in the morning thereof, at the office of said Regents in the City of Madison, Wisconsin, there were present Regents Backus, Berger, Butler, Callahan, Clausen, Faast, Gundersen, Richardson, Runge, Schmidtmann, Sholts, Waters, being all of the said Regents except Regents Drexler, Eimon, Mead, Ullsperger, and being a majority and quorum of said Regents.
- Upon motion of Regent Clausen, duly made and seconded, the following resolutions, after due consideration and discussion were unanimously adopted:

"Whereas, The Regents of the University of Wisconsin were authorized, in their discretion, to convey to the United States the title to such portions of the University lands as in the judgment of the Regents will afford a suitable site for federal forest products laboratories, and which are acceptable for such purposes by the federal authorities, whenever the federal authorities shall have available funds for the erection of such laboratories and shall have decided to locate such laboratories at Madison, Wisconsin, by Chapter 354, Laws of 1923, of Wisconsin, and,

Whereas, the Secretary of Agriculture was authorized to accept, on behalf of the United States, from The Regents of the University of Wisconsin, a donation by deed of conveyance satisfactory to the United States of such tract or tracts of land, as in his judgment may be suitable as a site for a building or buildings for the forest products laboratory; and to construct at Madison, Wisconsin, on said land, such fireproof building or buildings as in his judgment may be suitable for the use of the forest products laboratory of the Forest

Service, with modern equipment for laboratory tests and experiments; and there has been authorized to be appropriated by the United States therefor the sum of \$900,000, by Act of Congress approved April 15, 1930, (46 Stat. 167); and the Secretary of Agriculture has been authorized to obligate the United States for \$800,000 over and above \$100,000 appropriated by Act of Congress approved May 27, 1930. (46 Stat. 403), and

Whereas, The Regents of the University of Wisconsin have, in their discretion, selected the land hereinafter described as a site to be conveyed to the United States, pursuant to said Chapter 354, Laws of 1923, and said lands in the judgment of said regents will afford a suitable site for said federal forest products laboratories; and said lands are acceptable for such purposes by and to the federal authorities; and they have available funds for the erection of such laboratories; and have decided to locate such laboratories at Madison, Wisconsin; and

Whereas, the said tract or tracts of land are, in the judgment of the Secretary of Agriculture, suitable as a site for a building or buildings for the said forest products laboratory, and the form of deed hereinafter mentioned has been submitted to the Attorney General of the United States for his approval and has been approved as to form; and said deed of conveyance is satisfactory to the United States; and

BE IT RESOLVED:

- a. That the <u>building program</u> so submitted and considered is adopted and approved for the construction of the said Forest Products Laboratory Building, on said proposed site, and The Regents of the University of Wisconsin have found said building program of the Secretary of Agriculture to be in accord with a building program, which meets with the approval of the said Regents, and
- b. Be it further resolved, that the President and Secretary of The Regents of the University of Wisconsin are authorized and directed to execute, seal and deliver to the Secretary of Agriculture of the United States, the said "Building Program and Agreement";

c. Be it further resolved that B. F. Faast, President, and M. E. McCaffrey, Secretary of The Regents of the University of Wisconsin, are authorized and directed to execute, seal and deliver to the Secretary of Agriculture, for and on behalf of the United States, the said deed of conveyance, when the title to said lands has been approved by the Attorney General of the United States, and thereby to convey to the United States, pursuant to said Chapter 354, Laws of Wisconsin for 1923, the following described land in Madison Township, Dane County, Wisconsin:

BUILDING PROGRAM AND AGREEMENT

whereas, in the judgment of The Regents of the University of Wisconsin, that portion of the University lands hereinafter described will afford a suitable site for the federal forest products laboratory authorized by the Act of Congress approved April 15, 1930 (Public - No. 128 - 71st Congress), and the Secretary of Agriculture has approved and accepted such site as suitable;

AND, WHEREAS, by such Act of Congress the Secretary of Agriculture has been authorized to accept, on behalf of the United States, a deed of conveyance of such land, subject to the provisions for reversion of title hereinafter stated, and to cause to be planked ned, constructed and equipped thereon a suitable fireproof building, or buildings (with required service connections, ways and approaches) and such Act has authorized to be appropriated for such purposes, and empowered the Secretary of Agriculture to obligate therefor, the necessary funds;

AND, WHEREAS, it is contemplated by Chapter 354 of the laws of Wisconsin for 1923 that an agreement be entered into between The Regents and the federal authorities (the Secretary of Agriculture with respect to a building program for the construction, maintaining, and operating of a forest products laboratory upon such site,

NOW, THEREFORE, IT IS AGREED between The Regents of the University of Wisconsin and the Secretary of Agriculture (the latter acting for the United States of America), as follows:

Pursuant to the authority of the Act of Congress, approved April 15, 1930 (Public - No. 128 - 71st Congress), there shall be constructed upon the land conveyed to the United States by The Regents of the University of Wisconsin for that purpose such fireproof building or buildings as in the judgment of the Secretary of Agriculture may be suitable for the use of the forest products laboratory of the Forest Service, with modern equipment for laboratory tests and experiments, including the moving and installation of now existing equipment and the purchase and installation of necessary new equipment, the making of steam, sewer, water, gas, electrical and other connections, and approaches as may be required.

The plans and specifications for such building, or buildings, shall be promptly proceeded with, and shall provide for a building or buildings to cost approximately Nine Hundred Thousand Dollars (\$900,000), inclusive of equipment, service connections and facilities, and the necessary sidings, roadways, sidewalks and approaches, and of costs incident to examining, transferring and perfecting title to the land conveyed to the United States, and of plans, specifications, supervision, and of all other costs incident to the construction and equipment of the building, or buildings, provided for in said Act of Congress.

The construction of such building, or buildings, to be started as soon as practicable and to be diligently prosecuted until completion for use as a forest products laboratory of the Forest Service, such being the use for which the building is to be maintained and operated by the United States.

of Wisconsin, that portion of the University lands hereinafter described will afford a suitable site for the federal forest products laboratory authorized by the Act of Congress approved April 15, 1930 (Public - No. 128 - 71st Congress), and the Secretary of Agriculture has approved and accepted such site as suitable;

AND, WHEREAS, by such Act of Congress the Secretary of Agriculture has been authorized to accept, on behalf of the United States, a deed of conveyance of such land, subject to the provisions for reversion of title hereinafter stated, and to cause to be planned, constructed and equipped thereon a suitable fire-proof building, or buildings (with required service connections, ways and approaches); and such Act has authorized to be appropriated for such purposes, and empowered the Secretary of Agriculture to obligate therefor, the necessary funds;

AND, WHEREAS, the following building program and agreement have been approved by the federal authorities (the Secretary of Agriculture) and by The Regents of the University of Wisconsin;

"Pursuant to the authority of the Act of Congress, approved April 15, 1930.
