REGULAR MEETING OF THE BOARD OF REGENTS
OF THE UNIVERSITY OF WISCONSIN

Madison, Wisconsin

Held in Room 210, Wisconsin Center Building

Friday, October 13, 1967, 9:00 A.M.

President Greenquist presiding.

PRESENT: Regents Friedrich, Greenquist, Kahl, Nellen, Pasch, Renk, Werner, and Ziegler.

ABSENT: Regents DeBardleben and Gelatt. Regent DeBardleben entered the meeting at 9:15 A.M. Regent Gelatt entered the meeting at 10:05 A.M.

Vice President Clodius began with the presentation of the Gifts and Grants. President Harrington entered the meeting at 9:06 A.M. President Harrington explained that federal funds would not be as large (coming to the University in such large amounts) due to the difficulty of the federal government meeting all its commitments. He explained that the lessening of funds would in no way be a reflection on the quality of the teachers on this campus and people doing research work. President Harrington then called on Vice President Engman to make a statement about the Midwest Universities Research Association (MURA), and explained that Mr. Engman's remarks were tied to one of the gifts and also to the Food and Drug Administration. Mr. Engman explained about how the University, on the first of July, had taken over the operation and management of MURA at Stoughton, and, how the University, in September, had accepted a grant from the National Institutes of Health to develop a high voltage electron microscope source. He explained that at this meeting today the Regents were accepting another gift from the Department of Defense, (See item 28. on page 24. of October

Gifts and Grants), and explained how this work was being done under Professor Kerst of the Physics Department.

Vice President Engman went on to call attention to item 33. on page 32., of the list of Gifts, Grants, and U.S. Government Contracts, having to do with the University being considered as a possible location by the federal government for the Food and Drug Laboratory. He concluded by saying that "we feel the Food and Drug Laboratory is a giant step closer to coming to Madison."

President Harrington called attention to the supplemental gift on page 42. of the list of Gifts, Grants, and U.S. Government Contracts, and stated that it was a small grant, but of a good deal of importance, explaining that it has been difficult to get money for Fine Arts and that this was a breakthrough for UW-M from the Rockefeller Foundation.

Regent DeBardeleben entered the meeting at 9:15 A.M.

Regent Renk raised the question of grants from Michigan State, Princeton, and Harvard. Vice President Engman explained that these usually come as subcontracts from other institutions, and that this ordinarily begins as a federal program, and comes about because there is a person of particular competence that this University has that some other University does not have. Vice President Clodius explained that the University of Wisconsin is involved in many integrated organizations with other Universities, such as the Big Ten, and the C.I.C. Rather than staffing up an individual institution to cover all these various competencies, it is better, he explained, to share the particular competence of an institution in exchange for one of theirs.

Upon motion by Regent Werner, seconded by Regent Pasch, it was VOTED, That the gifts and grants listed in the statement of Gifts, Grants, and U.S. Government Contracts, presented at this meeting (Copy filed with the papers of this meeting), be accepted and the appropriate officers of the University be authorized to sign the agreements; and that the Federal contracts listed therein be approved, ratified and confirmed.

Vice President Clodius presented the following recommendations relating to the Report of Personnel Actions By The President of the University, and the Report Of Non-personnel Actions By Administrative Officers And Of Informational Items:

1. That the approximately 3700 actions by the President of the University since the last meeting of the Regents, relating to appointments, resignations, leaves of absence, and changes of status of faculty personnel with rank less than that of Associate Professor and other non-classified civil service personnel with salaries at the annual rate of \$12,500 or less, on file with the Central Business Office and the Secretary of the Faculty; and to non-resident tuition remissions, be approved, ratified, and confirmed.

2. That the Report of Non-Personnel Actions By Administrative Officers To The Board Of Regents And Informational Items Reported For The Regent Record (EXHIBIT A attached) be received for the record; and that actions included in the report be approved, ratified, and confirmed.

Regent Kahl moved approval of the above recommendations, the motion was seconded by Regent Friedrich, and it was voted.

President Harrington presented the following recommendations relating to bequests:

1. That the bequest by the late Alta Brecher, Milwaukee, Wisconsin, to the University of Wisconsin at Madison, to be used to support the loan programs for needy and deserving students and/or scholarships for such students, be accepted by The Regents of the University of Wisconsin in accordance with the terms and conditions of the Last Will and Testament of Alta Brecher, Deceased; and that the Secretary or Assistant Secretary be authorized to sign receipts on behalf of The Regents of the University of Wisconsin for this bequest and do all things necessary to effect the transfer of this bequest to the University of Wisconsin.
2. That the bequest by the late Florence W. Julian, Pell Lake, Walworth County, Wisconsin, to the University of Wisconsin, the income from which is to be used for a scholarship to be known as the "Richard Stanley Julian Scholarship," be accepted by The Regents of the University of Wisconsin, in accordance with the terms and conditions of the Last Will and Testament of Florence W. Julian, Deceased; and that the Secretary or Assistant Secretary be authorized to sign a receipt on behalf of The Regents of the University of Wisconsin for this bequest.
3. That the bequest by the late Ann Zack, Milwaukee, Wisconsin, to be used for the special purpose to further the study and research of the human brain, be accepted by The Regents of the University of Wisconsin in accordance with the terms and conditions of the Last Will and Testament of Ann Zack, Deceased; and that the Secretary or Assistant Secretary be authorized to sign a receipt on behalf of The Regents of the University of Wisconsin for this bequest.

The Secretary explained that the late Mrs. Alta Brecher, had bequeathed one-half of the residue of her estate to the University of Wisconsin at Madison to support the loan programs for needy and deserving students and/or scholarships for such students. He said that it was estimated that this bequest would amount to approximately \$16,000. The Secretary reported that the late Mrs. Florence W.

Julian had bequeathed \$5,000 to the University of Wisconsin-Madison, the income from which is to be used for a scholarship to be known as the "Richard Stanley Julian Scholarship," and that the scholarship was named in memory of Mrs. Julian's late husband. The Secretary also reported that the bequest by the late Mrs. Ann Zack represented one-fourth of the residue of her estate and amounted to \$3,473.47.

Regent Werner moved approval of the above three recommendations relating to bequests, the motion was seconded by Regent Renk, and it was voted.

At the request of President Harrington, Chancellor Sewell presented the following recommendation:

That the final plans and specifications be approved and authority be granted for advertising for bids for the Enzyme Institute Addition, Madison, at a project cost of \$1,455,000.

University Architect, Donald Sites, showed an architect's sketch showing an addition to the Enzyme Institute. He showed and explained elevations, sketches, and floor plans; and explained that the additions to the building included additional floors on the present building, as well as remodeling within the building. He presented a model of the building. He referred to the document, which had been distributed to the Regents, including the area and time schedule, budget, and outline specifications. He estimated that the bids would be taken in January, 1968. Referring to the estimated budget for this project, he noted that it involved an increase from a previous estimate of \$1,355,000 to \$1,455,000. He explained that the additional amount would be requested from State funds.

Regent Pasch moved approval of the above recommendation, the motion was seconded by Regent Friedrich, and it was voted.

President Harrington presented the following recommendation:

That the new Central Heating Plant at the University of Wisconsin-Milwaukee be located on the east side of the campus in the area of the old heating plant, immediately south of Sabin Hall and north of Merrill and Johnson Halls.

President Harrington noted that this was a matter that the administration had thought would be difficult to decide, but that a satisfactory solution had been found. He asked Chancellor Klotsche to explain the recommendation.

Chancellor Klotsche explained the need to improve the heating system at University of Wisconsin-Milwaukee since the Milwaukee Downer College, and the Milwaukee Downer Seminary property, had been acquired which resulted in the decision to centralize the heating into one plant.

Mr. William Murphy, Director of Planning and Development at UWM, pointed out on the map the different sites that had been considered for a central heating plant, consisting of five different sites. He explained that the proposed site, which would not conflict with the development of the campus, covered between one and one-half and two acres, and was in the area of the old heating plant of the former Milwaukee Downer College.

Regent DeBardleben inquired how far the site was from the north boundary of the "L" shaped campus; and Mr. Murphy stated that it was about 1,000 feet. Regent DeBardleben inquired whether it hadn't previously been proposed that the new heating plant be constructed off the "L" shaped campus; and Mr. Murphy replied in the affirmative, but explained that no specific site had been considered. Chancellor Klotsche explained that the heating plant must be completed by the time of the completion of the dormitories and the new Science and Engineering Buildings, which will be completed in 1970. He agreed that the original proposal was to construct the heating plant off the "L" shaped campus, but that the urgency caused by the development of the new buildings made it necessary to locate it on the presently proposed site. Regent DeBardleben stated that the urgency had not developed suddenly; and that this looked like a decision made on the spur of the moment because of inadequate planning. Chancellor Klotsche replied that there was no opportunity now to move off the "L" shaped campus for this project, since bids had been opened for the Residence Halls, which would require the new heating plant.

Regent Friedrich inquired whether anything further had been done about purchasing the old car barn property of the Milwaukee Transport Company. Regent Werner, Chairman of the Special Regent Committee on Acquisition of Land in Milwaukee, explained that a counter offer had been made by the University for that property, but that there had been no further developments.

Regent Nellen moved approval of the above recommendation, and the motion was seconded by Regent Renk.

President Harrington stated that the Regents have spent a good deal of time, particularly through the Special Regent Committee on the Acquisition of Land in Milwaukee, on the question of what additional land UWM is going to need, because UWM is going to continue to grow and reach 25,000 students before long. He noted that there were some other difficulties regarding moving off the "L" shaped campus, including those of a political nature. He noted that some people feel that the University should not move off the "L" shaped campus, but others feel that, if the University did, it should not move south or west. He stated that making the location of the heating plant the central issue, would result in losing this additional time, and he stated that we have already lost far too much time. President Harrington recommended approval of the recommendation. Regent DeBardleben stated that he would support the motion, but that it seemed to him that the long range planning had been that the heating plant was to be off the "L" shaped campus. He stated that it was unfortunate that we are forced into the position of using this prime land for a heating plant when it could better be used for academic buildings.

The question was put on the above motion and it was voted.

President Harrington asked Chancellor Adolfson to report on the following recommendation:

That the Regents of the University of Wisconsin support the establishment at Marshfield of a 100-bed student dormitory to be amortized by rental charges to students, the land to be deeded in fee to the University by the City or County (or both) without cost to the State, and recommend to the Coordinating Committee for Higher Education that this dormitory be approved as an exception to present CCHE dormitory policy, and further recommend that, if approved by the Coordinating Committee for Higher Education, the project be recommended to the State Building Commission for approval and financing under the Wisconsin State Agencies Building Corporation, subject to appropriate review and concurrence as to financial feasibility.

Chancellor Adolfson reported that the Marshfield people were anxious to go ahead with this project, and were anxious to have it approved by the Regents and the Coordinating Council for Higher Education. He pointed out that about 40% of the students at the Marshfield Center come from outside of the County. Regent Werner inquired as to the reason for the reference in the recommendation to "an exception to present CCHE dormitory policy". Chancellor Adolfson explained that the present policy of the CCHE was not to have dormitories at the two-year Centers.

Regent DeBardleben moved approval of the above recommendation, the motion was seconded by Regent Ziegler, and it was voted.

Vice President Clodius presented the following recommendation:

That a public hearing be held in Room 1820, Van Hise Hall, 1220 Linden Drive, Madison, Wisconsin, on the seventeenth day of November, 1967, at 1:30 P.M., to consider the amendment by The Regents of the University of Wisconsin of Section UW 1.04 of the WISCONSIN ADMINISTRATIVE CODE, relative to parking on University property (EXHIBIT B attached).

Vice President Clodius explained that the Parking and Transportation Board had been active in studying the problems relating to parking by students, faculty, visitors, and business visitors on the Madison Campus, and had made various recommendations to the central administration for revising the parking regulations, which would become effective after approval by the Regents following the proper administrative procedures.

At the request of Vice President Clodius, Chancellor Sewell reviewed some of the major changes proposed in the revision of this section of the Wisconsin Administrative Code. He explained that a major change was the elimination of listing of individual parking areas, and substituting instead authority for the President and Chancellors to designate parking areas. Another change was the elimination of the all area 77 parking permits, but Chancellor Sewell explained

that the President and the Chancellors would still be able to authorize the issuance of multiple lot parking permits. Another change, he explained was to make parking Lot 60 a permit lot, except for a toll gate area for parking by visitors. He explained that, under the current provisions, no permit is required for Lot 60. He also pointed out that the Student Court might refuse to enforce violations by students parking in Lot 60 unless the Code is revised. The Secretary explained that the elimination of the designation of parking areas in the Code was desirable, because, as new buildings are built and old buildings razed, temporary parking lots are established, and it is impractical to revise the Code with such frequent changes. He also explained that the recommendation merely provided for the time and place of the hearing on the proposed rule changes, which would not be acted upon by the Regents until after the public hearing.

There was discussion of elimination of the all area 77 parking permits. Chancellor Sewell explained that people finding it necessary to park in more than one place would be assigned permits for alternate parking lots.

There was discussion of the handling of the public hearing on the proposed rule changes. President Greenquist inquired whether there were any obstacles to meeting in the new building (Van Hise Hall); President Harrington and Vice President Engman both indicated that the next Regent meeting could be held in Van Hise Hall.

Upon motion by Regent Ziegler, seconded by Regent Pasch, it was VOTED, that the November meeting of the Regents be held in Van Hise Hall.

Returning to the recommendation relating to the public hearing on the proposed rule changes, President Harrington pointed out that the University parking regulations, in the Wisconsin Administrative Code, had originally been written primarily in the context of the Madison Campus, but that the proposed rules were written in an all-University context.

Regent Renk moved approval of the above recommendation relating to a public hearing on the proposed amendment to Section UW 1.04 of the Wisconsin Administrative Code, the motion was seconded by Regent DeBardeleben, and it was voted.

President Harrington stated that the next item was a report on enrollment. Copies of tabulations showing enrollment data were distributed to the Regents. President Harrington commented that the actual enrollment was very close to what had been anticipated, the estimates having worked out quite well this time. He explained that it was important to estimate enrollment as closely as possible, since there was now a new system in the State budgeting procedures. He explained that, previously, if the enrollment estimates were wrong and there were more students than anticipated, the University did not get additional State money for those students and had to go to the Board on Government Operations to obtain the use of the additional fees paid. He explained that, previously, if the enrollment fell below the number estimated, in some cases the University could keep the funds

that had been appropriated, and in some cases the University might have to return the extra funds. Under the new system, he explained, if there are additional students, the University receives more money, not only in fees, but also additional State funds; if the enrollment falls below the estimates, the University returns some of the funds to the State. He expressed the opinion that the new system seemed to be a good one. President Harrington reviewed the enrollment data, commenting on situations where the enrollment varied substantially from the previous estimates. He noted that the new two-year Center at Waukesha was already so much of a success that it appeared clear that it would have a couple of thousand students, now being our second largest two-year Center. He pointed out that, when there is an overflow of students in a Center, there is a problem of having enough staff. He noted we have other Centers that had more enrollment than anticipated, such as at Marshfield and at Wausau. President Harrington noted that the enrollment in the evening class program in Milwaukee did not meet expectations. He explained that an effort had been made to substantially improve the opportunities in that program, and, while there was a substantial increase in enrollment, there was not as much as had been estimated. He noted that the enrollment on the Madison Campus was increasing less rapidly than the enrollment at Milwaukee and the Centers, which he felt was good, because at Madison there are the problems of a large campus and of the special responsibilities of the Madison Campus.

President Harrington turning to the question of out-of-state students, pointed out that this Board had repeatedly supported the position of the value of out-of-state students, and had objected to limitations on undergraduate or graduate out-of-state students. He noted that the Coordinating Council, during this past year, had put a restriction on out-of-state undergraduate students, with a maximum of 25% on any one campus. He indicated that the out-of-state undergraduate enrollment was in excess of that percentage only on the Madison Campus; and stated that the Coordinating Council for Higher Education agreed that this percentage could be worked down over a period of years. He noted that the State Universities Board of Regents had requested the Coordinating Council to reconsider its rule so that it would provide for a maximum of 25% on a system-wide basis rather than on any one campus. He suggested that the Regents of the University of Wisconsin might consider joining with the State Universities Board of Regents on this matter.

President Harrington noted that the last Legislature had increased out-of-state tuition quite sharply for both the University and the State University systems, so that the out-of-state fees and tuition are now essentially the cost of educating the undergraduate student. Copies of tabulations relating to fees and tuition and cost of instruction for nonresident undergraduate students were distributed to the Regents. President Harrington noted that it was rather striking that now fees and tuition come extremely close to the cost of instruction. Regent Ziegler noted that one-half of the nonresident students are graduate students; and he suggested that the Regents be furnished information as to the cost of instruction for graduate students. President Harrington explained that the Coordinating Council and the Department of Administration, in considering the cost of instruction, have always eliminated the graduate students. He felt that that was a question that was so entirely different that it should not be discussed at the same time. He noted that there were no restrictions in any state on nonresident graduate students.

(Regent Gelatt entered the meeting at 10:05 A.M.)

There was considerable further discussion of the enrollment figures, particularly with reference to the decrease in the increase of students at Madison and the larger increases being experienced at University of Wisconsin - Milwaukee and the Centers.

President Harrington noted that the transfers of students into the University system have been significant and that the retention of students has improved considerably, which he suggested were part of the explanations for why there were more sophomore and junior students than freshmen students on the Madison Campus. Vice President Clodius pointed out that the total for freshmen is larger in the entire University system.

Regent DeBardleben noted that this Board was on record as saying that it believed it should control admission standards on recommendation of the faculty. He asked President Harrington whether he felt it would be helpful for the Regents to take some form of action at this time. President Harrington stated that he had raised the question because the State Universities Board had taken an action that any recommendation should be system-wide. He suggested that this Board might express its concurrence with that action. President Greenquist inquired whether the Regents would have more control over admissions if the restrictions were on a state-wide basis; and Regent DeBardleben replied that they would have more control than they do now.

There was discussion to the extent to which the undergraduate program is taught by teaching assistants. President Harrington expressed the opinion that too much of the undergraduate instruction is done through teaching assistants, and noted that the trend was toward the use of more teaching assistants because of the lack of funds.

Returning to the suggestion that this Board might consider concurring with the request of the Board of Regents of State Universities to the Coordinating Council for Higher Education, regarding the rule on limitation of admission of nonresident undergraduate students, Regent DeBardleben moved that this Board support the principle that the nonresident enrollment restriction should be system-wide, and should be administered within this system by this Board, and within the other system by its Board. The motion was seconded by Regent Pasch and it was voted.

Approved the advance of \$91,000 of 1971-73 State Building Trust Funds and authority to proceed with final working drawings and to bid and construct Stage II of Central Library, UWM, at a total project cost of \$4,331,800, except that bidding and construction shall not be undertaken until the 1971-73 budget is enacted.

6. Approved the allotment of \$85,000 of 1971-73 State Building Trust Funds for preparation of plans, bidding, and construction work necessary to remodel the fume hood exhaust system in the Chemistry Research Building, UWMSn.

7. Approved the allotment of \$55,000 of 1969-71 State Building Trust Funds for the relocation of a main underground campus telephone line, UWM.

8. Approved the allotment of \$35,000 of 1969-71 State Building Trust Funds for repair and resurfacing of the existing parking lot, UWP.

9. Approved an increase of \$45,900 in the budget for site development at UWGB, to a new project total of \$1,705,900, to allow for the award of contracts for Phase III of the project.

10. The Building Commission discussed the priority listing and funding of 1971-73 Minor Projects by the agencies, and passed the following motion:

"All agencies will establish for the October Building Commission meeting a priority listing of Minor Projects for each of the last three quarters of the current fiscal year and for the second year of the biennium using a dollar amount as listed below as a guide for their spending level. Agencies will list all minor projects already approved from 1971-73 minor projects funds along with the dollar level approved as the first quarter of the fiscal year list. Further, all agencies will, in May of 1971, present the priority list of minor projects for fiscal year 1972-73 broken down on a quarterly basis, using the remainder of their minor projects funds as provided in the approved 1971-73 budget. The funding level to be used by each agency in developing priorities for the biennium is based on the Assembly version and Conference Committee recommendation of funding, as follows:

ORDER OF THE REGENTS OF THE UNIVERSITY OF WISCONSIN
AMENDING RULES

Pursuant to authority vested in The Regents of the University of Wisconsin by Section 36.06 Wisconsin Statutes, The Regents of the University of Wisconsin hereby amends rules as follows:

Section UW 1.04 of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

UW 1.04 Parking. (1) Parking is prohibited at all times on roads, drives, and fire lanes traversing university parks and on all university lands, except that, the dean of the college of agriculture, or his designated representative, is authorized to establish necessary parking areas at Upham Woods and on university farms not on the main Madison campus, and the president of the university, or his designated representative, and the chancellors, or their designated representatives, are authorized to establish parking areas, parking limits, and method of parking, on the campuses under their jurisdiction, and may designate areas as appropriate and safe for parking for specific groups at specific times, providing such areas are properly posted and patrolled as parking areas.

(2) Except as provided in subsection (3), parking in university parking areas is prohibited to other than persons specifically assigned to such areas; and motor vehicles so assigned to any parking areas shall be identified by an appropriate parking permit affixed to the vehicle as designated by the president of the university, or his designated representative, or by the chancellors of each campus, or their designated representatives.

(3)(a) In order to provide off-street parking in university parking areas for patrons of public university events, such as, for example, athletic contests, motor vehicles may be permitted to park in areas designated for such purpose by the chancellors of each campus, or their designated representatives, for a limited time not exceeding twelve hours continuously and on payment of a parking fee.

(b) Visitor parking lots may be established, and appropriate fees may be established for parking in such lots, by the chancellors, or their designated representatives, on their respective campuses.

(4) Parking is prohibited at all times in areas which must be kept clear for the passage of fire apparatus. Said areas shall be designated by standard signs reading "Fire Zone, No Parking at Any Time, Day or Night" or "Fire Lane, No Parking at Any Time, Day or Night".

(5) Parking is prohibited at all times in areas which must be kept clear for vehicles to load and unload. Such areas shall be designated by appropriate signs.

(6) Motor vehicles parked in a restricted parking area without a permit, or motor vehicles parked in a fire zone, fire lane, loading zone, or no parking zone, and unlicensed or partially dismantled motor vehicles, may be towed off the university premises and stored at the owner's expense.

(7) Parking in university parking areas shall be prohibited as required for reasons of needed repair and snow removal.

The amendment contained herein shall take effect as provided in section 227.026(1), Wisconsin Statutes.
