REGULAR MEETING OF THE BOARD OF REGENTS

Madison, Wisconsin

Tuesday and Wednesday, January 18 and 19, 1938

The meeting convened at 10 A.M. on January 18, Vice President Combs presiding

PRESENT: President Dykstra; Regents Backus, Baker, Brown, Callahan, Christopherson, Combs, Gates, Glover, Grady, Hones, Runge, Wilkie. (President Wilkie occupied the chair during the time he was able to be present at the meeting.) " Lest meeting ter no Egrady + Ringe

ABSENT: Regents Mead, Miller, Richards.

Upon motion of Regent Gates, seconded by Regent Runge, it was VOTED, That the minutes of the meeting of the Board held on December 7 and 8, 1937, be approved as sent out to the Regents.

Upon motion of Regent Callahan, seconded by Regent Runge, it was VOTED, That the minutes of the meeting of the Executive Committee held on December 29, 1937, be approved, ratified and confirmed.

Recommendation No. 3 under Medicine was again taken up and upon motion of Regent Callahan, seconded by Regent Brown, was approved.

V Dean Garrison appeared before the Regents to discuss a matter of personnel in the Law School and upon motion of Regent Baker it was VOTED, That the Regents go into executive session. Upon motion of Regent Grady, seconded by Regent Backus, it was

VOTED, That Professor William H. Page be retained in service beyond the age of seventy, for full time during the ensuing academic year, on special contract, in view of the understanding had with the Dean of the Law School and the Board of Regents in the year 1926-27, plus such period during the summer session as his services may be required by the Law School.

✓ A communication from Attorney W. Wade Boardman with reference to this matter was received and placed on file.

The Regents then arose from executive session.

The Cashman Act and the decision of the Circuit Court (Judge Reis) with reference to it were brought up for consideration and Regent Grady made the following statement, which embodies a resolution, and moved the adoption of the resolution; seconded by Regent Brown:

Since the discovery of the fact that many <u>Civil Service em-</u> ployees of the University were subjected to a reduction of salary below the minimum prescribed, I have repeatedly called to the attention of this Board the illegality of such action. It has been met by the contention that such action was legal. Upon investigation, I am certain that it will be found that the illegality has been determined by a uniform line of court decisions.

The action of this Board has resulted in illegally depriving a large number of employees of compensation justly due them.

I have persisted in requesting that this be submitted to the Attorney General for his opinion as to the legality of the Board's action. On one occasion a motion to that effect was entirely disregarded, not even accorded the courtesy of a second, which would have permitted a vote.

When it was submitted, I understand the question was asked as to the legality of so-called <u>voluntary</u> waivers, instead of being characterized as <u>imposed</u> waivers. The waivers were not <u>voluntary</u>, they were <u>imposed</u> under the budget.

In view of a recent court decision and the many authorities upon the subject, I desire to again urge this Board to comply with the law of the state. As I construe the recent decision of Judge Reis, it assumes that this Board did not intend to reduce the salaries, which action would have been illegal and accompanied by severe statutory penalties. If it had been the intention to make payment equal to the amount of the waivers imposed, the duty now rests upon us to act promptly. Therefore, I offer the following resolution:

WHEREAS, a large number of employees of the University of Wisconsin under Civil Service have for several years past received less than the minimum wage prescribed by the schedule and rate as fixed by the Bureau of Personnel, and

WHEREAS, there is due such employees various sums equaling the difference between the minimum rate and the amount so paid, estimated by the Business Manager as follows:

THEREFORE, BE IT RESOLVED, that the President of the University and the Business Manager be authorized and instructed to immediately apply to the State Emergency Board for the appropriation of a sum sufficient to meet the requirement of payment to each of such employees the sum due, being the difference between the amount heretofore received and the amount to which they were entitled under the schedule and rate of minimum wage as prescribed by the Bureau of Personnel.

Regent Wilkie then moved the following substitute amendment, the motion being seconded by Regent Gates:

That as soon as judgments are duly entered in the Circuit Court of Dane County directing payment of back pay to employees and former employees, under the Cashman Act, the University proceed at once to make payment in compliance with said judgment and in such manner as may be lawful and proper, after receiving advice from the Attorney General as to the manner of payment in each type of case covered by the judgment.

Called vote was taken. Regents voting "Aye", Backus, Baker, Brown, Callahan, Christopherson, Combs, Gates, Glover, Hones, Runge, Wilkie. Regent Grady voted "No".

Regent Backus stated that he felt any payment of salaries waived should apply to the faculty as well as the Civil Service staff.

Regent Brown voted "Aye" for the reason that he felt it was the only consistent thing he could do and stated that he had never been in favor of the waiver system.

Regent Grady voted "No" for the reason that it does not embrace the resolution that all Civil Service employees be paid the amount due them. Called vote was then taken on the passage of the Wilkie substitute amendment, all Regents present voting and voting "Aye", except Regent Grady, who stated that he voted "Aye" in so far as the amendment may be considered as directing payment to that portion of the Civil Service staff as would be benefitted, but that he was forced to vote "No" because of the effect on his own resolution, which would compensate all as well as the few.

Upon motion of Regent Gates the meeting adjourned to 9:30 A.M., Wednesday.
