REGULAR MEETING OF THE EXECUTIVE COMMITTEE

Madison, Wisconsin

Friday, July 29, 1927, 2:00 P.M.

PRESENT: Regents Callahan, Olbrich, Grady; President Frank, Business Manager Phillips, Secretary McCaffrey.

The Business Manager presented a communication from Mr. Ernest Warner, President of the Madison Park and Pleasure Drive Association, relative to an underway through the University grounds at the foot of Allen Street.

RECOMMENDATIONS OF THE BUSINESS MANAGER

1. That upon the recommendation of Dean Snell, the lease of the West Side Realty Company property at 137 Second Street, Milwaukee, occupied by the University Extension Division, be extended to July 1, 1928, with no change in rental, and with the understanding that the lease may be continued beyond July 1, 1928, by giving four months' written notice to the West Side Realty Company; that the Business Manager be authorized to sign the lease.
