The Contest Is Open

To any boy or girl who is a resident of Manitowoc county and is sixteen years of age or younger.

RULES OF THE CONTEST

- 1. Scrap metal is to be delivered or arrangements made for delivery to any of the authorized collection depots listed below.
- 2. All scrap must be delivered to the collection depots not later than midnight July 31.
- 3. The collection depot attendant will issue weight receipts for all scrap iron and metals, showing the weight in pounds, date, description of materials covered, and the name of the person receiving credit.
- 4. All weight receipts are to be made out in duplicate. The contestant is to receive the
- original copy, and the collection depot attendant will mail the duplicate to the War Production Board office, 341 West College avenue, Appleton.
- 5. The original copy given to the contestant is to be mailed to the county clerk's office, county courthouse, Manitowoc, and must be postmarked not later than midnight, July 31.
- 6. Each contestant must be responsible for the weight receipts being orderly, legible and correct as to the spelling of his or her name. Any evidence which, in the opinion of the judges, indicates misrepresentation of fact will automatically disqualify the contestant.
