**IMPORTANT INFORMATION**

**Purpose and Scope**

The purpose of the Wisconsin Short Course in Firemanship is to present in practical form the best and latest information available on fire fighting, fire prevention, and the training of firemen. The short course is a four day school at which the men attending may obtain from experts, information and practical knowledge on the recent developments in fire fighting and prevention.

The course in firemanship is intended for Wisconsin firemen, both volunteer and paid, fire chiefs and officials, mayors, councilmen, building officials, and others who are interested in firemanship. By conducting this course every year at Madison, it is possible to bring together representatives of each local department in the state and to instruct them in the outstanding advances in fire fighting. These representatives will be qualified, upon returning to their localities, to instruct other members of their departments.

This short course, or four day school, is conducted jointly by the Industrial Commission of the State of Wisconsin, the Wisconsin State Firemen's Association, the Wisconsin Paid Firemen's Association, the Wisconsin Association of Fire Chiefs, and the University Extension Division of the University of Wisconsin.

**Registration**

Registration should be made for each Fire Department. Payment of the fee entitles each department to send as many delegates as desired for any or all sessions. The fees are \$5.00 for village and industrial departments, \$10.00 for fourth class cities, and \$15.00 for second and third class cities to be paid in advance.

**Time and Place**

The sessions of the short course will begin promptly at 9:00 a. m. and 1:00 p. m., June 23, 24, 25, and 26, 1931, and will be held in the Music Hall of the University, at State and Park Streets, Madison. Noonday luncheons will be held in the Wisconsin Union. Both of these buildings are near the lower campus, where the demonstrations will be held.
