PRESENT: Regents Callahan, Wilkie; President Frank, Business Manager Phillips, Secretary McCaffrey.

#### RECOMMENDATIONS OF THE PRESIDENT

- Administration and General -

l. <sup>V</sup> That M. E. McCaffrey, Secretary of the Regents, be appointed treasurer of the Agricultural Experiment Station. (In compliance with federal regulations requiring a separate treasurer for funds appropriated by the federal government for agricultural research.) Adopted. (To confirm verbal approval.)

2. V That the First National Bank of Madison, West Branch, be designated as the depository for the grants received from the federal government for the agricultural experiment station. (In compliance with federal regulations requiring a separate bank account for these funds.) (To confirm verbal approval.)

Adopted.

3. That 30 teachers and 60 unemployed women for whom instruction is furnished by the federal government and who will receive no academic credit for work done be permitted to register in the 1934 Summer School for Workers in Industry upon the payment of the Union and Infirmary fees.

4. That the following change of wording in the action taken by the Graduate faculty concerning the requirements for Master's degrees be approved:

(1) That the requirement for the M.A., M.S., or Ph.M. degree be modified as follows: When graduate work at other

institutions is offered for transfer toward a Master's degree, only complete semesters or quarters will be counted in determining this minimum period of required residence. Summer sessions at other institutions may not be transferred. Summers spent abroad in language study, advanced work taken at biological stations, and the like, may, upon recommendation of the department concerned, be accepted as one of the six required summer sessions. That the said Business Manager be and he is hereby authorized and directed to forthwith send to said Federal Emergency Administration of Public Works two certified copies of this Resolution and two certified copies of the proceedings of the Regents of the University of Wisconsin Executive Committee in connection with the adoption of this Resolution, and such further documents or proofs in connection with the approval and execution of said Grant Agreement as may be requested by said Federal Emergency Administration of Public Works.

#### Additional Scholarships - \$100 for one year August F. Steinbrecher Arthur Paul Hoffmann

Upon recommendation of the Secretary it was VOTED, That the gift of \$500 from the Alumnae of Alpha Alpha of Beta Sigma Omicron Sorority to establish a scholarship loan fund for women students at the University be accepted, together with the following regulations for the operation of the fund:

- 1. That this sum of five hundred dollars (\$500.00) be known as the Beta Sigma Omicron Scholarship Loan Fund.
- 2. That it be divided into Scholarship Loans, not to exceed a sum of fifty dollars (\$50.00) per person each year.
- 3. That not more than one hundred and fifty dollars (\$150.00) be loaned in any one calendar year.
- 4. That said Scholarship Loans be distributed to worthy senior and/or graduate women students at the University of Wisconsin, preference being given to senior and/or graduate students who are members of Beta Sigma Omicron Sorority.
- 5. That no additional loan be made to a person until her first loan has been repaid.
- 6. That said Scholarship Loans be repaid within three (3) years from the date when the original loan was granted, said loan to bear the following rate of interest: first year, no interest; second year, 3% interest; third year, 6% interest; said interest being payable at the end of the interest-bearing period.
- 7. That each person receiving one of the Scholarship Loans execute a promissory note payable at the end of one (1) year as security for the loan, with the understanding that renewals may be granted up to a maximum of three years from date of granting the loan.
  - 8. That loans be made in the usual manner upon recommendation of the Faculty Committee on Loans and Undergraduate Scholarships.
  - 9. That at any time, upon presentation of a written request signed by the following four persons: Miss Esther Krug, Miss Florence May Nichols, Miss Dorothy Schlatter, and Miss Royetta Smith, or their appointed

substitutes, as representatives of the Madison Alumnae of Beta Sigma Omicron Sorority, the said sum of five hundred dollars (\$500.00) may be withdrawn by any one or more of the undersigned or their representatives, upon making the proper arrangements with the Secretary of the Regents and upon allowing a reasonable period of time for collection.
