EVERYBODY'S LAW BOOK: LEGAL RIGHTS AND LEGAL REMEDIES; BUSINESS FORMS AND VALUABLE INFORMATION.

"Ignorance of the law excuses no one," is the maxim inscribed over the door of every temple of justice. Negatively it expresses the command, "Thou shalt know the law!"—a command which imposes upon everybody the necessity of acquiring a certain amount of legal knowledge.

Everybody's Law Book is a handy book of reference for lawyers and it is especially designed for three classes of readers—first, business men, second, students, and third, those who believe with Blackstone that a knowledge of the law is a necessary part of a liberal education.

The opening chapter, wherein is explained the complex system of American Law, is followed by a complete statement of all its sources and all the elements of judgments rendered by the various Courts within the Union. The experienced lawyer as well as the student will appreciate the value of such a statement—the like of which is not to be found in any other work—as it will enable them to see at a glance all the possible conditions of any legal problem which can be presented.

In the second chapter the general principles of the law are stated; and in the next, its leading maxims are enumerated. Then in the succeeding chapters, the distinctions between rights and remedies, actions and proceedings, criminal and civil torts, law and equity, the State and National jurisdictions and others, which are usually obscure and confusing to the laymen, are fully gone into and made plain. A chapter is devoted to the conflict between the laws of different States and countries. In it is told how such conflicts arise, and the rules for settling them are stated.

Following this is given a description of the Courts and their authority, and such a general account of the method of conducting a suit, making a defence, proving a case, obtaining and enforcing a judgment, as every one should know in order to act intelligently for the enforcement of his rights or the protection of himself, his property and his family against unjust demands or threatened injuries. From this portion of the work the reader will learn what things are necessary to be done before commencing suit, by way of demand, notice, tender, etc.; how long he may delay in beginning suit; and that he must do certain things to secure and preserve the evidence of his case or defence.

It is no part of the purpose of the author to instruct laymen in the art of managing cases in court. That is a branch of legal knowledge which should be sought for, when the necessity arises, from the trained practitioner. A sufficient examination of the procedure of the courts is given for the lay reader to know when to employ a lawyer, and what things to do and what things not to do before consulting one; so that, when he puts his case in his attorney's hands, he will not discover that it has been ruined by some act of omission or commission on his part.

The next division of the work deals with the law peculiar to persons and personal relations, and includes those exceptions to the general rules of law which are made on account of the privileges and incapacities of persons. Here will be found the law relating to Aliens, Emigrants, Citizens, Voters, Naturalization, Passports, Lunatics, Married Women, Notaries, Lawyers, Domicile, Partnerships, Corporations, Promises to Marry and Breaches thereof, Marriage and Divorce, Husband and Wife, Parent and Child and Guardian and Ward. Also Principals and Agents, Masters and Servants, Sureties, Guarantors, Debtors and Creditors.

Then comes a division devoted to Personal Property and Contracts—separate chapters treating of Sales of Personal Property, Warranties on such Sales, the Statute of Frauds, Bailments (goods returnable to the owner), Pledges, Liens, Chattel Mortgages, Notes, Drafts, Checks, Interest, Usury and Insurance.

Then follows a chapter on Torts or Civil wrongs.

The law relating to Estates in Land comes next, and includes an account of their Ownership and Transfer, Deeds and Covenants, Mortgages, Landlord and Tenant, Easements, Fixtures, Acknowledgments and Proofs, Recording Instruments, &c. A full and explicit account of the manner of searching titles to real estate is here given, so that any one who chooses can search a title for himself without the assistance of a conveyancer.

The manner of drawing and executing wills is then explained. This is followed, first, by the law of intestacy and, secondly, the duties of executors and administrators.

The succeeding chapters are devoted to special topics, viz.: Insolvency and Bankruptcy, Carriers, Bills of Lading, Stoppage in Transitu, Commercial Travelers, Stock and Grain Brokers, Promoters and Promoters' Agreements, Hotels, Farm Law, Horse Law, Newspaper Law, Advertisements and Advertising Agencies, Theatre Law, Patents, Trade Marks, Copyrights, Playrights &c., Internal Revenue, Homestead Laws, the Law of Ships, Custom-House Regulations, Importation of Goods, Pensions, Postal Laws and Regulations, Mining Laws, How the President is Elected and The Election of Senators and Representatives to Congress.

The chapters on Patents, Trademarks, and Copyrights are full of valuable information and contain such explicit instructions for securing the rights thereto that Inventors, Authors, and Trade-mark Owners should have no difficulty in attending to such matters for themselves.

After the closing chapter are added, besides others, summaries of the Statutes of the various States and Territories, namely: The Objects for which Corporations may be Formed under General Laws, Exempt Property and Homestead Exemptions, Insolvent Assignments and Preferences, Divorce Laws, Rates of Interest and Usury, Judgment Liens and the New York Mechanics' Lien Law. A dictionary of legal terms and phrases, a miscellany of useful information, and a collection of Forms complete the work. The latter includes Notes, Drafts, Contracts, Chattel Mortgages, Corporation-Certificates, By-Laws, Deeds, Mortgages, and Wills. Also those relating to Homesteads, Pensions, Patents and Trade-Marks. The forms are such as persons of ordinary intelligence can readily adapt to their respective wants and use without further assistance.

The aim has been to make a practical book for practical people—to supply a demand, which undoubtedly exists amongst students, laymen and even lawyers for a popular law book, far in advance of any heretofore issued, and which while helping the student to grasp the subject and become familiar with its theory, should impart at the same time a useful amount of present-day law.

No effort has been spared to prepare a work which could be considered the standard of its kind.

That it will meet with the approval and be of assistance to those for whom it is intended, is the earnest wish of
