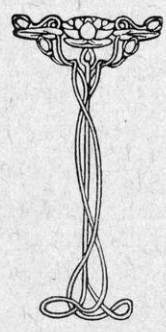

Students of the University of Wisconsin

We shall be leading the universities and colleges of the country when we strike for Peace on April 12th.

We Are Striking Because:

1) We will be adding our voices to the articulate expression of an intelligent understanding of the futility of War.

2) The Peace Strike is a rehearsal of what we can do in the event of threatening war.

3) We must erect a barrier within ourselves against potential war propaganda.

4) The Peace Strike is a stimulus both on the campus and throughout the nation to Peace consciousness.

5) It is a traditional expression of our united opinion against participation in war.

6) We must form an intelligent opinion on these vital issues:

War Budgets

The Nye-Kvale Bill and the status of the ROTC

The Oxford Pledge

The Industrial Mobilization Plan of the United States Army

The League of Nations and Collective Security

Neutrality and Isolation

Imperialism and fascism as causes of war

Government ownership of munitions factories.

Resolutions

We ask that you consider the Oxford Pledge, "to refuse to support the Government of the United States in any war it may undertake," and be ready to voice that consideration at the Strike.

The following resolutions will be brought up at the strike for consideration by the student body. We urge that you give them careful thought before forming any opinion.

1) Resolved that the ROTC be put on equal basis with physical training so that there should be coercion of students to take ROTC. Therefore, ROTC should be given at this university on a non-credit basis.

2) Resolved that we support the Nye-Kvale resolution to abolish compulsory ROTC.

3) Resolved that all courses on the Hill which pertain to the present social, political, and economic problems should stress more fully the question of world peace and the methods by which that peace may be obtained. Be it further resolved that a course in peace methods be instituted.

4) Resolved that we advocate a more extensive neutrality policy so as to include Italy and Germany as belligerents in the Spanish conflict.
