# FLOODS HIT W.S.H.

Floods came to Wisconsin Monday, March 15, and they even touched upon the grounds of WSH. It is a peculiar situation in the weather that caused this troublesome problem for people and their homes throughout the state. Sunday March 14, the temperature was above freezing and the snow was melting at a steady rate. During the morning and early afternoon it appeared to be a pleasant day; with the sewers even cooperating by not plugging up and causing pools of water to originate. During the middle of the afternoon a light fog started to cover the state. This fog cover continued to grow till about 7:00 in the evening. At this point the fog was so thick you could barely see in front of you. Warm rains started at this time, including a great display of lightning and the storm continued for most of the night with the rain turning into a downpour.

Around 9:00 P. M. over the communications system of the hospital came the word that the road in front of North Cottage was flooded and unpassable by car. This the first confirmed word that WSH was also involved with the flooding throughout the state.

At 10:00 P. M. maintenance men working in Kempster Hall noticed water leaking into the elevator shafts. They called up Mr. Ray Vander Geeten - Structural Supervisor of WSH; and Mr. John Cook - Mechanical Supervisor of WSH. The maintenance men related to these two supervisors of the possible flood that might occur.

Early Monday, March 15, at about 3:00 A. M. a crew started pumping out electrical pits so power would not short out. At this time the three elevators in Kempster Hall were raised to the 1st floor so the rising level in the elevator shafts could not come in contact with the elevator car or cables connected to them; the elevator surface in Kempster would have been out of service for about a week. This is because the equipment would have to be taken apart and dried out to insure proper running.

Approximately at 4:00 A. M. the elevator shafts of Kempster and the surrounding tunnel areas started to be pumped out into lake Winnebago. This pumping operation was going very good and the maintenance men had the west elevator back in operation when the electrical breaker system the pumps were on kicked out. The breakers went out because the pumps in the elevators couldn't handle the great amount of water and the strenuous work load. This was the only problem the crew ran into. While they fixed the breaker system the water level rose again. The elevator shafts in the basement were filled to floor level and there was an inch of water on the floor near the elevators. The breakers were fixed and by mid morning the flooding was completely under control.

In reply to what the cause of flooding was, Mr. Cook said, "due to the raining and melting conditions the surface water was coming into the system which caused more water than the pumps could handle." He also said, "in the 30 years I have been working at WSH this is the most severe flooding that I've seen." The other big question is. What if any solution is there to correct this flooding? "A better drainage system around Kempster and pumps that can handle a bigger capacity", was Mr. Cook's reply.

Beside Mr. Cook who headed the flood project a special thanks is due to six maintenance men who put in some long hours to get and keep control of the flooding in Kempster Hall. Let's all hope that this is the last or at least the worst flood that will hit WSH.

# Chaplain's Message

## THE EYE OF FAITH

Hebrews 11:27 "By faith....he (Moses) endured as seeing Him who is invisible."

It is often said: "Seeing is believing." Faith must wait for sight. Like a police escort in front of a motorcade, so sight must clear the way for faith.

In matters of things holy, of things of God, of Scripture, of salvation, this slogan takes the form of assertion: unless I can see it clearly in my mind I am not going to accept it in faith.

The "seeing-is-believing" attitude is based on the assumption the mind of man has a pair of good eyes and is fully capable of seeing. Why should one accept blindly what another says, if he can see for himself? Why should a man who can see receive the help of a seeing eye dog? It is this basic assumption which we must challenge. No man has seen God at any time. God never comes within the sweep of man's laboratory.

Even a healthy eye with 20-20 vision could not "see" God and things divine. As a matter of fact, man's mind is not healthy. The eyes of his understanding have been darkened by that which God calls sin.

Some people in life do have to take the word of others. They cannot rely upon their own sight. They must be led. I refer to the blind.

Faith is for the Blind; for those whose eyes have been covered with the thick scales of sin and error. Their eyes are out of focus, always directed to the things below, not to the things above, where Christ is.

Faith is for the Blind. Faith is their eye. God removes the scales of evil and enlightens the eyes of the understanding. By faith Moses "saw" Him who is invisible.

Faith is not blind. On the contrary, believing is seeing. Faith is the conviction of things not seen. Through faith's sight we can see God.

You can have this kind of Faith at this Easter season to believe that God's Son did die for you and was resurrected and one of these days will come again even as He promised.

# Issues 'n' Answers

## WHAT MAJOR CHANGE WOULD YOU MAKE WITHIN THE HOSPITAL? EXPLAIN.

More liberal liberty privileges - possibly using the "buddy system" for newly admitted patients.

All wards should hold ward meetings at least once a week.

The hospital administration should improve their public relations in respect to updating more information on mental illness. Also, to publicize the existence of Winnebago State Hospital and the treatment areas available to all Wisconsin residents.

More of a choice of activities; better movies, competitive sports between buildings, hopefully a swimming pool.

A need to up-date the bus schedule.

There is a lack of activity on weekends which make them very depressing. There should also be more group involvement.

Improve the food -- more tasty, too much repetition, same thing week after week.

Cut down on the tape recordings in Gordon Hall -- too much repetition, very boring.

Patient - Administration relationships should have more open rapport to have a more meaningful relationship which may solve problems that arise between both parties.

Nursing aides should talk more with the patients and less amongst themselves.

Better explanations given to the patients by their doctors when denied requests for home visits.

Patients should not be treated like 2 year old mental patients by the staff.

A quiet room on each ward designed just for letter writing or just a place for some peace and quiet - no talking allowed!

Open the Canteen on Saturday mornings.

Have an open bedroom policy in Kempster 2W, and experiment in a self-governing policy and open ward.

Take us for a ride on a week-end. I haven't been outside since I have been here.

Patients would like a closer relationship with their Doctors and Social Workers and would like to see them more often.

Have the Recreation rooms open more hours, especially on week-ends.

I think there should be a little compensation for the patients who are working.

Better form of job rehabilitation - have more people finding jobs for patients.

Have lesser punishment for minor faults. Example: Smoking in a no smoking area and having your liberty pulled.

Release patients earlier. Sitting here accomplishing nothing. Doing jobs that patients shouldn't. Too many employees are standing around and watching the patients doing their work.

Aides should encourage better table manners in the cafeterias.

More trips off grounds, especially on week-ends for the patients who do not have a lot of visitors.

Walking should be done to improve the tunnel between Kempster Hall and the Canteen. Despite the new ceiling, the floor is still wet which makes walking very hazardous. The lack of heat, plus the drabness, also makes many patients very wary of using this part of the tunnel.

When special programs are arranged for the patients at the Canteen, more respect should be given to the entertainers who so graciously give of their time.

# What You Should Know

Legal matters that involve privileges and duties in the outside world are always of interest to patients. What rights do they have, and what rights, if any, are lost?

Dr. Treffert, superintendent of the hospital, has answered questions most frequently asked by patients. He also reviews some of the provisions in the new Mental Health Act pending before the state legislature and which will be considered when they next convene.

## DO I HAVE THE RIGHT TO WRITE PERSONAL CHECKS?

A patient can cash personal checks by following this procedure: he endorses the check and the money is placed in his account at the hospital. For any amount up to \$8.00 a week, the patient may sign a ward request for weekly withdrawal on Sunday evening. The money will be received on Wednesday. If money is needed between these withdrawal times, or more money is needed for a special need, a special-request slip signed by the patient and the doctor is needed to obtain any withdrawal.

The special-request slip may be presented to the business office any time between the hours of 7:45 and 11:55 a.m., and 12:45 and 4:15 p.m. Please note these hours as no money can be released after the cashier's window is closed.

## YOU ARE ALLOWED TO COMMIT YOURSELF, THEREFORE CAN YOU SIGN YOURSELF OUT WHENEVER YOU WISH TO LEAVE?

Assuming that this would be a case of leaving against the doctor's order, a regular voluntary admittance can leave when he wants to, except in a situation in which the doctors (or the treatment team) feel the patient is dangerous to himself or others. In such a case, the hospital has thirty five days to institute a regular commitment. The new Mental Health Act would reduce this time limit to ten days.

When a person is committed as mentally ill, the decision to release him rests with the treatment team. The patient is conditionally released for a twelve-month period and until

this time is up, he may be readmitted to the hospital at the recommendation of the superintendent without going through the court procedure.

Inebriates, whether they come vol, untrarily or not, become court commitments, and can not leave until their doctor feels they are ready. They usually remain for about six weeks. The new Mental Health Act would eliminate such court commitments. This could make treatment difficult because inebriates might decide to leave the hospital before they are ready.

## CAN YOU LOSE YOUR DRIVER'S LICENSE IF COMMITTED TO THE HOSPITAL AS MENTALLY ILL?

A patient's drivers license is taken for safe keeping when he is admitted. This does not mean that the patient is not capable of driving. The license is returned when he leaves the hospital. When an ex-patient applies for a license for the first time, or for a renewal, he is asked whether he has ever been mentally ill. The Motor Vehicle Department might decide to write to the superintendent of the hospital to find out whether there are any mental or physical problems that could impair his driving. But the final decision is made by the Motor Vehicle Department.

## WHY ARE SOCIAL SECURITY CHECKS MADE OUT TO THE SPOUSE RATHER THAN THE PATIENT?

Social Security checks are not made out to the spouse in all cases. It depends on whether or not the patient is judged capable of handling his own financial affairs.

## CAN A PATIENT, ON HOME LEAVE, DRIVE A CAR?

Usually not because most of the patients are on medication that could interfere with their eyesight.

## IS IT AGAINST THE LAW TO DRIVE A CAR WHILE ON MEDICATION?

# CANTEEN

## PAST & PRESENT

The Canteen was first operated as a well organized business on August 4, 1952. At that time it occupied a small room in the old Administration Building. There was only one full time employee at that time, and she was assisted by one part-time helper. In those days the Canteen Carts which visited the wards were manned by O.T. staff members.

After a 15 year existence in their tiny facilities, the transfer was made on Aug. 21, 1967 to the present area in the Food Service Building. A staff of five were needed to handle the extended hours and added business. Besides the new quarters, at this time the vending machines were installed to expand the food line. And the main attraction of this facility is food - all manners, shapes and forms. Candy, ice cream cones and sundaes, fresh pop corn, potato chips and crackers are always in good supply. The machines have made hot and cold drinks, sandwiches, canned meals and fresh fruits available. Toys cosmetics, jewelry and greeting cards are a few of the many other items they handle. Smoking and reading needs can also be satisfied there.

The Canteen Carts which service the wards of Sherman, Kempster and Gordon Halls twice a week is still a very important part of the Canteen operation. This is especially necessary for the patients in the admission wards who as yet haven't any liberty time and are thus unable to get supplies by themselves.

The Canteen is looked upon by many patients as a place to spend their liberty time, not so much as a store but a spot to relax or find enjoyment in the juke box room. The nearly new 160 selection Seeburg juke box has now been in operation for a few weeks. Some new records have been inserted and more changes will be made. Taking good care of this machine will enable it to take good care of our music needs.

Another new addition to the Canteen is the Bulletin Board. It is for the use of all - so take advantage of it. Use it to suggest new records you would like to be able to hear. These comments will be used as a guide line to

aid in the selection of new records. It can also be used for ideas you will have about the Canteen situation, in general. All comments will be reviewed by the Social Chairmen and then channeled to the proper personnel for consideration of action.

Have you ever wondered about what happens to the profits from the Canteen operation. Salaries of the 5 personnel of course, as you would expect come off the top. But after that, this money is put to good patient use. The new juke box and the replacement records are a good example. Through the past years 15 T.V. sets for ward use have been bought and serviced, also from Canteen profits. The pop corn machine is another example. It is easy to see that patient enjoyment is the prime concern and guide line for expenditures.

A few evening and week-end activities are planned for patient entertainment and it would be very helpful if more of the wards would encourage participation. Many patients can not go to the Canteen without nursing supervision and very often they are the ones who would benefit most from this extra involvement.

The Canteen has shown many changes during it's relatively short life time. It has grown to meet our needs and will continue to expand its services as they are needed. It is yours to enjoy and use, so make the most of it.

# Lake Winnebago...

THE INDIANS HAD  
A NAME FOR IT... "STINKY"

Yep, the Indians, and later the white man, had a name for Winnebago. The translation is variously "dirty water," "smelly water" or "water of evil odor!"

Some historians claim the Winnebago tribe, after whom the lake was officially named, was known among other Indian tribes as the "smelly" ones. Another Indian name for the Winnebagoes was "Puant" (also Lake of the Puants) which also is translated as "stinky." Some also said it was due to a body odor peculiar to the Winnebagoes. Take your pick!

So, the designation of the lake carried on up to the present day. Two other factors help perpetuate the legend. "Dog Days" during which the lake is covered with a green scum are one cause. The green scum is the product of algae and under-water vegetation which occurs several times during summer. Another odor-providing reason is the periodic hatch of a certain lake fly. This occurs spontaneously as embryos of the flies float towards the shore where the actual hatch occurs. This hatching is accompanied by the emission of a fishy smell. The pesky lake fly has a marked characteristic - furry antennae. The fly has a life span in the air of 72-86 hours. But, they number in the billions, it seems.

Just as Lake Winnebago was named after an Indian tribe, other villages and cities in this area have names of Indian origin.

Some of these are as follows:  
 WINNECONNE - "place of shells"  
 OSHKOSH - named after a tribal chief, translated the word means "nail" such as finger or toe  
 MENASHA - either "thorn" or "island"  
 NEENAH - "water"  
 WAUPUN - originally "Waubun" and it means "early days"  
 MANITOWOC - "the devil's den" or "spirit land"  
 WAUPACA - "tomorrow"  
 FOND DU LAC - French for either "bottom" or "head" of the lake

These are but a few. Many communities are named after families or early settlers. Ex. O M R O is named after Charles Omer, an early trader. PICKETT is named after the family. RIPPON and BERLIN are named after Old World cities; Ripon, England, and Berlin, Germany.

Some communities have names that leave little to the imagination. Exs. are Green Lake, Green Bay, Two Rivers, etc.

To the non-native the name Butte des Morts is intriguing. It's origin is French. Translated, it means "Hill of the Dead." It is the name of an Indian burial ground which is alleged to

be on the west shore of Little Lake Butte des Morts, near Menasha.

At approximately the site of the historical marker there, ..... Highway 41....a major battle of two Indian tribes took place,

The dead of both tribes are believed buried there. A stone with a metal marker commemorates the historic event.

How's for animal names? the FOX river? WOLF river? BEAR Creek?

Speaking of the FOX and WOLF rivers, here are some tidbits of information:

The WOLF starts from a lake near Crandon, wending its way south toward a junction with the FOX not far from the village of Butte des Morts.

Lake Butte des Morts, then isn't a true lake. It is the wedding of the WOLF and the FOX. On the final rush to Green Bay, it is known and called the FOX river.

Lake Winnebago is a true lake fed by the waters of the combined FOX and WOLF as well as several other streams.

The FOX is one of the few rivers in the U.S. which flow northward.

No matter how good the food may be, it is impossible to enjoy it because of the atmosphere in the dining room. When patients stir their food all over the tray or turn their plates upside down, it takes away my appetite. These patients are not reprimanded or supervised. It would help one's appetite if these people could be more closely supervised or segregated within the dining room so one would not have to sit opposite them.

The food would taste better, and mealtime would be more enjoyable if the time in the dining room was devoted to eating. It is not appetizing to see someone having their hair combed at the table or other grooming procedures occur at the table as often happens in our dining room. Also, when accidents happen, it would help our appetites, if the bleeding patient were taken away from the dining room.

More privacy would be appreciated. We may be mentally ill, but we still have some pride, and it is degrading to have to undress in front of others when making a complaint to the doctor. It may be a minor complaint, but it is embarrassing to have to unrobe in a general area.

I have no complaints. I love my work and am very happy here.

#### MAY A PATIENT REQUEST A CHANGE OF DOCTORS OR SOCIAL WORKERS?

A request for a change is possible. However such requests are only rarely granted, and then only in very unusual circumstances.

#### CAN A JUDGE EXTEND A PATIENT'S PERIOD OF OBSERVATION WITHOUT COMMUNICATING WITH THE HOSPITAL OR WITHOUT A PATIENT'S CONSENT?

Theoretically, it is possible, but usually the doctor or other interested parties request the extension and it is okayed by the judge.

#### CAN A MAN BE DRAFTED WHILE A PATIENT HERE?

Yes. The hospital acts as an advisor by sending a final summary of the patient's condition. This helps

the draft board decide whether the person in question is an acceptable candidate.

#### IF A PATIENT IS WORKING OUTSIDE THE HOSPITAL, IS HE ALLOWED TO SPEND HIS MONEY AS HE WISHES OR MUST IT BE TURNED IN TO THE BUSINESS OFFICE?

The hospital prefers to have the money placed in the patient's account for safe keeping. It is available to the patient through ward requests on Sunday, or through a special-request slip signed by the patient and the doctor and presented to the business office during the hours of 7:45 to 11:55 a.m., and 12:45 to 4:15 p.m. Please note these hours as no money can be released after the cashier's window is closed.

#### CAN YOU GET MARRIED WHILE YOU ARE A PATIENT?

Yes, if the doctor decides you are legally competent.

#### CAN YOU GET A DIVORCE WHILE HERE AS A PATIENT?

Yes, if the doctor decides you are legally competent.
