REGULAR MEETING OF THE BOARD OF REGENTS

Madison, Wisconsin

Thursday, August 15, 1946, 9:55 A.M.

President Sensenbrenner presiding

PRESENT: Regents Callahan, Campbell, Grady, Jones, Kleczka, Sensenbrenner, Werner.

ABSENT: Regents Cleary, Hodgkins, Holmes.

Regent Hodgkins attended the committee meetings on Wednesday afternoon and on Thursday morning.

Upon motion of Regent Werner, seconded by Regent Kleczka, it was VOTED, That the minutes of the special meeting of the Board held in Milwaukee, Wisconsin, on July 25, 1946, be approved as sent out to the Regents.

RECOMMENDATIONS OF THE PRESIDENT

- Appointments -

1. That Blanche M. Trilling be appointed emeritus professor of physical education for women, to take effect at the close of the academic year 1946-47.

Upon motion of Regent Kleczka, seconded by Regent Callahan, recommendation No. 1 listed under Appointments was adopted.

2: That Sture A. M. Johnson be appointed professor of dermatology, beginning September 1, 1946; salary at the rate of \$6000 per annum, twelve months' basis; charge to item vice Foerster, p. 172.

Upon motion of Regent Grady, seconded by Regent Callahan, recommendation No. 2 listed under Appointments was adopted.

3. That Charles A. Wodomeyer be appointed director of the Racine Extension Center, beginning August 19, 1946; salary at the rate of \$4800 per annum, twelve

months' basis; charge to item for Director, Racine Center, Administration, p. 257, \$4500, and \$300 to additional instruction.

Upon motion of Regent Kleczka, seconded by Regent Jones, recommendation No. 3 listed under Appointments was adopted.

4. That LeRoy E. Luberg be appointed part-time administrative assistant in the President's Office for the period August 15 to August 31, 1946, inclusive, at a salary of \$100 for the period; chargeable to the part-time help budget of the President's Office.

Upon motion of Regent Jones, seconded by Regent Kleczka, recommendation No. 4 listed under Appointments was adopted.

- Resignations -

1. That the resignation of Parker D. Trask, professor of geology, be accepted, to take effect at the beginning of the academic year 1946-47.
Adopted.

2. That the resignation of Joseph D. Lohman, associate professor of sociology, be accepted, to take effect July 1, 1946.

Upon motion of Regent Kleczka, seconded by Regent Werner, recommendations 1 and 2 listed under Resignations were adopted.

1. That Gladys L. Borchers, associate professor of speech in the College of Letters and Science and the School of Education, be granted leave of absence, without pay, for the academic year 1946-47.
Adopted.

2. That John T. Salter, associate professor of political science, be granted leave of absence, without pay, for the academic year 1946-47.

- (a) \$ 500.00 - Evaporated Milk Association, Chicago, Illinois, for the renewal of an industrial fellowship in the Department of Biochemistry, to study the comparative value of butterfat, during the period July 1, 1946 to July 1, 1947. *Ample* X,
- (b) 1000.00 - Farm Foundation, Chicago, Illinois, for the continuation of a research fellowship in the Department of Agricultural Economics for a study of land tenure in the North Central states, particularly as regards succession of farms, during the period July 1, 1946 to June 30, 1947. *Ample*
- (c) 1000.00 - American Foundation for Pharmaceutical Education, New York, for a fellowship in the School of Pharmacy, for twelve months, beginning July 1, 1946, the fellowship to be known as "Fellow of the American Foundation for Pharmaceutical Education." *Agreement*

Upon motion of Regent Werner, seconded by Regent Callahan, it was
VOTED, That promotions numbered 1 and leaves of absence numbered 1 to 6,
inclusive, listed under Actions by the President, be approved.

The above actions by the President taken since the July 25, 1946, meet-
ing of the Board and approved by the Regents in the foregoing resolutions are made
a part of the records of this meeting.

President Fred presented a recommendation from Dean Middleton and upon
motion of Regent Werner, seconded by Regent Kleczka, it was

VOTED, That the following sentence be included in the Bulletin of the
Medical School and in the General University Catalog relating to admissions to the
Medical School:

"Preference will be given to applicants who have graduated
from Wisconsin secondary schools."

President Fred presented the following recommendation of Dean Fowlkes:

For full service in the summer session, in lieu of money compensation,
there will be allowed to members of the instructional staff, of the rank of
assistant professor or of a higher rank, one semester's leave of absence on
full salary for teaching twelve weeks in summer sessions and a year's leave
of absence on full salary for teaching twenty-four weeks in summer sessions.
Any eligible member of the staff may earn not more than eight-weeks leave
of absence credit in any one eight-week summer session or summer semester.

Upon motion of Regent Kleczka, seconded by Regent Callahan, the recommenda-
tion was adopted.

President Fred presented a recommendation from Dean Middleton that the salary of Dr. Ray Rueckert, assistant physician in the Department of Student Health, be increased from \$3200 to \$4000 per annum, effective July 1, 1946, to correct an error in the budget; increase chargeable to the salary and wage budget of the Medical School. Upon motion of Regent Kleczka, seconded by Regent Jones, the recommendation was adopted.

President Fred reported that the residents of the Monroe and Randall Park Trailer Camps have requested permission to establish a cooperative store to serve veterans attending the University. Upon motion of Regent Campbell, seconded by Regent Werner, the following recommendations of the Director of Residence Halls and of the President were approved:

- (1) That the Board of Regents approve the establishment of the "Mondall Veterans' Cooperative" on University property with the understanding that membership be limited to veteran students and their families.
- (2) That a portion of the building known as the Women's Fieldhouse (already assigned to the trailer projects) be rented to the "Mondall Veterans' Cooperative" as mutually agreed by the representatives of Randall Park, Monroe Park, and the Director of Residence Halls.

Upon recommendation of President Fred, and upon motion of Regent Werner, seconded by Regent Kleczka, it was

VOTED, That approval be given for the establishment of the following additional Army R.O.T.C. units at the University:

- (1) Transportation corps unit
- (2) Military police unit
- (3) Medical corps unit
- (4) Air corps unit.

Upon recommendation of the President, and upon motion of Regent Kleczka, seconded by Regent Jones, it was

VOTED, That the actions of the faculty relating to the degree of Bachelor of Naval Science and as recorded in the extracts from the minutes of the University Faculty meetings held on October 1, 1945, and on August 5, 1946, EXHIBIT A attached, be approved.

Upon recommendation of President Fred, and upon motion of Regent Callahan, seconded by Regent Kleczka, it was

VOTED, That the Director of Business and Finance be authorized to sign an agreement with the Milwaukee Board of School Directors for the use of the shop facilities of the Boys' Technical High School in Milwaukee for the job training of engineering students attending the University Extension Division in Milwaukee.

RECOMMENDATIONS OF THE DIRECTOR OF BUSINESS AND FINANCE

I. Contracts, Leases and Agreements

1. That the Director of Business and Finance be authorized to sign an agreement with the Monsanto Chemical Company to provide for the purchase from the Monsanto Chemical Company of radioactive materials to be used in the Department of Chemistry.

Adopted.

2. That the Director of Business and Finance be authorized to sign an agreement with the Monsanto Chemical Company to provide for the purchase from the Monsanto Chemical Company of radioactive materials to be used in the Department of Biochemistry.

Adopted.

3. That the Director of Business and Finance be authorized to sign a contract, and such other documents as may be required, with the War Department for the use of Air Materiel Command equipment and services by the Department of Mechanical Engineering.

Adopted.

4. That the Director of Business and Finance be authorized to sign a release to the First Central Company terminating the liability of the First Central Company under the lease to The Regents of the University of Wisconsin, now in effect on rooms 415-416, First National Bank West Branch Building, upon occupancy by the Veterans Administration.

Adopted.

Upon motion of Regent Kleczka, seconded by Regent Callahan, recommendations 1 to 4, inclusive, listed under the recommendations of the Director of Business and Finance (I. Contracts, Leases and Agreements) were adopted.

II. Trust Funds

1. That the resolution, which was adopted by the Regents on May 4, 1946, authorizing the buying, selling and transferring of registered bonds and stock or stock rights or interests therein in any corporation be rescinded; and that the following resolution be adopted in lieu thereof:

BE IT RESOLVED, By the Regents of the University of Wisconsin, a body corporate, created by Ch. 36 of the Wisconsin Statutes, that the Secretary of the Regents of the University of Wisconsin, the Trust Officer of the University of Wisconsin, the Director of Business and Finance of the University of Wisconsin, and the Controller of the University of Wisconsin, each be and hereby is authorized and empowered in the name of the Regents of the Univer-

sity of Wisconsin to buy, sell, assign, transfer and set over unto any person, persons or corporation, registered bonds of any description and stock or stock rights or interests therein in any corporation, now or hereafter standing in the name of or held by the Regents either in a corporate capacity or as trustee or as agent; to affix the seal of the Regents to any papers necessary for such purposes, and to designate and direct some person to make the transfer on the books of the Regents when required so to do.

Upon motion of Regent Callahan, seconded by Regent Kleczka, recommendation No. 1 listed under the recommendations of the Director of Business and Finance (II. Trust Funds) was adopted.

Upon motion of Regent Grady, seconded by Regent Jones, it was VOTED, That the Director of Business and Finance be authorized to sign a contract with William V. Kaeser of Madison for preliminary architectural studies for proposed alterations and improvements to the Memorial Union Building, the cost to be charged to funds provided by the Memorial Union Building Committee.

The Director of Business and Finance reported that the special session of the legislature had authorized the payment of an additional cost of living bonus of \$10.00 per month for such classifications of employees receiving base pay of \$200.00 per month, or less, as the need thereof is shown following a survey by the Emergency Board in cooperation with the Bureau of Personnel and the Budget Bureau. He reported the Emergency Board has as yet taken no action.

The Director of Business and Finance distributed copies of the opinion of the Attorney General under date of July 13, 1946, relating to a basic workweek in state service. (Copy of opinion attached.) He also distributed copies of a letter from the Wisconsin State Employees Association dated August 14, 1946, relating to a uniform workweek for civil service personnel. (Copy attached.) Upon motion of Regent Grady, seconded by Regent Jones, it was

VOTED, That the University defer action on a uniform workweek until the committee representing major state departments which is now studying the possibility of a uniform workweek throughout state service has reported its findings.

The Director of Business and Finance reported that bids had been opened on August 14 for the erection and completion of the temporary Quonset huts previously authorized by the Regents and that the revised schedule of costs was \$189,110.86 distributed as follows:

The appropriations previously made available by the Regents total \$129,000. Upon motion of Regent Jones, seconded by Regent Campbell, it was

VOTED, That an additional allotment of \$60,000 be made from unbudgeted 1-E balances and that the Director of Business and Finance be authorized to sign contracts with the low bidders, as follows:

The Director of Business and Finance reported that bids had been opened on August 14 for the construction of the nuclear physics research laboratory addition to Sterling Hall. The revised schedule of costs totals \$70,573, as follows:

He reported that the appropriation previously approved by the Regents was \$50,000. Upon motion of Regent Campbell, seconded by Regent Jones, it was

VOTED, That an additional allotment of \$20,573 be made from unbudgeted balances in 1-E for the construction of the nuclear physics research laboratory and that the Director of Business and Finance be authorized to sign a contract with the Fritz Construction Company, Madison, the low bidder, in the sum of \$61,690. (Copy of bids on file.)

The Director of Business and Finance reported that bids had been opened on August 14 for rebuilding the marquee on the Memorial Union Building. Only one bid, in the sum of \$19,397, was received. This was from George Nelson & Son of Madison. Upon motion of Regent Werner, seconded by Regent Campbell, it was

VOTED, That the Director of Business and Finance be authorized to negotiate with George Nelson & Son and to sign a contract for this work on a cost plus fixed-fee basis with the understanding that the total cost is not to exceed the amount of the bid of \$19,397.

The Director of Business and Finance reported that in accordance with authority from the Regents he has signed contracts for architectural services, as follows:

For the Engineering Building
Foeller, Schober, Berners, Safford and Jahn of Green Bay

For the Milwaukee Extension Building
Gerrit J. DeGelleke of Milwaukee

He also reported that the Governor has approved the contract for architectural services with Law, Law & Potter for the Biology Addition and with Weiler and Strang for the Home Economics Addition.

The Director of Business and Finance reported that in accordance with authority from the Regents he has signed applications to the Civilian Production Administration for permission to construct the following projects:

- (a) Addition to the Van Hise Dormitory -
- (b) Married veterans' apartments.

Secretary Peterson reported the receipt of a communication from Regent Holmes stating that it would be very difficult for him to attend meetings of the Regents on the days of the week specified in the revised by-laws adopted at the special meeting of the Regents on July 25, 1946. Upon motion of Regent Grady, seconded by Regent Kleczka, it was

VOTED, That the action of the Regents on July 25 relating to the time of the regular meetings of the Board be rescinded and that the by-laws be amended to provide that regular meetings shall be held on the Saturday following the second Wednesday in each month, except in the month in which the annual meeting is held, when the regular meeting shall be the date specified in Section 1 of Chapter I for the annual meeting. (Copy of Sections 1 and 2 of Chapter I of the by-laws, as revised, attached.)

Upon motion of Regent Jones, seconded by Regent Kleczka, the following resolution was adopted:

WHEREAS, it is the declared policy of the University of Wisconsin that in furtherance of its much-needed building program it will be necessary to expand into the residential and commercial areas of the city south of University Avenue between Park Street and Breese Terrace, and

WHEREAS, preliminary plans for University use of that area show that more effective use of it could be made if the Milwaukee Railroad switch yards were removed, thereby lessening the amount of noise, smoke, and dirt now existing, and lessening the time of occupation of crossings west of Park Street by train switching movements other than through service, and

WHEREAS, removal of the yards will facilitate the rehabilitation for residential and commercial purposes of the area surrounding the yards and contiguous with the area proposed for University expansion, and

WHEREAS, the proposed University expansion will lead directly to the growth of the population and business activity of the City of Madison, and hence will help to maintain and increase the traffic volume of the Milwaukee Railroad;

NOW, THEREFORE, BE IT RESOLVED that the Regents of the University of Wisconsin join with the officials of the City of Madison and the State of Wisconsin in requesting that the officers of the Milwaukee Railroad take immediate steps to remove the switch yards from their present location in the city.

Upon motion of Regent Jones, seconded by Regent Campbell, the following resolution was adopted:

WHEREAS, it is the declared policy of the University of Wisconsin that in furtherance of its much-needed building program it will be necessary to expand into the residential and commercial areas of the city south of University Avenue between Park Street and Breese Terrace, and

WHEREAS, preliminary plans for University use of that area show that the most effective use of it can be made only if the Illinois Central Railroad tracks now crossing the area are removed, thereby also lessening the amount of noise, smoke, and dirt, and

WHEREAS, street and highway access to the University area as well as to the City of Madison would be facilitated by the removal of the Illinois Central Railroad tracks from their present location in that area and west thereof, and

WHEREAS, studies of comprehensive plans for adequate growth of the City of Madison have led to repeated recommendations by trained engineers and consultants in city planning that Illinois Central Railroad trains be re-routed into the city over the tracks of the Lancaster branch of the Chicago and Northwestern Railway;

NOW, THEREFORE, BE IT RESOLVED that the Regents of the University of Wisconsin request that the officers of the Illinois Central Railroad plan for the early removal of the tracks of that railroad between Summit Station and Park Street in the City of Madison, and

FURTHERMORE that the officials of the City of Madison be invited to join with the University in making this request.

At 11 A.M. the Regents went into executive session.

At 11:20 A.M. the Regents arose from executive session.

Regent Jones presented the report of the Constructional Development Committee. Upon motion of Regent Jones, seconded by Regent Callahan, it was VOTED, That the plans for the construction of the married veterans' apartment buildings be postponed for the present on account of the fact that final construction estimates are in excess of budget allocations and the construction of these apartments at this time would require the allotment of an unwarranted sum from the postwar construction appropriation made available by the State. Regent Werner voted "No".

Upon motion of Regent Jones, seconded by Regent Kleczka, it was VOTED, That the Wisconsin University Building Corporation be authorized to proceed with the construction of the west addition of the Van Hise dormitory on the basis of the tentative estimates presented by the George A. Fuller Company on August 8, 1946, and that the Wisconsin University Building Corporation be authorized to award a contract for the construction of this project to the George A. Fuller Company on a cost plus fixed-fee basis. The estimated construction cost is \$554,843. The fixed fee is \$27,742. The total estimated cost of the project, including utilities, landscaping, furniture, architect's fees, supervision, etc., is \$700,000. It is understood that the administrative officers are authorized to agree to such revisions in the tentative estimated costs as are necessary.

Upon motion of Regent Jones, seconded by Regent Kleczka, it was VOTED, That the State Bureau of Engineering be requested to complete at once the plans and specifications for the Short Course Dormitory, and that the Director of Business and Finance be directed to advertise for bids at the earliest opportunity on alternate bases as follows: (a) Lump sum contract, and (b) cost of labor and material plus a fixed fee with an upset price and with provision for the distribution of savings in costs below the upset price between the contractor and the University.

Regent Jones reported that at the request of President Sensenbrenner he had attended, together with representatives of the city, state and University officials, a conference in Chicago on August 12, 1946, relating to the proposed elimination of the grade crossing of the Milwaukee Road at West Washington Avenue and to the removal of the switch yards from the City of Madison.

At 11:30 A.M. the meeting adjourned.

Extract from the Regular University Faculty Meeting held on October 1, 1945

"Professor L. F. Van Hagan, for the Faculty of the College of Engineering, moved approval of the following recommendation:

That the degree of Bachelor of Naval Science be conferred upon a Naval ROTC student when he has completed 136 credits with not less than 136 grade-points and when included within these credits are the 36 credits in Naval Science required by the Navy and such credits in fundamental engineering subjects as may be stipulated by the professional engineering department in which he majors.

Professor Van Hagan stated that a detailed curriculum could not be presented at this time, but that it will be presented to the Faculty at a later meeting. The motion for approval was carried."

Extract from the Minutes of the Special University Faculty Meeting held on August 5, 1946.

"On a motion by Dean Ruedisili, the Faculty approved the following recommendations of the Faculty of the College of Letters and Science:

- a. That the faculty approve in principle the establishment of a degree of Bachelor of Naval Science or a major in naval science under a Bachelor of Science degree.
- b. That while the full curriculum leading to this degree is being worked out, a candidate for this degree be allowed to register for three credits of naval science in each semester of 1946-47.

Dean Rundell moved the approval of the establishment of the Bachelor of Naval Science degree in the School of Commerce. The motion carried.

Dean Kivlin moved that the College of Agriculture establish the degree of Bachelor of Naval Science, and that the curriculum submitted in Document 767 (attached) be approved. The motion carried."

CURRICULUM LEADING TO THE DEGREE OF NAVAL SCIENCE
FOR STUDENTS IN AGRICULTURE

The Faculty of the College of Agriculture presents the following:

That the College of Agriculture establish the degree of Bachelor of Naval Science for those students who wish to take the prescribed curriculum as set up by the Naval Science Department. The suggested curriculum is recommended below, and does not give the degree of Bachelor of Science in Agriculture, but does permit a student to obtain an agricultural background with the Naval Science degree. The major included in the suggested curriculum would be Naval Science, and all of the other requirements of the College of Agriculture would be met. Students will be required to present 124 credits and 124 grade points for this degree.

Dear Mr. Opstedal:

You have submitted a list of inquiries with reference to the standard workweek and allowances of pay for overtime in the state service. Before taking up your questions in detail, your attention is directed to the following statutes and joint resolution which bear on your problems.

Sec. 14.59 provides as follows:

"The offices of the departments of state government shall be kept open on all days of the year, except Sundays and holidays, and office hours shall begin at eight-thirty o'clock A.M. and close at five o'clock P.M. with intermissions from twelve o'clock M. to one-thirty o'clock P.M. except Saturday afternoons when such hours may be observed as the heads of departments may think proper. During the summer months from May first to October first, departments may, in the discretion of the governor begin office hours at eight o'clock A.M. and close at four o'clock P.M. with intermissions of twelve o'clock M. to one o'clock P.M. Heads of departments shall grant to each clerk or other person in their employ, noncumulative leave of absence without loss of pay at the rate of three weeks for a full year's service."

Sec. 16.105 (1) provides in part as follows:

"The director, with advice and approval of the personnel board, shall ascertain and record the duties and responsibilities of, and establish grades and classes for, all positions to which this chapter applies. Each class shall include positions requiring duties which are substantially similar in respect to the authority, responsibility, and character of the work required in the performance thereof and shall be designated by a title indicative of such duties. Each class shall be so defined that the same requirements as to education, experience, capacity, knowledge and skill are demanded of incumbents for the proper performance of their duties, that the same tests of fitness may be used in choosing qualified appointees; and that the same schedule of pay can be made to apply with equity under like working conditions. . . ."

Joint resolution #47, 1937 legislature, provides as follows:

"Resolved by the Senate, the Assembly concurring, That it shall be the policy of the state of Wisconsin that the basis of employment in offices, departments and institutions of the state shall be a seven hour day and a five and one-half day week except where the duties are of a continuing nature and a shift arrangement on an eight hour basis is necessary and except in emergencies; that in the event of emergency overtime work, it shall be the policy of the state that employees be entitled to compensatory time off."

July 13, 1946

Sec. 103.47, enacted in 1929, provides as follows:

"The state department of public welfare shall make a study of the hours of labor in the state charitable and penal institutions and of the feasibility of placing the employes of these institutions on the eight-hour day basis, and the said board is authorized to put the eight-hour day into effect for guards at the state prison and the state reformatory as soon as it shall be practicable and the necessary funds shall be available."

Laws 1929, Ch. 447, which created the above statute, required the board of control to report to the 1931 legislature as to the results of its study and the action taken thereunder. We understand that, except on the farms, the eight-hour day is in force at all the institutions.

Your first question is as follows:

"Does Section 14.59 set a pattern which the bureau in performing its duty under Section 16.105 must recognize as the minimum (basic?) length workweek?"

It is clear from the foregoing statutes and joint resolution that it is the legislative intent that the basic workweek shall be five and one-half 7-hour days as prescribed in Sec. 14.59 except in penal and charitable institutions where an eight-hour day is the standard.

Your second question is as follows:

"Are the departments and agencies housed outside the capitol and office building at liberty to disregard Section 14.59 and to fix the length of the workweek to suit their own budget and administrative convenience?"

Sec. 14.59 is not limited to departments and agencies housed in the capitol and office building. However, it applies only to "offices" and "office hours", not to other forms of state service.

Your third question is as follows:

"Is it the bureau of personnel's responsibility to specify the length of the workweek, beyond which required employment becomes compensable overtime?"

The answer to this question is "No". The length of the workweek is specified in the Statutes, the 1937 joint resolution and by regulations of the state department of public welfare with reference to penal and charitable institutions. The joint resolution above quoted indicates the legislative intent that in the event of emergency overtime work the employes are to be given compensatory time off rather than overtime pay. But where a longer workweek is the rule and cannot be compensated by time off, that may be taken into consideration by the bureau in classifying the position and fixing the compensation, under Sec. 16.105 (1).

Your fourth question is as follows:

"Is it your opinion that legislation is desirable if not absolutely necessary to clarify the question of length of workweek?"

In view of the fact that the joint resolution of 1937 does not have the force and effect of law, but is merely advisory, it might be desirable that additional legislation be enacted to clarify this question.

Your fifth question is as follows:

"Is it a correct conclusion to say the departments housed in the capitol and office building must maintain office hours on Saturday mornings for all their employes or could the required hours be crowded in on five days and only a skeleton staff retained for such mornings?"

In view of the above-quoted joint resolution, it appears to be the legislative intent that the employes all work during the hours prescribed by Sec. 14.59, rather than having some put in five 8-hour days while others work five and one-half 7-hour days. Moreover, in order that persons having business with state agencies may be properly served, all personnel should be on duty during the hours prescribed by law unless on leave of absence.

CAPTION:

Basic workweek in state service is five and one-half 7-hour days except in penal and charitable institutions where an 8-hour day is the standard, under Secs. 14.59 and 103.47, Stats. and 1937 Joint Resolution No. 47. Sec. 14.59 is limited to state "offices" but is not limited to the capitol and state office building. The bureau of personnel is not responsible for fixing hours of work in state service, but may adjust pay schedules where longer hours are required. Overtime work is to be compensated by time off if possible. Under Sec. 14.59 all employes except those on leave must observe the office hours therein specified and it would not be proper to permit some to work five 8-hour days and maintain skeleton staffs Saturday mornings.

Dear Mr. Peterson:

Thank you for your letter of July 26 setting forth the position of the Regents of the University of Wisconsin on emergency salary increases and the uniform work week for civil service personnel.

It is our hope the Regents will give further consideration to these problems at their August 15 meeting.

In this connection we want to call to your attention the need for early and definite action on the uniform work week. The delay in securing a report from the State Director of Personnel's Committee, which has been studying the shorter work week, should not operate to postpone the establishment of a university policy on this matter.

In discussing the work week with the Director of Personnel we were informed that the Bureau of Personnel has no responsibility for setting the working schedules of the various state departments. His position is supported by the opinion of the Attorney General under date of July 13, 1946. Under the circumstances it appears the Regents of the University of Wisconsin have ample authority to establish a shorter uniform work week for civil service personnel within the provisions and intent of existing statutes and resolutions of the legislature relating to working hours.

It becomes increasingly difficult to build and maintain staff morale when weekly working schedules are 38½, 40, 42, 44, and 48 hours. The situation becomes clearly unfair when such discrimination exists among employees within identical job classifications.

We are prepared to discuss this matter further with you or the Regents at your convenience.
