# USE OF UNIVERSITY GROUNDS FOR ATHLETICS

was discussed:

April 21, 1924

The Committee appointed by President Birge to consider the use of the University grounds for athletics, especially with reference to the development of intramural athletics, submits the following recommendations:

Indus Fellow

- 1. That the part of Camp Randall south of Johnson Street (extended) be set aside and adapted for athletics.
- 2. That the Athletic Hall be located on Camp Randall.

(The committee emphasizes the importance of carrying out this project at the earliest possible date, because of the increased income it will immediately produce for future development.)

3. That, whereas an additional area of at least ten acres of level land is immediately needed for intramural athletic fields, the twenty-seven acres of the Isom Farm immediately west of the present holdings of the University and east of the College Hills Drive be purchased for the use of the College of Agriculture, and that the flat land (approximately 10 acres) north of the Linden Mall and east of the White Elm Drive be transferred to the Athletic Department for intramural athletics.

(The acquisition of the Isom Property will make possible readjustments on the part of the Department of Agriculture necessitated by its release of the ground adjacent to Linden Drive, in addition to that previously suggested as a site for the Forest Products Laboratory).
