SPECIAL MEETING OF THE BOARD OF REGENTS

University Club, Milwaukee, Wisconsin

Saturday, September 15, 1945, 9 A.M.

Called to consider appointments and such other matters
as may be properly presented

PRESENT: Regents Callahan, Campbell, Cleary, Grady, Jones, Kleczka, Sensenbrenner,
Werner

ABSENT: Regents Hodgkins, Holmes

Communications were received from Regents Hodgkins and Holmes in explanation of their absence.

Upon motion of Regent Cleary, seconded by Regent Campbell, it was VOTED, That the minutes of the special meeting of the Board held on August 11, 1945, be approved as sent out to the Regents and that the minutes of the Executive Committee meeting held on August 31, 1945, be approved, ratified, and confirmed.

RECOMMENDATIONS OF THE PRESIDENT

- Letters and Science -

1. That Stephen C. Kleene be appointed associate professor of mathematics for the second semester of 1945-46; salary \$2,250 for the semester; charge to item for professor, p. 39.

Adopted.

2. That the salary of John W. Williams, professor of chemistry, be redistributed for the period September 17 through October 31, 1945, as follows: \$541.66 to be charged to 15B 300, and \$541.66 to Chemistry, Letters and Science.

Adopted.

3. That James S. Earley, associate professor of economics, be granted leave of absence, without pay, from September 17 to September 30, 1945.

Adopted.

4. That the appointment of Harold R. Wolfe, associate professor of zoology, for the first semester of 1945-46 be transferred to the Graduate School, research.

Adopted.

Upon motion of Regent Callahan, seconded by Regent Werner, recommendations No. 1 to 4, inclusive, listed under Letters and Science, were adopted.

- Business and Finance -

1. That \$1,500 be transferred from Regents' Unassigned to the budget of the Personnel Council, Veterans testing office, for the payment of rent of space in the First National Bank Building.

Upon motion of Regent Grady, seconded by Regent Campbell, recommendation No. 1 listed under Business and Finance was adopted.

- Research -

1. That Michael W. Klein be appointed associate professor of chemistry for the period, September 1 to 16, 1945; salary \$200 for the period; charge to 15B 359. Adopted.

2. That Robert L. Reynolds, professor of history, be released from his special summer research appointment, to take effect July 31, 1945. Adopted.

Upon motion of Regent Cleary, seconded by Regent Callahan, recommendations No. 1 and 2 listed under Research were adopted.

- Gifts and Grants -

1. That the following gifts and grants be approved:

- (a) \$1,600 - Wilson & Co., Inc., Chicago, for the renewal of an industrial fellowship in biochemistry to study the effects of processing upon the nutritive value of meat and meat by-products for a 12 month period, beginning September 1, 1945; and that the Director of Business and Finance be authorized to sign the agreement.
- (b) 425 - The Pure Milk Association, Chicago, five scholarships of \$75 each and one scholarship of \$50 for students in the Farm Short Course for 1945-46, the scholarships to be known as "The Pure Milk Association Dairy Farmer Scholarships"; and that the Director of Business and Finance be authorized to sign the agreement. *Ch. file*
- (c) 1,000 - Winthrop Chemical Co., Inc., ^{33 Riverside Pl.} Rensselaer, N. Y., for a fellowship grant for the academic year 1945-46, to support a fellow working in the field of organic chemistry.
- (d) 850 - Watumull Foundation, Los Angeles, ^{927 Malibu Ave} California, to cover the first installment on the Watumull Foundation Scholarship in biochemistry for the academic year 1945-46, the second installment to be forthcoming about the first of the year.
- (e) 1,000 - Sylvania Electric Products, Inc., New York, for the renewal of an industrial fellowship in the Department of Physics for twelve months, beginning October 1, 1945, to study gaseous discharges under high frequency and microwave excitation; and that the Director of Business and Finance be authorized to sign the agreement.

Adopted.

2. That authority be granted to accept contributions for the purpose of erecting a building or buildings at Upham Woods; the fund to be designated "Upham Woods 4-H Building Fund".
Adopted.

Upon motion of Regent Cleary, seconded by Regent Kleczka, recommendations No. 1 (a to e) and 2 listed under Gifts and Grants were adopted.

Upon motion of Regent Grady, seconded by Regent Callahan, it was VOTED, That resignations numbered 1 to 36, inclusive, listed under Actions by the President, be approved.

Upon motion of Regent Werner, seconded by Regent Cleary, it was VOTED, That appointments numbered 1 to 108, inclusive, listed under Actions by the President, be approved.

Upon motion of Regent Kleczka, seconded by Regent Campbell, it was VOTED, That salary and service adjustments numbered 1 to 31, inclusive, listed under Actions by the President, be approved.

Upon motion of Regent Grady, seconded by Regent Kleczka, it was VOTED, That leaves of absence numbered 1 to 6, inclusive, listed under Actions by the President, be approved.

The above actions of the President taken since the August 11, 1945, meeting of the Board and approved by the Regents in the foregoing resolutions are made a part of the records of this meeting.

President Fred reported that the Navy has cancelled its V-12 medical training program at the University of Wisconsin as of February 9, 1946, that the Naval Reserve Officers Training program will start at the University November 1, 1945, and that the Navy V-12 engineering training will be included in that program.

The Director of Business and Finance reported that in accordance with Regent authorization he has signed a contract with the Veterans Administration for testing and counselling of veterans.

President Fred made a verbal report of the policy being followed relative to members of the faculty returning from leave.

President Fred reported that the Legislature has passed Bill No. 148A relative to University Extension fees over the Governor's veto.

Upon motion of Regent Jones, seconded by Regent Kleczka, it was VOTED, That it is the sense of this Board that a uniform plan of fee charges be established for undergraduate students enrolled in the University at Madison and in University Extension class centers in the state.

Upon motion of Regent Kleczka, seconded by Regent Werner, it was VOTED, That the regulation permitting an adult to audit one course per semester upon payment of \$2.50 per credit be eliminated and this item removed from the University bulletin.

Upon motion of Regent Grady, seconded by Regent Kleczka, it was VOTED, That with the consent of the appropriate dean or director students may enroll in the University at Madison or in Extension class programs on payment of fees as follows:

- (a) Residents of Wisconsin:
Six dollars per credit or the equivalent in non-credit courses up to a maximum of \$48 per semester
- (b) Nonresidents of Wisconsin:
Eighteen dollars per credit or the equivalent in non-credit courses up to a maximum of \$148 per semester

The above fees shall include laboratory and library fees, but all registrations on a unit or per credit basis exclude Memorial Union and Student Infirmary privileges.

The above schedule of fees shall become effective with the beginning of the academic year which opens in September 1945.

Upon motion of Regent Cleary, seconded by Regent Callahan, it was VOTED, That the schedule of fines for late registration published in the catalog apply to registrations in the day school of the Extension Division and that a fine of \$1.00 be charged in the evening class programs of the Extension Division for registration after the first two weeks of classes.

The University administration was authorized to establish an equitable schedule of refunds and to report at the next meeting of the Regents.

The Director of Business and Finance reported that the Attorney General has ruled that the Regents may lease classroom and office space in Milwaukee for the University Extension Division and that the Governor has approved the lease of space in the Mariner Tower Building.

The Director of Business and Finance reported that the Legislature has adopted a Joint Resolution authorizing the acceptance of Bankhead-Flannagan funds.

The Director of Business and Finance reported that Volmer H. Sorensen has been assigned temporarily to veterans' counselling work and released from services which he was to render to the Department of Public Service.

The Director of Business and Finance reported that a request had been received from the Army Air Forces for preliminary information re a reserve officers training corps and that the Administration has furnished the data requested.

Upon motion of Regent Grady, seconded by Regent Kleczka, it was VOTED, That at the request of the Veterans Administration the Attorney General be asked for an opinion regarding the legality of charging the nonresident fee for Wisconsin veterans enrolled under the provisions of Public Law No. 346.

The Director of Business and Finance brought up the matter of the sale of farm land to the City of Madison. Upon motion of Regent Grady, seconded by Regent Cleary, it was

VOTED, That this question be referred to the Campus Planning Commission, the University Administration, and the Constructional Development Committee for report to the next meeting of the Regents.

President Fred reported upon the efforts that are being made to secure a dean for the Law School.

Upon recommendation of President Fred, and upon motion of Regent Kleczka, seconded by Regent Cleary, it was

VOTED, That Ira L. Baldwin be appointed Dean of the College of Agriculture and Director of the Agricultural Experiment Station, with cash salary of \$10,000 per annum, effective at once. His cash salary shall be \$9,000 per annum when he occupies the Dean's residence on the campus.

Upon recommendation of President Fred, and upon motion of Regent Werner, seconded by Regent Cleary, it was

VOTED, That the salary of Vincent E. Kivlin, Associate Dean of the College of Agriculture, be increased from \$5,500 to \$6,000 for the academic year, effective with the beginning of the academic year 1945-46.

The Director of Business and Finance reported that there was a request from the Veterans Administration to lease space in the Wisconsin General Hospital and that the Attorney General had advised informally that the Regents are without authority to enter into such arrangements.

Regent Cleary made verbal report with reference to the matter of acquiring the Nakoma Country Club property for the Arboretum and the Departments of Physical Education.

President Fred read a letter of appreciation from Brigadier General Brehon Somervell. (Copy attached)

Upon recommendation of President Fred, and upon motion of Regent Werner, seconded by Regent Cleary, it was

VOTED, That Howard J. McMurray be appointed lecturer in the Department of Political Science for the academic year 1945-46, at a salary of \$4,500.

Called vote was taken. Regents voting "Aye": Callahan, Cleary, Grady, Jones, Sensenbrenner, Werner. Regents voting "No": Campbell, Kleczka. Motion carried.

The Director of Business and Finance reported that the Governor has approved the purchase of the Backus forty acres, the Lillian Oscar ten acres, and the Rieder Farm.

Regent Kleczka discussed the matter of construction in Milwaukee for the University Extension Division, suggesting that part of the postwar construction appropriation be used for an addition to the Milwaukee Center. It was agreed that the Constructional Development Committee will meet at the Milwaukee Center at 10:30 A.M., September 28, 1945, to visit the site.

The meeting adjourned at 2:15 P.M.
