RECOMMENDATIONS OF THE PRESIDENT

- Resignations -
- 1. That the resignation of Elmer L. Sevringhaus, professor of medicine, be accepted to take effect March 1, 1946.

 Adopted.
 - Termination of Leaves of Absence -
- 1. That the leave of absence for military duty granted to William J. Bleckwenn, professor of neuropsychiatry, be terminated; that he return to active service beginning March 1, 1946; salary \$6,000 per annum, 12 months' basis; charge to salaries.

- Salary and Service Adjustments -
- 1. That R. Ralph Benedict, associate professor of electrical engineering, be paid an additional \$130.63 for $52\frac{1}{4}$ hours of work during the period November 9, 1945 to February 13, 1946 for testing equipment in the electrical standards laboratory. Adopted.
 - Gifts and Grants -
- 1. That the following gifts and grants be accepted:
- (a) \$ 500 Fritzsche Brothers, Inc., New York, for the reestablishment of the Fritzsche Brothers fellowship in the School of Pharmacy for the academic year 1946-47.
- (b) 200 American Foundation for Pharmaceutical Education for scholarships for the academic year 1946-47 for capable students in the School of Pharmacy who need financial help and encouragement.
- (c) 9,000 Western Condensing Company, Appleton, Wisconsin, for the establishment of an industrial fellowship in the Departments of Agricultural Bacteriology, Biochemistry, Poultry Husbandry and Veterinary Science for the period June 1, 1946 to May 31, 1947, to study the use in poultry nutrition of whey, whey fractions and products arising from the fermentation of whey; and that the Director of Business and Finance be authorized to sign the agreement.

- (d) \$ 50 for the establishment of an annual scholarship, the scholarship to be known as the Villa Maria and to be awarded to a sophomore or junior woman who has been in residence at the Villa Maria for at least one year; and that the Director of Business and Finance be authorized to sign the agreement.
- (e) 750 for ten \$75-scholarships for the 1946 summer (8 weeks) session, from the Encyclopedia Britannica Films, Inc., in the Department of Education.

Special adjustment of all civil service employees of one step on April 1,
1946, and increase of minimum and maximum salaries of one step April 1,
1946, and that the Emergency Board be requested to increase the per diem
rate for the hospital to cover the increased cost of salaries for
hospital employees.

Upon motion, it was VOTED, That the following recommendation of the Finance Committee be approved: That the administration be authorized to proceed with plans for the construction of not more than forty houses for faculty occupancy at a cost of not to exceed \$7500 per unit.

Upon motion, it was VOTED, That the following recommendation of the Finance Committee be approved: That the present student wage schedule of 45¢ per hour be changed to a minimum of 50¢ per hour, and that the maximum student wage be 75¢ per hour.

Bureau, Supplies and Expense, be approved.

Upon recommendation of the Finance Committee, it was VOTED, That an appropriation of not to exceed \$225 per month be made from Fund 1-E Regents' Unassigned for social and educational activities at Badger Ordnance Works.

approved: That the Director of Business and Finance be authorized to make application to the Federal Public Housing Authority for federal funds to aid in paying the cost of converting Government buildings at the Badger Ordnance Works and at Truax
Field into family housing units and quarters for single students.

Upon recommendation of the Finance Committee, it was VOTED, That the following appropriations requested by Professor Withey for the College of Engineering be approved: Supplies and Expense \$2000, charge to Regents' Unassigned 1-E; Equipment \$5000, charge to 20.41(1)(G).

Upon recommendation of the Finance Committee, it was VOTED, That \$250 be allotted from Regents' Unassigned 1-E to Supplies and Expense, Naval R.O.T.C.

Upon motion, it was VOTED, That authority be granted to purchase, for the sum of \$35,000, from W. R. Mandt and Helen Mandt, his wife, $154\frac{1}{2}$ acres of land, more or less, described as follows:

West $\frac{1}{2}$ of Northeast $\frac{1}{4}$ of Section 27, except $5\frac{1}{2}$ acres thereof described as follows: Commencing in center of road on East line of West $\frac{1}{2}$ of Northeast $\frac{1}{4}$ of said Section 27 at a point 20 rods South of Northeast corner of said 80 acres; thence West 8 rods; thence South 10 rods; thence West 12 rods; thence South 40 rods; thence East 20 rods: thence North 50 rods to the place of beginning.
