At 12:15 p.m., it was moved by Regent Schenian and seconded by Regent Hanson that the Board of Regents recess into closed session to consider employment matters, as permitted by s. 19.85(1)(c), Wis. Stats.

The motion was unanimously carried on a roll call vote, with Regents Clusen, Finlayson, Fish, Grover, Hanson, Hassett, Knowles, Lyon, Nikolay, Schenian, Schilling, Vattendahl and Weinstein voting "Aye" (13) and no regents voting "No."

In closed session, the board considered appointment of a chancellor for UW-Superior.

Regent President Weinstein directed that the minutes show it was suggested that the resume of each candidate interviewed by the Regent Selection Committee should have been distributed to all regents.

The following resolution was adopted on a roll call vote, with Regents Clusen, Finlayson, Fish, Hanson, Hassett, Knowles, Lyon, Nikolay, Schenian, Schilling, Vattendahl and Weinstein voting "Aye" (12). Regent Grover left the teleconference before the vote was taken.

Resolution 3776:

That, upon the recommendation of the President of the University of Wisconsin System and the Regent Selection Committee, Dr. Ralph R. Doty be appointed Chancellor of the University of Wisconsin-Superior, effective August 15, 1987, at an annual salary of \$75,000.

The board arose from closed session at 12:40 p.m., at which time the meeting was adjourned, upon motion by Regent Nikolay, seconded by Regent Schenian.
