### ANNUAL MEETING OF THE BOARD OF REGENTS

Madison, Wisconsin

Friday and Saturday, June 16-17, 1939.

The meeting convened at 10 A.M. on June 16, President Wilkie presiding

PRESENT: President Dykstra; Regents Backus, Baker, Brown, Callahan, Campbell,

Combs, Gates, Glover, Hones, Kelly, Miller, Wilkie.

ABSENT: Regents Christopherson, Mead, Richards.

Regent Christopherson could not attend the meeting on June 16th but was present on Saturday morning, June 17th, the second day of the meeting. A telegram was received from Regent Mead from Chicago regretting that he could not come to the meeting.

Upon motion of Regent Callahan, seconded by Regent Gates, it was VOTED, That the minutes of the last meeting of the Board held on April 25, 1939, be approved as sent out to the Regents.

Upon motion of Regent Gates, seconded by Regent Callahan, it was VOTED, That the election of officers for the ensuing year be made a special order for 10 A.M. tomorrow.

The President read a communication from an ex-student with a donation equivalent to the amount of his out-of-state fees, \$310, who signed his letter "A Wisconsin Dividender".

### RECOMMENDATIONS OF THE PRESIDENT

### - Administration and General -

1. That degrees be granted, fellows and scholars appointed, and prizes awarded as shown in the Commencement Register, EXHIBIT A, enclosed.

Upon motion of Regent Kelly, seconded by Regent Glover, adopted.

2. That the following action of the Faculty be approved:

# Rule governing fraternities -

"No freshman shall lodge in a fraternity house in his first semester in this University. (See Rushing Regulations of Interfraternity Executive Board below, for exceptions:)"

- (1) Freshmen and transfers in their first semester here may accept invitation to live in a fraternity house provided that the active members of the chapter concerned shall have achieved a scholastic average of 1.3 for the preceding semester. (Further provisions are indicated in the 1938 rushing regulations.)
- (2) The number of freshmen or transfers accommodated in any fraternity house during the preferential rushing period shall not exceed 25 per cent of the capacity of the house as rated by the Dean of Men after his annual inspection, except that at least five shall be permitted in any house having the required minimum average.

Upon motion of Regent Glover, seconded by Regent Callahan, adopted.

3. That the amended constitution of the Wisconsin Union as shown in EXHIBIT B, attached, be approved.

Upon motion of Regent Kelly, seconded by Regent Callahan, adopted.

- 4. That the following actions of the Faculty be approved:
  - a. Entrance requirements.

That entrance requirements relating to the admission of graduates from Senior high schools be revised as follows: Add to the entrance requirements for the senior-high school the following alternative (insert before Section 4, b, page 36 of 1938-39 Catalog):

Or they may combine a unit or units from the last year of junior-high school with a unit or units from the senior-high school and satisfy the major and minor requirements of the four-year high school instead of meeting the requirements of the senior-high school. (EXHIBIT C attached.)

# b. Degree in Library Science.

The recommendation of the Faculty of the College of Letters and Science for the granting of a degree in Library Science as follows:

Upon completion of thirty credits and thirty grade points, including at least 26 credits and 26 grade points in Library School courses, those students entering the Library School under the new requirements effective September 1939 and thereafter, and those members of the class of 1938-39 who qualified for entrance under the new requirements, will be awarded the degree of Bachelor of Library Science.

# c. Mechanical and Electrical Engineering - course requirements:

The recommendations of the Faculty of the College of Engineering, as follows:

- (1) That the requirement of not less than six weeks of industrial practice for graduation in the Mechanical Engineering Course be abolished.
- (2) That the requirement of six weeks of summer engineering experience for graduation in the Electrical Engineering Course be abolished.

# d. School of Education - new course.

The recommendation of the Faculty of the School of Education for a new four-year course leading to the degree of Bachelor of Science (Applied Art) to be given in the School of Education until such time as it may be more appropriately assigned to some other school, college or division. (EXHIBIT D attached.)

Upon motion of Regent Callahan, seconded by Regent Glover, adopted.

5. That the Board of Trustees of the University Cooperative Company be enlarged from five to seven members, three of whom shall be students of the University to be selected by the Student Board or any organization of students which may in the future take the place of the Student Board.

Upon motion of Regent Glover, seconded by Regent Kelly, adopted.

- Gifts - 13911. La Salle - Olm n. Jones.

1. That the gift of Arthur Andersen and Company for the establishment of two scholarships of \$250 each for one year of graduate work in accountancy or economics be accepted. (The holders of the scholarships to be exempt from non-resident fees and the 10% laboratory deduction not to apply.)

Adopted.

2. That the gift of \$400 from the Wisconsin Home Economics Alumnae Association for the establishment of the Hazel Manning Student Loan Fund be accepted under the following conditions:

"Recommendations for loans to students shall be made by the Dean of the College of Agriculture.

"These loans shall be made to any deserving students in the junior and senior years in Home Economics courses.

"Loans to students shall bear no interest if paid on date due; notes renewed must bear 6% interest annually."

Adopted.

- 3. That the \$25 contribution from the Wisconsin Alumni Club of Marshfield be accepted and credited to the graduating class loan fund.

  Adopted.
- 4. That the gift of \$8,000 from Thomas E. Brittingham, Jr., for the appointment of a professor of music for two years be accepted.

  Adopted.
- 5. That the Comptroller be authorized to accept the remittance of \$100 from the Wisconsin Alumnae Club of Minneapolis to establish a student loan fund and that in accordance with the wishes of the donor, the money be used to aid needy worthy women students, the loans to be made free of interest for one year and to carry an interest charge of 5 per cent after one year.

  Adopted.
- 6. That the gift of \$385 from Marguerite Davis for researches in botany by Norman C. Fassett be accepted. Research budget. (No public announcement to be made.)

  Adopted.
- 7. That the grant of \$2,640 from the Rockefeller Foundation to aid in financing exploratory studies of Wisconsin individual income tax data for 1929-1936 under the supervision of a University committee, Harold M. Groves, chairman, be accepted.

  Adopted.

Upon motion of Regent Hones, seconded by Regent Gates, recommendations 1 to 7 under Gifts were adopted.

### - Dean of Men -

1. That Willard W. Blaesser be appointed assistant Dean of Men half-time and Secretary for and Co-Worker with the Volunteer Personnel Council half-time for the year 1939-40; salary \$2400 per annum, 10 months' basis; charge to the budget of the Dean of Men.

## - Comptroller -

1. That the Comptroller and the Superintendent of Buildings and Grounds be authorized to sign an application to the Works Progress Administration for the quarrying of stone for the development of the west side of the Stadium and for the University Boat House, the estimated cash outlay for which will be \$400 chargeable to the 5-C Athletic Council revolving fund. (Confirming verbal approval by the Executive Committee.)

- 1. That Gaylord I. Mullendore be reappointed county agricultural agent for Door County, beginning July 1, 1939; salary at the rate of \$2800 per annum; 12 months' basis, to be distributed as follows: University \$1700, County \$1100; charge to item for Mullendore, funds 3AE and 15AE.

- 2. That Harvey J. Weavers be reappointed county agricultural agent for Manitowoc County (rank of assistant professor), beginning July 1, 1939; salary at the rate of \$3,000 per annum, 12 months' basis, to be distributed as follows: University \$1800, County \$1200; charge \$700 to fund 3A, \$1100 to fund 15A. Adopted.

that the Central Unit of the new men's dormitories be named Theodore Kronshage Hall; that the refectory for Tripp and Adams Halls be named Van Hise Hall and the name of Van Hise House be changed to Winslow House; and that the reception room on the second floor of the new women's dormitory be called the Rose Schuster Taylor Room.

Upon motion of Regent Gates, seconded by Regent Kelly, adopted.

Regent Brown referred to a criticism which he had heard of the men's dormitories. Upon motion of Regent Gates, seconded by Regent Brown, it was VOTED, That this matter be referred to the Committee on Student Life and General Welfare with a request to visit the dormitories and report to the Board.

Upon motion of Regent Gates, seconded by Regent Callahan, it was VOTED, That the President's report, dated June 2, 1939, on the salary schedule presented by Regent Gates on April 25, 1939, together with the original resolution, be referred to the Educational Committee.

The matter of the distribution of <u>handbills</u> on the campus was brought up. Melvin Tumin appeared before the Board and presented a suggested plan, which was accepted for consideration. (See later action)

Upon motion, the meeting adjourned at 11:55 A.M. to 2:30 P.M.

# At 2:30 P.M. the Regents reconvened.

Upon motion of Regent Kelly, seconded by Regent Gates, it was VOTED, That the action taken at the morning session making the election of officers a special order for 10 A.M., Saturday. be rescinded.

Upon motion of Regent Brown, seconded by Regent Glover, it was VOTED. That the Regents now proceed to the

### ELECTION OF OFFICERS.

Upon motion of Regent Brown, seconded by Regent Glover, it was VOTED, That the rules be suspended and that the present officers be elected for the ensuing year. The motion was unanimously carried and

were declared elected.

Upon recommendation of the President, and upon motion of Regent Callahan, seconded by Regent Gates, it was

VOTED, That the President and Comptroller be authorized to make the necessary transfers and adjustments in the 1938-39 budget to complete the business of the University for the year.

President Dykstra presented a communication from Richard L. Guiterman, Executive Editor of the <u>Daily Cardinal</u>, requesting that a yearly subscription of \$1.50 be included in the University fees starting with the school term, September, 1939 to June, 1940. Upon motion of Regent Gates, seconded by Regent Hones, it was VOTED, That the matter be referred to the Business Committee to consider and report to the Board.

The President brought up the matter of the development of <u>University</u>

<u>Pay</u> and referred to objections made by men in the science departments and stated he had two letters with reference to the matter. Action was postponed.

Reference was made to the communication from Edward I. Crowley concerning dormitories. Upon motion of Regent Kelly, seconded by Regent Gates, it was VOTED, That the report made by President Dykstra under date of June 1, 1939, be approved. (Copy of report on file.)

Regent Backus brought up the matter of Bill No. 123, A, with reference to the <u>taxation</u> of agricultural lands held by the University of Wisconsin, under trust, and advised that this bill had passed the Assembly and that hearing in the Senate was postponed for two weeks in order that he might appear before the Senate

Committee in opposition to the bill. He also stated that he had a communication from Senator Young asking if he could appear on Wednesday, June 21, 1939, at 2 P.M.

Upon motion of Regent Hones, seconded by Regent Brown, it was

VOTED, That Judge Backus and Mr. McCaffrey be appointed as representatives to appear before the Senate Committee on Corporations and Taxation in opposition to this bill. Called vote was taken, all Regents present voting and voting "Aye".

The matter of the distribution of <u>handbills</u> on the campus was again taken up for consideration. Upon motion of Regent Gates, seconded by Regent Kelly, it was

VOTED, That President Dykstra prepare a revision of the resolution adopted at the meeting of April 25, 1939, and present it to the Board at its next meeting.

Regent Brown announced that the meeting of the Business Committee to consider the request of the Daily Cardinal would be held in the Administration Building on Wednesday, June 21, 1939, at 11 A.M.

The matter of the difference in appropriations available for 1938-39 and the amounts appropriated for 1939-40 by the legislature was discussed and especially the reduction of \$323,619 in 1A Operation. It was explained by the President that to avoid reduction in salary, it would be necessary to secure approximately \$100,000 from the Emergency Board and to increase student fees \$5.00 a semester.

At 4:05 P.M. adjournment was taken to Saturday. June 17th, at 10 A.M.

### Saturday, June 17th, 1939, 10 A.M.

The matter of the <u>budget</u> was again dicussed. The President presented several alternatives for consideration for the balancing of the budget. Action on this matter was postponed to the afternoon session.

Upon motion of Regent Glover, seconded by Regent Hones, it was VOTED, That the minutes of the meetings of the Executive Committee held on May 18 and May 31, 1939, and the special meeting of the Executive Committee held on June 11, 1939, as sent out to the Regents, be approved, ratified and confirmed, subject to authority/to make revision in the resolution waiving liquidated of the Executive Committee

damages and extending the time for completing the J. H. Findorff & Son contract on the Heating Plant Addition, PWA Docket Wis. 1594-F, which appeared in the minutes of the meeting of May 31, 1939.

### RECOMMENDATIONS OF THE SECRETARY

l. That before the distribution of income for 1938-39 is made \$100 be transferred from the Mary J. Eichelberger Fund Income to Suspense Account representing interest on \$10,000 of the \$20,000 Eichelberger Fund for three months-account Picnic Point payment.

Adopted.

- 2. That before the distribution of income for 1938-39 is made \$100 be deducted and credited to Albright Scholarship Fund income.

  Adopted.

Upon motion of Regent Gates, seconded by Regent Kelly, adopted.

At 11:45 A.M. the meeting adjourned to 2:30 P.M.

# At 2:30 P.M. the Regents reconvened.

The matter of the 1939-40 budget was again discussed. Regent Kelly presented a statement defining his position in this matter. (Copy attached.)

There was discussion of the possibility of the University undertaking to provide approximately two-thirds of the cut in 1A Operation by reductions in the budget and increased student fees of \$5.00 a semester, \$1.50 of which would be made available for library facilities. The President was directed to apply to the Emergency Board for an appropriation of at least one-third of the reduction in 1A Operation and \$30,000 additional for 2A University Extension Operation.

Regent Hones requested that he be recorded as opposed to an increase in fees.

At 4:35 P.M. the meeting adjourned, subject to the call of the President of the Board.

# Document 570 - May 1939

The student body at its annual spring election on March 29, 1939, gave approval by a vote of 1697 to 209 to several amendments designed to bring the Union constitution up-to-date and make it conform to the recent reorganization of student government and to the situation created by the withdrawal of Dormitories and Commons from Union operation.

A complete copy of the constitution as amended is submitted herewith. The new amendments are underscored.

CONSTITUTION OF THE VISCONSIN UNION, UNIVERSITY OF VISCONSIN

# ARTICLE I - NAME

The name of this organization shall be "The Wisconsin Union of the University of Wisconsin."

# ARTICLE II - PURPOSE

Section 1. The purpose of The Wisconsin Union shall be to provide a common life and a cultivated social program for its members.

Section 2. The motto of the Wisconsin Union shall be "Societate Crescit Lumen"- light is increased through human relationships.

Section 3. The emblem shall be the Indian Pi f Peace, with ribbons attached, displayed against a cardinal and white arrowhead shield which is superimposed on a mariner's compass card - a symbol of fellowship and unity among diverse peoples.

# ARTICLE III - MEMBERSHIP

The Wisconsin Union may include five classes of members as follows:

Section 1 - Student Members. Every student upon enrollment in the University and the payment of incidental fees, which include a fee for the operation and maintenance of the Memorial Union Building, shall become a member of The Wisconsin Union for the period of enrollment covered by the fees paid. He may become a life member upon the payment of the specified aggregate amount in Union fees, or in subscriptions to the Memorial Union Building Fund, or both together, such aggregate amount to be recommended by the Union Council and approved by the Board of Regents.

Section 2 - Faculty Members. Any member of the University staff is eligible to membership upon the payment of the annual fee or of the life membership subscription to the Memorial Union Building Fund voted by the Union Council. Faculty life members of the Memorial Union Building Association shall automatically be life members of The Wisconsin Union.

Section 3 - Alumni Members. Any former student of the University is eligible to membership upon the payment of the annual fee or of the life membership subscription to the Memorial Union Building Fund voted by the Union Council, and under such other conditions as the Council may determine. A special non-resident annual fee may be voted by the Council at its discretion. Alumni life members of the Memorial Union Building Association shall automatically be life members of The Wisconsin Union.

Section 4 - Patron Members. The Union Council shall have power to elect at its discretion a person to patron membership who is not connected with the University as a student, alumnis or faculty member, providing that he pay the annual fee or the life membership subscription to the Memorial Union Building Fund voted by the Union Council.

Section 5 - Honorary Members. The Union Council shall have power to elect honorary members at its discretion.

# ARTICLE IV - GOVERNMENT

Section 1 - The Union Council. The governing body of the Wisconsin Union shall be known as the Union Council, which body shall be responsible to the Board of Regents through the President and Comptroller. Nothing contained in this constitution is intended to limit in any way the final authority or control of the Board of Regents over all persons and organizations connected with or receiving benefits from the University or as superseding the University rules governing the social activities of the student body. The Union Council shall be constituted as follows:

Four student representatives, at least one a woman student, from the body recognized by the University as the all-student governing board and chosen by such board;

Four students, one a graduate student and at least one a woman student, in charge of Union House Committee or Club activity and elected by the members of the outgoing Union Council;

Two members of the faculty appointed by the President of the University;

Two alumni, one appointed by the President of the University and one chosen by the governing board of the Alumni Association;

The House Director of the Memorial Union Building;

The officer of the Memorial Union in charge of business operations, ex officio.

Section 2 - Officers and their Duties. The officers of the Union Council shall be as follows:

President - Student elected by the members of the outgoing and incoming Councils as provided for in the By-Laws.

Vice-President - Student president of the body recognized by the University as the all-student governing board.

Secretary - House Director.

Treasurer - Officer of the Memorial Union Building in charge of business operations.

Whenever the Union Council may so order, the offices of Secretary and Treasurer may be held by the same person.

The President shall preside at all meetings of the Union Council and of The Wisconsin Union, and perform such other duties as are incumbent upon the office.

The Vice-President shall perform the duties of the President in his absence.

The Secretary shall keep all records and the minutes of all meetings.

The Treasurer shall keep the financial accounts of The Wisconsin Union, making such reports as are requested by the Union Council.

The Union Council may provide for the appointment of such additional officers as it may deem in the interests of The Wisconsin Union.

All of said officers and members of the Union Council shall perform such additional or different duties as shall from time to time be provided or required by the Union Council, or as may be prescribed from time to time by the By-Laws.

Section 3 - Executive Committee. The Union Council at its discretion may authorize the officers, together with another member or members of the Council if it so chooses, to serve as an Executive Committee, acting for the Council between its sittings.

Section 4 - Functions. The Union Council shall direct the administration of the affairs of The Wisconsin Union and of the Memorial Union Building, subject to the counsel and approval of the Board of Regents.

All groups or individuals having jurisdiction in the Memorial Union Building, or using the building, shall be responsible to the Union Council. The Council shall have the power, provided it does not supersede University rules, to govern the activities of members, guests, and organizations in the building, and may suspend membership, deny the privileges of the building, and (or) impose fines to maintain discipline.

The Union Council shall approve all budgets for the social activities supported by The Wisconsin Union membership fees.

The Union Council shall recommend to the President of the University for appointment by the Regents the House Director of the Memorial Union Building. The administrative officers of the building shall be responsible to the Board of Regents through the Comptroller of the University for the financial management of their respective departments, but shall accept guidance in the performance of their duties from the Union Council. The officers of the Memorial Union building shall consider authoritative only such recommendations as to policy (excepting University business policy) as may come from the Union Council.

The Union Council shall fill any vacancies in its member-ship from the group represented by the retiring member and for a term expiring with the succeeding regular election or appointment.

The Union Council shall formulate its own rules of procedure and By-Laws.

Subject to the approval of the Board of Regents, the Union Council shall exercise all powers not herein especially assigned.

Section 5 - House Committees. House Committees and special interest clubs shall plan for and oversee the social and educational programs under their respective jurisdictions, submitting recommendations to the Union Council and carrying them into effect in cooperation with the House Director and the staff.

These committees and clubs shall consist predominantly of students, but may include faculty members and alumni. The House Committees shall be appointed by the Union Council and shall be responsible to the Union Council. Such clubs as may be sponsored by the Council may organize on a club basis, electing officers as their own organizational articles may prescribe.

The chairmen of such House Committees and clubs may be formed into a Union Directorate, with such purposes, functions, and procedures as the Council may provide in the By-Laws.

# ARTICLE V - AMENDMENTS

This consitution may be amended at any time during the first three fiscal years of operation of the Memorial Union Building by a majority vote of the Union Council, subject to the approval of the faculty and of the Board of Regents. After the third fiscal year, amendments, upon majority approval of the Union Council, must be submitted to student members for approval at a regular student election or on a special date fixed by the Union Council and publicly advertised two weeks in advance.

Such amendments on vote of the Council may be submitted to the resident faculty and alumni members of The Wisconsin Union by mail, in which case the ballots of these members shall be cast by mail, to be received by the House Director and counted by a special elections committee named by the Union Council.

Amendments shall be declared adopted which receive a two-thirds majority of votes cast (providing the affirmative votes number at least four hundred) and which receive the ratification of the faculty and of the Board of Regents.

Amendments may be proposed to the Union Council by members of the Jouncil or by the petition in writing of one hundred qualified members of The Wisconsin Union.

### Document 572- June 1939

RECOMMENDATION OF THE SPECIAL COMMITTEE ON ENTRANCE REQUIREMENTS

for revision of Paragraph 4 of Revised Document 458, 1933-4, relating to admission of graduates from senior-high schools

Objections have been made by junior-high school principals to the rule as given in the University Catalog for 1938-39, page 36, paragraph 4, concerning majors and minors required for entrance from senior-high schools. It was pointed out, among other things, that the selection of subjects in junior-high school was limited since the academic units which could be used from the junior-high school was restricted to mathematics, and the pupils insisted on taking vocational subjects in the last year of junior-high work.

The Committee therefore recommends that there be added to the entrance requirements for the senior-high school the following alternative (insert before Section 4, b):

Or they may combine a unit or units from the last year of junior-high school with a unit or units from the senior-high school and satisfy the major and minor requirements of the four-year high school instead of meeting the requirements of the senior-high school.

### Document 573 - June 1939

### MAJOR IN APPLIED ART

The Faculty of the School of Education presents for approval the following Four-Year Course leading to the Degree of Bachelor of Science (Applied Art), 124 credits, to be offered in the School of Education until such time as it may be more appropriately assigned to some other school, college, or division.

- I. Students must meet the basic requirements outlined in Sequence A or Sequence B.
  - A. <u>English</u>: 10 to 12 credits as follows: English 1, 6 cr.; English 30 or 33, 4-6 cr.

History: 10 to 12 credits, to be taken in year courses unless "100" courses are selected.

Natural Science: 10 credits in a year course.

Social Studies: A minimum of 6 credits to be selected from Economics la, 4 cr.; Sociology 1 or 2, 3 cr.; Geography 6, 3 cr.

Philosophy: 10 credits as follows: Philosophy 21, 3 cr.; Philosophy 11, 3 cr.; Elective, 4 cr.

B. Foreign Language: Intermediate knowledge of one language.

English: 10 to 12 credits as follows: English 1, 6 cr.; English 30 or 33, 4-6 cr.

History: 6 credits. A year course in European or American history.

Natural Science: 10 credits in a year course or in "17" courses.

Philosophy: 6 credits. Philosophy 53, 3 cr.; Elective, 3 cr.

Social Studies: A minimum of 6 credits to be selected from Economics la, 4 cr.; Sociology 1 or 2, 3 cr.; Geography 6, 3 cr.

# II. Major Requirements:

Completion of 54-58 credits in Art Education, and other art courses outlined in the "fields" set forth below, to include the following: Art Education 50, 51, one semester of 52, or 56, one semester of 54 and 55, 53, 62, and one semester of 120.

# Regent Kelly's Statement in re: 1939-40 Budget.

I wish to make my position clear in this matter. First, I am opposed to the principle of raising student fees, but the Legislature, having seen fit to cut the University budget \$331,000 annually, there is no other recourse for the Regents but to adjust themselves to this situation, and it is their duty to do so.

As far as I can see there are only three methods by which this can be accomplished. First, by instituting a straight 10% cut in the salaries of the personnel. Secondly, by raising the student fees in a large amount to cover this deficit. And, thirdly, by combination of plans whereby the student fees will be increased by a minimum amount not to exceed \$5.00 per semester and savings effected by drastic economies with efforts to cripple the service of these departments as little as possible.

The first plan cannot be considered. The teaching personnel is already in many instances insufficiently compensated and previous attempts to meet the situation in this manner resulted in conditions which have made it increasingly difficult to maintain the academic excellence of the institution. The second method would depart from the traditional policy of the State of Wisconsin which has pertained for 51 years and inflict undue hardship upon those seeking a higher education and would destroy the eviable position which the University has enjoyed in comparison with other state universities. The third method remains, therefore, the only one that can be considered. It has always appeared strange to me that many who have been the beneficiaries of lower educational costs in the State of Wisconsin should now glibly talk of hoisting higher fees upon the present and future generations in order to correct a situation for which they are in no way responsible. Reft of all cosmetic verbiage such a procedure must, in its last analysis, be termed an educational sales tax. It should be labelled as an emergency fee.

The perpetuation of such a tax or its subsequent removal must rest with the Legislature in its furture policies regarding budgetary grants to the University.

With the problem before us and with no alternative, I therefore reluctantly favor the adoption of the last plan I have discussed. This of course is predecated upon an appropreation from the Emergency Board to fill the gap which will still remain under this set-up.
