The Secretary read communications from Regents Gale, Nace, Faast and Mahoney in explanation of their absence.

Upon motion of Regent Butler, seconded by Regent Kronshage, it was VOTED, That the minutes of the meeting of the Board of Regents held on December 5th, as sent out to the regents, be approved, ratified and confirmed.

President Birge reported the death of Professor M. S. Slaughter. Upon motion of Regent Butler, seconded by Regent Waters, the following resolution was adopted.

The regents of the University of Wisconsin learn with deep sorrow that

Dr. M. S. SLAUGHTER,

prpfessor of Latin, died, while on leave of absence, in Rome, on December 29, 1923. Since 1896 Professor Slaughter has been a notable member of the faculty. He was, before all other things, a teacher of the humanities, not only through knowledge and skill, but even more through his own personality. He felt the great literature of the past as a product of its life, and he was able to make it a part of the life of the present in the hearts of his students. So his teaching handed on the humanities and continued their active influence in the modern world through the students who went out from the University; trained in his classes and enriched by his friendship.

The regents thus record their realization of the irreparable loss which the University has suffered in the untimely death of one who was a comrade and fellow-worker in the great enterprise of higher education, and their grief in the passing of one who, in temper and character, represented the highest ideals of our university life.
