RECOMMENDATIONS OF THE PRESIDENT

-Agriculture-

- 1. That Creagh Inge be appointed assistant in agricultural economics from September 15 to November 30, 1928; salary at the rate of \$165 a month; to be charged to labor, Country Life, p. 59. Adopted.
- 2. That A. E. Darlow be appointed assistant in animal husbandry for the academic year 1928-29; salary \$1400 for the year; to be charged to item vice Kleinheinz, p. 69.

- 3. That the resignation of A. W. Oliver, half-time assistant in animal husbandry, for the academic year 1928-29, be accepted.
