Held in the President's Office

Saturday, January 13, 1951, 10 A.M.

Vice President Werner presiding

PRESENT: Regents Arveson, Campbell, Grady, Hodgkins, Jones, Kleczka, Watson, Werner.

ABSENT: Regents Gelatt, Sensenbrenner.

Regent Gelatt was absent due to absence from the state and Regent Sensenbrenner due to illness.

Upon motion of Regent Hodgkins, seconded by Regent Werner, it was VOTED, That the minutes of the regular meeting of the Board held on December 9, 1950, be approved as sent out to the Regents.

Vice President Baldwin presented the report of the President.

REPORT OF THE VICE PRESIDENT OF BUSINESS AND FINANCE

I. Report of Actions Taken

1. Agreements for architectural services on an hourly basis entered into pursuant to authority granted by the Regents at their meeting on November 11, 1950:

- a. Agreement with Weiler and Strang, Madison, for services in connection with remodelling the Electrical Engineering - Art Education Building.
- b. Agreement with Lewis Siberz, Madison, for services in connection with remodelling the Education-Engineering Building.

2. In accordance with the authority granted by the Regents on September 27, 1947, for the Vice President of Business and Finance to sign contracts and leases not in excess of \$2,500, the following contracts and orders have been signed:

- a. Contract in the amount of \$1,034 with Edward T. Ver Halen Company, Inc., Milwaukee, for the furnishing of all labor and material required to complete the acoustical tile work in Room 101, Biochemistry Building, Madison.
- b. Lease from Curtis Smith, Kenosha, for a total rental of \$225 of nine acres of land for use by the College of Agriculture during the calendar year 1951 for truck crops research. (Chargeable to Fund 3-F)

- c. Lease to Peter Muench, Paul E. Lease from Milwaukee Auditorium Board of Engelmann Hall of the Milwaukee Auditorium Building from 11:30 A.M. to 2:00 P.M. on February 14, 1951, for Student Convocation, Milwaukee Extension Center, for a total consideration of \$70 covering rental of the Hall and use of the public address system.

Lease from The Athenaeum, Milwaukee, for a total consideration of \$171 of Main Hall for a series of six evening lectures by University faculty members sponsored by the Milwaukee Extension Center during the second semester of the 1950-51 academic year, open to the general public without admission charge.
- f. Rental from Kelley Properties, Eau Claire, of Room 8, 316 South Barstow Street, Eau Claire, during the period October 1, 1950 through December 31, 1950, for office space for the Extension Division field representative, in consideration of a total rental of \$52.50.

Upon motion of Regent Grady, seconded by Regent Hodgkins, actions 1 and 2 listed under the report of the Vice President of Business and Finance (I. Report of Actions Taken) were approved.

Regent Jones presented the report of the Business and Finance Committee. Upon motion of Regent Jones, seconded by Regent Grady, the following resolution was unanimously adopted:

"THAT, WHEREAS, Thomas E. Brittingham, Jr., and Margaret Brittingham Reid, Trustees of the University of Wisconsin Trust created under the Will of Thomas Evans Brittingham, deceased, have offered to convey as a gift to The Regents of the University of Wisconsin the property known as Eagle Heights located adjacent to the University Eagle Heights Farm, more specifically described as follows:

All of that part of the premises conveyed by The Regents of the University of Wisconsin to Alice Martens Young, individually, and Alice Martens Young, Trustee for Edward John Young, Jr., John Martens Young, Mary Alice Young, and William Hatton Young, by conveyance dated December 6, 1941, and recorded in the Office of the Register of Deeds on December 19, 1941, in Volume 417 of Deeds, page 478, Document 653627, lying south of Mendota Drive;

WHEREAS, This property is rich in Indian lore, of great historical interest to the general public, and is famed for its natural beauty; and

WHEREAS, Eagle Heights should be preserved for appropriate public and University purposes;

NOW, THEREFORE, BE IT RESOLVED, That the Regents gratefully accept for the benefit of the University and the State of Wisconsin this gift from Thomas E. Brittingham, Jr., and Margaret Brittingham Reid, Trustees of the University of Wisconsin Trust under the Will of Thomas Evans Brittingham, deceased, in accordance with the terms of the Deed of Conveyance."

Vice President Baldwin expressed the pleasure and appreciation on behalf of the University administration for the generosity of Mr. Brittingham and Mrs. Reid, as Trustees of the University of Wisconsin Brittingham Trust, in making this gift to the University.

Regent Grady concurred in the statement made by Vice President Baldwin and asked that the records show the appreciation of the administration as well as the Regents for the generosity of Mr. Brittingham and Mrs. Reid in making this gift to the University.

Res Halls
Upon motion of Regent Jones, seconded by Regent Grady, it was VOTED, That the adjustment in room and board rates in University Residence Halls approved by the Regents on September 30, 1950, be amended to establish a rate of \$88 for the second semester of 1950-51 in place of \$92 for space in double rooms at the Stadium Dormitories.

Upon motion of Regent Jones, seconded by Regent Hodgkins, it was VOTED, That the action of the Vice President of Business and Finance in employing H. O. Walther, Chicago, to make an appraisal of the Forbrich Estate properties at an estimated cost of \$750 be approved, and that funds for the cost of the appraisal be allotted from Unbudgeted 1-E Receipts.

Budget
Upon motion of Regent Jones, seconded by Regent Campbell, it was VOTED, That funds accumulated through June 30, 1950, totalling \$51,224.07 from overhead charges on Army-Navy research contracts be set aside as a reserve for termination costs of Government contracts;

(Cont.)

That funds accumulated through June 30, 1950, from overhead charges on industrial research contracts and on Public Health and other Government contracts, with the exception of Army-Navy contracts, be allotted to the respective colleges, schools and divisions in which the research was done, for the purchase of equipment and supplies, and that annually beginning July 1, 1951, the funds accumulated in the previous fiscal year from overhead charges on all sponsored research contracts, less the funds required to pay for expenditures disallowed by the auditors as direct charges, be made available to the respective colleges, schools and divisions in which the research work was done, for the purchase of equipment and supplies.

Mr. Jones, as Chairman of the Business and Finance Committee, moved the adoption of the following recommendation pointing out that he was making the motion as Chairman of the Committee inasmuch as a majority of the Committee had approved the recommendation but that he was reserving the right to vote against it:

That authority be granted to purchase the Duveen collection on Chemistry and related fields of science from Mr. Dennis I. Duveen, New York City, for a consideration of \$50,000 f.o.b. New York City, chargeable to the following funds:

and that the cost of shipment from New York City to Madison be charged to the General Library Budget.

Regent Kleczka seconded the motion to adopt the recommendation. A called vote was taken, Regents Arveson, Campbell, Kleczka, Watson, Werner voting "Aye"; Regents Grady, Hodgkins and Jones voting "No". The motion was declared carried.

Regents Grady and Jones explained that they were voting in the negative because they felt that University funds could better be spent for the purchase of new and up-to-date books and equipment for instruction and research purposes rather than for a collection of old books, the value of which, in their opinions, was largely of an historical and sentimental nature.

Upon motion of Regent Jones, seconded by Regent Hodgkins, it was VOTED, That the bequest by the late Grace Lown of the City of Sturgeon Bay, Wisconsin, to the University of Wisconsin for cancer research work in the

Medical School be accepted by the Regents of the University of Wisconsin in accordance with the terms and conditions of the Last Will and Testament of Grace Lown, deceased; and that the President, the Secretary or the Assistant Secretary be authorized to sign receipts in the name of the Regents for the funds received under this bequest, or to do all things necessary to effect the transfer of this bequest to the Regents.

Upon motion of Regent Jones, seconded by Regent Watson, it was VOTED, That the following schedule of costs for the West Wing Addition to the Home Economics Building be approved:

Recommendations of the Administrative Committee with respect to
Granting Credit to Students who Enter the Armed Forces Before
the Close of the First Semester 1950-51

A. That the following regulations be adopted.

1. A student who withdraws from the University in the first semester of 1950-51 and enters military service will receive the grades which he has earned for his semester courses without taking final examinations provided he has carried his courses up to the beginning of the Christmas recess. If a student wishes to secure the benefit of this regulation he must make application to the dean of his school or college at the time of withdrawal from the University.
2. If a student withdrew to enter military service earlier than the beginning of the Christmas recess he will be permitted, on request, to resume his studies at the same point in a subsequent semester.
3. To implement the recording of grades for students who enter the military service, it is recommended that instructors award such students grades of incomplete with the estimate of grade and the date of withdrawal indicated in parentheses. When the student complies with the provisions of 1 or 2 above, the incomplete will be removed.
4. The foregoing provisions cannot be applied literally to the professional schools. But their executive committees are hereby authorized to act so far as possible in the spirit of these regulations.

B. That the following legislation which was adopted at the opening of World War II be rescinded.

1. A student who is inducted into the armed forces under the terms of the Selective Service Act before the completion of the semester of residence for which he is registered will receive grades for the semester programme without final examinations if he has carried his courses to within four weeks of the end of the semester's examination period, and his semester grades will be his term grades dropped one step. E.g., if his term grade in a course is B his semester grade will be C. Or, if he prefers, he may with the permission of his college dean take early final examinations in the courses of the semester before withdrawing for induction. If the student withdraws for induction earlier than within four weeks of the end he will be permitted on request, to resume his studies at the same point in a subsequent semester.
2. A student withdrawing to enlist before the expiration of his deferment may not enjoy the benefits of the foregoing rule. But he will be permitted, on request, to resume his studies at the same point in a subsequent semester.
3. Cases of enlistment which approximate induction under the Selective Service Act are referred to the executive committee of the student's college for appropriate action.
