ADJOURNED MEETING OF THE BOARD OF REGENTS

Madison, Wisconsin

Wednesday, March 19, 1947, 1:30 P.M.

President Sensenbrenner presiding

PRESENT: Regents Callahan, Campbell, Grady, Holmes, Kleczka, Sensenbrenner, Werner.

ABSENT: Regents Hodgkins, Jones.

Regent Hodgkins was absent due to illness, and Regent Jones was absent from the State on business scheduled prior to the rescheduling of the Regents' meeting for March 19, 1947.

President Sensenbrenner made the following appointments to fill the unexpired terms of the late Regent Cleary on Regent Committees:

Executive Committee - A. Matt. Werner
Finance Committee - W. J. Campbell

and appointed Regent Grady as Chairman of the Executive Committee.

At the request of President Sensenbrenner, Regent Grady read the following resolution in memory of the late Governor Goodland:

"The Regents of the University of Wisconsin will ever remember with appreciation and gratitude

WALTER S. GOODLAND

who, ever unsparing of himself, served the State of Wisconsin with high courage and perfect integrity in all affairs, public and private, large and small. He was fearless and independent, but guided always by his sense of the common good. His life exemplifies those qualities of citizenship, moral and intellectual, which have made Wisconsin great and which our University seeks to foster.

The University expresses its gratitude as it enshrines his name on its highest roll of honor."

Upon motion of Regent Grady, seconded by Regent Campbell, it was VOTED, That the above resolution in memory of the late Governor Goodland be entered upon the record and that a copy of the resolution in appropriate form be sent to Mrs. Goodland. The motion was unanimously adopted by a rising vote.

At the request of President Sensenbrenner, Regent Grady read the following resolution in memory of the late Regent Cleary:

"MICHAEL JOSEPH CLEARY
1876 - 1947
In Memoriam

The Board of Regents of the University of Wisconsin records with deep sorrow the death on February 22, 1947, of Michael J. Cleary, one of its most useful and beloved members.

To the varied tasks of his great career he brought a superb endowment of mind and personality, enriched both through rigorous training, and by broad experience. Educated in the law at the University of Wisconsin, he devoted about fifteen years to its practice in a small Wisconsin town, which indelibly impressed upon him the aspirations and the problems of grass-roots America. For a single term he served in the Assembly of the Wisconsin Legislature, helping to shape laws which laid the basis of the regulation of the insurance business in this State. Next called to the service of the State as Executive Counsel to Governor Philipp, he soon was appointed Commissioner of Insurance. Thus began a career in the field of insurance which was to last for a human generation. It reached its climax during the last fifteen years of his life in the presidency of one of America's greatest insurance companies - also Wisconsin's largest corporation - the Northwestern Mutual Life Insurance Company of Milwaukee.

Great business executive that he was, whose advice and guidance were widely and eagerly sought, Michael Cleary never lost the common touch. He liked to help people and thought of his business as one of the greatest boons to mankind. Movements for the advancement and betterment of his city and state, his church and university, always could count on his active support, and within the limitations imposed by other responsibilities, upon his enthusiastic and inspiring leadership.

The University of Wisconsin has been the beneficiary of his most devoted public service. A towering figure in fighting its battles, a steadfast leader when the storms blew, he always commanded respect and inspired confidence. He brought to the work of the Board of Regents a fullness of perspective gained through broad experience that proved invaluable. He had an unfailing ability quickly and decisively to analyze any financial problem that came before him. His clear vision and great common sense contributed substantially to the shaping of policies in a highly dynamic period of University history.

Distinctive as were his achievements and distinguished as were his services, the imperishable memories of all who knew him well are those of

Michael Cleary, the man. When his Irish eyes were smiling, and his wit and humor lightly dancing, he was irresistible in any company. Kindly in his attitude toward others, he was intolerant only of sham. Sincere in his ideals, honest in the expression of his intellectual and moral convictions, courageous in standing up and being counted on the side of what he regarded right and best, he won and deserved the esteem of all his associates in enterprises, private or public.

'God give us men. The time demands
Strong minds, great hearts, true faith,
and willing hands.
Men whom the lust of office does not kill;
Men whom the spoils of office cannot buy;
Men who possess opinions and a will;
Men who have honor; men who will not lie.'

Of such is the Kingdom of God on earth, and to that eternal company belongs Michael Joseph Cleary."

Upon motion of Regent Grady, seconded by Regent Kleczka, it was VOTED, That the above resolution in memory of the late Regent Cleary be entered upon the record and that a copy in appropriate form be sent to the family of Mr. Cleary. The motion was adopted unanimously by a rising vote.

Upon motion of Regent Werner, seconded by Regent Callahan, it was VOTED, That the minutes of the regular meeting of the Board held on February 15, 1947, be approved as sent out to the Regents.

Leith, professor of agronomy, be employed on a contract basis for the period March 15, 1947 to June 30, 1947, to assist with the various aspects of foundation seed stock production; salary \$1419.35 for the period; charge \$900 to saving on salary of John Thomas, p. 125, and \$519.35 to saving on salary of Romain Zahm, p. 126.

Upon motion of Regent Callahan, seconded by Regent Kleczka, recommendation No. 1 listed under Contracts was adopted.

Upon recommendation of President Fred, and upon motion of Regent Werner, seconded by Regent Callahan, it was

VOTED, That William Frederick Steve, Emeritus Professor of Physics, be employed on a contract basis for the second semester of the 1946-47 academic year at a salary of \$990 on a part-time basis, with the understanding that the contract may be terminated at any time; charge to Letters and Science, Physics.

- Gifts and Grants -

1. That the following gifts and grants be accepted; and that the Director of Business and Finance be authorized to sign the agreements:

- (a) \$6000.00 - Arnold Dryer Company, Milwaukee, Wisconsin, for the establishment of an industrial fellowship in the departments of agricultural engineering, agronomy, animal husbandry, biochemistry, and poultry husbandry for a study of methods of operating hay drying equipment, during a twelve-month period beginning January 1, 1947.
- (b) 4500.00 - Barley and Malt Institute, Chicago 6, Illinois, (formerly known as the United States Maltsters Association) for the continuation of an industrial fellowship for a study of the quality of barley for malting purposes, during the period September 1, 1946 to August 31, 1947, in the departments of agronomy and plant pathology.
- (c) 600.00 - Kroger Company, Cincinnati, Ohio, for the establishment of two scholarships for freshmen in agriculture and two for freshmen in home economics; the selection of the scholars to be made by University officials.
- (d) 78.75 - to be added to the Leonard and Gertrude Salter Lecture Fund.
- (e) 10.00 - Dr. Paul C. Hodges, Chicago, Illinois, to be added to the Walter J. Meek Loan Fund.
- (f) 25.00 - For the Case Loan Fund from Mrs. Abraham Schinasi, New York City, in memory of her son, Seymour Boris Schinasi.
- (g) 540.00 - Friends of the late Professor Almere Scott to establish the Almere Scott Memorial Fund. The accumulated interest and principal, when necessary, are to be used at the rate of not to exceed \$20 per year for the annual freshman speech awards to be known henceforth as the Almere Scott Speech Awards.
- (h) 1014.00 - Contributions to a fund for the perpetuation of the memory of the late William J. Bleckwenn, Jr.; and that authority be granted to accept further contributions. (A definite statement regarding the use of the fund will be presented at a later time for the consideration and approval of the Regents.)
- (i) 25.00 - An anonymous gift to be used for cancer research.

President Fred presented a proposal from the Kappa Sigma Fraternity for the establishment of a scholarship to be awarded to members of the fraternity. Upon motion of Regent Kleczka, seconded by Regent Werner, it was

VOTED, That the proposal of the Kappa Sigma Fraternity for the award of scholarships to its members be accepted on the basis of the provisions of the Kappa Sigma Fraternity scholarship proposal. (Copy of proposal on file.)

President Fred distributed copies of a report by the University Housing Bureau on the student housing situation. (Copy on file.)

RECOMMENDATIONS OF THE DIRECTOR OF BUSINESS AND FINANCE

I. Contracts, Leases and Agreements

1. That the Director of Business and Finance be authorized to sign a lease agreement with the City of Green Bay for the use of land on which to place a temporary classroom and laboratory building to be provided by the Federal Government for the Green Bay Extension Center.

Upon motion of Regent Werner, seconded by Regent Grady, recommendation No. 1 listed under the recommendations of the Director of Business and Finance (I. Contracts, Leases and Agreements) was adopted.

II. Budget Items

1. That the Director of Business and Finance be authorized to request the Emergency Board for a supplemental appropriation of \$2517.66 for emergency salary increases approved April 1, 1946, and September 16, 1946, for civil service employees of the Psychiatric Institute, to cover the period ending April 30, 1947, and for a further supplemental appropriation of \$880 to cover the months of May and June, 1947, if the Legislature approves the continuation of the emergency civil service increases after April 30, 1947.

Adopted.

2. That \$1788 be allotted from the 5-1 General Appropriation to the budget of the Psychiatric Institute to supplement the appropriation made by 20.41(12) on account of increased costs of operation.

Adopted.

3. That the Director of Business and Finance be authorized to request the Emergency Board for a supplemental appropriation of \$32,060 for emergency salary increases approved April 1, 1946, and September 16, 1946, for civil service employees of the State of Wisconsin General Hospital and Wisconsin Orthopedic Hospital to cover the period ending April 30, 1947; and for a further supplemental appropriation of \$21,240 to cover the months of May and June, 1947, if the Legislature approves the continuation of the emergency civil service increases after April 30, 1947.

Adopted.

4. That \$70,000 be allotted from unbudgeted 1-E balances to the College of Letters and Science for operating supplies needed on account of the increase in enrollment and increased costs.

Adopted.

Upon motion of Regent Kleczka, seconded by Regent Campbell, recommendations numbered 1 to 4, inclusive, listed under the recommendations of the Director of Business and Finance (II. Budget Items) were adopted.

III. Miscellaneous

1. That upon the recommendation of the faculty of the Medical School authority be granted to merge the Medical School Loan Fund, consisting of \$145 in cash and \$16 in notes receivable, with the Walter Joseph Meek Loan Fund.

Adopted.

2. That upon the recommendation of the Director of the Extension Division, the out-of-state fee for high school correspondence study courses offered by the University Extension Division be established at the uniform rate of \$16 per course, effective with the year 1946-47.

Adopted.

3. That the Wisconsin University Building Corporation be authorized to purchase from Fred Gratz for a consideration of \$1800 the following three vacant lots in the area south of University Avenue:

- a) Lot 9, Block 4, Central Homes Addition,
- b) East 1/2 of Lots 1 and 2, Block 2, Central Homes Addition,
- c) Lot 4, Block 2, Central Homes Addition;

and that the Wisconsin University Building Corporation be authorized to borrow the amount of the purchase price from the State of Wisconsin (State Retirement System) for a term of thirty years at an annual interest rate of 3%.

Adopted.

4. That authority be granted to request the approval of the State Bureau of Personnel to continue the employment of Mr. Henry W. Woodstock, Operating Engineer in the Department of Mechanical Engineering, to June 30, 1947. Mr. Woodstock attains the age of seventy years in April, 1947.

Adopted.

Upon motion of Regent Kleczka, seconded by Regent Campbell, recommendations 1 to 4, inclusive, listed under the recommendations of the Director of Business and Finance (III. Miscellaneous) were adopted.

The Director of Business and Finance presented a resolution submitted by church and religious groups active on the campus, requesting the reservation of additional space in the area south of University Avenue for building sites for church and religious organizations. (Copy of resolution attached.) Upon motion of Regent Kleczka, seconded by Regent Werner, it was

VOTED, That the request of the church and religious organizations for additional building sites in the area south of University Avenue be referred to the Steering Committee of the Campus Planning Commission for study and report to the Regents.

The Director of Business and Finance reported that he had been unable to negotiate a contract with Geo. Nelson & Son for the rebuilding of the marquee on the Memorial Union Building in accordance with the terms approved by the Regents at their meeting on August 15, 1946. Upon motion of Regent Holmes, seconded by Regent Werner, it was

VOTED, That the action taken by the Regents on August 15, 1946, authorizing the Director of Business and Finance to negotiate a contract with Geo. Nelson & Son for rebuilding the marquee on the Memorial Union Building be rescinded; and that the Director of Business and Finance be authorized to negotiate with Geo. Nelson & Son and to sign a contract for this work on a cost plus fixed-fee basis with the fixed fee not to exceed \$2000.

The Director of Business and Finance presented a report from the Director of Residence Halls regarding the unsuccessful efforts that had been made to have the

Madison Bus Company furnish additional bus service between Madison and Truax Field. Upon motion of Regent Werner, seconded by Regent Kleczka, it was

VOTED, That the University of Wisconsin join with the Madison Housing Authority, the City of Madison, and the residents of Truax Field to petition the Public Service Commission to extend and increase the bus service for the residents at Truax Field.

The Director of Business and Finance presented a request from the Governor's Educational Advisory Committee for the University of Wisconsin Extension Division to furnish and coordinate related instruction materials for on-the-job trainees in accordance with the provisions of Public Laws 16 and 346, 78th Congress, to be financed by state appropriation to the University of Wisconsin, with the understanding that the request for the estimated appropriation of \$262,000 for the biennium would be supported by the Governor's Educational Advisory Committee and the heads of the various state departments concerned with the on-the-job training program. Upon motion of Regent Grady, seconded by Regent Callahan, it was

VOTED, That the University consent to the administration of the program, provided the funds are appropriated by the Legislature on application of the Governor's Advisory Committee and that the Legislature be notified to that effect.

The Director of Business and Finance presented a form of contract that had been prepared by the State Director of Purchases covering the furnishing of university diplomas. Upon motion of Regent Werner, seconded by Regent Kleczka, it was

VOTED, That the Director of Business and Finance be authorized to sign a contract with the E. A. Wright Company for the furnishing of university diplomas for the period covering requirements for graduation in May, 1947, and continuing to include requirements for diplomas through the summer session of 1948.

The Director of Business and Finance reported that the Constructional Development Committee of the Regents and the Steering Committee of the Campus Planning Commission met on March 18 in the office of the President of the University with the committee appointed by the Mayor of Madison to consider the effects of the university expansion program upon the City of Madison, at which meeting it was agreed that the location of the railroad rights-of-way in the area south of University Avenue was the most immediate problem confronting the University and the City of Madison, and that a joint effort should be made to secure a solution to this problem. Upon motion of Regent Kleczka, seconded by Regent Grady, the following resolution was adopted by unanimous vote:

WHEREAS, The Regents of the University of Wisconsin in a resolution unanimously adopted at a special meeting held on May 4, 1946, designated the area between Park Street and Breese Terrace which lies south of University Avenue and north of Regent Street as property that is needed for the expansion of the University campus, and

WHEREAS, The rights-of-way of the Illinois Central Railroad and of the Chicago, Milwaukee, St. Paul and Pacific Railroad traverse the above

described area, and

WHEREAS, The City of Madison, the University of Wisconsin, and the State of Wisconsin are concerned with the problems created by the location of such railroad rights-of-way,

NOW, THEREFORE, Be It Resolved, That Dean I. L. Baldwin, Dean M. O. Withey, and A. W. Peterson, Secretary of the Regents, be appointed as a committee, representing the University of Wisconsin, to join with committees representing The City of Madison and the State Planning Board in conferring with the Public Service Commission of Wisconsin for the purpose of finding a solution to the problems created by the location of railroad rights-of-way in The City of Madison.

The Secretary reported that the annual joint meeting of the Regents and the Board of Visitors, which is usually held in March, will be held at noon on Saturday, April 12, 1947.

The meeting adjourned at 2:35 P.M.

TO THE REGENTS OF THE UNIVERSITY OF WISCONSIN

A RESOLUTION PRESENTED BY REPRESENTATIVES OF CHURCHES AND RELIGIOUS GROUPS
ACTIVE AT THE UNIVERSITY OF WISCONSIN

After careful consideration of the estimated future needs of religious agencies serving the students of the University of Wisconsin, and in view of the proposed expansion of the campus of the University in the years to come, we, representatives of churches and religious groups which serve the student community, respectfully request the Regents of the University of Wisconsin:

- 1) To recognize formally the fundamental importance of the religious agencies in the cultural life and training of students; and
- 2) To include the future needs of the campus religious agencies in the expansion plans of the University by adding to the block between University Avenue, Mills, West Johnson and Brooks Streets, already designated for their use, the block between University Avenue, Charter, West Johnson and Mills Streets, and the west half of the block between University Avenue, Brooks, West Johnson and Park Streets; or in lieu of the latter half block, the area between West Johnson, Mills, West Dayton and Brooks Streets.

Such action on the part of the Board of Regents would be most reassuring to the parents of the State who feel that the secular education provided by the University must be supplemented by a program of spiritual training, as well as to those individuals and groups who are disturbed by the future dislocation of established church houses through the development of announced expansion plans. The area suggested would insure the minimum necessary land area for the three churches on State Street if completion of the lower campus plan makes it desirable for them to move, and will provide for other churches not yet suitably housed. Joint planning and grouping of facilities would result in an impressive and harmonious addition to the campus; an addition which would make it possible to better serve the needs of the student body.
