REGULAR MEETING OF THE BOARD OF REGENTS

Madison, Wisconsin

Saturday, October 27, 1945, 9 A.M.

President Sensenbrenner presiding

PRESENT: Regents Callahan, Campbell, Cleary, Grady, Holmes, Jones, Kleczka, Sensenbrenner, Werner

ABSENT: Regent Hodgkins

A communication was presented from Regent Hodgkins in explanation of his absence.

Upon motion of Regent Grady, seconded by Regent Jones, it was VOTED, That the minutes of the regular meeting of the Board held on September 29, 1945, be approved as sent out to the Regents.

RECOMMENDATIONS OF THE PRESIDENT

- Administration and General -

1. That the following actions of the Faculty be approved:

- (1) Recommendation of the Faculty of the College of Letters and Science for a new course leading to the degree of Bachelor of Science (Physical Medicine). EXHIBIT A, attached.

Upon motion of Regent Cleary, seconded by Regent Kleczka, recommendation No. 1 (1) listed under Administration and General was adopted.

- (2) Recommendation of the Faculty of the College of Engineering "That the degree of Bachelor of Naval Science be conferred upon a Naval ROTC student when he has completed 136 credits with not less than 136 grade-points and when included within these credits are the 36 credits in Naval Science required by the Navy and such credits in fundamental engineering subjects as may be stipulated by the professional engineering department in which he majors."

It was explained that a detailed curriculum could not be presented at this time, but will be presented to the Faculty at a later meeting.

Upon motion of Regent Werner, seconded by Regent Holmes, recommendation No. 1 (2) listed under Administration and General was adopted.

- (3) Recommendation of the Faculty of the Law School
"That the grade-point average of 1.3 required of students entering the Law School without a Bachelor's degree be waived as to students who have served in the armed forces during World War II."

Upon motion of Regent Kleczka, seconded by Regent Cleary, recommendation No. 1 (3) listed under Administration and General was adopted.

- (4) Recommendations of the Administrative Committee (Confirming approval of the Executive Committee)
- (a) That an eight-week term be established to run concurrently with the last half of the present semester;
 - (b) That this arrangement be continued in succeeding semesters so long as the need exists.
 - (c) That a fee of \$43.00 per person for residents of Wisconsin and \$93.00 for nonresidents, which includes infirmary, union and library fees prorated, be charged for the term.

Upon motion of Regent Callahan, seconded by Regent Campbell, recommendation No. 1 (4) listed under Administration and General was adopted. Regent Grady voted "No".

There was discussion on (c) under recommendation No. 1 (4), led by Regent Grady, on the basis of a nonresident fee charged Wisconsin students under the GI Bill of Rights. Upon motion of Regent Campbell, seconded by Regent Kleczka, it was VOTED, That the Board go on record that in case a hardship on veterans is caused by this each veteran is to be reimbursed the amount which might be deducted from any bonus or other payment made him and that the fees received are to be earmarked for this purpose until July 1, 1946, when further consideration will be given the matter.

2. That Scott H. Goodnight, Dean of Men, be granted the emeritus status, beginning July 1, 1945.
Adopted.

3. That Curtis Merriman, Registrar, be granted the emeritus status, beginning July 1, 1945.
Adopted.

Upon motion of Regent Jones, seconded by Regent Kleczka, recommendations 2 and 3 listed under Administration and General were adopted.

- Business and Finance -

1. That the Director of Business and Finance be authorized to sign an agreement with The Linde Air Products Company for the sale and delivery of oxygen for a period of five years at the following rates:

For less than 75,000 cu. ft. per month \$.775 per 100 cu. ft.
For 75,000 cu. ft. and over per month .725 per 100 cu. ft.
For cylinder oxygen \$.85 per 100 cu. ft. with an additional charge of \$.15 per 100 cu. ft. for delivery.

Upon motion of Regent Cleary, seconded by Regent Werner, recommendation No. 1 listed under Business and Finance was adopted.

2. That the Director of Business and Finance be authorized to sign a lease for the rental of 60 acres of land at the Peninsular Branch Station from Tony, Myrtle, and Stanka Tadey at an annual rental of \$360 for the period January 1, 1946 to December 31, 1950.

Upon motion of Regent Werner, seconded by Regent Campbell, recommendation No. 2 listed under Business and Finance was adopted.

3. That the following 5-AA Short Course Dormitory and Dining Hall budget for 1945-46 be approved:

Upon motion of Regent Werner, seconded by Regent Campbell, recommendation No. 3 listed under Business and Finance was adopted.

Upon motion of Regent Cleary, seconded by Regent Kleczka, recommendation No. 4 listed under Business and Finance was adopted.

Upon motion of Regent Jones, seconded by Regent Kleczka, recommendation No. 5 listed under Business and Finance was adopted.

6. That \$400 be transferred from Regents' Unassigned 1-E to the Office of the Dean of Women for the employment of additional staff needed on account of the increase in enrollment.

Upon motion of Regent Cleary, seconded by Regent Campbell, recommendation No. 6 listed under Business and Finance was adopted.

7. That \$2,000 be transferred from Regents' Unassigned 1-E to the Department of Physical Education for Women for the employment of additional staff needed on account of the increase in enrollment. (Confirming approval by the Executive Committee.)

Upon motion of Regent Callahan, seconded by Regent Kleczka, recommendation No. 7 listed under Business and Finance was adopted.

8. That the following budget for the Department of Naval ROTC be approved, chargeable to Regents' Unassigned:

Upon motion of Regent Holmes, seconded by Regent Werner, recommendation No. 8 listed under Business and Finance was adopted.

9. That \$800 be transferred from Regents' Unassigned 1-D to the budget of the Secretary of the Faculty for the purchase of a new addressograph machine.

Upon motion of Regent Werner, seconded by Regent Cleary, recommendation No. 9 listed under Business and Finance was adopted.

10. That \$2,100 be transferred from Regents' Unassigned 1-D to the College of Engineering to supplement the gift of \$2,500 proffered by the Wisconsin Valley Improvement Company, making a total of \$4,600 for the installation of a new flume in the Hydraulic Laboratory and for necessary laboratory remodeling.

Upon motion of Regent Jones, seconded by Regent Kleczka, recommendation No. 10 listed under Business and Finance was adopted.

11. That the fines for late registration be waived in the case of veterans who are prevented from enrolling on regular registration dates by reason of late discharges from the service; that this regulation be effective with the beginning of the regular academic year 1945-46; and that the Bursar be authorized to refund fines collected in conflict with this change in the rules.

Upon motion of Regent Kleczka, seconded by Regent Grady, recommendation No. 11 listed under Business and Finance was adopted.

12. That \$200 be transferred from Regents' Unassigned 1-D to the budget of the Centennial Committee for the purchase of necessary equipment.

Upon motion of Regent Werner, seconded by Regent Cleary, recommendation No. 12 listed under Business and Finance was adopted.

13. That the following additional budget be approved for the Housing Bureau:

1. That Saturday morning classes in rhythm and dance be offered by the Department of Physical Education - Women for boys and girls of Madison, six to twelve years of age, on a fee basis, \$5.00 per semester per child, and that the following

budget for the first semester be approved, with the understanding that expenditures shall not exceed actual receipts: Estimated Receipts - \$250; Estimated Expenditures - \$250.

2. That faculty recreation classes be resumed for the first semester of 1945-46; that a fee of \$3.00 per person be charged; and that the following budget be approved with the understanding that expenditures shall not exceed actual receipts:

1. That the appointment of Wilbur M. Hanley, associate professor of geography, be corrected to read "for the second semester of 1945-46" instead of "for the academic year 1945-46".

Adopted.

2. That the appointment of Walter A. Morton, professor of economics, be transferred from the College of Letters and Science to Graduate School Research for the second semester of 1945-46.

Adopted.

3. That the leave of absence granted Charles F. Edson, Jr., assistant professor of history, be cancelled for the balance of the academic year 1945-46, to take effect October 15, 1945; and that his salary for the remainder of the academic year 1945-46 be \$3,111.12; charge to Regents' Unassigned 1-E.

Adopted.

Upon motion of Regent Kleczka, seconded by Regent Cleary, recommendations 1 to 3, inclusive, listed under Letters and Science were adopted.

- Education -

1. That the salary of Warren H. Southworth, associate professor of education, be increased from the rate of \$5,000 to the rate of \$5,500 per annum effective October 1, 1945; charge to 15B, gifts (transfer from Wisconsin Department of Public Instruction to the University of Wisconsin).

Upon motion of Regent Werner, seconded by Regent Cleary, recommendation No. 1 listed under Education was adopted.

- Agriculture -

1. That E. B. Gordon, professor of music, be appointed to direct two choral music groups each week for fifteen weeks and to lead the chorus on special occasions

for the Farm Short Course, November 19, 1945 to March 9, 1946; salary \$300 for the period; charge to agr. short course (lectures), fund I, p. 66.

Adopted.

2. That William B. Sarles be promoted from associate professor of agricultural bacteriology to professor of agricultural bacteriology, to take effect November 5, 1945; and that his salary be increased to the rate of \$4,200 for the academic year.

Adopted.

3. That a short course be given in the College of Agriculture, from November 5 to 15, 1945, on the artificial breeding of cattle; that a fee of \$15.00 per person be charged; and that the receipts be budgeted as follows:

Upon motion of Regent Cleary, seconded by Regent Grady, recommendations 1 and 2 listed under Medicine were adopted.

- Engineering -

1. That Lloyd F. Rader be appointed professor of civil engineering for the academic year 1945-46; salary \$4,500 per annum; charge to Engineering budget.

Adopted.

2. That James G. Woodburn, professor of civil engineering, be granted leave of absence, without pay, for the academic year 1945-46 to serve full time with the Campus Planning Commission.

Adopted.

Upon motion of Regent Holmes, seconded by Regent Grady, recommendations 1 and 2 listed under Engineering were adopted.

- Research -

1. That Walter A. Morton, professor of economics, be given a special research appointment for the second semester of 1945-46; salary \$2,375 for the semester; charge to allotment 45;21.

Adopted.

2. That the appointment of Merrill Jensen, associate professor of history, be changed from the second semester to the first semester of 1945-46; salary \$2,000 for the semester; charge to allotment 45:21.

Adopted.

Upon motion of Regent Cleary, seconded by Regent Werner, recommendations 1 and 2 listed under Research were adopted.

- Gifts and Grants -

1. That the following gifts and grants be accepted:

- (a) \$ 12.00 - Central Little Sauk 4-H Club, Osakis, Minnesota, proceeds from a play given by the Club to be used for cancer research.
- (b) 4,500.00 - United States Maltsters Association, Chicago, Illinois, for the continuation of an industrial fellowship in the Departments of Agronomy and Plant Pathology for 12 months, beginning September 1, 1945, to study the quality of barley for malting purposes; and that the Director of Business and Finance be authorized to sign the agreement.
- (c) 1,400.00 - annually for a five-year period, September 1, 1945 to August 31, 1950, from Standard Brands, Inc., New York City, for the establishment of a graduate fellowship in biochemistry, the purpose of the fellowship to be to encourage outstanding young men to secure training, especially in the field of fermentation biochemistry; and that the Director of Business and Finance be authorized to sign the agreement.
- (d) 1,200.00 - annually for a three-year period, beginning November 1, 1945, from the Pabst Brewing Company, for the establishment of an industrial fellowship in agricultural bacteriology, to study amyloitic enzyme production by micro-organisms; and that the Director of Business and Finance be authorized to sign the agreement.
- (e) 1,000.00 - Holton & Hunkel Greenhouse Company, for the continuation of an industrial fellowship in horticulture, established August 1, 1944, to study the factors involved in the initiation and development of flowering buds of azalea, gardenia and similar greenhouse plants; and that the Director of Business and Finance be authorized to sign the agreement.
- (f) 3,733.33 - Aeration Processes, Inc., Columbus, Ohio, for the continuation of an industrial fellowship in dairy industry, to study the factors affecting the adsorption of substances on fat globules in dairy products, for the period October 1, 1945 to January 31, 1947; and that the Director of Business and Finance be authorized to sign the agreement.
- (g) 1,000.00 - Allied Chemical & Dye Corporation, New York City, for the renewal of the Allied Chemical & Dye Corporation Fellowship in chemistry for the academic year 1945-46.

(h) \$ 1,200.00 - Monsanto Chemical Company, St. Louis, Missouri, for renewal of an industrial fellowship in chemistry to study catalytic hydrogenation beginning with the second semester of 1945-46.

(i) 400.00 - American Foundation for Pharmaceutical Education, to be used to renew the "Pharmacy Foundation Scholarships" for the academic year 1945-46.

Upon motion of Regent Werner, seconded by Regent Kleczka, recommendation No. 1 (a) to (i), inclusive, listed under Gifts and Grants, was adopted.

(j) The mathematical library of Professor Edward B. Van Vleck to the Extension Division of the University at Milwaukee, Wisconsin.

Upon motion of Regent Grady, seconded by Regent Kleczka, recommendation No. 1 (j) listed under Gifts and Grants was adopted.

(k) \$ 200.00 - Miss Louise A. Green, Washington, D. C., to be used in a manner most useful to the University; credited to 15B.

Upon motion of Regent Grady, seconded by Regent Holmes, recommendation No. 1 (k) listed under Gifts and Grants was adopted.

Upon motion of Regent Cleary, seconded by Regent Callahan, it was VOTED, That resignations numbered 1 to 65, inclusive, listed under Actions by the President, be approved.

Upon motion of Regent Holmes, seconded by Regent Werner, it was VOTED, That appointments numbered 1 to 249, inclusive, listed under Actions by the President, be approved.

Upon motion of Regent Cleary, seconded by Regent Werner, it was VOTED, That salary and service adjustments numbered 1 to 25, inclusive, listed under Actions by the President, be approved.

Upon motion of Regent Holmes, seconded by Regent Grady, it was VOTED, That leaves of absence numbered 1 and 2, listed under Actions by the President, be approved.

The above actions of the President taken since the September 29, 1945, meeting of the Board and approved by the Regents in the foregoing resolutions are made a part of the records of this meeting.

Upon motion of Regent Grady, seconded by Regent Werner, it was VOTED, That authority be granted to the United States Armed Forces Institute to sell a small quantity of correspondence course materials which they have purchased for the University.

Director Peterson brought up the matter of the establishment of a Gage Laboratory in the College of Engineering and presented the following recommendations:

(1) That the offer of the Chief of Ordnance, United States Army, to transfer government equipment to the University for the establishment of an Ordnance Gage Laboratory be accepted and approved.

(2) That \$5000 be allotted from the appropriations made by 20.41 (1) (F) and 20.41 (1) (G) of the Statutes to remodel and equip laboratory space in the Mechanical Engineering Building for the Ordnance Gage Laboratory.

Upon motion of Regent Kleczka, seconded by Regent Campbell, the recommendations were adopted.

Director Peterson presented a report on Veterans' Housing and explained the need for additional housing. Upon motion of Regent Holmes, seconded by Regent Kleczka, it was

VOTED, That authority be granted to install additional trailers on the campus, the location to be determined after further study, and the financial arrangements to be worked out by the administration in consultation with the Finance Committee of the Board.

Upon motion of Regent Werner, seconded by Regent Kleczka, it was VOTED, That the administration be authorized to complete arrangements for the use of Badger Village houses by veterans attending the University and to make arrangements to secure Government buses on a lend-lease basis to provide the necessary transportation; and that the idea of moving such houses to Madison be abandoned.

Director Peterson reported that an opinion was received from the Attorney General, copies of which have been sent to the Regents, holding that it was not illegal to charge nonresident tuition for Wisconsin students registered under the GI Bill of Rights.

The Director of Business and Finance explained the petitions received from University artisans regarding vacation pay for those in the skilled trades employed on the prevailing wage rate. Upon motion of Regent Grady, seconded by Regent Cleary, it was

VOTED, That the Director of Business and Finance request an opinion from the Attorney General as to the rights and duties of the Regents in the situation in view of the rules of the Bureau of Personnel and the existing statutes.

President Fred distributed the 1944-45 report to the Wisconsin Alumni Research Foundation Trustees on research. (Copy on file)

President Fred presented the report of the 1945 summer semester and eight-week summer session. Upon motion of Regent Holmes, seconded by Regent Kleczka, it was

VOTED, That the report be approved. (Copy of report on file)

Upon recommendation of the President, and upon motion of Regent Cleary, seconded by Regent Holmes, it was

VOTED, That subject to approval by the Faculty, the Regents authorize the administration to proceed with plans for an eight-week summer session and a fifteen-week summer semester for 1946 at an estimated cost of \$100,000 in addition to fee receipts.

Upon recommendation of President Fred, and upon motion of Regent Kleczka, seconded by Regent Cleary, it was

VOTED to approve reactivation of advanced R.O.T.C.

Upon recommendation of President Fred, and upon motion of Regent Holmes, seconded by Regent Kleczka, it was

VOTED to provide equipment for 117 Chemistry Building at an estimated cost of \$25,500 - equipment \$20,500, installation \$5000, to be charged to the appropriation of \$300,000, 20.41 (1) G.

Upon recommendation of President Fred, and upon motion of Regent Cleary, seconded by Regent Jones, it was

VOTED to build an underground addition to Sterling Hall, approximately 56½' x 27½' x 17' high, to be charged to 20.41 (1) D, Regents' Unassigned.
at an estimated cost of \$20,000, (amended 12-1-45)

Upon recommendation of President Fred, and upon motion of Regent Jones, seconded by Regent Campbell, it was

VOTED, That the salary of Floyd W. Duffee, professor of agricultural engineering, be increased from \$5500 to \$6250, effective November 12, 1945.

Upon recommendation of President Fred, and upon motion of Regent Cleary, seconded by Regent Kleczka, it was

VOTED to authorize the appointment of an additional associate professor of mathematics for the second semester of 1945-46, at a salary of \$4250 per annum.

Upon recommendation of President Fred, and upon motion of Regent Kleczka, seconded by Regent Campbell, it was

VOTED, That Professor William B. Sarles be appointed Assistant to the President on a half-time basis, beginning November 5, 1945, and a full-time basis in the summer, his total salary to be as follows:

Half time, Agricultural Bacteriology, academic year	\$2100.00
Half time, Assistant to the President, " "	2100.00
Full time, Administrative work, during the summer	1400.00
Total	\$5600.00.

Upon recommendation of President Fred, and upon motion of Regent Warner, seconded by Regent Callahan, it was

VOTED, That Oliver S. Rundell be appointed Dean of the Law School at a salary of \$9000 per annum, twelve months' basis, effective November 1, 1945.

President Fred made a verbal report on the present enrollment at the University, stating that there were 2940 men enrolled and 5324 women, a total of 8264; that the increase over September 1944 was 35% and that 775 of the students registered are veterans.

Regent Jones presented the recommendations of the Constructional Development Committee:

1. That the project of fireproofing and remodeling the corridors and hallways in Bascom Hall be approved and that the plans be put in final form.

Upon motion of Regent Jones, seconded by Regent Cleary, adopted.

2. That the project of building a wing on the west end of the Biology Building and making necessary alterations in the present building be approved.

Upon motion of Regent Jones, seconded by Regent Campbell, adopted.

3. That the project of building a wing on the west end of the Home Economics Building and making necessary alterations in the present building be approved.

Upon motion of Regent Jones, seconded by Regent Cleary, adopted.

4. (a) That the Regents reconsider the action of September 27, 1941, approving a location for the Short Course Dormitory east of the Stock Pavilion.

Upon motion of Regent Jones, seconded by Regent Callahan, adopted.

(b) That Babcock Drive be relocated to extend approximately due south from its present north end and that Observatory Drive be extended westerly from its present location in front of King Hall to its intersection with relocated Babcock Drive.

Upon motion of Regent Jones, seconded by Regent Callahan, adopted.

4. (c) That the location of the proposed Short Course Dormitories and Forum Hall in the general area west of Agricultural Hall and bounded on the north by relocated Observatory Drive, on the west by relocated Babcock Drive, and on the south by the line established by the front of Agricultural Hall be approved.

Action deferred.

(d) That the building of a Short Course Dormitory to be located in this area be approved. Regent Jones voted "No".

Action deferred.

Upon motion of Regent Grady, seconded by Regent Kleczka, it was VOTED, That action on Recommendation No. 4 (c) and (d) be deferred until the next meeting of the Board.

5. That the project for the construction of the Dairy Building be approved and that it be located in the general area bounded by Linden Drive on the north, relocated Babcock Drive on the east, the Milwaukee Railroad on the south, and the general area of the Stock Pavilion on the west.

Upon motion of Regent Jones, seconded by Regent Holmes, adopted.

6. That approval be given to the project for the construction of dormitories for men to the extent of 650 men and dormitories for women to the extent of 400 women, subject to suitable financial arrangements being made without subsidy from the postwar construction fund.

Upon motion of Regent Jones, seconded by Regent Callahan, adopted.

7. That the project for the development of a permanent type of housing for married veterans be placed on the priority list for an allotment of not to exceed \$300,000 from the postwar construction fund if no other method of subsidy financing is available.

Upon motion of Regent Jones, seconded by Regent Campbell, adopted.

REQUIREMENTS OF THE COURSE LEADING TO THE DEGREE OF BACHELOR OF SCIENCE
(PHYSICAL MEDICINE)

The Faculty of the College of Letters and Science recommends that a course leading to the degree of Bachelor of Science (Physical Medicine) be established in the College of Letters and Science and in the Medical School. The requirements for graduation are to be as follows:

A total of 124 credits and at least 124 grade-points.

English: 12 credits; or English, 6 credits, and History, 6 credits.

Science: 39 credits to include at least one course in each of the following subjects: General chemistry, physics, zoology, anatomy, physiology, physiological chemistry, kinesiology.

Psychology: 10 credits.

One of the following:

(a) Foreign language, 14 credits (to be earned in college) not more than 8 of which may be in a first-year college course; or intermediate knowledge in one foreign language, as disclosed by an attainment examination.

(b) Social Sciences - Economics, Cultural Geography, History, Philosophy, Political Science, Sociology and Anthropology, (as listed in foot-note, p.47, bulletin 1942-44), 14 credits.

Speech: 6 credits.

Home Economics 119 (or its equivalent): 2 credits

Physical therapy: Theoretical and technical training, 30 credits in the senior year, to include courses in applied anatomy, pathology, medical sciences, massage, therapeutic exercise, electrotherapy, hydrotherapy, ethics and administration, bandaging and asepsis, research technique and clinical practice. (Course as specified for the Certificate in Physical Medicine in the Medical School.)

Electives: 11 credits.

The senior year is a 12-month year, the last three months being spent full time in the treatment of patients.
