- (e) 10,500.00 - Nutrition Foundation, Inc., New York City, for the renewal of a research fellowship for a study of the relation of nutrition to dental caries in the monkey, for a three-year period, July 1, 1948 to June 30, 1951, in the Department of Biochemistry. *Agreement*
- (f) 6,300.00 - Nepco Foundation, Port Edwards, Wisconsin, for the establishment of an industrial fellowship for a study of insect control in stored pulpwood, and prevention of damage to adjacent timber from beetles emerging from such piles, for the period April 1, 1948 to March 31, 1951, in the Department of Economic Entomology. *Agreement*
- (g) 3,600.00 - Chas. Pfizer & Co., Inc., Brooklyn, New York, for the establishment of an industrial fellowship for the study of production of new antibiotics on pilot plant scale, for the period April 1, 1948 to March 31, 1949, in the Department of Biochemistry. *Agreement*
- (h) 1,250.00 - The California Company of New Orleans, Louisiana, for the establishment of a graduate fellowship in the Geology Department during the 1948-49 fiscal year for research in petroleum geology. (In addition, the California Company agrees to pay tuition in the amount of \$120 for the academic year if the student to whom the fellowship is awarded does not have his tuition paid because of former military service.) *Agreement*
- (i) 3,600.00 - Cutter Laboratories, Berkeley, California, for the establishment of an industrial fellowship in the Departments of Agricultural Bacteriology, Biochemistry, and Botany (College of Letters and Science), for a study of factors affecting the production of penicillin by molds, during the period July 1, 1948 to June 30, 1949. *Agreement*

- ✓ (k) 6,500.00 - American Iron and Steel Institute, New York City, for research during the period May 1, 1948 to April 30, 1950, on the plastic flow of reinforced concrete; the research to be under the administration of the Engineering Experiment Station and conducted in the materials laboratories of the Department of Mechanics. *Agreement*
- ✓ (l) 30,000.00 - Carnegie Corporation of New York, \$10,000 payable annually for three years beginning 1947-48, for support of studies of the law in action.
- (m) 500.00 - Wisconsin Fur Breeders Association, Green Bay, Wisconsin, for the continuation until December 31, 1948, of a research fellowship, established February 1, 1947, in the Department of Veterinary Science, for studies to improve methods of fur farming. *Agreement*
- (n) 750.00 - Sherwin-Williams Company, Cleveland, Ohio, and the Acme White Lead and Color Works, Detroit, Michigan, for the renewal of an industrial fellowship in the Department of Agronomy, for a study of the use of 2,4-D as a weed killer, for the period May 1 to December 31, 1948. *Agreement*
- (o) 3,600.00 - National Cheese Institute, Inc., Chicago, Illinois, on behalf of the American Dairy Association, for the establishment of an industrial fellowship in the Department of Dairy Industry to study the physical and biochemical changes of fats and proteins during aging of cheese, for the period July 1, 1948 to June 30, 1949. *Agreement*
- (p) 2,500.00 - The Borden Company Foundation, Inc., New York City, for the continuation of the Borden Undergraduate Research Award in Medicine, to be awarded annually to the senior student in Medicine who has carried out the most meritorious project in research while enrolled in the Medical School; the awards to be made on the basis of the provisions contained in the letter-agreement dated May 29, 1945, covering the previous grant. *Agreement*
- (q) 1,420.00 - Standard Oil Company of California, San Francisco, California, for the establishment of a research fellowship in chemical engineering during the period July 1, 1948 to June 30, 1949, which will have for its purpose a study of problems in reaction kinetics dealing with the regeneration of catalysts and formulation of the operating variables involved therein. (\$1250 is fellowship stipend, and \$170 covers fees.) *Agreement*

- (r) \$ 4,500.00 - The Jane Coffin Childs Memorial Fund for Medical Research, New Haven, Connecticut, for support of investigations on the metabolism of carcinogenic azo dyes and the effect of chemical structure on their activity, in the department of cancer research during the three-year period beginning July 1, 1948, and ending June 30, 1951, at a rate not to exceed \$1500 a year, in accordance with the provisions contained in the donor's letter dated May 15, 1948. *Letter in Gift File*

REPORT OF THE DIRECTOR OF BUSINESS AND FINANCE

I. Report of Actions Taken

1. In accordance with authority granted by the Regents on September 27, 1947, for the Director of Business and Finance to sign contracts and leases not in excess of \$2500, the following contracts, leases and orders have been signed:

- (a) Lease, Grant Newby, Plover, Wisconsin, for the use of twenty acres of pasture land adjacent to the Coddington Experiment Station during the period June 1, 1948 to November 30, 1948, at a total rental of \$ 40.00
- (b) Contract, Spooner Electric Service, Spooner, Wisconsin, for materials and labor to install electrical work in the machine shed at the University Experiment Farm, Spooner, Wisconsin 495.00
- (c) Contract, Raymond Concrete Pile Company, for making test borings on the sites of proposed new buildings at the University of Wisconsin, not to exceed 2000.00
- (d) Contract, Perkins Sheet Metal Company, Madison, Wisconsin, for materials and labor for furnace modifications at 935 University Avenue 431.00
- (e) Contract, Parkinson Construction Company, Milwaukee, Wisconsin, for labor and materials for repairs to black-top walks and drives, building retaining wall, and repair of steps at Milwaukee Extension Center 1000.00
- (f) Contract, Cirves Electric Company, Madison, Wisconsin, for labor and materials for electric wiring and labor to install fixtures in Rooms 135 and 185, Chemistry Building 1893.00
- (g) Lease No. VA7b(RE)-92, Veterans Administration, covering the subleasing of space at 432 State Street, Madison, Wisconsin, for the period ^{beginning} May 5, 1948, used by the University for Veterans Testing and Counselling Center operated under contract with the Veterans Administration, monthly rental 115.73

- (h) Marathon County Board for light, heat and janitor service in Marathon County Normal School Building and Marathon County Youth Buildings for the month of April, 1948, occupied by the University Extension Center \$ 250.00
- (i) Use of Memorial Hall, Racine, Wisconsin, by the University of Wisconsin Extension Division for a school dance on April 30, 1948 85.00
- (j) Use of Woman's Club Building at Racine, Wisconsin, by the University Extension Division for Pro Arte concert on April 16, 1948 35.00
- (k) City of Racine for use of high school gymnasias for practice and games from January 6, 1948 to March 17, 1948 345.00
- (l) Use of Green Bay YMCA gymnasium by University Extension Division from December 15, 1947 to March 13, 1948 60.00.

2. In accordance with authority granted by the Regents for the Director of Business and Finance to sign contracts and agreements for educational services requested by the Government, supplements have been signed to Veterans Administration Contracts No. VA30r vr-286 and No. VA30r ve-200 to provide for the addition of two courses to each of these contracts which provide for the furnishing by the University of Wisconsin Extension Division of educational and training to veterans enrolled under Public Law 346 and for vocational rehabilitation training for veterans enrolled under Public Law 16, respectively.

Approved.

Upon motion of Regent Gelatt, seconded by Regent Campbell, actions 1 and 2 listed under the report of the Director of Business and Finance (I. Report of Actions Taken) were approved.

Upon recommendation of the Director of Business and Finance, and upon motion of Regent Arveson, seconded by Regent Kleczka, it was

VOTED, That the President of the University and the Director of Business and Finance be authorized to make budget transfers and adjustments within the totals of the approved 1947-48 budget necessary to complete the business of the University for the fiscal year ending June 30, 1948.

The Director of Business and Finance reported that a Navy contract had been received covering research work in astronomy. Upon motion of Regent Werner, seconded by Regent Callahan, it was

VOTED, That Office of Naval Research Contract No. N8onr-575, covering research in astronomy during the period June 15, 1948 to June 14, 1949, under which the Navy is to provide \$3636 for this work, be approved, and that the Director of Business and Finance be authorized to sign the contract.

Regent Werner presented the report of the Finance Committee. Upon motion of Regent Werner, seconded by Regent Kleczka, it was

VOTED, That the administrative officers be authorized to complete the details of the 1948-49 budget in accordance with the schedules presented to the Finance Committee and as amended by the Finance Committee at its meeting May 27, 1948 (which was attended by other members of the Board), and that the budget be presented to the Regents for formal adoption at the June meeting.

Upon motion of Regent Werner, seconded by Regent Gelatt, it was

VOTED, That \$50,000 be allotted from the I-E general operation revolving fund to the Wisconsin Press to provide working capital for the printing of books and other scholarly documents approved by the University Press Committee including special Centennial publications.

Upon motion of Regent Werner, seconded by Regent Callahan, it was

VOTED, That, effective June 1, 1948, the minimum daily rate for private and special rate patients in the Wisconsin General and Orthopedic Hospitals be increased from \$10.50 to \$12.50;

That the Emergency Board be requested to increase the daily rates for public patients, effective June 1, 1948, as follows:

Wisconsin General Hospital from \$9.00 to \$11.00
Orthopedic Hospital from \$6.50 to \$ 8.00; and

That the Emergency Board be requested to transfer \$75,000 from the contingency appropriation made in section 20.415 (3) to the appropriation made in section 20.41 (10) (A) to cover the estimated accumulated loss in hospital operations to June 1, 1948.

Upon motion of Regent Werner, seconded by Regent Kleczka, it was

VOTED, That, at the suggestion of the Emergency Board, the Regents authorize and request the Emergency Board to transfer \$62,518 from the appropriation made in Section 20.415 (3) to the appropriate appropriation accounts to cover the cost of the \$10.00 emergency step increase for civil service employees for the months of October, 1947 through March, 1948, and that \$45,876 be transferred from 20.415 (3) to the appropriate appropriation accounts to cover the cost of the October emergency step increase and the new civil service compensation plan for the period April 1, 1948 through June 30, 1948.

Upon motion of Regent Werner, seconded by Regent Callahan, it was

VOTED, That an increase from \$55,000 to \$61,700 be approved in the budget for Supplies and Expense, Fund 20, University Extension, Lectures, for the year 1947-48.

Upon motion of Regent Werner, seconded by Regent Kleczka, it was

VOTED, That the authority granted by the Regents on September 27, 1947, and by the Executive Committee on May 6, 1948, for the financing and construction of the Enzyme Laboratory Building be amended to further provide:

- (a) That the Wisconsin University Building Corporation be authorized to borrow an additional \$50,000 (Total \$350,000) from the Wisconsin Alumni Research Foundation for the construction and equipment of the Enzyme Laboratory Building;
- (b) That the President and Secretary be authorized to sign such amendments to the memorandum agreement with the Wisconsin Alumni Research Foundation and to the leases with the Wisconsin University Building Corporation as are necessary on account of the inclusion of equipment costs and the increase in the funds to be borrowed for this project;
- (c) That the Wisconsin University Building Corporation be authorized to award the contract for the elevator in the Enzyme Laboratory Building to the S. Heller Elevator Company, Milwaukee, Wisconsin, on the basis of their low bid in the amount of \$10,608; and
- (d) That the following revised schedule of costs for construction and equipment of the Enzyme Laboratory Building and the Addition to the Naval Armory Heating Plant (required for the Enzyme Laboratory Building project) be approved:

REPORT OF THE COMMITTEE ON THE TRAINING OF TEACHERS IN BUSINESS EDUCATION
(As approved by the School of Education Faculty April 12, 1948)

The School of Education Committee on the Training of Teachers in Business Education recommends that:

1. A program in secretarial subjects be added as soon as possible to the offerings now available for prospective business-education teachers at the University of Wisconsin.
2. The secretarial subjects be within the joint program of the School of Education and the School of Commerce for the training of business-education teachers.
3. The program in secretarial training shall consist of 18 credits* in the total program of 130 credits required for graduation. The 18 credits to be distributed in the following courses:

*Beginning Typewriting	2 credits
*Advanced Typewriting	2 credits
*Fundamentals of Shorthand	4 credits
*Advanced Shorthand Dictation	4 credits
Secretarial Technique	3 credits
Office Procedures	<u>3 credits</u>
TOTAL	18 credits

*Students will be exempted from the courses in typewriting and/or shorthand if proficiency is shown by attainment examinations. If the student is exempted from any course (or courses) in typewriting and/or shorthand, he shall select an equivalent number of elective credits.

The first course in typewriting and/or the first course in shorthand shall be taken without credit by those students who have had MORE than one year in high-school typewriting and/or shorthand and who do not meet proficiency standards as determined by attainment examinations.

Registration for credit in these courses is limited to students enrolled in the Secretarial Science Program.
