ANNUAL MEETING OF THE BOARD OF REGENTS

Madison, Wisconsin

Friday, May 24, 1946, 9 A.M.

President Sensenbrenner presiding

PRESENT: Regents Callahan, Campbell, Cleary, Grady, Holmes, Kleczka, Sensenbrenner, Werner

ABSENT: Regents Hodgkins, Jones

Regent Hodgkins was prevented from attending the meeting because of the railroad and coal strikes; Mr. Jones had to be in St. Paul because of a previous engagement.

Upon motion of Regent Werner, seconded by Regent Cleary, it was
VOTED, That the minutes of the special meeting of the Board held on May 4, 1946, be approved as sent out to the Regents.

The Regents then proceeded to the election of officers. Upon motion of Regent Werner, seconded by Regent Cleary, it was
VOTED, That the Secretary be instructed to cast a unanimous ballot for Regent F. J. Sensenbrenner for the office of President. The ballot was cast and Regent Sensenbrenner was declared elected President for the ensuing year.

Upon motion of Regent Kleczka, seconded by Regent Grady, it was
VOTED, That the Secretary cast a unanimous ballot for Regent Arthur T. Holmes for the office of Vice President. The ballot was cast and Regent Holmes was declared elected Vice President for the ensuing year.

The matter of the election of the Secretary of the Regents was discussed, and Regent Cleary stated that the present secretary, M. E. McCaffrey, had requested that inasmuch as he had reached retirement age he be relieved of his duties as Secretary. Regent Cleary further stated that an agreement had been made with Mr. McCaffrey to continue as Trust Officer and as a member of the business office staff to negotiate for the purchase of land and property and that provision for this appointment would be made in the budget for 1946-47. Upon motion of Regent Cleary, seconded by Regent Kleczka, it was

VOTED, That this arrangement be approved, effective July 1, 1946.

Upon motion of Regent Cleary, seconded by Regent Callahan, it was
VOTED, That the Secretary cast a unanimous ballot for A. W. Peterson for the office of Secretary of the Regents. The ballot was cast, and Mr. Peterson was declared elected Secretary for the ensuing year, effective July 1, 1946.

Upon motion of Regent Cleary, seconded by Regent Callahan, it was
VOTED, That the office of Assistant Secretary be created and that Clarke Smith be elected Assistant Secretary for the ensuing year, effective July 1, 1946. A further statement of Mr. Smith's duties and responsibilities will be presented to the Board for approval at the June meeting of the Board.

RECOMMENDATIONS OF THE PRESIDENT

- Appointments -

1. That LeRoy E. Luberg be appointed Assistant to the President (full time), beginning September 1, 1946; salary \$5,000 per annum; charge to item for Assistant to the President in the 1946-47 budget.

Upon motion of Regent Kleczka, seconded by Regent Callahan, recommendation No. 1 listed under Appointments was adopted.

2. That B. D. Leith, Professor of Agronomy, be employed under special contract to devote full time to the management of the University Hill Farms and the production, processing and distribution of foundation seed stocks for the period July 1, 1946 to December 31, 1946; salary \$2,400 for the period; charge to the 1946-47 budget.

Upon motion of Regent Holmes, seconded by Regent Grady, recommendation No. 2 listed under Appointments was adopted.

3. That Alden W. White be appointed Secretary of the Faculty as of July 1, 1946.

Upon motion of Regent Cleary, seconded by Regent Kleczka, recommendation No. 3 listed under Appointments was adopted.

- Faculty Actions -

1. That the following actions of the Faculty be approved:

- (1) Recommendation of the Faculty of the School of Education for a revision of the requirements in the general or nonprofessional and nonspecialized courses for teachers. Document 764, attached.

Upon motion of Regent Cleary, seconded by Regent Kleczka, recommendation No. 1 (1) listed under Faculty Actions was adopted.

- (2) Recommendation of the Graduate School and other schools and colleges concerned as follows:

That the plan under which a student (under prescribed conditions) may, at the end of the seventh semester, be admitted to the Graduate School, and at the end of the eighth semester receive both a baccalaureate degree and the degree of M.A. be rescinded as of June 1946, with permission, however, for students admitted to the privileges of the plan before the date mentioned to complete their work in accordance with it if they so desire.

Upon motion of Regent Werner, seconded by Regent Holmes, recommendation No. 1 (2) listed under Faculty Actions was adopted.

- Salary and Service Adjustments -

1. That the appointment of Oliver S. Rundell, Dean of the Law School and Professor of Law, be extended to include the month of June 1946; salary \$833.33 for the charge to balances in the Law School budget.

Upon motion of Regent Cleary, seconded by Regent Grady, recommendation listed under Salary and Service Adjustments was adopted.

2. That J. Homer Herriott, Associate Dean of the Graduate School, be placed on full time basis from May 26 to June 30, 1946; salary \$666.67 for the period; charge to Regents' Unassigned.

Upon motion of Regent Kleczka, seconded by Regent Callahan, recommendation listed under Salary and Service Adjustments was adopted.

- Resignations -

1. That the resignation of William B. Sarles, Assistant to the President, be accepted; to take effect September 1, 1946. (Dr. Sarles will resume his duties as Professor of Agricultural Bacteriology on full time basis.)

Upon motion of Regent Cleary, seconded by Regent Holmes, recommendation No. 1 listed under Resignations was adopted.

2. That the resignation of James M. Dorrans, Associate Professor of Mining and Metallurgy, be accepted; to take effect May 22, 1946.

Upon motion of Regent Werner, seconded by Regent Holmes, recommendation No. 2 listed under Resignations was adopted.

3. That the resignation of Lewis H. Kessler, Professor of Civil Engineering, be accepted; to take effect June 28, 1946.

Upon motion of Regent Cleary, seconded by Regent Callahan, recommendation No. 3 listed under Resignations was adopted.

- Short Courses -

1. That a special short course in artificial breeding of dairy cattle be held at the College of Agriculture; that a registration fee of \$15 per person be charged; that receipts be budgeted as follows: Receipts: 30 Registrations @ \$15, \$450; Disbursements: Supplies \$375, Labor \$75 - Total \$450.

Upon motion of Regent Werner, seconded by Regent Grady, recommendation No. 1 listed under Short Courses was adopted.

- Degrees -

1. That degrees and certificates be granted and graduate fellows and scholars appointed as shown in the Commencement Register for 1946.

Upon motion of Regent Kleczka, seconded by Regent Cleary, recommendation No. 1 listed under Degrees was adopted.

- Gifts and Grants -

1. That the following gifts and grants be accepted:

(a) \$ 1,250 - Commercial Solvents Corporation, Terre Haute, Indiana, for the renewal of a research fellowship in the Department of Biochemistry to study the importance of biotin, folic acid and related compounds in poultry nutrition, for 12 months, beginning July 1, 1946; and that the Director of Business and Finance be authorized to sign the agreement.

(b) 2,800 - Research Corporation, New York City; for the establishment of a research fellowship in the Department of Biochemistry, to study the nutritional factors involved in growth and metabolism, during the period July 1, 1946, to June 30, 1948; and that the Director of Business and Finance be authorized to sign the agreement.

Upon motion of Regent Werner, seconded by Regent Kleczka, recommendation No. 1 (a) and (b) listed under Gifts and Grants was adopted.

Upon motion of Regent Cleary, seconded by Regent Werner, it was
VOTED, That resignations numbered 1 to 18, inclusive, listed under Actions
by the President, be approved.

Upon motion of Regent Kleczka, seconded by Regent Werner, it was
VOTED, That appointments numbered 1 to 60, inclusive, listed under Actions
by the President, be approved.

Upon motion of Regent Holmes, seconded by Regent Callahan, it was
VOTED, That salary and service adjustments numbered 1 to 18, inclusive,
listed under Actions by the President, be approved.

Upon motion of Regent Cleary, seconded by Regent Kleczka, it was
VOTED, That promotions numbered 1, listed under Actions by the President,
be approved.

Upon motion of Regent Werner, seconded by Regent Callahan, it was
VOTED, That leaves of absence numbered 1, listed under Actions by the
President, be approved.

ADDITIONAL ACTIONS BY THE PRESIDENT

Since the May 4, 1946, Meeting
of the Board of Regents (Copy attached)

Upon motion of Regent Cleary, seconded by Regent Werner, it was
VOTED, That resignations numbered 1 to 10, inclusive, listed under Additional
Actions by the President, be approved.

Upon motion of Regent Kleczka, seconded by Regent Callahan, it was
VOTED, That appointments numbered 1 to 64, inclusive, listed under Additional
Actions by the President, be approved.

Upon motion of Regent Kleczka, seconded by Regent Callahan, it was
VOTED, That salary and service adjustments numbered 1 to 13, inclusive,
listed under Additional Actions by the President, be approved.

The above actions by the President taken since the May 4, 1946, meeting of
the Board and approved by the Regents in the foregoing resolutions are made a part
of the records of this meeting.

Mr. LeRoy E. Luberg, the newly appointed Assistant to the President of the
University, was called in and addressed the Regents.

The Director of Business and Finance reported that copies of the communications received from Dr. W. F. Lorenz, the State Board of Health and the State Department of Public Welfare, and a Committee of the College of Agriculture in regard to the proposed acquisition by the State of Badger Ordnance Works had been sent to all Regents. He stated that it was his understanding that the Board would like to indicate their desire to cooperate with the other state departments for use of the Badger Ordnance property for educational purposes insofar as it will be available for those purposes. Upon motion of Regent Cleary, seconded by Regent Kleczka, it was
VOTED, That the proper officers of the University be authorized to join
with the State Board of Health and the State Department of Public Welfare in requesting the Governor's approval of the application for the acquisition of this property by the State.

VOTED, That the Wisconsin University Building Corporation be authorized
to proceed with contracts for the construction of up to forty houses for veterans
who are members of the faculty and staff at an estimated cost of not to exceed \$7500
per unit.

President Fred reported upon his request to the State Planning Board to
make a restudy of the Campus, including the proposed expansion south of University
Avenue. Upon motion of Regent Grady, seconded by Regent Werner, it was

VOTED, That the action of the President be approved.

The matter of acquiring property in the area south of University Avenue
was discussed, and upon motion of Regent Cleary, seconded by Regent Callahan, it was

VOTED, That the administrative officers and the Constructional Development
Committee be authorized to proceed with negotiations for the purchase of properties
which are offered for sale but that no properties be purchased without approval of
the Board.

Regent Campbell presented the following recommendations of the Construc-
tional Development Committee for approval:

1. That the erection of a temporary structure for library reading room facilities
on the Lower Campus just east of the flag pole to the east of the State Historical
Library be approved, said structure to be approximately forty feet wide and to extend
240 feet from north to south, with a covered passageway connecting to the State
Historical Library, all as approved by the State Historical Association.

Upon motion of Regent Cleary, seconded by Regent Callahan, adopted.

2. That the Regents approve the temporary allocation for physical education and
intramural purposes, for both men and women, of the field now being used by the Col-
lege of Agriculture as a horse pasture, approximately 6.8 acres in area, bounded on
the north by the present intramural field, on the east by Elm Drive, and on the sout
and west by wire fences, in accordance with the joint recommendation of the Direc-
tors of Physical Education for Men, Physical Education for Women, the Professional
Course in Physical Education, and Intercollegiate Athletics; it being understood
that the three trees near the southeast corner of the field are to be removed, that
the field be mowed, and that such minor grading and seeding be done as are found
essential for the use of the field in the fall of 1946.

Upon motion of Regent Kleczka, seconded by Regent Cleary, adopted.

3. That the location of the addition to Sterling Hall for a laboratory for nuclear
physics, as shown on the State Architect's sketch, be approved.

Upon motion of Regent Cleary, seconded by Regent Callahan, adopted.

4. That the Steering and Master Plan Committee of the University Campus Planning
Commission be given authority, following further study of methods of securing
emergency classroom and office space, to report to the Constructional Development
Committee when it has found the best solution to a problem, the Constructional
Development Committee to have power to act.

Upon motion of Regent Kleczka, seconded by Regent Cleary, adopted.

5. That J. G. Woodburn be retained as Executive Secretary of the University Campus Planning Commission for the period of $1\frac{1}{2}$ months beginning July 1, 1946.

Upon motion of Regent Werner, seconded by Regent Kleczka, adopted.

President Fred recommended the appointment of the following members of the Athletic Board for 1946-47:

Dr. W. F. Lorenz, Chairman (continuing)
Prof. R. V. Campbell "
Prof. M. H. Willing "
Prof. W. B. Sarles (to replace Prof. Emil Truog).

Upon motion of Regent Kleczka, seconded by Regent Callahan, the recommendation was adopted.

At the request of Dean Ingraham, President Fred recommended that the Department of Sociology, Anthropology, and Social Work be divided into two departments to be known as (1) the Department of Sociology and Anthropology and (2) the Department of Social Work. Upon motion of Regent Cleary, seconded by Regent Kleczka, the recommendation was adopted.

RECOMMENDATIONS OF THE DIRECTOR OF BUSINESS AND FINANCE

1. That the supplies and expense budget of the 5-E Theater revolving fund be increased by \$4,000 on account of additional expenses incurred in theater productions, chargeable to additional receipts realized.

Adopted.

2. That the Director of Business and Finance be authorized to sign a contract with the War Department for the loan of gage laboratory equipment to the University and the establishment of a gage laboratory at the University. (The offer of the Government to transfer this equipment to the University for the establishment of an Ordnance Gage Laboratory was accepted by the Regents on October 27, 1945.)

Adopted.

3. That the Director of Business and Finance be authorized to sign an agreement with the War Department for the loan of equipment to the University for astronomical research purposes.

Adopted.

4. That authority be granted to transfer \$5,000 from Fund 3-K to Fund 11 Revolving Fund Surpluses to supplement the transfer of \$10,000 authorized by the Regents on March 9, 1946, for the purchase and erection of two steel storage sheds for seed grain stocks at the West Hill Farm.

Adopted.

5. That the following schedule of costs for the seed grain storage project on the West Hill Farm be approved (Chargeable to Fund 11 Revolving Fund Surpluses):

Adopted.

6. That the contract for the construction of foundation walls and floors for the steel grain storage buildings on the West Hill Farm be awarded, in the amount of \$3,975.00, to Hans Spartveidt, Madison, Wisconsin, and that the Director of Business and Finance be authorized to sign the contract.

Adopted.

Upon motion of Regent Werner, seconded by Regent Kleczka, recommendations 1 to 6, inclusive, listed under the recommendations of the Director of Business and Finance were adopted.

The matter of the purchase of the Charmany Dairy Farm, consisting of approximately 217 acres with improvements, was discussed. It was understood that the consideration would be \$56,000, the machinery would cost \$8,130, and the one-year lease of \$500 on the Barnes farm would be assumed by the University, the crop land to be taken over now and the buildings and pasture land on August 5, 1946. Upon motion of Regent Grady, seconded by Regent Werner, it was

VOTED, That this matter be referred to the Finance Committee with power to act. (NOTE: The Finance Committee met after the Board adjourned and approved the purchase by the Wisconsin University Building Corporation of the Charmany Dairy Farm, subject to a favorable report on the price after Regent Cleary had checked the records on this property in the files of the Northwestern Mutual Life Insurance Company. Mr. Cleary subsequently reported that the price of \$56,000 is satisfactory.)

Upon recommendation of the Director of Business and Finance and upon motion of Regent Holmes, seconded by Regent Callahan, it was

VOTED, That the uncommitted balance in the 1-D allotment made by the Regents on December 1, 1945, for the construction of a basement addition to Sterling Hall to provide a research laboratory for nuclear physics, be transferred to Regents' Unassigned and that the President and the Director of Business and Finance be authorized to allot this money for the purchase of necessary capital equipment, with the understanding that funds for the nuclear physics laboratory will be provided from available funds after July 1, 1946.

The Director of Business and Finance reported that the project of renting space in the Pereles Building in Milwaukee has been dropped and that the College of Agriculture has withdrawn its recommendation for rental of property from George T. Miller, of Antigo, Wisconsin.

The Director of Business and Finance discussed the matter of financing the proposed Quonset huts on the lower campus for temporary library space at an estimated cost of \$75,000. Upon motion of Regent Cleary, seconded by Regent Kleczka, it was

VOTED, That the \$47,669 of forfeited library deposits in 20.41(1)(E) be transferred to 20.41(11) and that any additional amounts needed be transferred from the General Library Building Reserve, in which there is a balance of approximately \$165,000, to 20.41(11) Revolving Fund Surpluses and appropriated for construction and equipment needed to provide temporary library space. Total not to exceed \$75,000.

Upon motion of Regent Grady, seconded by Regent Werner, it was

VOTED, That the Director of Business and Finance be authorized to sign applications to the Civilian Production Administration and the Federal Public Housing Authority, or other appropriate federal agency, for building permits and priority assistance in connection with University construction projects approved by the Regents.

The Director of Business and Finance reported that the University has received approval for acquiring additional housing units at Truax but that the Government will not pay for mess halls, kitchens, etc. The approval of additional housing provides for 1000 men. The estimated cost to be paid by the University is \$62,500. Upon motion of Regent Werner, seconded by Regent Cleary, it was

VOTED, That the Emergency Board be requested for an appropriation of \$62,500 for reactivating and converting the buildings and for the repair and purchase of equipment needed for veterans' housing at Truax.

Upon motion of Regent Cleary, seconded by Regent Kleczka, it was

VOTED, That in order to meet increases in costs, the Director of Business and Finance be directed to request the Emergency Board to increase the per diem charge for state and county patients in the Wisconsin General Hospital and Orthopedic Hospitals as follows:

and that the rate for special rate and private patients be increased from the present minimum of \$7.00 per day to \$8.50 per day, effective July 1, 1946.

Upon recommendation of the Director of Business and Finance, and upon motion of Regent Cleary, seconded by Regent Campbell, it was

VOTED, That the revised summer session budget, exclusive of the Engineering eight-weeks term, in the amount of \$403,483, be approved.

Upon recommendation of the Secretary and Trust Officer, and upon motion of Regent Kleczka, seconded by Regent Callahan, it was

VOTED, That a gift of \$5,000 from the University of Wisconsin Foundation, representing a contribution from the Wisconsin Educational Foundation, Inc., to the University of Wisconsin Foundation, be accepted for the establishment of the University of Wisconsin Foundation Scholarships. These scholarships are to be awarded upon recommendation of the special committee on scholarships, of which Frank O. Holt is chairman, and under the following provisions:

- (1) Scholarship: High school and test records must be predictive of successful work in the University.

- (2) Character and Leadership: High school principal's recommendation must be that character is exemplary and that leadership qualities are high.
- (3) Special abilities: High school career must give evidence that special ability, exercised on the campus, will redound to the advantages of the University.
- (4) Scholarship to be made available to either a boy or a girl.

Upon recommendation of the Secretary and Trust Officer, and upon motion of Regent Werner, seconded by Regent Callahan, the following resolution was adopted;

WHEREAS, the Wisconsin University Building Corporation received a conveyance by executor's deed to Lots 16, 17 and 18, Block 6, University Heights in the City of Madison, Dane County, Wisconsin, from the Central Wisconsin Trust Company and Harry L. Butler, executors of the will of John M. Olin, deceased, upon the express condition that the property so conveyed or an adequate portion thereof, or other property not comprised in the premises known as the homestead property of said John M. Olin, shall be used as a site for such garage as the Regents of the University of Wisconsin may now or hereafter maintain in connection with said homestead property of John M. Olin, said conveyance to the Wisconsin University Building Corporation being for the use and benefit of and for the ultimate acquisition of the Regents of the University of Wisconsin, and the said Regents having maintained a garage on Lot 18 aforesaid which is entirely adequate in connection with the above described homestead property of John M. Olin and for the occupants thereof,

NOW, THEREFORE, Be It Resolved by the Regents of the University of Wisconsin, that the sale and conveyance of Lots 16 and 17, Block 6, University Heights in the City of Madison, Dane County, Wisconsin, by the said Wisconsin University Building Corporation to J. S. Timlin and Mina L. Timlin, joint tenants, by deed dated April 11, 1929 and recorded May 17, 1929 in Vol. 332 of Deeds, page 396, instrument #503351 Dane County Registry as to said Lot 17, and by deed dated and recorded June 8, 1931 in Vol. 185 Deeds, page 231, instrument #528292 as to said Lot 16, be and the same is hereby in all respects confirmed.

Be It Further Resolved, that the Regents of the University of Wisconsin release and surrender all of their right, title and interest accruing to them under said deed from the executors of the will of John M. Olin, deceased, to the Wisconsin University Building Corporation recorded in Volume 278 of Deeds, page 547, Dane County Registry, and that pursuant hereto the President and Secretary of the Regents of the University of Wisconsin be and they are hereby authorized and directed on behalf of the Regents of the University of Wisconsin to execute a quit claim deed to the said premises to the said J. S. Timlin and Mina L. Timlin, joint tenants, or to the survivor of them, his or her heirs and assigns forever.

The Secretary and Trust Officer reported upon communications which had been received with reference to the acquisition of the balance of land held by the Lake Forest Company and others adjoining the Arboretum. Upon motion of Regent Grady, seconded by Regent Callahan, it was

VOTED, That this matter be referred to the Finance Committee.

Upon motion of Regent Cleary, seconded by Regent Callahan, it was
VOTED, That this meeting be adjourned subject to the call of the
President of the Regents.

At 10:30 A.M. the meeting adjourned.

SCHOOL OF EDUCATION REPORT ON THE TRAINING OF TEACHERS

The Faculty of the School of Education recommends that the present requirements in the general or non-professional and non-specialized education of prospective teachers be revised as follows:

- I. That the present Pre-Education Sequences be abolished.
- II. That the new curriculum requirements of Curriculum A (B.A. general course and B.S. general course), recently adopted by the College of Letters and Science, be adopted by the School of Education as setting the patterns for the Pre-Education programs of students entering the School of Education as Juniors or Seniors.
- III. (a) That a minimum of 40 semester hours of the general education requirements of Curriculum A be completed by the beginning of the Junior year or by such time thereafter as students may seek admission to the School of Education.
(b) That not less than 12 semester hours (or equivalent) of English be completed before graduation.
- IV. That a speech requirement be met as set forth in the recommendation adopted by the faculty on March 11, 1946.
- V. These requirements except IV above shall not apply to students registered in special courses, including Art Education, Applied Arts, Occupational Therapy, and Physical Education.
- VI. That the following advice for students and advisers be printed in the catalog:

"Students who expect to enter the School of Education after two or more years of college work are advised to take at least elementary courses in as many as possible of the fields that serve as foundations of the later required professional courses, Educ. 73, 74, and 75. Such subject fields are Physiology or Zoology I, Psychology, and a selection from the introductory courses in the several Social Studies."
