## Introduction

Since November 1947, the problem of Korea had been a concern of the United Nations. In Resolution 293 (IV) of October, 1949, the General Assembly recalled it's previous declination that there had been established a lawful government of the Republic of Korea having effective control and Jurisdiction over that part of Korea where the United Nations Temporary Commission on Korea (UNICOK) was able to observe and consult, in which the great majority of the Korean people reside.

On June 25, 1950, the Commission reported that Military Action had been undertaken by the North Korean Forces against the south. The Commission further related that these actions were a direct violation of the General Assembly's Resolution and that such an attack strikes at the foundation of the United Nation's Charter.

By December 12, 1950, "Korean Black Box" formal Cease Fire negotiations between the UNC Commissioner, General Ridgeway, Admiral Joy of the Korean People Army, and General Nam II of the North Korean Army regarding the proposed Cease Fire Zone at the 38th Parallel.

The United Nations allowance for a Neutral Nation Supervisory Council consisting of sixteen countries to marshall the cease fire negotiations. Resolution on issues such as the treatment and the exchange of prisoners became a sticking point in the negotiation. By September 1952 most of the fighting had stopped, and the U.S., U.N.C., and Communist leaders were attempting to negotiate a resolution that all could agree to.
