SPECIAL MEETING OF THE BOARD OF REGENTS

Madison, Wisconsin

Saturday, August 11, 1945, 9 A.M.

Called to consider the Navy program, student housing,
and such other matters as may be properly presented

President Sensenbrenner presiding

President Fred stated that a group of Naval officers were spending August 10 and 11 at the University of Wisconsin to work out plans for the new NROTC Unit to be assigned to the University. President Fred also announced that the Regents and some members of the faculty would lunch with the Naval group today and that they were to meet at Adams Hall at 12:30 P.M. He stated that the Naval parade would be held at 2 P.M. and that at 3 P.M. a round-up or closing session would be held in the Rose Taylor Room in Kronshage Hall; that a buffet supper would be held for the Regents, some members of the faculty and the Naval group, and their wives, at 6:30 P.M. tonight at 130 Prospect Place.

At 9:15 A.M. a roll call was taken:

PRESENT: Regents Campbell, Cleary, Grady, Jones, Kleczka, Sensenbrenner

ABSENT: Regents Callahan, Hodgkins, Holmes, Werner

Communications were presented from the four Regents absent in explanation of their absence.

Regent Cleary moved, with second by Regent Grady, that the minutes of the special meeting of the Board held on June 27, 1945, be approved as sent out to the Regents and that the minutes of the meetings of the Executive Committee held on June 27 and July 12, 1945, be approved, ratified and confirmed. Director Peterson called attention to an error in the minutes of the meeting of the Executive Committee held in Milwaukee on July 12, 1945. Recommendations No. 1 and 2 under Education, covering appointments of Edward A. Krug and Russell T. Gregg, were for the first semester only instead of the academic year 1945-46. It was

VOTED, That this correction be made, the recommendations as amended to read as follows:

That Edward A. Krug be appointed associate professor of education for the academic year 1945-46; salary \$4250 for the year; vice Gordon Mackenzie, resigned, p. 56.

That Russell T. Gregg be appointed associate professor of education for the academic year 1945-46; salary \$4500 for the year; vice Paul H. Sheats, resigned, p. 56.

The motion was then put and carried unanimously.

The above actions of the President taken since the June 27, 1945, meeting of the Board and approved by the Regents in the foregoing resolutions are made a part of the records of this meeting.

Director Peterson presented the following report on housing for married veterans:

1. Trailers Made Available by Federal Government

As a temporary measure to help relieve the student housing situation, particularly for married veterans, it is proposed that approximately 100 house trailer units be moved from the Badger Ordnance Trailer Camp at Prairie du Sac to Madison.

The Federal Housing Agency has authorized the University to use these trailers for veterans' housing. The trailers are now vacant and Army officials have assured us that the removal of the trailers from the Badger Ordnance site will not interfere with the war effort.

2. Emergency Board has Approved

The State Emergency Board has approved the project and has agreed informally to appropriate up to \$40,000 to pay the cost of renovating, repairing, moving, and installing the trailers and of furnishing utilities, roads and walks.

3. Location at Camp Randall

It is proposed to place the trailers in the Camp Randall area on the site occupied by barracks during World War I, which lies west of Randall Avenue between the Memorial Arch and the Highway Laboratory. This area is now assigned to intramural and Wisconsin High School athletics. The site is conveniently located and residents of the trailer camp will have easy access to stores, hospitals, playgrounds, public transportation, and University classrooms and laboratories.

4. Equipment and Facilities

Each trailer contains kitchenette equipment and facilities in addition to living room and sleeping accommodations. Laundry, bath, and toilet facilities are contained in separate trailer units which will be centrally located. All trailers are fully insulated and are heated by individual oil stoves. The standard equipment includes two studio couch beds, table, four chairs, ice box, oil stove, and gasoline or oil cooking unit. (Efforts are being made to substitute electric plates for the gasoline and oil cooking units.) The expansible units include additional living room and bedroom space and correspondingly more furniture.

Residents will furnish their own linen, bedding, dishes, and kitchen ware.

5. Rentals

It is suggested that monthly rental charges should not exceed \$25 for the standard trailer, with slightly higher rates for the larger expansible units. The rental would include payment for all operating costs including heat, light, water, fuel for cooking and heating water, repairs, insurance, and janitor services for the bath, toilet, and laundry units. The only operating item to be furnished by the occupants would be ice for the refrigerators.

The plan, therefore, is to provide low-cost but comfortable and livable accommodations.

6. A Temporary Arrangement

It is not suggested that the proposed use of trailers is an entirely satisfactory answer to the housing problem. It is at best a temporary arrangement made necessary by the critical shortage of housing accommodations, particularly for married students. The agreement with the Federal Housing Agency limits the use of the trailers to veterans of World War II. A relatively high proportion of the veterans are married. No University dormitories are available or suitable for married couples. Privately owned apartments are practically all occupied. The only possibility of providing housing in Madison for these students in the short time available before school opens in September appears to be the use of trailers.

7. Proposed Procedure

On account of the very short time available before the trailers will be needed and the amount of work that must be done to prepare the site, install utilities, roads and walks, and move the trailers, it will be necessary to use the facilities of the Wisconsin University Building Corporation to do the work.

8. Recommendations

- a. That the offer of the National Housing Agency to make available approximately 100 trailers and auxiliary equipment to the University of Wisconsin for housing veterans enrolled as students in the University and their families be approved and that the Director of Business and Finance be authorized to sign the necessary leases, agreements, or other documents with the federal government.
- b. That the area adjacent to Camp Randall needed for the trailer camp (generally described as follows: the area surrounded by Randall Avenue on the east, Memorial Park on the south, a line running due north from the northwest corner of Memorial Park on the west, and the north boundary of the athletic field on the north), be leased to the Wisconsin University Building Corporation for a term of one year on condition that the said Corporation install roads, walks, utilities and trailers, together with necessary equipment, for veterans' housing; and that the President and the Secretary of the Regents be authorized to sign the lease.
- c. That the Wisconsin University Building Corporation be authorized to advance the necessary funds, not exceeding \$40,000, to pay the initial cost of providing trailers and services for veterans' housing at the Camp Randall site described above.
- d. That as soon as the actual initial costs are known the Director of Business and Finance be authorized to request the State Emergency Board to appropriate the funds necessary to cover those costs up to a maximum of \$40,000. (The Emergency Board has agreed informally to make this appropriation.)
- e. That the amount of the Emergency Board appropriation be transferred to 20.41 (11) Revolving Fund Surpluses and disbursed from that appropriation to the Wisconsin University Building Corporation as final and complete reimbursement for the Corporation's costs in providing trailers and services for veterans' housing and that thereupon the lease between the University and the Corporation covering the trailer camp area be cancelled.
- f. That the Division of Residence Halls be authorized and directed to operate the trailer camp for veterans of World War II who are enrolled as students in the University and for their families at rentals not exceeding \$25 per month for the standard size trailers and \$32.50 per month for the expansible unit, and that net receipts not needed to cover operating costs be set aside in a separate reserve account in the 20.41 (5)(a) revolving appropriation to be reverted to the State General Fund on direction by the Legislature. (This is in compliance with an informal agreement with the Emergency Board.)

Upon motion of Regent Cleary, seconded by Regent Campbell, it was VOTED, That the report be approved and the recommendations (a) to (f) included in the report be adopted.

President Fred referred to a proposed federal appropriation for postwar construction of dormitories for veterans to be offered to educational institutions on a matching basis. Upon motion of Regent Cleary, seconded by Regent Kleczka, it was

VOTED, That the President of the Regents be authorized to write the Wisconsin senators and representatives favoring this legislation.

President Fred asked Director Peterson to present the matter of a proposed lease of quarters in the Mariner Tower at Sixth Street and Wisconsin Avenue in Milwaukee. Mr. Peterson stated that the area proposed would cover 10,000 square feet at an annual rental of \$20,000 and would provide for ten classrooms and necessary instructional offices, the lease to be for two years with the provision of being extended to the third year. Upon motion of Regent Kleczka, seconded by Regent Cleary, it was

VOTED, That the lease be authorized subject to approval by the Attorney General as to legality.

President Fred called attention to the Bankhead-Flannagan appropriation which would provide \$338,000 a year for agricultural extension work throughout the state of Wisconsin. Upon motion of Regent Cleary, seconded by Regent Kleczka, it was

VOTED (a) That authority be granted the administrative officers of the University to request legislative approval, and

(b) That plans for expenditure be referred to a special Regent committee for study and report.

The President of the Board appointed Regents Jones, Grady and Campbell.

President Fred stated that he had appointed Dean Baldwin as Vice Chairman of the Campus Planning Commission and that he had also appointed the following Steering Committee:

Director Peterson reported that the University of Wisconsin Foundation is preparing a list of projects for which gifts may be sought.

Director Peterson presented a communication from Emerson Ela, of Madison, offering the Nakoma Country Club for a consideration of \$110,000 and asked the Secretary of the Regents to discuss the matter. The Secretary stated that he regarded the price named as excessive and presented the following recommendation:

That the letter from Emerson Ela of Madison, representing the Bondholders Committee of the Nakoma Country Club, dated August 7, 1945, be referred to the Constructional Development Committee of the Regents for consideration and report to the Board; that it is the sense of the Regents that the property should be acquired for Arboretum purposes and at the same time used by the University for courses in physical education and for recreational purposes if it can be secured at an acceptable price and if plans for financing can be worked out.

Upon motion of Regent Kleczka, seconded by Regent Campbell, adopted.

The President reported that the Governor had released funds for plans and specifications for new construction as follows:

The Director of Business and Finance stated that the Attorney General's opinion relating to charges to revolving funds for administrative overhead was negative and asked that an appropriation of \$40,000 be made from Regents Unassigned to Business Administration to replace the proposed revolving fund transfers. Upon motion of Regent Cleary, seconded by Regent Jones, approved.

Upon recommendation of the President, and upon motion of Regent Kleczka, seconded by Regent Campbell, it was

VOTED, That Volmer H. Sorensen be appointed personnel consultant at a salary of \$4,500, on the twelve months' basis, effective September 1, 1945; charge to Regents Unassigned.

A communication was presented from Arthur L. May, Chief Clerk of the Assembly, transmitting a copy of Joint Resolution No. 95, A, adopted by the 1945 session of the legislature, desiring that arrangements be made for a course of instruction in Greek at the University. Upon motion of Regent Grady, seconded by Regent Kleczka, this matter was referred to the President of the University.

A communication was presented by V. E. Kivlin, Acting Dean and Director of the College of Agriculture, relating to the transfer of the Rural Electrification Coordination Division from the Department of Agriculture to the College of Agriculture of the University of Wisconsin.

Dean Middleton appeared before the Regents and made a very interesting talk with reference to his experiences in connection with the European war.

Regent Jones stated that there would be a meeting of the Constructional Development Committee immediately following the Board meeting and asked that all Regents present attend the meeting.

Regent Grady, Chairman of the Welfare and Student Life Committee, reported on the Theta Chi case and stated that a majority of the committee (Regents Grady and Holmes) favored adoption of the recommendations of the Faculty Committee designated by the Regents to hear the appeal from the decision of the Faculty Committee on Student Life and Interests. Regent Campbell, the third member of the Welfare and Student Life Committee, stated that he disagrees with the recommendations of the majority of the Regent committee. Regent Grady moved the adoption of the findings, conclusions and recommendations of the committee designated to hear the appeal of Theta Chi Fraternity as they appear in the records. The motion was seconded by Regent Cleary. A called vote was taken, Regents voting "Aye" - Grady and Holmes (by letter); Regents voting "No" - Campbell, Cleary, Jones, Kleczka, Sensenbrenner. The motion was declared lost.

Regent Kleczka then presented the following motion as a substitute to a minority report which Regent Campbell had prepared:

The Board has considered the record in the Theta Chi case. It is the judgment of the Board that the punishment imposed, regardless of technicalities, is justified and is now adequate. It is the further judgment of the Board that the fraternity should now be reinstated subject to such reasonable regulations as the proper faculty committee may impose. Further we suggest that the hazing rule be considered to the end that its meaning be made clear and definite.

The motion was seconded by Regent Cleary and adopted. Regents Grady and Jones voted "No".

Regent Cleary moved, with second by Regent Kleczka, that the Kleczka motion just passed be adopted as a substitute for the minority report of Regent Campbell and as the decision of this Board as to this matter. Regents Grady and Jones voted "No".
Motion Carried

THE ALLEN J. SHAFER JR. MEMORIAL AWARD

It is the desire of Allen's parents that the income from the Allen J. Shafer Jr. Memorial Fund be awarded annually, upon recommendation of a special committee to be appointed by the President of the University, in the form of scholarships to outstanding male students of the University of Wisconsin, on the basis of these criteria:

1. High scholarship throughout his course.
2. Good citizenship, Unselfishness, tolerance and democratic spirit, and service as an example in those qualities.
3. Contribution to the welfare of the school and of the student body.
4. Keen interest and participation in the competitive athletic program.
5. Effective leadership in extracurricular activities.

The first awards shall be made in 1945 to a male member of the Freshman and Sophomore Classes. An amount of \$200.00 will be contributed by Mr. and Mrs. Allen J. Shafer, Sr., for these awards. These awards shall be in the amount of \$100.00 each.

After the year 1945 the income on the investment of the principal shall determine the number of awards to be made. It is hoped that eventually the principal of the fund shall produce income sufficient for four cash scholarship awards of \$100.00 or more annually, one for each of the outstanding male members, adjudged on the above criteria, of each of the four classes of university students, Freshman, Sophomore, Junior, and Senior. The Freshman and Sophomore scholarship awards shall be granted first and so on up the scholastic ladder through the Junior and Senior Classes, as the income warrants.

The scholarship to the entering Freshman is to be awarded upon entrance to the University of Wisconsin and granted to him upon completion of one semester of successful university work. In like manner, the sophomore award shall be granted upon the successful completion of three semesters of successful university work; the junior award shall be granted upon the successful completion of five semesters of successful university work; the senior award after successful completion of seven semesters of successful university work.

When the income exceeds the annual figure of \$400.00 the scholarship awards or the principal shall be increased at the discretion of the committee administering the awards.

A scholarship award may be made to a student recipient as he progresses through the University, but the awarding committee shall review each year the accomplishments of the recipient of an award. The recipient of the award in any year shall be the recipient in succeeding years if he maintains sufficiently high standards. If the Committee judges that any recipient shall have failed to maintain the standard which was the basis for his original award, the awarding committee shall select another qualified male student of the same class to receive the award. The disqualification of a recipient does not preclude his eligibility for the award in a succeeding year.

It is our hope and belief that, conducted on these high bases, this "Living Memorial" in the name and memory of our beloved son will go on forever doing the good that Allen loved so dearly.
