





### EARLY HISTORY

HE early history of Fond du Lac county, Wisconsin, while linked closely with that of other counties in this section of the state, has an identity of its own to which there is a growing interest attached with each

passing year.
Attracted here by the fertile lands, much of which was covered with dense forests and which abounded with streams and lakes and countless springs the early settlers, confronted by all the hardships and privations known to pioneer life, builded well the foundation for agricultural, commercial and civic progress of the most aggressive type. On this foundation municipalities have risen, diversified industries have been developed and a prosperous community, one that in point of stability and enterprise ranks second

to none in the state, is the result.

Bound together by a common tie of early day hardships endured, and early day pleasures enjoyed together, the surviving Fond du Lac county pioneers some years ago formed an organization known as The Old Settlers' Club. It has been the custom of this society since its inception to hold annual picnics and at the most recent of these, the one held in 1911, it was decided that it might be well to have some of the principal events in which they had participated in the early days, written into permanent records. It was further decided to embellish these bits of pioneer history with illustrations including portraits of many who had been prominently identified with the early history of Fond du Lac county. As a part of this work group photographs were taken. The first group included those pioneers who were 85 years old and older; the second group comprised those who were 78 years old and older, while the third group comprised those who had been residents of Fond du Lae county for 62 years or many Fond du Lac county for 63 years or more.

In addition to these portraits of pioneers there have been included in the Historical Album here presented, portraits of members of the younger generation, those who are actively engaged at the present time in building upon the foundation which had been so well prepared for them.

In the preparation of this volume it has been the purpose to place it at the disposal not only of members of the Old Settlers' Club, but within the reach of the public at a nominal price, one which merely covers the cost of production. As a result it is hoped that a copy may find its way into every home in Fond du Lac county and that many may reach friends and former residents of the county.

Owing to the limitations of space the biographical matter is necessarily limited to a brief statement of facts and a mere mention of the most important events in the lives of those persons

whose portraits are shown.

#### WHENCE THE NAME FOND DU LAC.

The name Fond du Lac is compounded of three French words, th, being literally translated, read thus:—"the bottom of the which, being literally translated, read thus:—"the bottom of the lake." But this is by no means their signification, when applied to this county in Wisconsin. It is an idiom of the French language to call the end of a river, a street, or a lake, remote from the speaker, the fond, or bottom—regardless of its altitude. The French traders who visited this country during its nameless infancy, came in from Canada by way of the lakes, and referred to this locality as the fond—or further end of Lake Winnebago; hence Fond du Lac; the same name being applied to the western extremity of Lake Superior for the same reason. The name was afterward given to the river which flows into the "further end" of Winnebago—and then in due course of time to the county, the village and the city itself.

#### SOME OF THE EARLY TRADERS.

The first trading post for traffic with the Indians, within what are now the confines of Fond du Lac county, and of which a reliable record is preserved, was established in 1787, at the forks of the Fond du Lac river by Jacob Franks, of Green Bay. In 1819 Peter B. Grignon, also from Green Bay, passed a winter at a trading post on the West Branch, the cellar of whose shanty was plainly to be seen when the first permanent settler arrived in 1836.

It was located on the east bank between Forest Avenue and Division street, and the site is now covered by the plant of the Gurney Refrigerator Co.

#### THE FIRST PERMANENT SETTLEMENTS.

The organization of a joint stock company at Green Bay in 1835 may be taken as the initial step toward a permanent settlement of Fond du Lac county. By the first of January, 1836 this company had come into the ownership of 3705 acres of land in what was then Brown county. In the meantime a village plat had been surveyed and named "The Town of Fond du Lac." The village existed, however, only on paper for it was not until the spring of 1836 that the company commenced the erection of what is known as the "First House in Fond du Lac County." This house which was erected on: "Lot 9 in Block 9" of this "Town" is described as a "double log house with an open hall through the center, and a stairway leading to chambers above. It had a back addition used as a kitchen. Brothertown Indians (civilized) came from Brothertown, some fifteen miles distant, to raise the structure." Colwert Pier, coming from Green Bay, was the first occupant of the house being joined by his wife at this place on the sixth of June 1836, Mr. and Mrs. Pier were the only white residents of the county till March 11, 1837, when Mr. and Mrs. Edward Pier and two children arrived. On June 18th, 1837 Norman Pier and Albert Kendall joined the colony. On June 17th, 1837, Harriet Pier, and September 3rd, 1837, Mr. and Mrs. Calvin Pier and son Oliver arrived, this constituting the entire white population until March 1838.



#### THE FIRST HOUSE IN FOND DU LAC.

The first house in Fond du Lac was built in 1836, by the Fond du Lac Land Co. for a place of entertainment for travelers and to attract settlers. It was first occupied by Colwert Pier, who acted as host until the death of his wife in 1838. Mr. Pier was succeeded as landlord by Dr. M. C. Darling, who remained only for a few months until he could erect a similar house of his own. John Bannister occupied the house till 1839 acting as landlord and post master. Late in 1839 Dr. Darling leased the building, removed the postoffice to his own house at the corner of Main and First streets and closed the company house. How long it was closed is not known, but it is recorded that the Messrs. Weikert and Clock opened the first store in Fond du Lac in that building in 1844, occupying the north section, while George McWilliams had rooms in another part. William Carey in 1845 was living in a third section of the house and died there in 1846. In 1846-7 Col. Davis occupied the building and boarded the workmen who were building the first steam mill ever erected in the county. In 1848 it furnished a temporary home for three families, those of Mr. John Kuicks, Mr. Leander Landerman and a third whose name is unknown. In 1852 Mark Harrison made a sketch of it for his celebrated painting and to him it is due that the present generation has a correct picture of the First House in Fond du Lac County.

#### FOND DU LAC COUNTY NONAGENARIANS.

Following is a partial list of the Old Settlers of the county who have reached the age of 90 years or over. The list is furnished by Franklin Swett.

E. O. Ackley, age 92 years, born 1820 and came to Fond du Lac county in 1850.

August Baganz, age 95 years, born in Frankfort, Germany, in 1817. Settled in the town of Forest in 1858. His son, August Baganz, lived in and owned the Log Tavern in the town of Forest.

Mrs. Edward Carr is 92 years old, and was born in Queens county, Ireland, in 1820, coming to Fond du Lac county in 1848. She now makes her home with her daughter, Mrs. McCullough on a part of what was the Swett homestead in the town of Empire.

Jacob Dilling, 94 years old, born in Kleinladenbach, Grand Duchy Hesse, Germany, May 1, 1818. In September, 1851, he settled in the town of Forest where he resided until 1902, when he came to this city, where he now lives with his son, J. M. Dilling, 35 Amory street.

Mrs. Rumina Dye, aged 92, was born in Alleghany county, N. Y., Sept. 12, 1820. She came to Wisconsin in 1840, settling in Sheboygan county. She came to Fond du Lac in 1852.

James A. Hersey, aged 90, was born at Ira Corners, N. Y., in 1822 and settled in Fond du Lac in 1844 when he became associated with Dr. Darling in the real estate business. He built a home directly across the street from the county jail, residing there for many years.

Joseph Jones, age 90 years, was born in 1821 and came to Lamartine to live in 1848.

Richard Kaye, aged 93, was born in Yorkshire, England, March 8, 1819. He came to Wisconsin in 1841 and settled in Burlington. In the spring of 1848 he settled in the town of Empire, living there for several years and then coming to the city, where he has resided since.

Christopher Keyes, aged 97 years, was born in Fermanagh, Ireland, April 14, 1815. He came to Fond du Lac in 1855 and continues to make his home at this time on the farm of 165 acres on which he first located. Mr. Keyes has the reputation of being the oldest resident in the county.

T. P. King, age 93 years, was born near Utica, N. Y., in 1819 and settled in the town of Forest in 1845.

Mrs. B. A. Mayhew (deceased at 93) was born in Dover, Dutchess county, N. Y., April 2, 1818 and in company with her husband settled in the town of Empire in 1849.

Patrick Mulvey, age 92 years, was born in Ireland in 1819 and settled in Byron in 1842.

Thomas Price, age 90, was born in Radnarshire, Wales, Dec. 3, 1821 and settled in Kenosha county in 1844. Two years later he came to the town of Oakfield, Fond du Lac county and purchased land for a farm, bringing his family there in 1847, where he has since resided.

Mary Tiboderay, age 92 years, was born near Quebec, Canada, Nov. 1, 1819, and came to Fond du Lac in 1848. She resides with Mrs. Robert Shields, 48 East Twelfth street.

W. W. Wheeler, 90 years old, was born August 4, 1822, in Montpelier, Vt., moving to Wisconsin in 1853. He settled in the town of Lamartine and later moved to Oakfield in 1855 where he has resided since.

Mrs. James Wells, age 93 years, was born in County Cavan, Ireland, Dec. 15, 1818. She settled in the town of Empire in 1850.

Urban Scherzinger, the father of German Scherzinger, was born on the farm "Hohsteig" Guetenbach, Baden, Germany, 1781. He died 1871.

German Scherzinger was born in 1832 at Guetenbach, Baden, Germany. He learned the clock and watch trade in the Black Forest the original home of clock making, left his home January 1st, 1850 and worked nearly two years in France, arrived at New Orleans, La., Dec. 23, 1851, went to Louisville, Cincinnati and New York, and came to Fond du Lac in May 1855, where he established himself in the jewelry business on the east side of Main street, but for the last 48 years his jewelry store has been at 16 South Main street.

#### PORTRAITS AND BRIEF SKETCHES.

Among other representative pioneers of Fond du Lac county and those who have been active in the development of the city and county in later years, the following may be mentioned:

DR. J. M. ADAMS, physician and surgeon, was born in Lowville, Lewis County, N. Y., came to Fond du Lac in 1845. He purchased a large farm four miles south of Fond du Lac, on which he resided six years. He died on December 22nd, 1864.

A. B. ADAMSON was born in Eldorado in 1878. He was elected County Superintendent of Schools in 1900, serving until July 1st, 1907. He was recommended by the Civil Service Commission for Assessor of Incomes in December, 1911, and appointed to that office in January, 1912. He is a graduate of Oshkosh Normal and the Law College of Northwestern University


SQUIRE ARTHUR was born in Martinsburg, Lewis County, N. Y., in 1810, came to Fond du Lac in 1845, owned a farm of 300 acres near the four mile house.

DR. E. E. ATKINS, physician and surgeon, was born in Tioga County, Penn., March 27th, 1847, commenced the practice of medicine in 1877; was elected mayor of the city in 1895.

EDWARD BEESON was born in Columbiana county, Ohio, July 7, 1814 and came to Wisconsin twenty years later. In 1846 he entered land for a farm near the old Crofoot place south of this city, the next year coming to the city to learn the printing trade in the old Fond du Lac Journal office. The following year he purchased an interest in the paper and continued in the printing and newspaper business to the time of his death.

DR. L. A. BISHOP was born in the town of Eden, in this county, August 24th, 1846, being the first white child born in that town. In 1870, he graduated from Hahnnemann Medical College, Chicago. He was mayor of the city of Fond du Lac in the year 1902-3, and is prominent in professional, fraternal and political circles.

COL. N. BOARDMAN, civil engineer, was born on Grand Island, an island in Lake Champlain, Jan. 31, 1825. In 1846 he began an exploration in the mineral regions of Lake Superior, camping on the present site of Duluth, then occupied by a solitary Indian wigwam. He coasted along the south shore to Brule River, then struck through the wilderness to Chippewa Falls,

where he secured a bark canoe in which he descended the Chippewa and Mississippi rivers, a distance of 800 miles; thence continued the journey in a "prairie schooner" to Chicago. In 1852 he came to Fond du Lac as civil engineer of the now C. & N. W. Ry. and served until his enlistment as first lieutenant in the Second W. V. C. in September, 1861. After the war he returned to Fond du Lac, where he spent the remaining years of his life.

REV. CHARLES BOUCHER was born in Canada May 10, 1832. Was educated at St. Hyacinthe Seminary, graduating with the class of 1854. In 1857 he was ordained a priest, his first appointment being a missionary charge. He was given the pastorate of St. Louis church in Fond du Lac in 1880, where he was greatly beloved during the nearly thirty years he served

the parish.

HENRY BOYLE, one of Fond du Lac's representative citizens, was born in Waterloo, Seneca county, New York in 1851. He came to Fond du Lac in 1873, where with his brother John they established a retail grocery business at the corner of N. Main and Johnson streets, and a few years later commenced in a small way the manufacture of the now famous Yeast Foam. The Messrs. Boyle are favorably known throughout the country and by their integrity and close application to business have secured for themselves a handsome competence.

GEN. EDWARD STIVENSON BRAGG, was born in the state of New York on Feb. 20th, 1827; he was educated at Hobart College, graduated in 1847. He first made his home in Fond du Lac City in 1850; he was district attorney for one term in 1853. May 14th, 1861, he enlisted as captain of Infantry Volunteers. He participated in 45 engagements during the war. He was wounded once and blown from his horse by the shock of a cannon ball on another occasion. He was minister to Mexico during President Cleveland's first administration; he was appointed minister to Cuba and consul general to China by President Roosevelt. He served several terms in congress and was one of the ablest and most brilliant lawyers who ever appeared in the courts of this state. He is now residing in the same homestead where he settled before the war.

MONMOUTH BRIGGS was born in Scranton, Penn., February 20, 1827; he located in the town of Eden in 1850; he spent his

life on the farm there and died October 11, 1904.





- ALMOND W. CHAPMAN was born in the town of Hebron, Washington county, N. Y., June 15, 1833. He came to Fond du Lac city in 1855. In 1858 he was the first to establish an ice business in this city. For twenty-seven years he furnished music at dancing parties and other entertainments.

LUCY CHAPMAN, daughter of Joseph King, one of our earliest pioneers, was born February, 1840, in Fond du Lac. She was the first female white child born in the county.


- ALEXANDER HAMILTON CLARK was born in Leonardsville, N. Y., April 9, 1816, came to Green Bay in 1836 and to Fond du Lac in 1843 and bought the farm now owned by Theodore Treleven. He moved into the city in the spring of 1850, opened a tailor shop on Forest avenue and the east side of Main street built a house on the corner of Fifth and Marr, on a lot presented to his wife by Dr. Darling on condition that he come to the town, and kept his shop many years after, although following several other kinds of business. He was a fine musician, playing first violin for dances in this city and the surrounding cities and towns. He taught dancing school for years and was a machinist and engineer. He died May 9, 1902 in the same house he built in 1850.
- ELIHU COLMAN, attorney at law, was born at Oneida, Brown county, Wis., May 11, 1841. He came to the city of Fond du Lac in 1847. In 1861 he enlisted in the First Wisconsin Cavalry. He was U. S. District Attorney for the Eastern District of Wisconsin.
- COL. HENRY CONKLIN was born on Long Island, April 10, 1793. With his wife and eight children he came to Taycheedah in 1841. He brought the first fine cattle and sheep into the county. He also erected the first grist mill. His son, Judge Wm. D. Conklin, was a well known lawyer. Another was the first chief of police. Theodore is now the only survivor of the family. Col. Conklin died April 4, 1867.
- ALVAH CROFOOT was born in Lewis county, N. Y., in 1833 and came to Wisconsin with his parents in 1840, locating first at Green Bay, but three years later became a resident of Fond du Lac. He spent his early life on the farm and later took to lumbering and few men were more familiar with the details of the business than was Mr. Crofoot. He was senior member of the firm of A. Crofoot & Co., whose lumber yard and office were located on Western avenue, adjacent to the plant of C. J. L. Meyer.
- MASON C. DARLING was born in Amherst, Mass., in May, 1801. He came to Sheboygan, Wis., in 1837 and to Fond du Lac in 1838. Dr. Darling was probably the most prominent figure in the early history of the city.
- COL. C. H. DE GROAT was born in Cortland, N. Y., in 1837. When twelve years old he came with his parents to Fond du Lac where he resided all the rest of his life, with the exception of the four years he gave to his country in the war. He

enlisted in Company K of the First Wisconsin regiment on the fourth day of September, 1861. He afterwards returned the fourth day of September, 1861. He afterwards returned home to recruit a company for the Thirty-second Wisconsin regiment then forming in Oshkosh. In September of 1862 he was commissioned captain of Company C of the Thirty-second and in the spring of 1863 was promoted to major. In less than a year he was promoted to lieutenant colonel and in 1864 to colonel and took command of the regiment. In 1865 he was breveted brigadier general for faithful service, and mustered out, for the war was over. With health permanently impaired he took up a citizen's life again and because of the malady contracted in the service, was more or less handicapped

all the rest of his days. Col. DeGroat died August 15, 1904, in the sixty-fifth year of his age.

GUSTAV DE NEVEU, one of the earliest settlers of Fond du Lac county, was born in Savigny, France, March 30, 1811. He came to Fond du Lac in 1838, where he purchased about 500 acres of land in the town of Empire. He built his first house and

of land in the town of Empire. He built his first house and made a permanent settlement in 1839.

MADAM HARRIETT DE NEVEU was born on the Isle of Mackinac, December 16, 1818. In 1824 her parents moved to Green Bay where she lived until she was married in 1840 when she came to the Buena Vista farm in the town of Empire.

WILLIAM DE STEESE was born in Burlington, Racine county, Wis., April 14, 1850. He came to Lamartine, Fond du Lac county, with his parents in 1861. He enlisted in Co. D, Thirty-eighth Wisconsin Volunteer Infantry, March 17, 1864 at the age of thirteen years and eleven months, as private soldier and served through the war. Was in the battles of the Wilderness, and in the Siege of Petersburg, Va. At the close of the war and in the Siege of Petersburg, Va. At the close of the war he returned as corporal. He served the C. M. & St. P. Ry. Co. as conductor thirty-five years and in 1900 went into the real estate and insurance business.

JAMES D. DOTY, the ablest and one of the most comprehensive of our pioneer statesmen was born at Salem, Washington county, N. Y., Nov. 5, 1899; he was a delegate to the Territorial Legislature of Wisconsin in 1840. He built a house in the town of Empire in 1838 where he lived two years. He was president of the original Fond du Lac Land Co. and the site

of the Village of Fond du Lac was chosen by him.

F. F. DUFFY, attorney-at-law, was born in Richmond, Va., Feb. 2, 1851, came to Fond du Lac in 1872. In 1884 he took in J. H. McCrory as law partner. He was city attorney in 1878, was district attorney in 1880-82-84.

MRS. RUMINA DYE was born in Alleghany county, N. Y., in 1820, came to Sheboygan county, Wis., in 1840; in 1852 to Fond du Lac county.



OSCAR HENRY ECKE, attorney-at-law, was born at Stevens Point, Wisconsin, Feb. 5, 1863; he graduated at the University of Wisconsin in 1887; he graduated from the University Law School in 1894. He was engaged for a period of two years as instructor in elocution at the university where he graduated and for one year was assistant state librarian at Madison, Wis. Since 1895 he has been engaged in the practice of law in the city of Fond du Lac, having been associated with Attorney H. E. Swett for ten years and later with Attorney W. W. Hughes. From 1889 to 1901 he was city attorney for the City of Fond du Lac. In 1906, Judge Fowler appointed Mr. Ecke assistant

district attorney to assist in the investigation of the grand jury. HIRAM EDGERTON was born in Rome, Oneida county, N. Y., Sept. 30, 1802; he came to the town of Fond du Lac in 1847 where he purchased 160 acres of land. Mr. Edgerton was of the hale and hearty type of man and lived to a ripe old age. On his eighty-seventh birthday he plowed a furrow two miles long, the equivalent of one-quarter of an acre, accomplishing this

feat in forty-four minutes.

CHARLES F. EDGERTON was born in Rome, Oneida county,
N. Y., and came to Fond du Lac in 1847; he enlisted in 1861
as a private in Co. "B," Wisconsin Cavalry. During the Battle
of L'Anguille, Ferry, Ark., he was wounded. He carried the rebel lead until he died.

JAMES EWEN was born in New York City in 1806 and came to Fond du Lac in 1849, where he was landlord of the hotel known as the "Lewis House" for over ten years.

- R. C. FAIRBANK, attorney-at-law, was born in the town of Fond du Lac Jan. 25, 1870, commenced the practice of law in 1902. Been justice of the peace since 1907. Member of library board for past two years.
- L. J. FELLENZ was born on a farm near Campbellsport, Wisconsin, November 29, 1882. He received his early education at the public schools of Campbellsport and later entered Oshkosh Normal from which he graduated in 1902. He attended the law department of the University of Wisconsin, graduating there in 1907. For two years he practiced law at Fort Atkinson and has since that time been a member of the bar of Fond du Lac.
- GEO. H. FERRIS was born at St. George, Orleans county, Vermont, in 1834. Came to Fond du Lac in 1846.

FRED A. FOSTER, attorney-at-law, was born at Port Washington, Wis., June 20, 1871. He came to Fond du Lac, Nov. 1911.

EGBERT FOSTER was born at Poughkeepsie, N. Y., April 2, 1809. Came to Eden, Fond du Lac county, 1846. Died Nov. 11, 1886. Kept the Eden postoffice for many years.

JUDGE CHESTER A. FOWLER, attorney-at-law, was born in Rubicon, Wis., Dec. 24, 1862. Admitted to practice of law 1889. Practiced at Omaha, Neb., five years, at Portage, Wis., eleven years. Elected circuit judge in 1905. Came to Fond du Lac in 1909.

EDWIN H. GALLOWAY was born in Lewis county, N. April 12, 1825; he came to Fond du Lac in the summer of 1848 and soon afterwards became engaged in the lumber business, in which he continued for a period of ten years. He was the principal stockholder and the manager of the Fond du Lac Savings bank. He served his adopted city as treasurer and mayor. For several years he was chairman of the county board of supervisors and convent two terms in the logislature. of supervisors and served two terms in the legislature. died May 7, 1876.

JEROME GIBSON was born in 1823; he was a Mexican War veteran; he came to Fond du Lac in 1847; in 1849 he built a house on the corner of Fourth and Ellis streets in the city of Fond du Lac. Fourth street at that time was an Indian trail; he lived at this location fifty years. He was a painter by trade, was foreman of the Pulse Wagon Co. paint shops; he did work on the Amory hall in 1856. When the Chicago & North Western R. R. shops were built, he took charge of their paint department and remained in this position until the shops were moved to Chicago. He died March 27, 1905 at the age of 82.

DAVID GIDDINGS was born in Essex Co., Mass., July 4, 1808. Came to Wisconsin in 1835, to Sheboygan in 1838 and to Fond du Lac in 1866, where he purchased the John B. Macey farm of 400 acres.

GEORGE GIDDINGS, born in Sheboygan in 1852, came to Fond du Lac in 1866. He was partner in the firm of DeGroat & Giddings, owners of the Middletown Foundry on Rees street.


MRS. DAVID GIDDINGS was born in 1825, at Worcester, Mass., and came to Fond du Lac in 1864.







Meyer in Fond du Lac, Hermansville and Chicago, 1876 Mr. Gordon moved to a farm in Oakfield and while there he built the Episcopal church in Oakfield. He died Feb. 26, 1900.

ried on by his sons and a daughter.



GEORGE E. MEIKLEJOHN was born in Putnam, Washington county, N. Y., 1820. Came to the town of Empire in 1857.

C. J. L. MEYER was born at Minden, West Prussia, May 19, 1831. Came to Fond du Lac in 1855 where he afterwards built up the largest plant for the manufacture of sash, doors and blinds in the world at that time.

DR. W. E. MINAHAN was born in Chilton, Calumet county, April 20, 1867; he graduated from the Oshkosh Normal school in June, 1888, and from Rush Medical College in 1891. He settled in Calumetville in the fall of that year and practiced medicine until he made his first trip to Europe in 1899. Upon his return from that trip he located in the city of Fond du Lac, practicing until the trip to Europe, which ended in going down with the ill-fated steamer Titanic on April 15, 1912. He was one of the foremost physicians here.

HENRY CONKLIN MOORE, son of B. F. and Eliza Mary Moore was born in Taycheedah Jan. 2, 1848. He came to the city in 1849 and has continued his residence here until the present time. He is one of the few of his age living here who were born in the county. He graduated from the high school in 1864 and was for years connected with the First National Bank of this city. He is now retired from active business.

B. F. MOORE, capitalist, president of the First National Bank and of the LaBelle Wagon Works of this city, was born at Clinton, Maine, July 10, 1819. He came to Taycheedah in 1841. In 1844 he was united in marriage to Miss Eliza Mary Conklin in a log

cabin in the town of Empire.
MRS. ELIZA MARY MOORE, nee Conklin, daughter of Col. Henry Conklin, was born at Poughkeepsie, New York, June 27, 1827. In 1841 she came with her parents to the town of Taycheedah to live in a log cabin where she was married to B. F. Moore Oct. 27, 1844. This was the first marriage B. F. Moore Oct. 27, 1844. 





WM. M. PHELAN, carpenter, contractor, was born in Kilkenny, Ireland, April 27, 1819, came to Fond du Lac in 1850, served the city in several capacities, was elected street commissioner in 1853, alderman in 1854-56-62, and was assessor about eigh-

teen years.

OWEN E. PRITCHARD was born April 9, 1831 in Wales. 1851 he came to this country, settling in Oshkosh. He was married to Mary Elizabeth Jones in 1857 and in 1861 moved to Fond du Lac, where he resided till the time of his death, Nov. 17, 1911. Mr. Pritchard was a coach builder in the old C. & N. W. R. R. shops and following the transfer of the shops to Chicago he engaged in the grocery business at the corner of Arndt and Brooke streets, retiring from active business some four years prior to his death. Mrs. Pritchard survives him.

DR. A. J. PULLEN, physician and surgeon at North Fond du Lac, was born at Grafton, Vermont, educated at the University of Vermont, graduated in medicine and surgery and received the degree of Ph. D., M. D. in 1897; studied medicine and surgery in Europe; was appointed surgeon for the Soo Line Railway, also for the Chicago and North Western; was elected treasurer of Fond du Lac county in 1897 and at this time is the incumbent of the office. He was three times elected president of the village of North Fond du Lac.

W. A. READER, undertaker, was born at Columbus, Ohio, March 11, 1838, came to Fond du Lac in 1855, and was for some years

the leading undertaker in this city.

M. K. REILLY, attorney-at-law, was born in the town of Empire, Fond du Lac county, graduated from Oshkosh Normal school in 1889, College of Law in 1895, was district attorney of Fond du Lac county for two years, city attorney five years; delegate to the National Democratic Convention at Denver in 1908 and chairman of the democratic city committee, 1909 to 1910.

JUDGE A. E. RICHTER, attorney-at-law, was born in Saxony, Germany, February 8, 1853, came to Fond du Lac in 1882, was elected clerk of the court for Fond du Lac county and has been in the practice of law since 1885. In 1888 he was elected


county judge and has remained in this capacity ever since.







Hitherto the settlers had been obliged to follow an Indian trail which was very obscure and often nearly obliterated. road has since then been known as the Milwaukee road. He died Feb. 16, 1870. Lovisa Simmons, his wife, survived him until Feb. 29, 1888.
- J. A. SMITH, editor and publisher. Founder of the Commonwealth. Mr. Smith founded the Western Freeman, October 5, 1854. In September, 1856, Mr. Smith purchased the Fountain City Herald which had been established by Royal Buck Nov. 9, 1852, combining the Herald and Freeman under the new name, the Commonwealth, the first issue appearing under the new name October 15, 1856. The Commonwealth is thus the successor of the Fountain City Herald and the Western Freeman, publication having been continuous since its founding, Nov. 9, 1852. Mr. Smith was born in Brownsville, Jefferson county, N. Y., July 21, 1823, and died at Ft. Atkinson, Wis., June 23, 1892.
- O. C. STEENBERG was born in Tompkins county, New York, in 1836 and came to Fond du Lac in 1862, as principal of the Fond du Lac High school. In 1864 he was elected superintendent of the city schools and in 1871 he purchased an interest in a sash, door and blind factory, becoming sole proprietor of the same

in 1877.
FRED G. STEENBERG is proprietor of the O. C. Steenberg sash, door and blind factory, a worthy successor to his father and

FRANKLIN SWETT was born in the town of LaGrange, Walworth county, Wis., March 25, 1845, and moved with his parents to the town of Empire, Fond du Lac county, in 1846, where he lived until 1882, at which time he moved to the town of Waupun where he owned a farm of 173 acres which he sold and moved to the city of Fond du Lac. He was a carpenter and builder, spent four years in the study of architecture, two years of which were spent with Fernekes and Doliver, architects in Milwaukee.

He has designed over thirty fine residences in the city of Fond du Lac. He has held various positions of trust and has held different school offices, was assessor of the town of Empire and is at present secretary of the Fond du Lac County Old

Settlers' Club.

H. E. SWETT was born at the town of Empire in this county September 9, 1864. He graduated from the Oshkosh Normal school in 1891. He was a member of the faculty of that school and taught in the city schools at Oshkosh. He graduated from the University of Wisconsin Law School in 1894. He was dis-trict attorney of this county for four years.

GOV. N. P. TALLMADGE was born in Chatham county, N. Y., Feb. 8, 1795. He was elected to the United States senate from the state of New York March 4, 1833, in which capacity he served until he was appointed territorial governor of Wisconsin in 1844, at which time he settled in the town of Empire, Fond du Lac county. He purchased a large tract of land about four miles south-east of Fond du Lac and called his home Rienzi. Realizing that provision must be made for death as well as life he selected the present location of Rienzi cemetery, giving ten acres for the same, reserving the high ground op-posite the entrance for a private burial ground for himself and his descendants. More than fifty of them are now buried there.

MAJOR WILLIAM R. TALLMADGE was born February 27, 1800 and died January 2, 1880. He was the brother of Governor Tallmadge and emigrated in 1845. He bought eight hundred acres of government land at Calumet Harbor and turned his attention to tilling it and raising stock. This Major Tallmadge was the first owner of the old plank road between Fond du Lac and Calumet which is now the only existing toll road in the state and the only road from Taycheedah to Fond du Lac. In 1846 there were seventeen young men of the Tallmadge family who married and raised families. At this date Miss Iola Tallmadge, and the widow and daughter of R. G. Tallmadge, are the only residents of Fond du Lac to represent the name.

REV. FATHER M. J. TAUGHER was ordained as priest June 24, 1878. He accepted a call to this city as pastor of St. Joseph's Catholic church in 1886, and served until his death in the year

1911, a period of twenty-five years.

PAUL THIEL, register of deeds for Fond du Lac county, was born in Ripon, Jan. 23, 1880, and was elected to his present position in 1910.

JOSEPH TRELEVEN was born in Cornwall, England, August

28, 1814, and came to Fond du Lac in 1843.

GEORGE W. WATSON, born in the town of Eldorado, May 28, 1860, graduated from Oshkosh Normal school in 1895, was sheriff in 1894 and 1895 and is at present the postmaster of Fond du Lac.

JAMES WM. WATSON, born in Rocksbouroughshire, Scotland, February 14, 1849, came to the town of Springvale, Fond du Lac county, 1862, was clerk of the court from 1884 to 1888, began the practice of law in 1888, was elected to the state as-sembly the same year, was elected chairman of the committee on state affairs in 1891, was a member of the United States Overflow Committee. Died May 21, 1910. G. W. WHITE, engaged in the business of furniture and under-


