# COMPANY A, 127TH INFANTRY 32ND DIVISION



OW that the world is adjusting itself to peace time conditions, the great armies of nations are being demobilized. America's divisions are being dismissed as fast as their services can be spared. One that interests us particularly is the Thirty-second, originally composed of National Guard units from Wisconsin and Michigan. There can be no mis-

take; you know the boys by the red, barred arrow on the upper part of the left sleeve.

Friends in the army are friends forever. Even though the boys, who fought side by side, may be from every corner of the United States, everlasting impressions have been made. Even after the day of demobilization, years hence, you shall recall Bill and George and Barney (apologies to our top sergeant) and the way they checred you and helped you. To make it possible for us to keep a clear record of our own little organization, Company A, 127th Infantry, accept this little history of the making, re-making and enviable active service of the company.

Company A is no spring chicken or mushroom variety of infantry outfit. After the Spanish American war the company was formed; or to be more accurate, re-formed under state militia regulations at Marshfield, Wisconsin. Interest was always keen, and weekly or bi-weekly drills in the home armory developed material for the big event yet undreamed of in America. Little did the interested leaders think they were developing excellent material for America in a world war. However, the efforts were not in vain—many boys who learned "squad right" and as skirmishers in Marshfield became officers in the great American Expeditionary Forces in France.

The boys became cager for the "real life." But the chance came and in June, 1916 Marshfield responded to President Wilson's call by sending her company to the Mexican Border. Three officers and eighty-nine enlisted men threw aside the blue serge, donned the olive drab, rolled packs, shouldered muskets and marched away. They went to Camp Wilson (now Camp Travis) at San Antonio, Texas. The boys realized they were to live a new life — **a** life of hard drilling and possible action. They put every effort into the work. They drilled and filked and tolled for eight months. In February, 1917 the company returned to the home rendezvous as fit as any infantry in America. They were mustered out February 17, 1917. Everybody jumped back to their civil vocation with the same spirit that they took to soldiering.

The great war had been raging in Europe for two and a half years. Nation after nation was drawn into the spreading flames, and it was the same month that Company A returned home from her border service that the Hun U-boat warfare policy took bitter effect. Twice the flames from Europe leaped as far as Washington—three times—and the third time the fire caught. America was in flames! Again the nation's call to arms was sounded and again did Marshfield respond with Company A—mobilized at home on July 15, 1917 with three officers and less than one hundred enlisted men.

The Wisconsin National Guard was mobilized at Camp Douglas where the preliminary preparations for war time basis were made. Companies A and L. 2nd Wisconsin Infantry, were sent to Camp McArthur, Waco, Texas as advance detachment from the regiment. They were charged with the task of staking out the new "tented city" in the south. The remainder of the regiment followed up and on Sept. 24, 1917 the 1st and 2nd Wisconsin Infantries were drafted into Federal Service under the new distinction of the 127th U. S. Infantry. In this new order of things Company A received a large number of men from the 6th Wisconsin who had enlisted at Marshfield.

With the new camp neatly established and only one object in view—to beat the Hun—the 127th went to work. Her sister regiments, 125th, 126th and 128th took to the new task with equal vigor. The nucleous of a great division was gradually being rounded out, and as reports show since the war is over, General Willis G. Hahn, who made and brought the division to the scene of battle, was working on exceptionally good material.

The period of time between August 21, 1917 and January 21, 1918, at Camp McArthur, was no vacation. The 32nd division had been organized, trained and equipped to go overseas. Company A left the camp on January 21, 1918, routed for Camp Merritt, New Jersey which meant they would be sailing for "over there" in a very short time. They arrived in Camp Merritt January 28. The boys were well quartered, well fed and in high spirits. Any soldier who has been quartered in Camp Merritt knows what a fine camp it is —the last touch of the good old U. S. A.—with good beds, fine kitchens and mess rooms, excellent baths and plenty of heat and light everywhere (except out of doors). All this and leaves to New York City.

The great news came at last. They were to sail for France! But with the good news came a hard-felt blow. Boys who had enlisted to be together; who had trained and prepared themselves together; who wanted to fight together, were split. An epidemic of mumps cut the Company strength down to six officers and 145 enlisted men, leaving 87 behind. But the division had to sail regardless of the depletion of strength. On February 15th the company marched to the railroad, boarded the alotted cars, slipped into Hoboken and went on board the U. S. S. George Washington. The great ship lay in dock for three days, taking on cargo and coal. At 10:30 p. m., February 18th the water monster slipped out past the statue of liberty and out to sea—a cargo of sturdy, eager and typical Americans going "over there" to do their bit.


The trip across the sea was uneventful, everybody being confined in accordance with strict regulations. It was a long, tiresome trip, the only thing really interesting being the destroyers that seemed to dive and buck like a wild horse. Land was sighted, somewhere in the Bay of Biscay, on the 2nd day of March. The big ship pulled into the Brest harbor at 3:30 a.m., March 4th, 1918. The 127 Infantry remained on board until March 7th, when the weary troops filed off the gang plank direct to a train that had been pulled in to await this load.

From Brest the Company was transported to Rest Camp No. 1, Base Section 2 (Camp Genicart, about three kilometers from Bordeaux, France), arriving there on March 9th. Stayed in Genicart for two days, resting, washing up and getting the kinks out of the "sea legs." At this time it was thought that the 32nd division was to be made the 1st Depot Division. Many officers and men were transferred from the division to combat outfits but Company A remained untouched. The company was attached to a labor battalion at St. Sulpice in March and worked there until April 5th, building warehouses and preparing buildings for the big army to come overseas.


The good news came that the 32nd was to remain intact, at least temporarily, so preparations were readily made to get them in shape for the lines. The division was assigned to the tenth training area, so Company A left her work at St. Sulpice on April 5th, by rail and on April 9th they detrained at Vaus Sou Aubigny and marched ten kilometers to Coucelles. The Company took up intensive training at Courcelles, learning the new dope on specialty weapons and trench warfare. While in the training area one hundred replacements from the 41st Division were received. The new personnel all came from the west so they readily fitted in their proper places.

After one month of training and equipping the division was pronounced fit and received order to proceed to Alsace to take over the first sector on the Western front. Company A left Courcelles on May 14th, marched to Langres, from which place they were transported to Phaffans by rail. The hike from Courcelles to Langress was a real test, not only because of the distance, but the men were carrying heavy packs, automatic rifles and the full supply of loaded clips for the automatic rifles. Arrived at Phaffans 10:00 a.m. May 15th. Left Phaffans for Novillars at 9:00 p.m. May 21st and arrived at Novillars at 1:00 a. m. May 22nd. Left Novillars at 9:00 p. m. June 2nd and arrived at Lutram 11:00 p.m. same date. The first trip into the trenches was made on June 9th at the Schonholz Sector. Came out of the Schonholz Sector June 21 and moved back to Retzwiller. Left Retzwiller at 9:00 p.m. July 2nd and relieved Company E, 127th Infantry in Maroc Sector, relief completed at 1:25 a.m. July 3, 1918. At this time the Boche got wise and put over heavy artillery fire bringing about the first casualties in Company A; 1 killed and 5 injured. On July 4th the Company had its second casualties. A party returned from a patrol and one of their own grenades was accidentally discharged, killing one, (Sgt. Willard Purdy) and wounding three.

During this period of "breaking in" on the Alsace front the big show was becoming very interesting over on the Marne. The Boche was not only stopped, but he was being driven back. The Americans, were having a taste of the hardest fighting the world had ever witnessed. The boys in the 32nd were eager to go over the "hot" sector. But, as was expected and hoped, the change was to be made. On July 23rd, 6:30 p. m., Company A entrained at Novillars. The train pulled out in the direction of the hotly contested area and at 4:30 a. m., July 24th, the Company detrained at Verberis. At Verberis the company was loaded onto trucks at 9:45 p. m., July 28th and moved to Chateau Thierry. From Chateau Thierry they hiked to Blemes, arriving at 12:00 p. m. the same date. At Blemes the 127th Infantry bivouaced in a near-by woods. At 4:45 p. m., July 20th the company was ordered into the

lines and at 5:00 a.m., July 30th they were in line at Roncheres. Up to this time the Third American Division had been doing wonderful work along the line now taken over by the Thirty-Second. The game was to be very different from the Alsace sector, but everybody felt equal to a repitition of the work done by the 3d division. On July 31st, at break of day, Company A made her first attack. The enemy was not holding back a thing. Machine guns and all calibres of artilery were very active. In the face of it all we find Company A in Cierges on August 1st. Then on they went to Cohen, on August 2nd and still on to the village of Dravegny. On August 4th the company was in the big show of the week, being an important element in the attack and capture of Fismes on the River Vesle. Fismes was the scene of some real hard scrapping. The Boche seemed determined to hold the town and for days it was occupied one one side by the Yanks and on the other side by the Boche. At 11:00 p. m., August 5th the 127th Infantry was relieved and proceeded back over the ground that they had fought over. For two nights they hiked, and on August 11th the regiment went into "pup tents" at Vezilly Woods. The regiment remained in these woods for several days, resting, cleaning up and feeding up. Company A received twelve (12) casual replacements. In the fighting from Roncheres to Fismes the company suffered the loss of one officer killed, and 118 enlisted men killed and wounded.

For four days, August 4th to 7th inclusive, the company was without a single officer, but 1st Sergeant Joseph Seidl took command, led the company over the top and made his objective like a veteran leader. Sergeant Seidl was recommended for the Distinguished Service Cross for his wonderful work and received praise from every rank and file.

Every "dough boy" remembers how the allies were hammering the Boche, first in one place and then in another, from the North Sea to Palestine. The British and French had been making wonderful progress all along the line from Soissons to the North Sea. However, determined resistance was met with It looked as though help would be needed to on the front west of Juvigny. oust the Hun. The 32nd Division was called upon to do the job. The division started moving northward from their position back of the Vesle. Company A hiked from Vezilly Woods to Cuise LaMotte on August 24th. On August 26th they hiked from Cuise LaMotte to vicinity of Vic sur Aisne. The 127th went into line on August 28th, Company A in reserve. August 29th the 32nd attacked and the stubborn resistance of the Boche was broken. A company, in reserve, witnessed the prettiest covering barrage ever laid down as the "red arrows" went forward. On September 1st the company went into line and passed on through and beyond Juvigny. She stayed in line until September 4th and was then drawn back to Bruizzy and placed in reserve. On September 7th they left Bruizzy and hiked back through Cuise LaMotte and pitched "pup tents" in a large woods about five kilometers norteast of the village of Piorrefonds. Left the woods on September 9th and took a train at Orrouy on the same night, destination unknown. On September 10th the regiment detrained at Curel.

In the Juvigny engagement the company had one man killed and 23 wounded.

In the Curel area the division rested, cleaned up and took up training. At this time Company A received 60 replacements from the 39th division. The Meuse-Argonne offensive was launched on September 26th but the 32nd was not chosen to be in the show from the start. But it had to come sooner or later, so on September 20th the division started moving in the direction

of the big guns. Company A left Curel on September 22nd and marched to Bruil. At Bruil they were taken on trucks to Fleury, arriving at 3:00 a.m. Sept 23. The 32nd was army reserve. Company A, in reserve, was stationed near the hammered village of Jubrecourt from September 25 to 29, and here the company received 40 replacements from the 31st division. On October 1st the 1st battalion was in line with Company A in reserve. On October 3rd Company A went into line near Gesnes. On the morning of October 5th the company advanced two kilometers and that night they were relieved and went into support. From October 9 to October 24 the company was in line, 16 days of attacking, short rations, lying in mud and chasing the Boche. On the night of the 24th they went into reserve position in Bois d' Vere where they remained until October 31st. On the first day of November the company moved to the Argonne forest. Left the Argonne at 4:00 a. m. on the 4th and hiked to Romagne. From Romagne to Cologne and thence to Bruilles on November 8th. At 4:00 p.m. call to arms was sounded and the company went into line northeast of Breheville. On the 9th the company advanced nine kilometers before meeting with a real strong resistance. Then it was a case of the old game of jumping from one shell hole to another-slow; but, true to the old reputation. Remained in line on the tenth and eleventh. Had orders to attack at 7:00 a. m. November 11th, but at 6:45 the message from the battalion commander stating that attack was called off on account of the signing of the armistice. At 11:00 a. m. the entire line was quiet-the Hun was beaten at his own game. The company remained in its final front line position until November 14th when the 3rd battalion relieved the first. The battalion moved to Breheville on November 15th and remained there two days delousing and cleaning up in general. November 16th the battalion moved to the Boche billets in the woods south of Jametz.

In the Argonne-Meuse offensive Company A had three officers killed in action and one wounded; one hundred and eight enlisted men killed and wounded.

In the period of time between the signing of the armistice and November 15th the American Army of Occupation was being formed—the Third Army. The 32nd division, with the 1st and 2nd, was to make up the 3rd corps, a part of the army destined for Germany and the new watch on the Rhine. The 127th Infantry, in their billets near Jametz, were making every preparation for the long hike. At 5:00 a. m. November 17th, with the band playing the famous 32nd march, Colonel Langdon moved his regiment across "No Man's Land" and swung the column off towards Germany.

The hike to the Rhine was a real test for the men who had been in the big fighting. With intermittent rests of two or three days, it took from November 17th to December 11th, in very unpleasant weather, up and down heart-breaking hills and with meals at no regular fixed time. On November 20th the regiment crossed the border of France, Belgium and Luxemburg. On November 23rd the 1st battalion marched into Born, Luxemburg, on the bank of the River Saur, where they remained until December 1st, doing guard duty on the German Frontier. On December 1st the 127th proceeded across the River Saur and into Germany. Company A was advance guard of the regiment on December 2nd and 9th. Arrived on the River Rhine on December 11th and the company was detached from the battalion to do guard duty on the Rhine at St. Sebastian-the first troops on the famous river. December 13th the regiment crossed the River Rhine and proceeded to Herschbach and Selters to establish outposts on the Coblenz Bridgehead. In the time spent in the Bridgehead Company A has been stationed in Alsbach and Herschbach.

During the time this Company of sturdy, true Americans were stationed in the village of Herschbach, Germany, they were put to the test of their little game in the U. S. called Squads East and Squads West and went thru this, day after day with the same spirit as heretofor, day after day they toiled at the work put before them and eagerly waited for the little paper that meant so much to them, "Orders to go home." These however were not to be had so easily, although they meant more to the boys than the famous bugle call that lined the boys up for their pay.

All this time the boys devoted their time to baseball, football and other pastimes that shortened the stay in the European country, and they played an important part in the upkeep of the Record for the 1st Battalion. All honors went to the boys of this Company as odds were against them in all things in with they competed, baseball especially was their hobby and they took all honors away from all Companies, and finally two Battalions which consisted of all picked men of the Regiment, Company "A" held it's own, playing games that closed in their favor with the scores of small numbers. After they had beaten all Companies and Battalions that were placed before them they received a challenge from Headquarters Company of this regiment for the Regimental Championship game. This was to be no easy mark for the boys and they knew it, but they went forth with the same spirit with which they went into the game of beating the Hun and they came out the victors, upholding the record as they had in the last two years. The final game was to be played shortly after the Brigade championship but rainy weather postponed the game from one day to the other until the long waited for "Orders to go home" were received. The time from then on was spent in general cleanup and inspection. Never before in the history of Company "A," 127th Infantry did the boys fall in for inspection or in fact anything as they did on these last days of their army life. "Cooties," their old friends that had remained at their side and on their sides all through this great War were to be left behind. No man with pets like these would be allowed to leave that soil if he showed the least sign of having tried to smuggle these war veterans over to the United States. Soldiers were not seen on the streets in this village until they had said goodbye to their Cootie pals. It was an old scene to see the boys together in a room using the Red iron which they borrowed from the German inhabitants, ironing their blankets and the seams of their clothing. The final inspection in Germany gave the report as, "Company A, No Cooties, ready for embarkation."

This was great news to all and everyone that knew the little poem that follows, say that they had never expected that this day would ever come. The poem was written by a soldier after three months in the Army of Occupation.

> We are here sweetheart in the Fatherland, On the banks of the Famous Rhine. The weather is wet and our feet are cold, And we drink from a great big Stein. Our slum and our beans come regular, While the Germans are thin from starvation. Oh:—Life is one sweet round of joy. IN THE ARMY OF OCCUPATION.

The Kaiser is done, he had his day 'Till he crossed the Dutch Frontier. Cf him we are rid, and we sit on the lid And wonder why we are here. We fought and bled, and some are dead, For the honor and love of our Nation. We hit them a crack, now we want to get back, FROM THIS ARMY OF OCCUPATION.

The Crown Prince is a joke, and I hope he will creak And with Ludendorf, go down to Hades, With the men we'll be stricter, and drink up the liquor And fraternize only with the ladies. Oh:—This life is getting monotonous, dear, I'm afraid we will starve of stagnation. For we have no fun when the drill is done, IN THE ARMY OF OCCUPATION.

Cigarettes are a luxury, honey and rare, For up here there is no Y. M. C. A. They say they are back in the S. O. S. The Y. M. C. A. and the K. of C. they say Are cousins of some kind of relation In vain they are sought by the soldiers who fought IN THE ARMY OF OCCUPATION.

Dream on, dream on, sweetheart of mine We may come home some day. But to us it seems in all our dreams, We'll be feeble and old and grey. Tell the Red Cross nurse, when I ride the hearse To my billet in St. Peters Station, The Old Man's my pride, for he lived and died, IN THE ARMY OF OCCUPATION.

On the morning of April 18th at 7:00 a. m. Company A was lined up on the avenue waiting for the order to move. Trucks were drawn up. This was something unusual as every move had been made via foot, and the boys took that as one of the greatest treats they had ever had in their life. All German inhabitants were there to give the boys a "Gutes Glick," and many German women were seen to cry as the boys left for home. All boys of the 32nd Division made friends most anywhere as their kind ways and disposition won places in the hardest heart. Although being our enemies, these people have done wonderful things for some of the boys. Company A especially seemed to be "their boys" and whenever a soldier would ask the civilians for anything they would ask from what Company he was from. If he said from Company A, they would say "Ah, das ist gute" and he was sure to get what he wanted.

Company A left Herschbach, Germany by trucks and passed by the way of Coblenz and on to Neiderdieber, where they boarded a train and left for Brest, France at 12:30 P. M. the 18th. The trip was an interesting one and hardships were forgotten. There was to be no more riding in cars marked 40 Hommes, 8 Chevaux, which in French means 40 men or 8 horses. These cars allow 10 square feet to every twenty men, not counting his pack and riffle. All cars were real American Made beacoup (enough) room for everyone. The thing that interested the men were the large Moselle Vineyards along the Moselle River, these yards extending in all directions and built mostly on the mountain sides, having taken many years and hard labor to obtain the crops they are receiving from these fields today.

We passed through the second largest tunnel in the world and finally stopped for a lunch given by the Red Cross at Trier, Germany. Here we met the Famous Poland troops going to war, which gave the boys a thrill, after going through all they had gone through, and then to see others leaving their homes to receive the hardships they themselves had received.

Company A detrained at Brest, France at 5:10 p. m. April 21 and marched to Camp Pontonegen, to wait transportation for home. Here they received (more) inspections of personnel and paper work, and marched to the port of embarkation at 7:00 A. M., the 24th of April and embarked on board the U. S. S. Cap Finisterre, a German vessel which had been taken over by the Americans as spoils of War. This vessel had not been used for four years and was under control of a German crew until the American officers had learned the mechanism, this of course would take no time at all.

The trip across the "Pond" was uneventful, the weather being very pleasant and favored us with a calm sea, the company being first to complete their inspection was first to sail and was sent ahead as an advanced detachment of of the Division. being part of the ship that held Headquarters Company and a detail of Company B. This Regiment, some 680 men and a great number of Red Cross workers composed the detachment.

Differences can not be explained between the two trips of crossing the water. Lights were lit and the famous 127th Infantry Band from Marshfield, Wisconsin, favored us with concerts and dance music. Most every night dances were held on board, and with all other amusements men did not have time to get the sickness that is so common among sea travelers.

At 7:00 A. M. May 5tth, 1919, all eves were set on the one girl which all had been longing to see for years. It was something that can not explained, men stood rigid on the deck and had tears in their eyes as they neared the New York harbor. Here they were met by the New York Welcome Committee, which came up to the side of the ship with bands playing, and a heavy barrage of oranges. The first piece that met our ears was "Home Sweet Home. People who have not been over and who have not actually been in the game in France, cannot imagine the feeling the soldier boys had upon receiving this welcome upon their arrival in the land of Paradise.

The great ship Cap Finisterre dropped anchor in the New York harbor and the quarantine flag was raised. This brought the medical officers on board and in less than an hour the flag was lowered and the boat proceeded on it's way. At 10:00 A. M. we reached the New York Docks and at 12:30 all men had disembarked, once more on U.S. soil. Here we were fed by the Red Cross and proceeded via train for Camp Merritt, New Jersey, for final examination of records and inspections. We arrived at this camp at 2:00 P. M. the same day and passed through the Sanitary Process plant at 4:00 P. M. Here we received new clothes and after this shook hands with all comrades that were with us through the great struggle and all Wisconsin men shouldered arms and marched away to the area assigned to them. On the 14th day of May orders were received to prepare for moving to Camp Grant, Illinois for discharge. Men were to leave at 2:00 P. M. and at 1:30 everything was in A-1 condition and the company of 63 men were lined up ready to leave camp, when the tide similar to the one which cut the company in two in 1918, came in and cut the Company down to 35 men, leaving 28 in quarantine for typhoid

fever. These men that were placed in quarantine were mostly old men that were placed in quarantine at Camp Merritt, New Jersey in 1918 and knew all about being a casual and our sympathy goes with them through all the hardships they may have endured.

The remnants of Company A, thirty-five men left Camp Merritt, New Jersey at 2:00 P. M. and arrived at Camp Grant, Illinois at 7:00 A. M., May 16th. There they received, Oh, yes, "more inspections" and finally were ordered to the discharge depot for final disposition of their records and to receive their discharge papers. On the 17th of May Company A marched to the station and received pay due them, "the last time to fall in line." Wasn't it a grand and glorious feeling?

Company A left Camp Grant, Illinois at 5:00 P. M. and arrived at their home rendezvous, Marshfield, Wisconsin, the most patriotic little city in the north west.

#### SOME NOTES AND DATA

Left Marshfield Wisconsin, July 15, 1917.

Left for France, February 18, 1918.

Battles engaged in—5 engagements, from May 18, 1918 to Nov. 11, 1918, with ten days rest. During these ten days we received the hardest drilling we received in our army days.

In Germany as Army of Occupation for 5 months.

Left France, April 25, 1919.

Arrived in Good Old United States, May 5, 1919.

Back home to Marshfield, Wisconsin, May 18, 1919.

Captain Horace L. Anderson, commanding Company A, mentionedd in this sketch as First Lieutenant Horace L. Anderson, wounded once in action, received his two bars in November, 1918, while commanding a company at the Army Candidates Schools at La Valboune, France.

1st Sgt. Joseph P. Seidl, was commissioned a 2nd Lieutenant of Infantry on November 7th, 1918 and lucky for his company, he was assigned for duty.

In her A. E. F. life, Company A has sent three instructors back to the United States; Lieutent Ballam and Sergeant Goodin on July 23, 1918 and Corporal Willard O. Christensen on August 15th, 1918.

Two Sergeants were commissioned 2nd Lieutenants of Infantry at the Army Candidates School at Langres, France–Sergeants Peterson and Zumach.

Two men received decorations for gallantry on the field of action.

Sgt. Willard D. Purdy of Marshfield, Wisconsin.

Cook Leo Kick of Marshfield, Wisconsin.

Sgt. Willard D. Purdy had charge of a patrol which had just returned from No Man's Land, and had lined up the men for inspection as to disposing of their hand grenades. After the inspection he took the grenades from his own pocket and accidentally pulled the pin on one of the three and as the cap that discharges the grenade exploded, Sgt. Purdy looked hastily in all directions to see whether he could throw same without injury to some of his comrades. Seeing that this could not be done without loss of life he yelled, "For God's sake beat it." or words to that effect, and held the three grenades in his hands and bent over them. The explosion which followed shortly after killed Sgt. Purdy instantly and wounded Cpl. Sweating of the Scout Platoon and Pvts. Kennedy and Hill of Company A. Sergeant Purdy was awarded the distinguished service cross for the above. This was forwarded to his mother at Marshifeld, Wisconsin.

Cook Leo Kick, while in action on the Soissons front received a severe shrapnel wound in the arm while cooking for the company, which was then in reserve. The dinner which Cook Kick was preparing was ready to be taken off of the field oven when the accident occured and although the wound inflicted was very painful, he stayed with the kitchen and kept the beaus from burning and thus saved the dinner for the men. Cook Kick was recommended for his gallantry and received the Croix de Guerre from the French government while with the Army of Occupation in Germany.
