REGULAR MEETING OF THE BOARD OF REGENTS

Madison, Wisconsin Saturday, November 21, 1942, 9 A.M.

President Glover presiding

The Comptroller was appointed to act as Secretary pro tem in the absence of Mr. McCaffrey.

PRESENT: Regents Callahan, Cleary, Ekern, Glover, Kleczka, Sensenbrenner, Vergeront.

ABSENT: Regents Hodgkins, Holmes, Werner.

Word was received from Regents Hodgkins, Holmes and Werner in explanation of their absence.

Upon motion of Regent Cleary, seconded by Regent Sensenbrenner, it was VOTED, That the minutes of the regular meeting of the Board held on October 31, 1942, be approved as sent out to the Regents.

RECOMMENDATIONS OF THE PRESIDENT

- Administration and General -

1. That the following changes in requirements, voted by the Faculty on November 2, 1942, be approved:

Engineering

That until further notice the three-credit requirement of

engineering economics in the chemical engineering course be waived, and that students be required to substitute elective credits for the three credits formerly required in engineering economics.

Law

That the requirements for a senior paper or other work in lieu thereof, and the requirements for drafting exercises be waived for the duration.

Modicine V

That for the duration of the war the course for physical therapy technicians include the following requirements:

Admission

Candidates for admission must have had two years of academic college work including courses in physics and biology in an approved college.

Curriculum

The curriculum includes six months work in anatomy, clinical practice, electrotherapy, ethics and administration, hydrotherapy, massage, pathology, physiology, principles of physical therapy, psychology, therapeutic exercise, and electives. The credits in these subjects apply only to the physical therapy course.

Cortificate

A certificate is issued by the Medical School at the end of the course to those who have successfully fulfilled all of the requirements including an extensive written, oral and practical final examination.

President Dykstra presented a confidential communication from the Dean of the College of Agriculture in which he suggested eight names for Honorary Recognition in the College of Agriculture and in which he explained that due to the difficulty in transportation and hotol accommodations, the plan of the College of Agriculture this year is to have a two-day session in each of eight districts over the state and that the Honorary Recognition will be conferred upon one person at

each of these district Farm and Home Week Sessions.

Upon recommendation of the President, and upon motion of Regent Sensenbrenner, seconded by Regent Cleary, it was

VOTED, That the list of names be approved. (list of names on file) (It is understood that no announcements are to be made at this time.)

President Dykstra presented the revised Summer Session budget for September, 1942 to June, 1943, totalling \$21,350. (Copy on file)

(It is understood that the salary of the Summer Session Director will be redistributed so that \$4000 will be charged against the School of Education, academic year basis, and \$2400, on a twelve months' basis, against Summer Session.)

Upon motion of Regent Cleary, seconded by Regent Kleczka, the budget was approved.

President Dykstra stated that the Director and Assistant Director of Radio Station WHA are entering war service and it is therefore necessary to make certain temporary changes in personnel, effective December 1, 1942. Upon recommendation of the President, and upon motion of Regent Kleczka, seconded by Regent Vergeront, the following recommendations of the Director of Station WHA were adopted:

- (1) That William G. Harley be made Acting Director of Radio Station WHA and that his salary be increased from \$2700 to \$3000.
- (2) That Walter Krulevitch be made Acting Program Supervisor, WHA, and that his salary be increased from \$1800 to \$2400.

- (3) That Joyce M. Jaeger/be made Acting Director of the Wisconsin School of the Air at a salary of \$2400.
- (4) That Mrs. Romance C. Koopman be made Acting Script Editor, WHA, at a salary of \$2040.
- (5) That Roy C. Vogelman, now part-time announcer and newscastor, WHA, be placed on a full-time basis at a salary of \$1500.

Upon motion of Regent Kleczka, seconded by Regent Callahan, the following appropriations from Regents' Unassigned were approved:

President Dykstra called attention to the action of the Regents dated September 28, 1940, which provides that students who enter the armod services of the nation will receive a full refund of fees paid for the semester in which they enter the services. President Dykstra recommended that this regulation be extended to include students who enter the American Field Service. Upon motion of Regent Sensenbrenner, seconded by Regent Callahan, this recommendation was adopted.

Upon motion of Regent Cleary, seconded by Regent Vergeront, it was VOTED, That the actions taken by the President since the last meeting of the Board (October 31, 1942) be approved and made a part of the records of this meeting.

Upon motion of Regent Cleary, seconded by Regent Kleczka, the following recommendations of the Comptroller were adopted:

- 1. That the Comptroller be authorized to sign new contracts with the United States Navy on the basis of renegotiations that have been explained to the Regents.
- 2. That the President and the Comptroller be authorized to present to the Emergency Board increases in civil service salaries within established salary ranges in critical positions where such increases are within the totals of the budgets approved.
- 3. That the President and the Comptroller be authorized to waive the rule relating to partial retirement of civil service employees who have reached the age of seventy years in such cases as they deem expedient and necessary on account of the employment conditions in the present war emergency.

The Comptroller reported that 360 rescues had been made from Lake Mendota by the Life Saving Crew during the past season.

At the suggestion of Regent Cleary, Chairman of the Finance Committee, and upon motion of Regent Sensenbrenner, seconded by Regent Vergeront, it was

VOTED, That the legislative requests for 1943-45, as presented to the State Budget Director by the Finance Committee and administrative officers, be approved.

Comptroller Peterson made a report on the matter of turning in the cannons

on the University campus for scrap and stated that it was the recommendation of the Director of the Legislative Reference Library that the Board of Regents do nothing without legislative action since there seems to be no record as to just how the Regents came into possession of the cannons.

President Dykstra stated that the National Committee, which is interested in scholarships for Scandinavian students, particularly Icelanders, were inquiring as to whether the University of Wisconsin could make available a scholarship to a student from Iceland. Upon motion of Regent Cleary, seconded by Regent Kleczka, it was

VOTED, That the President be authorized to correspond with the committee . and say that the University will be glad to cooperate with them in bringing an Icelandic student to the University.

At 9:50 A.M. the meeting adjourned.
