## REGULAR MEETING OF THE BOARD OF REGENTS

Madison, Wisconsin

Wednesday, March 14, 1934, 9 A.M.

In the absence of the President and the Vice President of the Board Regent Callahan presided

PRESENT: President Frank; Regents Baker, Berger, Callahan, Chris-

topherson, Combs, Drexler, Eimon, Grady, Gundersen, Runge,

Sholts, Ullsperger; Regent Wilkie came in later.

ABSENT: Regents Backus, Clausen, Mead.

Regent Backus telephoned that he was unable to attend the meeting because of an injury to his foot. Regent Clausen was present at the committee meetings on March 13, but was unable to remain for the board meeting. Regent Mead is still in Florida.

Action was taken on the recommendations of the President, which had been previously considered in committee meetings. The recommendations are as follows:

President Frank presented a memorandum from Major Gonser advising that the federal government contemplated building twenty-five armories for land grant colleges throughout the country, each to cost \$400,000; the institution being required to furnish the land, and maintain the building, the federal government paying for the construction and equipment of the building. Major Gonser was requested to get further information, especially with reference to whether the money was available or whether an appropriation would have to be secured.

Recommendation No. 13 under Letters and Science, was again taken up for consideration. Regent Drexler moved, seconded by Regent Grady, that the recommendation be disapproved. Called vote was taken.
