# REGULAR MEETING OF THE BOARD OF REGENTS

Madison, Wisconsin

Wednesday, December 3, 1924, 10:00 A. M.

Regent Casperson was present for all of the committee meetings on Tuesday. A communication was received from Regent Schmidtmann advising that he could not come on account of a severe cold.
