REGULAR MEETING OF THE BOARD OF REGENTS

Madison, Wisconsin

Saturday, January 19, 1946, 9 A.M.

President Sensenbrenner presiding

PRESENT: Regents Callahan, Campbell, Cleary, Grady, Hodgkins, Holmes, Jones, Kleczka, Sensenbrenner, Werner

Upon motion of Regent Cleary, seconded by Regent Campbell, it was VOTED, That the minutes of the regular meeting of the Board held on December 1, 1945, be approved as sent out to the Regents.

Upon motion of Regent Callahan, seconded by Regent Kleczka, it was VOTED, That the minutes of the special meeting of the Executive Committee held on Friday, December 14, 1945, be approved, ratified and confirmed.

RECOMMENDATIONS OF THE PRESIDENT

- Administration and General -
- 1. That the following actions by the Faculty be approved:
- (a) Recommendation of the Faculty of the Graduate School of the program presented by the College of Engineering for off-campus work in Milwaukee, beginning March 1946, or as soon thereafter as deemed feasible. (Copy attached)
- (b) Recommendation of the Faculty of the Law School as follows:
 That the degree of Master of Laws (LL. M.) be established for students
 who have completed the requirements for a certificate in Law in this Law
 School, or the equivalent thereof at another law school having similar
 requirements, and who thereafter successfully complete an additional
 year's work of 26 credits in the Law School.

 (The above degree will be administered by the Law School and not through
 the Graduate School.)

For Non-Residents of the State of Wisconsin

Non-veterans - \$18.00 for each major division of the course or \$90.00 for the entire course. Veterans eligible under the G.I. Bill of Rights - The cost of the veterans' instruction or fees as agreed to between the University and the Veterans Administration.

President Fred explained that due to the shortage of rooms for students and in order to provide rooms for Wisconsin veterans, it is necessary, starting at once, to place applications for admission from out-of-state veterans on the same basis as other out-of-state students. It is understood that this action will be modified as soon as housing conditions permit.

In view of this action it becomes necessary to adjust the salaries now being paid to jobs foremen to keep them in proper relation to the wages paid journeymen. Upon motion of Regent Cleary, seconded by Regent Callahan, it was

Upon motion of Regent Jones, seconded by Regent Callahan, it was VOTED. That the Director of Business and Finance be directed to request the Bureau of Personnel to renew the request for an increase in the salary range of the Superintendent of Buildings and Grounds.

The Secretary presented a letter from John Berge, Executive Secretary of the Wisconsin Alumni/Association, requesting the transfer of the funds received for the Julius E. Olson Scholarship-Loan Fund, totaling \$9,724.62, to the University Trust Funds, the fund to be administered in the same manner as other trust funds handled by the University of Wisconsin and under the following conditions:

The income may be used for either cash scholarships or for loans.

Recommendations for either scholarships or loans are to be made by the Faculty Committee on Leans and Undergraduate Scholarships, but scholarships and loans are to be available to both graduates and undergraduates and to men and women.

Student loans are to be made for not to exceed one year but with the understanding that they may be renewed when necessary, the interest rate to be 3% per annum. When a student pays his loan or interest on a loan, it is to be added to the principal.

Any student who has had a cash award and wishes to pay into the fund in the future will be permitted to do so, and authority is given to receive additional donations from time to time as they may be tendered.

Upon motion of Regent Cleary, seconded by Regent Campbell, it was VOTED, That the transfer and administration of the fund in accordance with the above conditions be approved.

The Secretary reported upon the Caroline Young Estate; setting up "The Peter Young Fund" as a memorial to her father, and stated we had received in cash \$39,486.73, in stocks \$53,616.90, and in bonds \$11,856.41; that dividends had been received to date and credited to income in the amount of \$1,464.76; that \$5000 was yet to come from the trustees which has been withheld for contingencies; that seventeen shares of Cincinnati Gas and Electric Company 5% Preferred Stock has been called and that the proceeds, aggregating \$1,827.50, had not yet been received, making the total of the estate at present, including income, \$113,262.30.

Robinson, et al., Respondents, directed the County Court of Milwaukee County to tender "to the Regents of the University of Wisconsin appointment as successor trustees to the women trustees with all the powers and subject to all the duties of such trustees", f Williams THEREFORE, BE IT RESOLVED that the Board of Regents of the University shall and hereby does agree to act as successor trustees to the women trustees with all the powers and subject to all the duties of such trustees provided for in the will of Florence Porter Robinson, deceased, and to perform all duties of administering the trust imposed by said will on said women trustees.

BE IT FURTHER RESOLVED that when the County Court of Milwaukee County tenders to the Regents of the University of Wisconsin the appointment as successor trustees to the women trustees, the Secretary of this Board shall deliver a copy of this resolution to the Honorable F. W. Bucklin, Acting County Judge of the County Court of Milwaukee County, and that the Secretary of this Board be authorized to receipt for the proceeds of the Estate for the Regents when they are turned over to the University.

Regent Jones discussed the situation with reference to the allotment of land in relation to requests of Physical Education, College of Agriculture, College of Engineering and Residence Halls and stated that the Constructional Development Committee would meet in the President's Office on Wednesday, January 30, 1946, at 10 A.M.; that in the meantime the Steering Committee would be requested to reexplore the situation and bring in a report. Regent Jones urged all Regents to be present at this meeting.

The matter of acquiring the King property in the area designated for the site of the Dairy Building was discussed. Upon motion of Regent Jones, seconded by Regent Holmes, it was

VOTED, That the Director of Business and Finance be authorized to carry on further negotiations with Mrs. King on the basis of acquiring the property upon six months' notice.

President Fred referred to the plans that had been discussed for the use of Badger Ordnance Works to accommodate student veterans. Upon motion of Regent Holmes, seconded by Regent Werner, it was

VOTED, That the President and the faculty be authorized to proceed with plans for establishing a temporary educational center or branch of the University at Badger Ordnance Works.

Dean Elwell of the School of Commerce appeared before the Board at 10.55 A.M. and requested a change in name of what is now listed as "The School of Banking of the University of Wisconsin". This is a two-weeks' course and extends for three years. Dean Elwell stated that the attendance for this coming summer will be limited to the capacity of Chadbourne Hall, which is 150. After considerable discussion a motion was presented by Regent Kleczka, seconded by Regent Callahan, to change the name to "The School of Banking at the University of Wisconsin for the Central States". This motion was carried. Regents Grady and Werner voted "No".

At 11:15 A.M. the meeting adjourned.

Document 749 - January 7, 1946 (as amended) Recommendations of Special Committee on Admissions

The policy of admission which has prevailed is that Wisconsin students, out-of-state veterans, present and former students who are in good standing will have priority over new non-resident non-veteran students. It is assumed that this policy will be continued. It is the policy upon which the following recommendations are made.

I. Recommendations upon Admission Procedures

- A. That no change be made in the admission of Wisconsin students, or at present, of out-of-state veterans.
- B. That, subject to the exceptions outlined in C, D and E below:
 - 1. No new non-resident non-veteran students be permitted to enter the second semester of 1945-46.
 - 2. Permits granted to new non-resident students for the summer semester or for the 8-week summer session carry no commitment for permission to register in the fall semester of 1946-47.
 - 3. Applications of new non-resident non-veteran students for permission to register in the fall semester of 1946-47 be held until July 1, 1946, at which time better knowledge of housing and enrollment prospects should enable the University to determine the admission requirements which will yield a student load which the University can handle. Applicants should be informed of this action. (if increased housing accommodations become available, the date of July 1 may be moved to an earlier date.)
 - 4. Permits to register issued for previous semesters, but not used, be cancelled.
 - C. That there be the following exceptions from the regulations described in B above.
 - 1. Students appointed to teaching or research assistantships.
 - 2. Students appointed to University scholarships and fellowships carrying compensation, where the appointment is made primarily on the basis of scholarship.
 - 3. Students appointed to legislator's scholarships.
 - 4. Students with a bachelor's degree entering the University with a G. P. A. of 1.75 or above.

- 5. Wives or husbands of students who are admitted.
- 6. Students of high quality who are resident in foreign countries and who enter the University directly from those countries.
- D. That the Registrar and / or his officers and the Deans of the college compose a committee which will be empowered to make individual exceptions as the total circumstances require. In general the Registrar and Dean of the college concerned will act for the committee. This regulation will permit allowing students of very exceptional promise to enter.
- E. That the Registrar may make exceptions in the case of students where commitments have been already made.

II. Other Recommendations

- A. That the faculty suggest to the Deans of the various colleges and schools that it would be appropriate at this time to be stricter in the matter of dropping and readmitting students who have been doing unsatisfactory work.
- B. That, in view of the housing shortage, high school principals of Wisconsin be urged to recommend for entrance only those students who have shown aptitude for college work.
- C. That the administration of the policies contained herein be placed in the hands of the Administrative Committee of the University with a request to report changes in these policies to the University Faculty.
- III. That the Faculty feels that the above measures insofar as they diminish opportunity for out-of-state students to attend the University, tend in an unhappy fashion to deprive Wisconsin's own young men and young women of the educational values which derive from broadly international personal acquaintanceships on the Campus.

PAUL E. STARK MEMORIAL FUND

Statement of Intent and Conditions

The Paul E. Stark Memorial Fund is to be established at the University of Wisconsin for the general purpose of furthering the University's program of education and research in the field of real estate and urban land economics. The monies in the Fund are to be expended under the direction of a committee composed of the Dean of the School of Commerce, the chairman of the Committee on Education of the National Association of Real Estate Boards, and the professor in charge of the Real Estate Curriculum in the School of Commerce.

The Fund may be used to provide financial assistance to graduate students in real estate and urban land economics with the objective of encouraging them to enter upon careers of teaching and research. In addition, the Fund may be used for any purpose which in the judgment of the administering committee will further the development of a program of education and research in real estate and urban land economics.

It is the intention of the donors that the Fund shall be used to meet expenses for which regular state appropriated University funds are not readily available. It is a condition of the gift that the expenditures out of the Fund shall not be governed or limited by state laws and regulations which control the expenditure of state appropriated money.
