REGULAR MEETING OF THE BOARD OF REGENTS Madison, Wisconsin

Tuesday and Wednesday, March 8 and 9, 1938

The meeting convened at 10 A.M. on March 8, Vice President Combs presiding

President Dykstra; Regents Brown, Callahan, Campbell, Christopherson, Combs, Gates, Glover, Kelly, Miller.

Upon motion of Regent Gates, seconded by Regent Miller, it VOTED, That the minutes of the meeting of the Board held on January 18 and 19, 1938, be approved as sent out to the Regents.

Upon motion of Regent Callahan, seconded by Regent Glover, it was VOTED, That President Dykstra be appointed as the University representative to serve on the Madison and Regional Planning Committee.

RECOMMENDATIONS OF THE PRESIDENT

- Administration and General -

That authority be given to use the \$2000 grant from the du Pont Company under their post-doctorate plan (accepted by the Regents at the January 18-19, 1938 meeting) for the employment of a research assistant in chemistry, the position not to be subject to the ten per cent charge applied to fellowships. Adopted.

- 1. That the loan fund committee as constituted at present be continued, and that its primary function be the establishment of the policies which shall govern the granting of loans and that somewhat less time be given in committee meetings to the discussion of routine details.
- 2. That a loan office be established in the Administration Building, that such office be under the general supervision of the Business Manager, and that all applications be initiated, routed to the proper faculty member or members for approval, and completed in the loan fund office.
- 3. That the following procedure be established:
 - a. Student makes application for loan at the loan fund office in the Administration Building. (See exception in #4 below.)
 - b. The manager of the loan fund office refers to a Kardex visible record to determine the student's past record, if any, on loans from the University.
 - c. The manager will indicate such record on the application. The student is then given a mimeographed statement directing him to go to the office of the Registrar for a tran-

script of his grades and a preliminary interview and then to other faculty members for interviews. It is suggested that the Dean of Men see all men students, and the Dean of Women all women students. Two other interviews seem desirable - one with the persons in charge of the Student Employment Office and the other with the committee member who represents the college in which the student is enrolled. The Committee will determine the conditions under which additional interviews may be desirable.

- d. If the loan is approved by the Dean of Men or the Dean of Women, and the other committee members to whom he has been sent, the student returns to the loan fund office where the loan is completed by the manager. The manager will prepare the note and the Kardex file record, obtain the student's signature to the note, issue the check, and deliver it to the student. If the loan is not approved by the persons to whom the applicant has been sent, the manager will refer the application to the Committee for final action.
- e. The manager of the student loan office shall be in charge of collections, but all receipts of cash and checks shall be accepted by the Cashier's Office only. All notices of notes due and all follow-up work shall be prepared and sent out by the loan fund office in accordance with instructions to be issued by the loan Committee.
- f. The manager may grant extensions and renewals and authorize partial payments and payments of interest in accordance with rules and regulations to be established by the Committee.
- g. All notes issued and accepted, whether originals or renewals, shall be delivered at the end of each day's business by the manager of the loan fund office to the Cashier's Office, and the University Cashier shall be in sole charge and control of all original notes, subject only to necessary auditing procedure.
- h. The Cashier's Office shall maintain the necessary detailed and summary records of all loan funds, and shall furnish necessary re-

ports to the manager of the loan fund office and to others as required. This procedure is in keeping with sound accounting principles and will reduce the duplication of records to a minimum.

- i. The manager will meet with the committee and furnish such reports as may be directed.
- 4. The special loan funds that are now under the sole authority of some officer of the University, such as the Secretary's loan fund, the Agricultural, Engineering, and Law Funds, shall be administered as outlined above, except that the loan may be completed by the manager of the loan fund office on the sole recommendation of the officer named, i.e., the Secretary of the Regents for the Secretary's loan fund, the Dean of the College of Engineering for the Engineering fund, etc.

It is suggested, however, that it may be advantageous in many ways if the officers in charge of these loans would require applicants to go through regular channels in order that the information regarding the student to be obtained from the Registrar and the Dean of Men or Dean of Women would in all cases be complete.

- 5. It is recommended that such funds as the Strong Fund, where the cash is not held by the University, be administered through the loan office according to the regular procedure.
- 6. It is recommended that a suitable office be made available for the manager of the student loans on the first floor of the Administration Building, across the corridor from the Cashier's Office.
- 7. It is also recommended that as soon as this procedure is approved, the manager of the loan office be selected immediately from the present civil service staff of the University, salary to be charged to Regents' Unassigned, and that the manager, the Comptroller's office, the Cashier's office, and the Registrar's office immediately prepare all necessary forms for the administration of the approved procedure.

President Dykstra presented a communication from Ambassador Joseph E. Davies, offering the gift of a collection of icons, if they could be properly housed within the next three or four years, and to

loan them for exhibition purposes during the commencement period of 1938. The letter referred also to the collection of paintings which he has presented to the University. It was felt that President Dykstra's reply to this letter should constitute a conditional acceptance and upon motion of Regent Callahan, seconded by Regent Christopherson, it

VOTED, That the Secretary of the Board be instructed to make proper acknowledgment of the letter from Mr. Davies and that so far as the collection of pictures is concerned, the matter be left in the hands of the President to be worked out to the best of his ability.

President Dykstra read a letter from the corresponding secretary of the Wisconsin University Teachers Union, calling attention to the fact that no action has been taken on the June, 1937, resolution of the Regents. The President suggested that reply be made to the effect that the committees appointed have been meeting and it is believed by the Board that these meetings are proceeding in conformity with the action of the Board taken in June, 1937, and that the matter is proceeding. Upon motion of Regent Christopherson, seconded by Regent Callahan, it was

VOTED, That the letter be placed on file.

✓ Upon motion of Regent Callahan, seconded by Regent Kelly, the following recommendation of the President was adopted:

That authority be granted to loan \$25,000 or more of the money in 20.41(15)B (M.W.McArdle Cancer Fund) including the \$12,000 about to be received from the University's interest in Maxwelton Braes, to the Anchor Savings Building & Loan Association of Madison, for one year at 3% interest payable semiannually, the amount of the note or any part thereof to be callable on thirty days' notice - the Anchor Association to furnish collateral so that the amount of the obligation will not exceed 50% of the fair market value of such collateral.

✓ Upon recommendation of the President and upon motion of Regent Brown, seconded by Regent Callahan, it was
VOTED, That \$2600 be allotted to the School for Workers in

Industry for the final quarter of the current fiscal year and that the following budget submitted by the committee be approved:

The total appropriation is \$29,000. This allotment makes the total budget for the year \$26,600.

The matter of providing quarters for the YWCA was discussed and the question raised as to whether the University could pay the Union approximately \$20 per month for quarters, or furnish suitable quarters elsewhere without rent. Upon motion of Regent Brown, seconded by Regent Kelly, it was

VOTED, That an opinion be secured from the Attorney General's office as to whether the Regents can legally make an appropriation for

such purpose.

Harriet Spector and Gordon Dupee, students, appeared before the Board with reference to their application for the use of Music Hall on March 16 by the North American Committee of the League for Liberal Action, for an address by Miss Fredericka Martin, chief American nurse in Spain, admittance to be charged and the proceeds to go to the relief of Spanish Loyalists. After considerable discussion the matter was put over until the Wednesday session of the Board. (See page 37)

Upon motion of Regent Glover it was VOTED, That the Regents now proceed to the matter of men's dormitories, which was made a special order of business. Mr. Stevens of the State Engineer's office was present and showed drawings of the proposed dormitories. Regent Gates presented the following resolution and moved its approval, seconded by Regent Brown:

RESOLVED, That the preliminary plans and arrangements for proposed dormitories for men students are hereby approved

and that the State Engineer is authorized to proceed to complete details and specifications; that the Executive Committee is empowered to approve all such details and to call for bids and let contracts for a number of such units, not to exceed eight, housing approximately eighty students each, according to the judgment of the committee after bids have been received; that the officers of the University Building Carporation ation be empowered to sign contracts on behalf of the Building when such contracts have the approval of the Executive Committee. The Executive Committee is further authorized to pay such fees for architectural service as it deems necessary.

The Regents then adjourned to Wednesday morning at 9 A.M. and visited the engineering shops to look at two types of dormitory rooms which were set up there.

Wednesday, March 9, 1938, 9 A.M.

The Regents met pursuant to adjournment, all present who were present on Tuesday, March 8.

The resolution of Regent Gates re dormitories, which was presented on Tuesday afternoon, was unanimously adopted. A poll of the Regents was taken on their choice of the two rooms as set up in the engineering shops building and all agreed that the one with the equipment on one side and with a removable desk was more satisfactory.

The matter of granting Music Hall to the North American Committee to Aid Spanish Democracy was again taken up for consideration.

Upon motion of Regent Glover, seconded by Regent Campbell, it was

VOTED to abide by the action of the Regents taken on March 8,

1933, which reads as follows:

VOTED, That the use of university buildings by public bodies and non-profit making associations having an educational purpose be approved on a charge basis and at times not interfering with other university uses, the basis to be agreed on between those in charge of such buildings and the high schools and other public bodies and associations desiring such use, provided that such bodies and associations are not profit-making bodies and that the use appears to be to

the advantage of the university in carrying out its educational program, it being understood that this authority is permissive, not mendatory, and does not prohibit the officers of the university from granting, at cost, the use of a university building for an approved public meeting for which no admission is charged.

Regent Kelly presented the following suggestion for an addition to the above ruling:

It is further established as a policy of the Board of Regents that the university buildings shall not be used by any organization, student or otherwise, for implied or ultimate objective of raising funds for any purpose other than those of an educational or curricular student activity. The decision as to the purpose for which these buildings are to be used shall be determined or approved by the committee on the use of university auditoriums. This action of the Regents shall in no way be interpreted as a curtailment of the right of free expression of student opinions or their right of public assembly.

Upon motion of Regent Gates it was
VOTED, That this matter be referred to the Student Life and
General Welfare Committee. A communication presented by the Business
Manager on the subject was also referred to this committee.

Deans Middleton and Fred appeared before the Board to discuss the matter of plans for cancer research and the possibility of providing for a 10,000,000 volt generator for use in this connection and other scientific research. The matter of funds available was discussed and Dean Fred explained that if the program was to be carried out the sum of \$122,000 would be needed from outside sources. No definite action taken.

President Dykstra presented the report of the faculty committee on their nominations for honorary degrees and recommended to the Regents the granting of the following honorary degrees at the commencement in June:

degrees

Upon motion of Regent Callahan, seconded by Regent Miller, the recommendation was unanimously approved.

Upon recommendation of President Dykstra it was VOTED, That in accordance with the recommendation of the faculty of the College of Agriculture the name of the department of agricultural chemistry be changed to the department of bio-chemistry, this change to carry with it the change in titles of the staff.

Upon recommendation of President Dykstra and upon motion of Regent Gates, seconded by Regent Callahan, it was VOTED, That the following rules relating to exemption of graduate students from non-resident tuition be approved:

In general, graduate students are required during the regular year to pay the same fees as are undergraduates, with the following exceptions: (a) instructors, graduate teaching and research assistants, fellows, and scholars are exempt from the non-resident tuition fee and from laboratory fees in courses taken either in the department in which they hold appointments or in the department in which they major; (b) honorary fellows and honorary scholars are exempt from the nonresident tuition and from the incidental fee of \$12; honorary fellows, in addition to these exemptions, are exempt from payment of laboratory fees; (c) instructors and graduate teaching and research assistants are exempt from laboratory fees in the department in which they hold appointments and, unless otherwise specified in their appointment, from the non-resident tuition. (e) (d) members of the teaching and research staff of the University not designated in (a) above, members of the State Geological and Natural History Survey, members of the technical staff of the Forest Products Laboratory, staff members of the United States Department of Agriculture stationed at the University and engaged in research, technical experts employed in any department of the state government, and officers of the United States Army detailed as students by proper authority are exempt from the non-resident tuition fee. The registration, physical education, infirmary and Union fees are required of all students.

When any candidate for a higher Ph.D. degree holding an appointment listed in the preceding paragraph shall have paid to the University as a graduate student seven semesters or summer session fees, he shall be exempt from further payment of the incidental portion of the general fee but not from the registration, physical education, infirmary or Union fees, in both the regular and the summer sessions, as long as he shall continue to hold such official appointment. In the administration of this rule, one, but only one, nine-week summer session fee or its equivalent may be counted as two of the seven fees above mentioned; also the full amount of any prescribed fee shall be charged. A maximum of two semesters may be credited from other schools as two of the seven fees.

Upon motion of Regent Glover, seconded by Regent Campbell, it

voted, That the recommendation of Dean Baldwin to request an appropriation of \$3000 from the Emergency Board to provide equipment for the WPA project of research in social sciences be approved.

President Dykstra reported on his investigation of research in diseases of fur-bearing animals and stated that a sub-committee of the Graduate Research Committee would have charge of the work and that funds were available through the Conservation Commission to carry it on to the end of the present fiscal year. Upon motion of Regent Gates, seconded by Regent Glover, it was

VOTED, That \$8000 be accepted for that purpose, 1/3 to come from the Conservation Commission, 1/3 from the Emergency Board and 1/3 from the breeders of fur-bearing animals. It is understood that addi-

tional appropriations will be made for the year 1938-39.

President Dykstra announced that Mr. J. D. Phillips, Business Manager, retires from University service on July 1, 1938, and recommended leave of absence for Mr. Phillips on the summer session basis from April 1 to July 1; it is to be made a matter of record that he does not leave his position as Business Manager until July 1, 1938.

Upon motion of Regent Callahan, seconded by Regent Gates, this recommendation was approved.

President Dykstra then stated that this leaves open the question of the operation of the business office during the next three months and recommended that during the period April 1 to July 1, 1938, the present comptroller, A. W. Peterson, be authorized to act in the absence of the Business Manager in those capacities which are set up in the rules of the Board of Regents.

Upon motion of Regent Kelly, seconded by Regent Gates, this recommendation was approved.

Regent Gates discussed the possible need of extending the time for opening of bids on the addition to the Memorial Union Building, which date has been set for March 18, 1938. Upon motion of Regent Glover, seconded by Regent Kelly, it was

VOTED to authorize an extension of time for opening of the bids, if necessary, in cooperation with PWA and the State Engineer's

office.

RECOMMENDATIONS OF THE BUSINESS MANAGER

1. That upon the recommendation of the State Director of Purchases, the contract for diplomas for the period from February 15, 1938 to February 15, 1941, be awarded to the B. C. Kassell Company of Chicago at a unit price of \$.47 for each diploma including name, date, and degree, and that the Business Manager be authorized to sign the contract.

Adopted.

2. That \$4500 be transferred from Regents' Unassigned 1-D to General University Service - Life Saving, for the purchase of a new launch.

Adopted.

- 3. That upon the recommendation of Colonel Weaver \$125 be transferred from Regents' Unassigned 1-D to Military Science Equipment.

 Adopted.
- 4. That upon the recommendation of the Athletic Board, authority be granted to prepare preliminary plans for the proposed <u>future</u> development of Camp Randall Stadium, the estimated cost of \$250 to be charged to the 5-C Athletic Council Revolving Fund.

The amortization of \$53,370 will require an annual rental of \$4269.60. To this there may be added the amortization of not in excess of \$2000 for connecting the property with University utilities. The total annual rental, therefore, will not exceed \$4500.

 Adopted.
- 14. That upon the recommendation of the President, \$78.93 be transferred from Regents' Unassigned 1-A to General University Service Supplies and Expense, to cover taxes on the WHA transmitter house, in lieu of rent in accordance with the lease.

 Adopted.



Upon motion of Regent Callahan, seconded by Regent Glover, approved.

Business Manager Phillips reported on the waiver payments and on a recommendation from Director Halverson that no change be made in dormitory room rates for the coming summer session.

A statement was made with reference to the work done by the CCC camp at the Arboretum and upon motion of Regent Callahan, seconded by Regent Kelly, it was VOTED, That President Dykstra be requested to write to Mr.

VOTED, That President Dykstra be requested to write to Mr. Arno Cammerer, Director of the National Park Service, Washington, D.C., an expression of the appreciation of the work performed by the Camp at the Arboretum.

Regent Callahan presented a request from the American Legion for an appropriation of \$100 for the Memorial Day exercises, to be held on the State Capitol grounds instead of the University campus. Action was postponed to the April 27 meeting of the Board.

Dean Holt appeared before the Board to discuss the situation in the University Extension Center in Milwaukee and the matter of credit courses given by the Milwaukee Vocational School. He explained the shortage of revenue in the University Extension Division, but stated that the budget for the biennium would be in balance.

At 12:15 the Regents went to the Memorial Union Building for the annual joint session of Regents and Visitors.

The report of the Board of Visitors recommended more coopera-

tion between the two boards. A quorum of the Board of Regents was present and upon motion of Regent Callahan, seconded by Regent Gates, it

VOTED, That the President of the Board of Regents be requested to appoint Regent members on a joint committee of Regents and Visitors.

President Dykstra suggested that quarterly meetings of the Regents and Visitors might be held on the second day of the meeting of the Board of Regents. Upon motion of Regent Gates, seconded by Regent Kelly, it was

VOTED, That a joint meeting of Regents and Visitors be held at the next meeting of the Board, April 27, 1938.
