ANNUAL MEETING OF THE BOARD OF REGENTS

sion.

A communication was received from Regent Mead in explanation of his absence.

President Dykstra called attention to an invitation to the Regents to the luncheon of the 4H Clubs at the Men's Dormitories, the garden party for members of the Wisconsin Alumni Research Foundation at 4 P.M. at the home of Mr. T. E. Brittingham, the dinner to the past presidents of the Wisconsin Alumni Association at the Madison Club at 7 P.M., and the Alumni banquet on June 18.

President Dykstra requested a correction in the minutes of the meeting of the Regents held on June 3, in which it was stated that provision was to be made for ten graduate scholarships of \$250 each, one for each of the nine State Teachers Colleges and one for Stout Institute, if the Committee on Research finds it feasible to do so.
