- (b) 25.00 - Madison Garden Club, Madison, Wisconsin, for the viburnum planting program at the University of Wisconsin Arboretum. (Fund 15-758)
- (c) 500.00 - Mr. F. S. Turneure, Ann Arbor, Michigan, to be added to the Dean F. E. Turneure College of Engineering Student Loan Fund. Funds previously received are to be transferred from the Trust Fund Account, added to this contribution and placed in the Student Loan Fund. Loans may be made to students without interest while they are enrolled in the College of Engineering, but such funds are to bear interest at the rate of 4% per annum after the borrower is no longer a student. (Student Loan Fund)
- (d) 236.18 - Student Service and Relief Commission of Student Board to be added to the Campus Chest Foreign Student Emergency Fund. Any foreign student attending the University of Wisconsin will be eligible to receive a gift of not to exceed \$50.00 from this fund on the basis of a recommendation from the Committee on Loans and Undergraduate Scholarships. - (s) 2,000.00 - Minnesota Mining and Manufacturing Company, St. Paul, Minnesota, for the renewal of the "Minnesota Mining and Manufacturing Company Fellowship in Chemistry" during the 1952-53 academic year. \$1,400 will be used as the stipend of the fellow selected, and \$600 will be used to cover tuition and other expenses. The selection of a graduate fellow is to be left entirely at the discretion of the University. However, the donors have indicated an interest in subject matter related to polymerization. The major basis for selection, however, is to be "unusual promise as a scientist." (Fund 15-114)

An award of \$500 is to be made to a student in mining and the same amount to a student in metallurgy. The scholarships shall be awarded to undergraduate students who are residents of Wisconsin, for excellence in chemistry or biology and whose qualities show promise in research particularly in cancer research, upon the recommendation of the Committee on Loans and Undergraduate Scholarships. - (b) 5,000.00 - National Science Foundation, Washington, D.C., in support of research on the Chemistry and Metabolism of Biologically Active Substances for a period of approximately one year beginning September 1, 1952, in the Department of Biochemistry. This grant may be revoked in whole or in part by the Foundation after consultation with the principal investigator and the grantee institution. (Grant No. NSF-G48) (Fund 16D-669)

- a. A pilot study in which the participating faculty will have students in one of their classes assigned as advisees. The number of students assigned to one of these experimental sections will be reduced by approximately one-quarter.
- b. A pilot study in which a small group of advisers will devote approximately one-third of their time to the advising program. They will advise approximately thirty freshmen and in addition will, after studying the program for a semester, make recommendations regarding a college-wide program.
- c. Revision of the Course Assemblies. At these meetings freshmen prepare their study lists for the first semester. In the past, a member of the Dean's staff has been in charge of some 900 students. We propose to break up this large group into units of 20 to 30 and to assign an experienced faculty member to each group.
- d. Assignment of a member of each department to handle inquiries from advisers in other departments and from students. He will provide information concerning major requirements, assist students in comparing their aptitudes and interests with those required for a major in that department, keep abreast of professional opportunities for majors.
- e. Making available to advisers additional information regarding the student's scholastic ability, his interests, aptitudes, health, and also periodic reports of academic achievement.
- f. Preparation of fuller, more useful, and more clearly stated information regarding degree requirements and administrative procedure. Wherever possible this material will be summarized in chart form.
- g. Delegation of following duties to a member of the Associate Dean's staff:
 - (1) The coordination of the pilot studies with the program which will continue to operate under the old system.
 - (2) The preparation of reports regarding the pilot studies.
 - (3) The improvement of information materials, and the simplification of various procedures currently in use.

He will devote one-half time to the advising program within the College.

Regent Renk stated that the plan for a study of the improvement of the advisory system in the College of Letters and Science was a good step in the direction of meeting the suggestions by the Board of Visitors and some of the Regents for the improvement of the advisory system.
