Confirming my conversation with you this morning, the University is the beneficiary now of a trust fund as the result of the death on September 22, 1932 of my uncle, Beverly Marvin Brittingham. I quote the fifth paragraph from the will of Mary C. Brittingham:

"FIFTH: (1) I give and bequeath unto my trustee, hereinafter named, the sum of Ten Thousand Dollars, in trust, to pay the income therefrom from time to time, at least quarterly, to my brother-in-law, Beverly Marvin Brittingham, during his lifetime, and upon his death to pay the principal of said trust fund to the Board of Regents of the University of Wisconsin, and to their successor or successors, upon the following conditions: Said fund shall be known and designated as the Mary Clark Brittingham Fund; no part of the principal thereof shall ever be used or expended, but the net income from the same shall, under the supervision or upon the recommendation of the Professor of Medicine (of said University of Wisconsin) be devoted to investigations and research in the field of internal medicine."

This money is invested in a long term five per cent. (5%) note of the family corporation of which my brother-in-law in Chicago is president. It is the finest investment that I know of so far as safety and income are concerned, as the entire number of securities which my father left us children are owned by the company owing this note. This was the property of my mother when she died. It was the property of the trust fund set up for my uncle during his life, and as such it is all the trust has to offer to the University. The authority to invest in this note was granted in a further stipulation in the will on page six, an extract of which follows:

"My said executor and trustee is expressly authorized to invest and reinvest the property or funds coming into his hands in such securities as he shall deem best, or to retain any security which I may own."

Should the University decide to accept this, I would like to request that some kind of a report giving the fields of research for

which this money has been spent, as defined in the above quoted paragraph, be sent each year.

The Business Manager is authorized to enter into a rental agreement with the officers of the Northern Wisconsin Tobacco Cooperative Association whereby the University agrees to lease to the Tobacco Association for a period of five years, with the privilege of cancellation after the end of one year at the pleasure of the Tobacco Association, the building originally known as the Forest Products Service Building and attached barn used by the Forest Products Laboratory and now vacated and reverting to the University. The Northern Wisconsin Tobacco Cooperative Association will use this building for experimental purposes in connection with their program of finding new market outlets for Wisconsin tobacco and in this program of experimental work they will have the advice and counsel of certain members of the staff of the University.

In the execution of this cooperative program with the Tobacco Association the University is not committing itself to any budgetary expense. The Association itself will buy the machinery and equipment necessary for the experimental work and will assume entire responsibility for the work carried on in the building and will pay all costs involved.

In consideration of the use of the building the Tobacco Association agrees to pay to the University rent at the rate of \$30 per month for the building and \$20 per month for heating and high pressure steam. The steam consumption will be measured during a part of the first year of this agreement and the charge for succeeding years will be based on the meter readings.

Actual cost of city water, gas, electricity, and telephone service will be paid for by the Tobacco Association.

The Tobacco Association agrees to assume the cost of maintenance of the building during the life of this agreement, and to turn the building back to the University at the expiration of this agreement in as good a condition as it is at present, ordinary wear and tear excepted.

It is understood that since the old Forest Products Service Building and attached barn is now a part of the College of Engineering plant, the College of Engineering will have first claim on the space being made available to the Tobacco Association when the building is vacated by the Tobacco Association in accordance with the terms of the rental agreement.
