The reading of the minutes of the meeting of the Board held on June 17, 1933, was dispensed with and the minutes were approved as sent out to the Regents.

## RECOMMENDATIONS OF THE SECRETARY

1. That an appropriation of \$550 from University Trust Funds Principal, Torger G. Thompson Estate, be made for the remodeling of the house at 618 Division Street, Madison.

Upon motion of Regent Backus, seconded by Regent Sholts, adopted.

2. That a check for \$500 from Theodore Herfurth be accepted as the initial payment on a fund to perpetuate the Theodore Herfurth Efficiency Prize; that the amount be credited to the University Trust Funds Principal and that authority be granted to receive additional sums in the future; that the \$500 received be allowed to participate in the income of the trust funds for 1933-34; that the income each year be added to the principal until the principal is sufficient to provide for the \$100 annual prize.

#### RECOMMENDATIONS OF THE BUSINESS MANAGER

1. That the following resolution relating to the University Club be adopted:

"WHEREAS, At a special meeting of the Executive Committee of the Regents held on April 28, 1933, the following resolution was unanimously adopted:

That deed to the University Club property be accepted subject to a total encumbrance of \$140,000, which is first lien and sole lien upon the property, upon condition that the second mortgage bonds are wiped out for 50 cents on the dollar on the principal amount; that if present second mortgage bonds should not be retired for 50% of the principal amount, then the Regents may return title to the University Club House Association. It is understood that the Annuity and Investment Board has placed in escrow \$23,000 to retire the second mortgage bonds on the 50% basis above indicated and for other uses of the Club House Association. Sixty days from date hereof, if the mortgage is not satisfied, the \$23,000 in escrow is to be returned to the Annuity Board and title to the property is to revert to the University Club House Association.

RESOLVED, That since the University Club House Association deeded the property to the Regents of the University of Wisconsin on April 29, 1933, and since the second

mortgage bonds have all been retired on the 50% basis, the \$140,000 note and mortgage, and the deed to the Regents be released from escrow: that the \$140,000 mortgage be paid by the University Club in accordance with the attached amortization schedule, which provides for 60 semi-annual payments of \$4,274.95 each, beginning October 28, 1933; that these payments be made direct by the University Club to the State Annuity Board in monthly installments; that the monthly installments due May 28, 1933, June 28, 1933, July 28, 1933, be made as soon as the papers in escrow are released; that the said University Club is permitted to remain in possession of the said premises until further order or direction of the Board of Regents."

transfer properly payable out of 1-A, but not exceeding the \$2700 set up in proposed budget. Any addition to the proposed physical education budget following report by the physical education committee will be absorbed out of the Regents' Unassigned fund. The physical education committee will report to the executive committee, to which this matter is referred with power to act.

The <u>budget for 1933-34</u> was taken up for consideration and President Frank distributed three statements showing specific fund appropriations, a summary analysis of 1-A, Operation, and a statement of 1-A Salaries and Wages, showing various salary ranges, size of staff, money involved, etc., for the convenience of the Regents in arriving at the waiver necessary to produce \$462,652. The President explained that the Finance Committee had spent two full days in considering the budget in detail.

Upon motion of Regent Grady, seconded by Regent Mead, it was

VOTED, That a registration fee of \$5 for each semester be charged each student in the future and that a graduation fee of \$5 be established.

Upon motion of Regent Wilkie, seconded by Regent Gundersen, Regent Grady's motion was amended to the effect that in addition to the fees mentioned there be charged in the Schools of Law and Medicine additional professional school fees, amounting in the case of the School of Law to \$25 per semester per student and in the School of Medicine to \$50 per semester per student, and that in each case there be established scholarships to worthy and needy students, consisting of the amounts of said professional fees, the number of the scholarships to be arrived at by consultation of the Executive Committee with the Deans of the Law and the Medical Schools, with full power to the Executive Committee to determine the number to be awarded. The Executive Committee is also directed to fix a schedule of charges, if any, which should be made against students taking work in the said professional schools who are not regularly enrolled therein.

Called vote was taken, all Regents present voting and voting "Aye", except Regent Berger, who voted "No".

Called vote was then taken on the original motion, all Regents present voting and voting "Aye".

President Frank read resolutions which were presented by W. M. Card, instructor in English, representing a committee of in-

structors and assistants, with reference to the reduction of time of service and application of waivers, also resolutions presented by the Teachers' Federation. Professors Harold Groves and Ethel Thornbury and Instructor Card appeared before the Regents to discuss the matter.
