REGULAR MEETING OF THE BOARD OF REGENTS

Madison, Wisconsin

Saturday, November 15, 1947, 10 A.M.

President Sensenbrenner presiding

PRESENT: Regents Arveson, Callahan, Campbell, Gelatt, Grady, Hodgkins, Jones, Kleczka, Sensenbrenner, Werner.

Upon motion of Regent Werner, seconded by Regent Kleczka, it was VOTED, That the minutes of the postponed regular meeting of the Board held on October 25, 1947, be approved as sent out to the Regents.

RECOMMENDATIONS OF THE PRESIDENT

- Faculty Actions -

1. That the following faculty actions be approved:

- (1) Recommendation of the College of Letters and Science for changes in the requirements for the degree of Bachelor of Music and the University Teachers' Certificate:

Candidates for the degree of Bachelor of Music who wish to obtain the University Teachers' Certificate are required to register also in the School of Education at the beginning of the junior year and to earn (subject to the quality-of-work rule) a total of 125 credits and 125 grade-points, including a minimum of 40 credits in Letters and Science and the 19 required credits in Education. The degree for such students will not be awarded unless and until the requirements for the certificate have been met, and vice versa.

Elementary Schools, 4 credits.
2. Education 5, Music Education for  
Secondary Schools, 4 credits.
3. Education 73, The Child: His Na-  
ture and His needs, 3 credits.

rection of Learning, 5 credits.

Barschall as expert consultant, University of California, in connection with research conducted at Los Alamos, New Mexico, by the University of California under contract with the United States Government.

President Fred read a letter from City Manager Leonard G. Howell in which Mr. Howell expressed the appreciation of the City of Madison for the orderly manner in which the University of Wisconsin 1947 Homecoming activities were conducted.

### III. Report of Contracts and Leases Signed

1. In accordance with authority granted by the Regents for the Director of Business and Finance to sign contracts and agreements for educational services requested by the Government, a contract has been signed with the United States of America for a course of instruction in Journalism for six Army Ground Forces Officers. The Government will pay the equivalent of the non-resident tuition. The period of the contract is for the academic years 1947-48 and 1948-49.

2. In accordance with authority granted by the Regents for the Director of Business and Finance to sign leases, contracts and agreements for the use of the Badger Ordnance Works, and with the approval of the Public Housing Administration, sub-leases have been signed for the following facilities:

In accordance with authority granted by the Regents for the Director of Business and Finance to sign leases, contracts and agreements required for the use of the Badger Ordnance Works, a consolidated lease has been signed covering all of the facilities at Badger which are being used by the University. This lease supercedes the separate agreements for the barracks area, the row housing area, and the staff housing area. The period of the lease is November 1, 1947 to June 30, 1948, and is automatically extended for additional terms of one year each unless cancelled by either party on thirty days' notice. The rental is \$15 per year per family dwelling unit and all net proceeds from the operation of the housing project.

Upon motion of Regent Kleczka, seconded by Regent Campbell, the report of contracts and leases signed by the Director of Business and Finance in accordance with Regent authority was approved.

### IV. CONFIDENTIAL REPORT - NOT FOR PUBLIC RELEASE

1. The Navy Department has authorized an increase in the amount of Contract NOrd 9938 from \$125,000 to \$267,000, and also has authorized an extension of the term from August 31, 1948 to August 31, 1949.

Upon motion of Regent Grady, seconded by Regent Werner, the confidential report was approved.

Regent Werner presented the report of the Finance Committee. Upon motion of Regent Werner, seconded by Regent Arveson, it was

VOTED, That to meet additional costs of labor, food and supplies all per diem rates in the State of Wisconsin General Hospital be increased \$1.00, effective December 1, 1947, and that the Emergency Board be requested to approve an increase from \$8.00 to \$9.00 per day in the rate for public patients.

Upon motion of Regent Werner, seconded by Regent Hodgkins, it was

VOTED, That the Director of Business and Finance be authorized to sign a service contract with the Otis Elevator Company for the maintenance and repair of all hospital elevators and lifts, at an estimated cost of \$5232 annually; chargeable to 10-A Hospital Operation Funds.

Upon motion of Regent Werner, seconded by Regent Hodgkins, it was

VOTED, (1) That Cummings Hall dormitory (School Building #1507) be closed temporarily on December 1, 1947, for the balance of the fiscal year;

(2) That the University Housing Bureau and the Division of Residence Halls be directed to make every possible effort to provide other housing accommodations for the married students living in the hospital area at Truax Field to the end that the use by the University of housing facilities in the Truax Hospital may be discontinued by June 30, 1948.

Upon motion of Regent Werner, seconded by Regent Grady, it was

VOTED, That the penalty for the late payment of fees be waived for the first semester of 1947-48 in the case of Paul M. Laughton, a Canadian veteran, who was prevented by illness from registering at the regular time.

Upon motion of Regent Werner, seconded by Regent Kleczka, it was

VOTED, That the 2-AB University Extension Division revolving fund budget be increased \$4000 for the fiscal year 1947-48 to provide funds for off-campus School for Workers classes, distributed as follows: Salaries and Wages \$3400; Supplies and Expense \$600.

Upon motion of Regent Werner, seconded by Regent Hodgkins, it was

VOTED, That the Director of Business and Finance be authorized to sign an agreement with the National Academy of Sciences, Washington, D.C., for a research project to be conducted in the South Pacific area, at an estimated cost of \$8125, the funds for which will be provided by the National Academy of Sciences, and that authority be granted to advance funds for travel and miscellaneous expenses to Professor John H. Useem. *Agreement in Gift Sec.*

Upon motion of Regent Werner, seconded by Regent Kleczka, it was

VOTED, That upon the recommendation of the Director of the Summer Session, the fees for the eight-week summer session be increased from \$45 to \$50 and that a fee of \$70 be charged in the Law School summer session of ten weeks, effective with the 1948 summer terms.

✓ Regent Jones presented the report of the Constructional Development Committee. Upon motion of Regent Jones, seconded by Regent Hodgkins, it was

VOTED, (1) That on the recommendation of the Campus Planning Commission as set forth in the Minutes of the Commission under date of November 4, 1947, authority be granted to complete the plans and specifications for the New Engineering Building, Library Building, and Dairy Industry Building;

(2) That the Director of Business and Finance be authorized to request the Governor to release additional funds from the Post-War Construction appropriation for the preparation and completion of plans and specifications as follows:

Dairy Industry Building	\$ 65,000
Engineering Building	175,000
Library Building	82,000.

Mr. Roger Kirchhoff, State Architect, and Dean Withey explained the construction and location of the proposed Library and Engineering Buildings and displayed models of the proposed buildings.

✓ Upon motion of Regent Jones, seconded by Regent Kleczka, it was VOTED, That the Director of Business and Finance be authorized to sign a contract with Hansen and Dobberman of Superior for architectural services in connection with the Service Building for the Spooner Branch Station. (The estimated amount of the contract on a percentage basis is \$2500.)

✓ Upon motion of Regent Jones, seconded by Regent Werner, it was VOTED, That the Director of Business and Finance be authorized to sign a contract with Schmidt, Garden and Erickson, architects and engineers, Chicago, Illinois, for architectural work in connection with the proposed additions to the State of Wisconsin General Hospital Building, with the understanding that the total commitment for architects' services will be within the appropriation made available by the Legislature for the preparation of plans and specifications.

✓ Upon motion of Regent Jones, seconded by Regent Hodgkins, it was VOTED, That on account of increased costs of construction and additional construction work, the Wisconsin University Building Corporation be authorized to borrow \$50,000 additional, making a total of \$800,000 instead of \$750,000, for the construction of the Charles Sumner Slichter Dormitory (addition to Van Hise Dormitory). (On September 14, 1946, the Regents authorized a loan of not to exceed \$750,000.) This is in addition to approximately \$41,300 for furniture and furnishings charged to the 5A Residence Halls Revolving Fund.

✓ Upon motion of Regent Jones, seconded by Regent Werner, it was VOTED, That the Wisconsin University Building Corporation be authorized to pay a fee of 5% to the George A. Fuller Company for work on the Charles Sumner Slichter Dormitory in excess of the scope of the original project. The estimated cost of the additional work performed is \$54,480, and the estimated additional fee on this basis would be \$2,724.

## PREMEDICAL COURSE

Premedical requirements.- Beginning with the year 1948 for civilians and 1949 for veterans the following courses and electives to make a total of 90 credits will be required for admission to the University of Wisconsin Medical School. English composition, 6 credits; English or American Literature, 6 credits; general chemistry 8-10 credits; organic chemistry 8 credits; zoology 5 credits; embryology, 3-5 credits; physics, 8-10 credits; physical chemistry, 3 or 4 credits; mathematics, one semester in college or credit for 3a, 3-4 credits; a reading knowledge of either French or German which may be satisfied by the completion of the fourth semester of french or German at the University of Wisconsin or an accredited college, with a grade of C, or by passing a reading knowledge or attainment examination in either language to be given by the appropriate department at the University of Wisconsin; and, Greek and Latin Derivations of Scientific Terms, General Classics 38, 3 credits, required of those who have not had 2 years of Latin in high school.

The candidates for the B.S. degree, Medical Science, must complete at least 90 credits including those indicated in the preceding paragraph, and a major in medical science with a total of 120 credits.

The candidates for the B.A. degree, Medical Science, must meet the specific requirements mentioned above, the special requirements of the B.A. degree in the General Course, and a major in Medical Science with a total of 120 credits.

Major.- A major in Medical Science is provided for the students in the premedical courses who pursue the regular three year premedical sequence and who meet both the premedical and special degree requirements. The work of the major consists of a minimum of 25 credits in closely related medical subjects. In their senior year such students register in the Medical School as well as in the college of Letters and Science.

Twenty-four (24) credits shall be required for the M.A. degree in Hispanic Studies. Eight to twelve (8-12) credits should be taken in the Department of Spanish and Portuguese and the remaining 12-16 in related fields included in the major. Candidates should include in their programs at least one seminar for a year. A thesis is required.
