SPECIAL MEETING OF THE EXECUTIVE COMMITTEE

Madison, Wisconsin

Friday, August 26, 1938, 10 A.M.

A special meeting of the Executive Committee of the Regents of the University of Wisconsin was held on the 26th day of August 1938.

The meeting was called to order by the Chairman of the Executive Committee and on roll call the following answered present: John Callahan, Harold M. Wilkie, Clough Gates, constituting the entire membership of the Executive Committee.

After discussion of the offer of the United States of America to aid by way of grant in financing the construction of dormitory buildings including necessary equipment, the following resolution was proposed by Regent John Callahan and read in full:

A RESOLUTION ACCEPTING THE OFFER OF THE UNITED STATES TO THE REGENTS OF THE UNIVERSITY OF WISCONSIN TO AID BY WAY OF GRANT IN FINANCING THE CONSTRUCTION OF DORMITORY BUILDINGS INCLUDING NECESSARY EQUIPMENT

Be it resolved by the Regents of the University of Wisconsin

SECTION 1. That the offer of the United States of America to the Regents of the University of Wisconsin to aid by way of grant in financing the construction of dormitory buildings, including necessary equipment, a copy of which offer reads as follows:

1. Subject to the Terms and Conditions (PWA Form No. 230, as amended to the date of this Offer), which are made a part hereof, the United States of America hereby offers

to aid in financing the construction of dormitory buildings, including necessary equipment (herein called the "Project"), by making a grant to The Regents of the University of Wisconsin (herein called the "Applicant") in the amount of 45 per cent of the cost of the Project upon completion, as determined by the Federal Emergency Administrator of Public Works (herein called the "Administrator"), but not to exceed, in any event, the sum of \$229,909.

2. By acceptance of this Offer the Applicant covenants to begin work on the Project as early as possible but in no event later than 8 weeks from the date of this Offer and to complete such Project with all practicable dispatch, and in any event within 16 months from the commencement of construction.

3. This Offer is made subject to the express condition that, if the Administrator shall determine at any time that the Applicant has paid or agreed to pay, whether directly or indirectly, a bonus, commission or fee to any person, firm or corporation for attempting to procure an approval of the Applicant's application, or for alleged services in procuring or in attempting to procure such approval, or for activities of the nature commonly known as lobbying performed or agreed to be performed in connection with the application, then the Administrator shall have the right, in his discretion, to rescind this Offer and any agreements resulting herefrom, and, in the event of such rescission, the United States of America shall be under no further obligation hereunder.

SECTION 2. That said Regents of the University of Wisconsin agree to abide by all the Terms and Conditions relating to such grant, a copy of which Terms and Conditions were annexed to the Government's offer and made a part thereof.

SECTION 3. That the Secretary of the Regents of the University of Wisconsin be and he is hereby authorized and directed forthwith to send to the Federal Emergency Administration of Public Works three certified extracts from the minutes of this meeting showing the adoption and containing the full text of this Resolution, and such further documents or proofs in connection with the acceptance of the Government's offer as may be requested by the Federal Emergency Administration of Public Works.

The above resolution was seconded by Regent Clough Gates and was adopted, with the following voting aye: Callahan, Gates, Wilkie, and the following voting nay: None.

Upon motion duly made and seconded, the following resolutions relating to additional dormitories for men were adopted:

Resolution authorizing loan from Annuity Board to provide 55% of estimated cost of five additional men's dormitories and kitchen:

That the Wisconsin University Building Corporation be authorized to borrow \$281,000 from the Annuity Board to be amortized over a period of thirty years with interest at four per cent per annum, and that authority be given to combine this loan with the present loan of \$289,280 maximum incurred May 3, 1938, making the total combined indebtedness of the Corporation for new men's dormitories \$570,280. It is understood that any part of the \$289,280 loan not needed for the three units of men's dormitories now under construction may be used for necessary construction and equipment costs in connection with the five additional units of men's dormitories and the kitchen to be financed under the P.W.A. grant of \$229,909, Project - Wisconsin 1501-F.

Resolution approving leases between the Regents and the Wisconsin University Building Corporation:

(a) That in accordance with the provisions of section 36.06 (6) of the Wisconsin Statutes the lease of lands by the Regents to the Wisconsin University Building Corporation executed May 3, 1938, and covering the site on which the new men's dormitories are located and will be located be ratified, confirmed, and approved in so far as it pertains to the area to be used for the construction of five additional units of men's dormitories and a kitchen as proposed in the acceptance of the offer of the United States, P.W.A. Docket Number Wisconsin 1501-F.

(b) That in accordance with the provisions of section 36.06 (6) of the Wisconsin Statutes, the President and the Secretary of the Regents be authorized to sign an amendment to the lease of buildings from the Wisconsin University Building Corporation executed May 3, 1938, or a new lease if necessary, to provide for an annual rental to be paid by the Regents from earnings of the Department of Dormitories and Commons in an amount sufficient to amortize the loan or loans from the Annuity Board incurred by the Wisconsin University Building Corporation in a period of thirty years with interest at four per cent per annum. The lease of May 3, 1938, specifies an annual rental of \$16,729.09 to amortize the loan of \$289,280 in thirty years. The additional loan

of \$281,000 to aid in financing the five additional units and the kitchen will require an annual payment of \$16,250.26. Therefore, if the total amount of \$570,280 is borrowed, the required annual cash payment on account of new men's dormitories will be \$32,979.35.

Resolution approving trust agreement for P.W.A. funds to aid in financing men's dormitories and kitchen:

That the President and the Secretary of the Regents be authorized to sign a trust agreement with the Wisconsin University Building Corporation for the custody and disposition of P.W.A. funds received by the Regents to aid in financing the construction of men's dormitories and kitchen, including equipment, P.W.A. Docket number Wisconsin 1501-F.

Schedule of costs - Additional men's dormitories and kitchen.

That upon the recommendation of the State Chief Engineer the following schedule of costs for five additional units of men's dormitories and kitchen be approved:

and that the Wisconsin University Building Corporation be authorized to revise the details of the schedule of costs within the total.

Approval of plans and specifications:

That the plans and specifications prepared by the State Bureau of Engineering for five additional units of men's dormitories and a kitchen be approved.

Authority to advertise for bids and award contracts:

That the Wisconsin University Building Corporation be authorized to advertise for bids on five additional units of

men's dormitories and a kitchen, including necessary equipment and to award contracts in accordance with the terms and conditions of the offer of the United States to aid in financing the project, P.W.A. Docket No. Wis. 1501-F.

The Comptroller reported on the finances of the Department of Dormitories and Commons and on the investment, indebtedness and amortization costs of the dormitory plant, as follows:

- (a) The present dormitories, both men's and women's, produced \$34,000 excess of revenue over expense available for amortization of loans in 1937-38.
- (b) The mortgage loans incurred by the Building Corporation for dormitories and commons will total \$1,105,280, when the projected plan for additional dormitories is completed, as follows:

- (c) The annual amortization cost of the loans totalling \$1,105,280, with interest at 4% will be \$63,918 for thirty years. This is approximately \$34 per year per student housed, including the students housed in all University dormitories, new and old.
- (d) It may be advisable to finance the annual carrying charge of \$63,918 by paying a part of it from cash applicable to reserves, thus reducing the amount to be charged against the annual operating revenues. This is the policy that has been followed in amortizing the loan for the construction of Tripp and Adams halls.

Regent Gates suggested that when it is time to establish definite rates and operating policies for the new units, consideration be given to a revision of the amortization schedules to permit the amortization of the entire principal sum over a longer period than thirty years.

Upon the recommendation of the Comptroller, it was VOTED, That beginning with the fiscal year 1939-40, the rates for room and board in the University dormitories be established at a figure sufficient to cover costs including a sum sufficient to meet annual rentals for amortization of construction and equipment loans, it being understood that costs include a suitable reserve basis for building repairs and equipment replacements and repairs.

Mr. Roger Kirchhoff, State Architect, presented sketches and a plot plan of the proposed lake shore dormitories for women. Mr. Kirchhoff suggested that these dormitories be placed between the Observatory hill road and the lake, and parallel with the road and the lake, and that the development include five connected units, with the central unit placed near the upper side of the area and the remaining units placed farther down the slope toward the lake and to the east and west of the central unit. The natural grade of this area will permit the substitution of a first floor for the top floor, as the "wing" buildings are located farther down the slope, thus making it possible to adhere to the general plan of three stories and basement in all of the five connected units.

Mr. Kirchhoff estimated that about five hundred girls could be housed in the five units, and that the PWA project (Wisconsin 1503-F) that has been accepted by the Regents would finance the central unit, which will include the kitchen and diningrooms, and two of the "wings". This would provide rooms for about 260 girls.

Upon motion duly made and seconded, it was VOTED: (a) That the site proposed for the new women's dormitories be approved.
(b) That the general plan for new women's dormitories presented by the State Architect be approved.
(c) That the State Architect be authorized to complete the plans and specifications for the proposed central unit and two "wings".

Upon motion duly made and seconded, it was VOTED, That the Public Works Administration be requested to extend the time for the commencement of construction of women's dormitories beyond the deadline of eight weeks from August 11, 1938, established in the PWA offer - Docket Wisconsin 1503-F.

Upon motion duly made and seconded, the following recommendations of Dean Sellery, on behalf of the President, were adopted:

1. That the title of George T. Fox be changed from football assistant to instructor in intercollegiate athletics for the academic year 1938-39; no change in salary, p. 29. (To correct an error in the budget)

3. That the Comptroller be authorized to approve bills and to make disbursements for necessary supplies, expense, and payrolls when approved by the University Radio Committee for radio stations WHA and WLBL, which have been transferred to the University as of September 1, 1938, pending the approval of a budget for the radio stations.

Adopted.

4. That the budget for the Agricultural Short Course dormitories and dining halls be approved, as shown in EXHIBIT A, attached.
Adopted.
